LeAnn Nelson, Director of Professional Development with NDEA

I little background on me. In the 1980's I graduated with a BA in elementary education and minor in computer information systems. At that time they did not know how to connect education with the technology. I ended up taking a lot of courses that I didn't need, which was a lot of programing courses, cobalt and etc. With education technology that is not the direction that technology went. So in the early 1990's I was the technology coordinator in a school district. In that position, I helped in purchasing the tools, technology, train teachers on the uses of software. O this it was Microsoft word. How do you use. We didn't get into how to integrate it into your classroom. Until recently, I assisted educators with integration of technology into curriculum. To successfully integrate technology it is important that teachers understand how to successfully integrate so that it enhances the curriculum. This means that they have to use the technology to learning strategies, align to technology standards, assess a tool successfulness by meeting the goals and objectives, and support and facilitate the use of technology with the students.

With initiatives such as the ND Teaching of Technology, ND educators are making huge strides in successfully integrating technology. It is not easy process. It is a different way of thinking and learning technology.. Even though I have researched, trained, and have observed successful integration, I have not actually been involved in implementing into the classroom. Because I have not been in the classroom for several years. This is why we feel it is important to have teachers on the Council, they give that different perspective.



HB#1444 relates to the membership of the Educational Technology Council(ETC). The legal description of the ETC is that it is responsible for the coordination of educational technology for elementary and secondary education. I was surprised to learn that the ETC Council which has 12 voting members and 3 non voting members did not include a single mandatory classroom teacher. It is possible that one of the groups represented MAY include a classroom teacher but this may or may not be the case. My short amendment requires that Section 1 letter i. would require that the two representatives of school districts will be active classroom teachers. Written testimony in Opposition of HB 1444 Lisa Feldner, Chairman Educational Technology Council January 27, 2003

I'm here to speak in opposition to HB1444. I serve as the Chairman of the Educational Technology Council or ETC. Please bear with me while I read two of the primary power and duties of the ETC from ND Century Code as it relates to our mission. The powers and duties are 1) to coordinate the use of technology and the development of technology systems to enhance educational opportunities for elementary and secondary education; and 2) to cooperate with state agencies and other organizations to develop statewide educational technology systems.

Prior to the 2001 legislative session, there was concern that the ETC was not meeting the needs of schools in the state. The Information Technology Committee, a legislative interim committee, asked a consultant to conduct a series of focus groups around the state to gain input. Based on the consultant's findings, the interim committee made two recommendations that were adopted by the 2001 legislature.

First, that the ETC be moved from the Department of Public Instruction to the ND Information Technology Department (ITD) in order to facilitate better coordination between all of the state technology initiatives. The ETC's budget and appropriation were also moved to ITD.

Second, that the ETC be reorganized to more closely reflect the stakeholders in North Dakota's educational community. At that time, there were only two educators appointed to the ETC: a superintendent and a teacher. There were no special education directors, even though special education is a field that relies heavily on assistive technologies. There were no technology coordinators even though they are responsible for the technologies employed in their schools. ND Association of Technology Leaders,

ND Council of Educational Leaders,

ND School Boards Association,

ND Special Education Directors,

ND State Association of Non-public Schools,

2 School district representatives – 1 from a district under 400 students.

When this council was appointed in 2001, there were two teachers. Since that time, however, one of them has become a high school principal. Potentially there could be six teachers depending on the recommendations coming from the represented organizations. For example, of the 200+ members of the ND Association of Technology Leaders, 80% are teachers who also have technology duties in their schools. LEGISLATIVE PROGRAM

- 1. The reimbursement for increases in teacher salaries provided by the 2001 Legislative Assembly, which reimbursed school districts for teacher salary increases up to \$1,000 for the first year of the biennium and up to \$3,000 for the second, should be continued at no less than the same compensation level for the 2003 biennium.
- 2. Teacher salaries are a matter of paramount importance and it is the responsibility of each local school district to determine such salaries, in accordance with local conditions and needs, so as to attract and retain quality professional instructional personnel.
- 3. The association continues to believe that the changing of school district boundaries is a matter for local determination. Therefore, any legislation that permits a reorganization to be effective without a favorable vote of the patrons of the district or districts that are affected, will be opposed.
- 4. The association opposes school district boundary changes or school closings based solely on reasons of location, size or level of grade offerings. We continue to believe that school district reorganizations based on factors that clearly show educational advantages for pupils are appropriate.
- 5. The 90% cap on state transportation costs should be eliminated and districts should be reimbursed for 100% of cost. Reimbursement for busses with a capacity of transporting 10 or more students should be increased from 67 cents to 75 cents per mile for transporting students living outside the incorporated limits of a city. Transportation services for special and vocational education should continue to be funded.
- 6. All schools should have access to improved distance learning technology for instructional purposes at this program should continue to be fund. Especially, the state should continue funding for the state-wide network. School boards should have the authority to levy up to 5 mills to meet funding costs. In addition, school building fund tax moneys should be allowed to be used for the purchase and

- maintenance of educational technology equipment for student instruction.
- 7. The establishment of each school's calendar is a matter of local control. The legislative assembly should permit schools to have more flexibility to determine the length of a school day. Schools should also be given the authority to provide an additional two days of state-funded professional staff inservice training to meet the standards for highly-qualified teachers under the federal "No Child Left Behind" Act.
