(17.8) BRUCE MURRY; ND PROTECTION & ADVOCACY PROGRAM: (Testimony in opposition.) We support the amendments offered by Rep. Kelsh. This Bill would allow townships, counties and cities to regulate it's obligation of transitional living. The United States Supreme Court has ruled that it is unconstitutional to dissolve developmental disabilities group home out of residential neighborhoods. I would propose a one word amendment which would have similar results to Rep. Kelsh's amendment. It would limit the scope of the Legislation to correctional facilities.

(19.5) CINDY GREY; SENIOR PLANNER/ZONING ADMINISTRATOR: (Testimony in opposition) (See attachment #5)

(24.1) CHAIRMAN GLEN FROSETH: In licensing group homes, the neighboring surroundings must be a considering factor?

(24.6) CINDY GREY: In the four years that I've been with the city of Fargo, I believe we've considered for strictly group home- transitional living facilities, no more than five applications. There are a couple of instances where in the downtown area, we have recently put in, in a transitional area right between a commercial district and a residential district that is serving individuals who sustain brain damage and cannot live on their own. Some cases it's transitional

Mr. Chairman and members of the committee, my name is Allan Stenehjem. I am the executive director of the Mental Health association in North Dakota. The MHA is a non-profit volunteer citizens organization affiliated with the National Mental Health Association.

The mission of the Mental Health Association in North Dakota is to ensure the availability of appropriate, accessible, and adequately funded treatment and support services for persons with mental illnesses and to remove the stigma associated with mental illness, throughout the state of North Dakota. During the last 3-4 decades, our organization has worked closely with the legislature, the department of Human Services, consumers and their families to move our state's delivery system from an over reliance on institutional or custodial care to a community-based system of care that enables them to be independent productive citizens.

The concept of HB 1491 is opposite of the approach the state adopted following the ARC lawsuit. That was to provide protection to persons with disabilities. Under section 25-16-14 the state made is clear that:

"a licensed group home serving six or fewer developmentally disabled persons must be considered a permitted use in a single-family or equivalent least-density residential zone, and a licensed group home serving eight or fewer developmentally disabled persons must be considered a permitted use in any area zoned for residential use of greater density than single-family use"

HB 1491 would put in effect state law that would not only allow discrimination against a certain class of citizens but it would say YOU SHALL discriminate against a class of citizens.

Mr. Chairman and Members of the Committee:

My name is Cindy Gray, Senior Planner/Zoning Administrator from Fargo. I am here today to speak for the City of Fargo in opposition to House Bill 1491.

Local zoning codes are designed to deal with the intricate details of development. Defining how different land uses relate to each other is one of the foundational elements of zoning law.

Most local zoning codes already address the appropriate placement of transitional living facilities, in addition to the appropriate placement of other types of residential, commercial, and industrial uses. The changes proposed by this bill would eliminate a local jurisdiction's ability to evaluate the merits of individual proposals when making zoning decisions regarding the placement of transitional living facilities. The type of individuals served by transitional housing may vary greatly, with some fitting well in a neighborhood setting near a school, and others needing an alternative location. This bill does not differentiate between those groups.

Transitional housing is an important component of the housing market. Transitional living facilities often provide some of a community's most disadvantaged individuals with an opportunity to move toward a more independent and self-sufficient lifestyle. Transitional living facilities tend to be operated by well-respected agencies that have a commitment to serving the best interests of their clients and the community of which they are a part.

Local officials are concerned about the appropriateness of each development that is proposed within their jurisdiction. Transitional living facilities are reviewed with the same level of scrutiny as are other developments. The circumstances that surround each proposal are likely to be more complex than a blanket "1,000 foot buffer" can accommodate. I encourage you to recommend a "do not pass" for HB 1491.

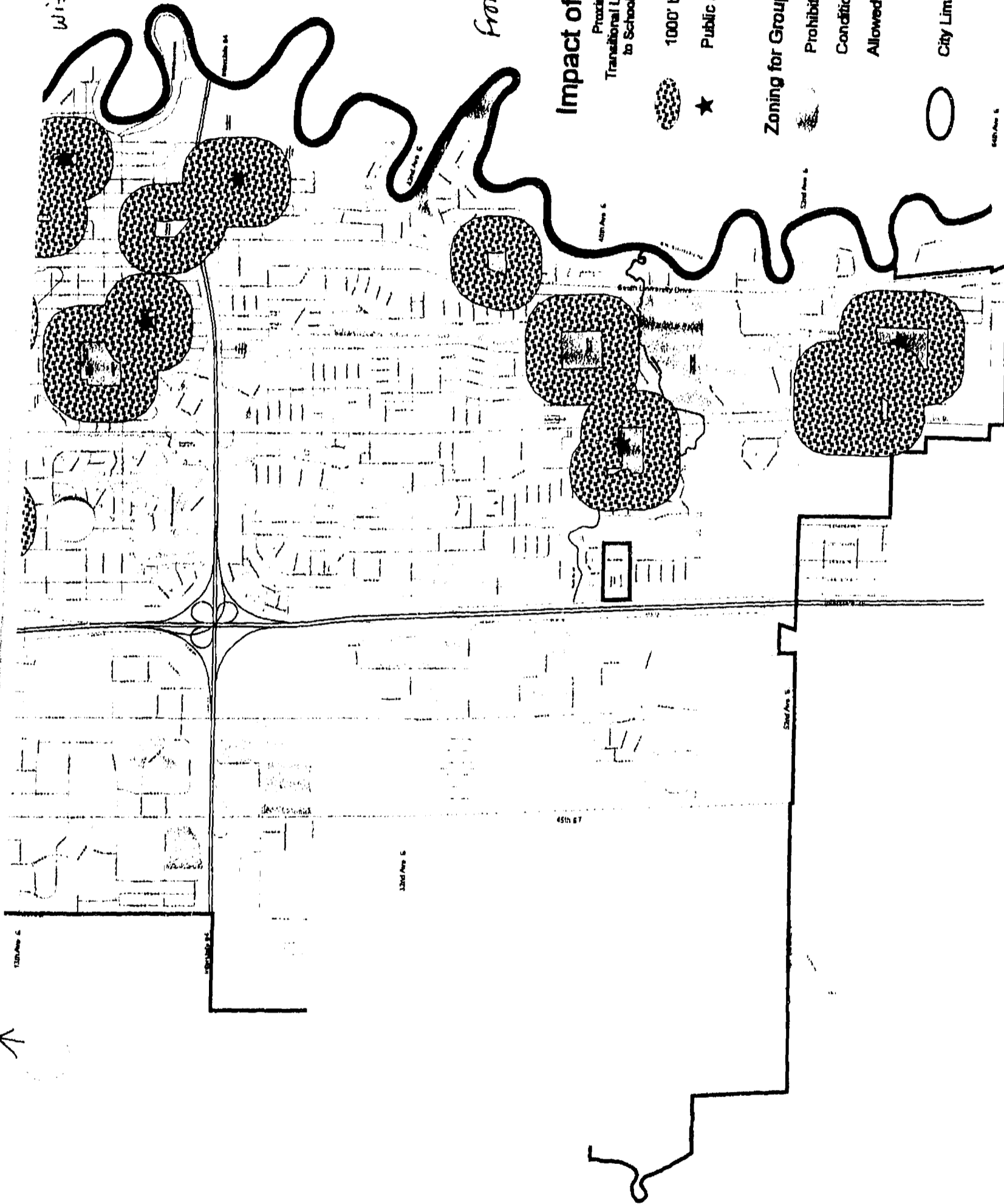

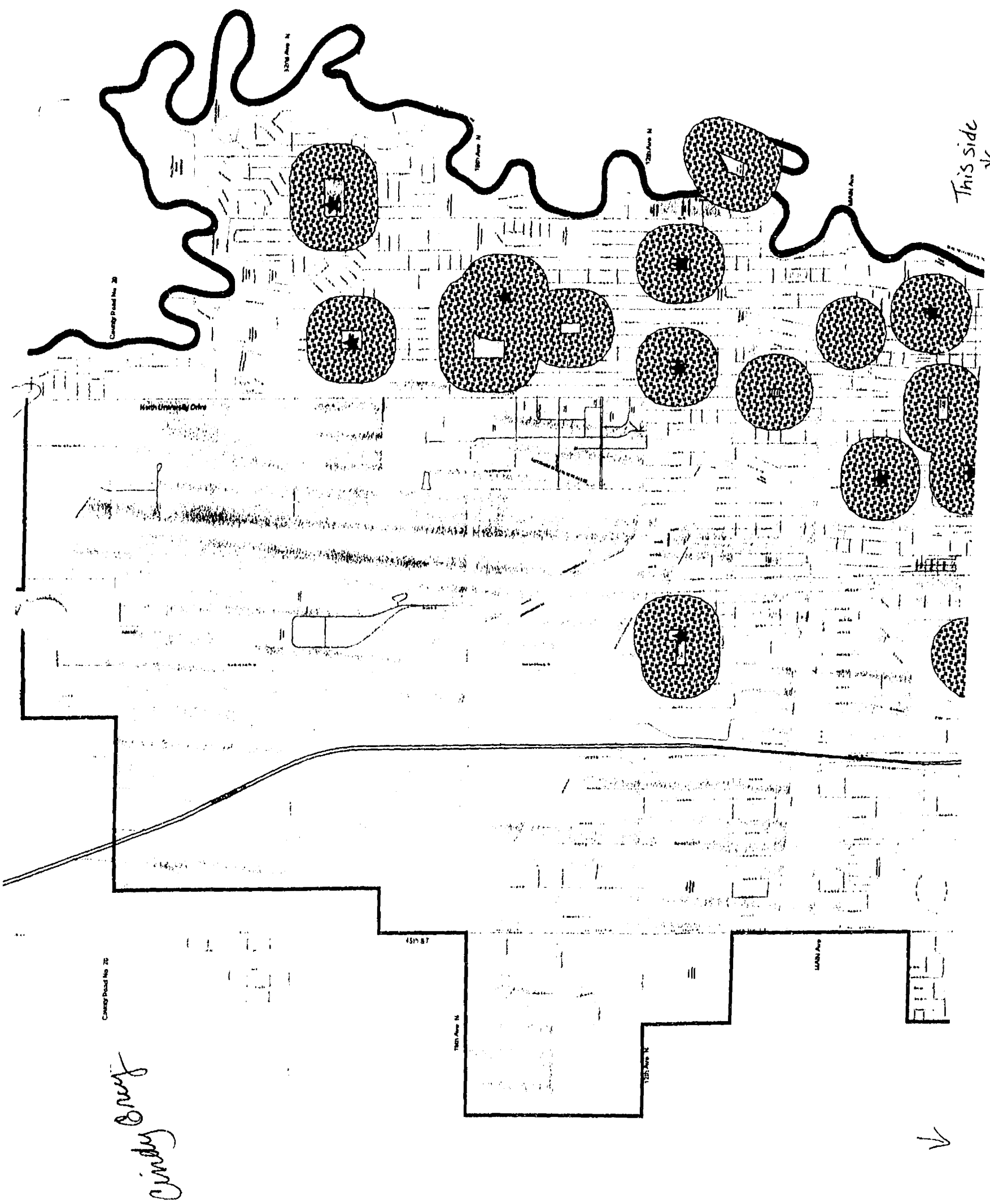

Mr. Chairman, Members of the Committee:

I am the Director of the newly opened Bismarck Transition Center operated by Community Counseling and Correctional Services, Inc. of Butte, Mt. We operate a facility for the transitioning of inmates from the prison system to the community in a manner that will assist them to remain in society as law bidding and tax paying citizens.

When the DOCR went looking for buildings in the Bismarck-Mandan area they did meet with some opposition from some citizens. The location that we are located in is an industrial section of town, several blocks from residential housing, it is an excellent location for us. Some of our neighbors didn't think we should be here, but most all have changed their minds and even employ some of our residents. This location and approval was all done through the City of Bismarck and their Planning Commission with the final approval of the City Commissioners.

All Cities and Counties now have the ability to limit or restrict business's or others from building in their cities through their codes. Why put another limitation on them? Let them continue to function as they have, it works now.

Transition Centers have been around in one form or another for many years and are becoming almost a necessity to easing prison populations, and assisting the residents in returning to a productive life again. The definition spelled out in the proposed legislation may limit some of the facilities in operation, and covers many types of facilities including adult and juvenile.

I would also like to invite the Committee to come and see our facility, to see what we offer and the advancements our residents have made.

Thank-You for your time and consideration on HB1491 to leave the cities and counties with their authority that they now have.

Mr. Chairman and distinguished members of the committee. My name is Keith Gilleshammer and I am the Executive Director of Center, Inc. Centre is a private non-profit North Dakota agency that provides transitional living services as well as other offender and non-offender recovery services in facilities in Fargo, Bismarck, and Grand Forks. We have been providing these services for more than 25 years.

I believe the language of this bill will have negative consequences that will go beyond the intent of the bill. Offering restrictions on placement and definition of transitional living facilities, as written, will create unnecessary complications in an existing process that is working well at all levels listed in the bill. I know of instances where approval for construction and renovation was given when appropriate and when denial was ordered from the local regulating authority.

I offer, as an example, the facility we just opened in Grand Forks. We consider this to be a Centre transitional living facility. There are adults living on one floor that attend chemical dependency day treatment at the human service center across the street. There are adolescents living on another restricted access floor. They attend in-patient chemical dependency treatment on the same floor. Included in the treatment programming are school classes that are taught in a classroom provided. The teacher is from the Grand Forks Public School System and she teaches an approved curriculum for these teens so they can maintain their place in that school system. According to the sections addressing school, it appears a teacher could not conduct classes in our facility unless exceptions to this bill were made.

Placement of transitional facilities is a complicated issue and one that requires a lot of meetings, planning, study and cooperation with local authorities. My experience to this point is that the processes and systems for locating these facilities has proven to be successful. Additional legislation relating to this issue does not seem to be necessary. Our placement of a new facility in Grand Forks was a cooperative effort with a number of requirements from local authorities that needed to be met before approval was given to construct. That system functioned well. The facility is now one year old and has surpassed expectations.

With all due respect, my recommendation for House Bill No. 1491 would be to "do not pass."
