REP. GENE NICHOLAS, CHAIRMAN Called the hearing to order.

WADE MOSER, NORTH DAKOTA STOCKMAN'S ASSOCIATION, Testified in support of the bill. Thanked Rep. Monson for introducing the bill for them. It was on behalf of a member of theirs who wanted the legislation introduced. There appears to be a lot of changes in the bill, however, our request was, in the trespass section of the statute and specifically, the running at large, the bison are not included. When we approached the legislative council, our intent was just to add the word "bison". This statute had not been amended since 1981, for a very small section. Most of the language had been written in 1943, and had not been changed. The legislative council did a lot of updating of the language. The main meat of it is on page 1, line 9 and 10, where they define what livestock is, and where they added "bison". The problem our membership has run into, is the fact that there are more bison out in the countryside, and we feel they have to be treated like all the other livestock. There was a producer who has had a lot

Minutes:

Chairman Flakoll opened the hearing on HB 1503. All members were present.

Representative Monson introduced and testified in favor of the bill. This is primarily a housekeeping bill brought to his attention by one of his constituents. This piece of code has not been changed since 1943. Livestock, in other areas of the code, has been defined to include bison but it has not been changed here. The constituent has had a problem with a neighbor's bison getting out and being left out and he has no recourse under current law.

Senator Seymour asked the definition of a housekeeping bill?

Representative Monson said a housekeeping bill changes a word here and there to accommodate other changes in other parts of the code.

Senator Urlacher asked if this would have an effect on open range areas or the park?

Representative Monson said he thought wild buffalo in the park would not be considered livestock but he expects Wade Moser will know more about this.

Wade Moser, Executive Director of the North Dakota Stockmen's Association, testified in favor of the bill. (meter #4192). There has been a problem with bison running at large and when the affected party contacted his state's attorney to seek relief, the state's attorney said he couldn't prosecute because bison were not included in the livestock at large section of the code. 'The bill will include bison. They continue to have a problem in Towner county because bison are not worth much and the owner said he is not going to put any more money into them. To answer Senator Urlacher's question, page 1, lines 15, 16 and 17 excepts grazing areas. Senator Flakoll asked if there is a need for farmed elk to be included in this bill? Mr. Moser said that's a good question. He said it is his understanding with their fencing

requirements, they are fenced in pretty well.

Senator Klein asked if we need an emergency clause so the bison can be rounded up before summer? This would be a tool for the state's attorney.

Senator Urlacher said this is a good idea. This problem exists in other areas of the state.

Mr. Moser said with the drought, it is difficult for the bison producers to find additional pasture because of their fencing requirements. They may be pushing the limit a little.

Senator Urlacher said one problem is determining what is an adequate fence.

Mr. Moser said that is a good question. In the next couple of years the fence issue will need to be addressed. He gets two or three calls per month from insurance agents, attorneys or ranchers wanting to know what is a lawful fence? There is a fence viewers law that is ancient that leaves it up to the county commissioners to determine what is a lawful fence.

Senator Urlacher says he knows it needs to be done but he hopes it isn't over defined and doesn't result in the only way to build a legal fence is to follow specific regulation.

It was moved by Senator Klein, seconded by Senator Urlacher and passed on a roll call vote that the Senate Agriculture Committee take a Do Pass As Amended action on HB 1503. Voting yes were Senator Flakoll, Senator Erbele, Senator Klein, Senator Urlacher, Senator Nichols and Senator Seymour. There were no negative votes cast. Senator Erbele will carry the bill to the floor.
