SENATE HUMAN SERVICES COMMITTEE SENATOR JUDY LEE, CHAIRMAN **MARCH 19, 2003 HCR 3038**

Madame Chair and members of the committee, for your record, my name is Amy Warnke, State Representative from D'strict 42. I appear before you today in support of HCR 3038.

Basically, this resolution came about as a direct result of HB 1467, which failed to pass the House in the first half. That bill would have required the state of North Dakota to refuse federal Title X funds. Title X funds are those which fund our public health units for things such as STD education, screening for breast and prostate cancer, infertility services, family planning services, etc. Under the federal guidelines, any state that accepts TitleX funds must follow all tenets of the program, including services for prognancy termination. Herein lies the controversial area of the Title X funding. The House felt that pregnancy termination services make up a very small part of the overall funding and use of the grant dollars and therefore, could not justify letting the entire grant go. We also discovered that if the state refuses to accept the funds, they would be available for a private entity to claim, such as the Red River Women's Clinic in Fargo, or Planned Parenthood. This was a risk that we, in the House, were unwilling to accept.

This resolution simply urges Congress to allow states flexibility in the use of Title X funds so that they conform to the policies of the accepting state.
