



Good morning Chairman Froseth and members of the Political Subs Committee. For the record, my name is Dorvan Solberg and I am a representative from Dist. 5 which includes Burke, Divide, most of Williams and the NW part of Mountrail Counties. I have distributed an amendment for you this morning to the proposed resolution HCR 3047). This amendment merely excludes one word which I believe is out of place and not appropriate. I bring you this resolution on behalf of the people and groups in the Williston area who have worked so hard to bring the soon to be opened visitor center at the famous confluence of the Yellowstone and Missouri Rivers to a reality. The confluence area is rich in the history of Lewis and Clark and the two forts, Fort Union and Fort Buford. It is no more than fitting that the people whose hard work has brought this visitor center to a reality should have the distinct honor to select a name for this great addition to our tourist industry in North Dakota. The city of Williston along with our congressional delegation and a number of people who were involved in the fund raising efforts have raised \$3.5 million to fund this worthwhile project. 

This committee was chaired by Noel Poe Superintendent of Theodore Roosevelt National Park, and reported to the Lt. Governor who chaired the Yellowstone-Missouri Confluence Commission (NDCC 55-06) on the development ideas, which were approved and the project went forward. In reviewing documents of this committee from the last five years, at no time has the State Historical Society of North Dakota held an open public meeting to seek in-put into naming this center. My name is Robert Thomson and I am President of the Yellowstone-Missouri Confluence Chapter of the Lewis & Clark Trail Heritage Foundation, Inc. I come before you to testify in favor of HCR 3047 and the name "Yellowstone-Missouri Discovery Center" for the new visitor center being built by the State Historical Society at the confluence of the Yellowstone and Missouri rivers. The Confluence of the Yellowstone & Missouri rivers has long been a spot of intrigue and fascination. As Meriwether Lewis and William Clark, co-leaders of the **Corps of Discovery**, ascended the Missouri River in 1804 they were already aware of the existence of the Yellowstone-Missouri Confluence. It was to them an extremely important destination point as it marked the end of Euro-American knowledge of the area. From the point of the Confluence on the **Corps of Discovery** would be entering "Terra Incognito"; they would be **discovering** people, places, flora and fauna previously unknown to Euro-Americans.

As Meriwether Lewis, first to arrive at the Confluence, observed the flood plain of the Yellowstone-Missouri Confluence region he witnessed huge herds of buffalo, elk and antelope, abundant numbers of white tail and mule deer, packs of wolves, many coyotes, ground squirells, prairie dogs, geese, pelicans, and more. Lewis had just **discovered** a wonderland of diverse animal life previously known only to the Native Americans that lived and hunted in the region. Despite the fact that a few French fur traders had traveled to the Confluence before the **Corps of Discovery** this Serengeti-like bio-diversity had never been reported. What a wonderland to enter! The herds intermingled with one another and, according to Lewis' own notes, hardly seemed to notice or care that he was present.

The Yellowstone-Missouri Confluence would continue to be an important landmark for decades to come, for traveling bands of Native Americans, for fur traders, soldiers, pioneers and for modern day tourists. Since before the time of Lewis & Clark, **discovery** has always played an important role in the Confluence region.

The proposed name "Yellowstone-Missouri Discovery Center" evokes that feeling of awe and wonderment that Meriwether Lewis, and countless others after him, have felt upon visiting the Confluence area. It also creates a link between Lewis & Clark and the new visitor center, in that President Thomas Jefferson's name for the expedition itself was the Corps of Discovery. As the Lewis & Clark Bicentennial is the impetus for this project it should be paramount to create a direct tie between the two.

Having "Yellowstone" before "Missouri" may be thought by some to be incorrect, but geographically speaking it is the confluence of the Yellowstone River with the Missouri River. There is even precedence in the North Dakota Century Code for placing Yellowstone before Missouri. NDCC 55-06 authorized the formation of the Yellowstone-Missouri Confluence Commission, which is chaired by the Lt. Governor.

The Johnstown Heritage Discovery Center in Johnstown, Pennsylvania "Tells the Lory of Immigrants to Industrial Cities." This discovery center focuses on the history and cultural heritage of a region, exactly as a discovery center at the confluence of the Yellowstone and Missouri rivers would do.

The name selected by the State Historical Society, Missouri-Yellowstone Confluence Interpretive Center, is too long, clumsy, does not roll of the tongue, provides no instant spark of imagination, and is unmemorable. In addition, the name was chosen without any input from the people of the Confluence region – people who helped to raise the money to build the new visitor center.

Mr. Chairman and members of the Political Subdivisions Committee, good morning, my name is Claudia Berg, Director of the Museum & Education Division, for the <u>State Historical Society</u>. I am here representing Merl Paaverud, Director of the State Historical Society. He is testifying at another committee hearing this morning. I appreciate the opportunity to provide information related to HCR 3047. 1. V. J.

On behalf of the State Historical Society I would like to say that we were surprised and quite disappointed when HCR 3047 was presented. Where did this come from? Since 1999, we have worked side by side with the community of Williston on this project, taking great pride, like the community, in its development. Numerous organizations, individuals, agencies and staff members have invested a great deal of time and resources in this project to make it a must-see destination for regional, national, and international visitors.

To explain the name selection process, the following points are offered:

### The Mission

The mission of the confluence center is to present the northwest region of the state as an historic district. To connect the geology, natural, Native American, fur trade, military, and settlement history to the development of contemporary issues in the region today. Transportation is the thread that weaves the stories of the confluence together. *Tracks, Trails, Rivers, and Roads*, a 2,000-square-foot permanent exhibit, will anchor the interpretation in the Missouri-Yellowstone Confluence Interpretive Center.

### **The Process**

- The planning process, involved discussions with such Williston-area groups as the Yellowstone-Missouri-Fort Union Commission and the Fort Buford Sixth Infantry. Planning for the building and subsequently the name of the facility began in 1999. Although not unanimous, the majority of people involved with the process agreed with the name selection of Missouri-Yellowstone Confluence Interpretive Center.
- An additional opportunity for input was the public forum held in Williston at the State Historical Society's Community Conversation in January 2002. Numerous topics were covered, and tourism and partnerships were two of the main areas of interest that evening. There were no concerns or alternative ideas voiced at this meeting regarding the new building at the confluence.
- The Confluence Interpretive Center name has been used since August 1999. As of November 6, 2002, when a meeting was held in Williston for public input on confluence center exhibits, no comments were made stating a concern for the building name. Fabrication of building signage is currently in production.

### The Name

- The emphation the Missouri River is based on the prominent role the Missouri has played in the history of North Dakota. It is this river that formed the transportation route that impacted the development of the northern great plains and the region now known as North Dakota.
- The Missouri River is the heart of the historic corridor from the South Dakota border to the





Clark near Washburn and Fort Pierre at Pierre, South Dakota. Western North Dakota's frontier military story was forged on overland trails and the Missouri River. The name Yellowstone-Missouri works well for organizations in the immediate Williston area; Missouri-Yellowstone describes the geographic region that addresses the history of North Dakota. This new facility, along with Fort Buford State Historic Site, serves as the northwestern North Dakota anchor for the State Historical Society's statewide interpretive master plan, that has been developed with much local input. Other historic site anchors include the Chateau de Mores in southwestern North Dakota, Fort Abercrombie in southeastern North Dakota, and the Pembina State Museum in northeastern North Dakota.

- The term *confluence* was selected to identify where this building would be located. The word confluence succinctly means the coming together of the two rivers. A recent survey was made of people in-state and out-of-state, those in the private sector, and those in the museum profession. All groups associated Yellowstone with Montana or the national park, while Missouri was identified as a river by those from North Dakota and as the state by those living elsewhere. Using the word *confluence* identifies the location as the meeting place of these two specific rivers.
- The term *interpretive center* was selected for the function of the exhibits. Visitors have expectations of functions and features, based on a building's name. A discovery center is most frequently associated with a science-related, hands-on experience. This is an exciting way for children to learn, especially about science and technology. The goal to associate the term *discovery center* as a Lewis-and-Clark-related place was lost on everyone surveyed, both in the profession and the general public. Without a reference to Lewis and Clark when using the term, discovery center implies something quite different that what was intended as a bicentennial tourism destination. National surveys as well as the North Dakota Tourism Division's survey state that heritage tourism travelers are knowledgeable and savvy travelers. Knowledgeable, experienced travelers have seen discovery centers, interpretive centers, and other types of museums and have differing expectations of each facility.
- In the American Association of Museums directory, listing some 8,000 museums in the United States, four institutions are listed with Yellowstone as the first word in their title, and all four are geographically located in south-central Montana and near the Wyoming border.
- Finally, as a marketing tool, the current name, Missouri-Yellowstone Confluence Interpretive Center, provides clear and concise destination information. Through marketing plans and public relations efforts that will include the use of this descriptive and accurate name, it will be the stories of the people and the confluence that will provide the memorable experiences that the visitors to this historically important area will remember.

In the meeting, the State Historical Society claimed to have "secured the ... Hennessy. money" for the visitor's center when the funds were actually raised by Main Street Williston with the help of Sen. Byron Dorgan, D-ND, Sen. Kent Conrad, D-ND, and Rep. Earl Pomeroy, D-ND.

Solberg said that he worked on the bill because he feels that the people of Williston funded the center and should therefore be allowed to choose its name.

"The people in Williston have worked so hard to make this a reality," he said. "They should be able to name it."

Tuesday, Solberg spoke on the floor to point out the misleading information given by the State Historical Society. "It was a hard fought battle," he said.

The Historical Society also argued that the word "discovery" makes the center sound like a science center which will deter visitors.

The Corps of Discovery was the original title of the Lewis & Clark expedi-

"If it's good enough for Tromas Jef-Terson, it's good enough for me." said

The name of the center will be printed on highway signs, maps and Web sites so advocates of the name Yellowstone-Missouri Discovery Center argued that the shorter name will be easier to accommodate. Bill supporters also claim the Historical Society's name is harder to say and remember.

"It's long, cumbersome and clumsy," said Solberg.

The name Missouri-Yellowstone Confluence Interpretive Center also is misleading because it is geographically incorrect, added Hennessy, It would contend the center's location marks the confluence of the Yellowstone river, not the Missouri river.

Although the center still lacks a name, it's due for completion this summer.

Hennessy said they focused on fundraising and technical portions of the project for so long that finding a name was placed on the back burn-

When they did start looking for a

name, the group searched through journa' entries of the explorers and discovered what an impact this area had on Lewis and Clark, he said.

The entire portion of Lewis & Clark's journey up to the Mandan Villages had already been mapped. After the expedition left Mandan the first spot they discovered was the Yellowstone confluence.

"Both coming and going, the discovery of the Yellowstone River was important to Lewis and Clark," said Hennessy.

Hennessy said that the name also stemmed from the creation of a Yellowstone-Missouri Fort Union Commission in 1959 by the late Sen. Frank Wenstrom.

"It was easy to follow Wenstrom's lead," Hennessy said.

Although negotiations with the State Historical Society have not gone well, Hennessy said it's important for the name to also pass in the Senate and become official.

"It's imperative that we have a short, descriptive, marketable and accurate name," said Hennessy. "It's absolutely imperative."





### LETTERS TO THE EDITOR Name should not ruin years of cooperation

### To the Editor:

The Williston area community has much to be proud of in its support of the history of the confluence area of the Missouri and Yellowstone rivers. You have set the standard in North Dakota on how to develop community support and involvement in the promotion and preservation of local history and heritage.

It is because of this energy a. I enthusiasm that the state's history agency, the State Historical Society of North Dakota, has enjoyed partnering with area residents over the years to interpret and promote the rich and unique history of the Confluence area.

This is one of the reasons why we were so disappointed in the story that appeared in your Thursday edition about the legislative action concerning the name that was selected for the new history center being built at the confluence.

As a one-time resident of Williston and former chairman of the Friends of Fort Union, I have a special enthusiasm and appreciation for the outstanding success the community has achieved in developing and promoting the history of the area. But that also makes it all the more disappointing when stories like Thursdcy's article appear.

The State Historical Society has worked hard with the community in developing this interpretive center at the confluence. There have been honest differences of opinion regarding what it should be named. But it does no one any good to hurl false charges about what this agency has or has not done in regard to this project.

The legislative bill in question, HCR 3047, would change the name of the center from the Missouri-Yellowstone Confluence Interpretive Center to what some local supporters want to call it, the Yellowstone-Missouri Discovery Center. The assertion by bill supporters is that this is something they have carned because they have funded the center.

The record about this project needs to be made clear. The center's cost, including the development of exhibits, is a 'ittle over \$2 million (this does not include another nearly \$1 million for the reconstruction of the infantry barracks at nearby Fort Buford State Historic Site). The 8,500-square foot confluence cen-ter is being built through a combination of local, state and federal funding. Williston-area residents have been superb in their financial commitment to this project, raising \$252,000 as their local contribution. This represents about 15 percent of the project's total cost, and is the local match that was required for the \$1 million TEA-21 federal grant approved in early 1999 that launched this effort. We have also used the TEA-21 program with similar success at several other sites, including the Pembina State Museum, Fort Abercrombie and Fort Totten.

The state's Congressional delegation secured much of the confluence center's funding, and all of us are deeply grateful for their strong support. The Williston community's extensive contacts with the delegation were vital in helping make that funding happen, and we certainly appreciate that work. The for

The state's commitment has included a mix of financial support and an extensive staff effort on the part of the State Historical Society. In the development of the project over the past few years, several employees of this agency have spent countless hours working with the Congressional delegation and the Williston community in providing them with detailed information and answering many questions, as well as selecting the name we believe is best for the center. As recently as Nov. 6, when we hosted a community meeting in Williston to gather public input on exhibit ideas for the facility, no comments were made stating any concerns about that name.

All four of the State Historical Society's divisions have been actively involved in the details, from environmental reviews and construction design to budget management and exhibit development – hardly a mere "semantic tap dance" in terms of describing our level of professional commitment and involvement. The State Historical Society also has the long-term financial and staff responsibility for operating and maintaining it. With that responsibility, we believe, goes the selection of a name that conforms to the standards used for naming the other historic sites throughout the state that we are entrusted to manage.

The issue here should not be who has earned the "right" to name the center. It is about trust, respect and cooperation. It is about working together for the common good of a project that will significantly enhance the understanding of the key role the confluence area played in the westward expansion of the United States. In making this project a reality, local, state and federal cooperation has always been imperative. This cooperation requires compromises on the part of everyone involved. It also involves respect for each other, which we believed was breached when this legislation was introduced in the North Dakota House of Representatives without our knowledge and after production of the signs for the center had already begun.

We do not want something like the name of this center to damage the many years of partnership and cooperation we have enjoyed with the Williston area community and the bright future that lies ahead in telling the story of the rich history of your region.

I encourage anyone who is interested in a more detailed explanation about why we chose the name we did for the center to contact me, either by phone or email. I will be happy to provide this for you.



### Minutes of Friends of Fort Union Meeting, Sept. 24, 2092

Present: Frank Keogh, Andy Banta, Randy Kane, Greg Hennessy, Dean Strinden, Leon Olson, Chuck Stalaaker, Lois Rennerfeldt, Tom Wilder, Davo Finders.

Mosting began at 8 p.m. Minutes of last meeting were approved as submitted.

Tressurer's Report - Checking account: \$36, 163.33. Friends have received \$6,400.80 for barracks furnishings. \$15,688.70 -CD. CDs at ASR: 43,460.53, and \$37,520.54. There is also a CD at First National Bank worth \$40±.

#### Old Basiness

- A. North Star Caviar (Hennessy) Because of low water and over-harvest concerns, Fish and Gume is possibly going to cut the mag limit for both sites to 2,000 peddlefish total, instead of 3,000. The Friends question the rationale, but have no real 'authority' to contradict it. Unsure of what will be the result of such an action, but will probably just have to ride it out. Perhaps the Friends could out a deal with the Montana side for a portion of their quota, but this is unclear. Caviar bidding is weak at this time.
- B. Confluence Development (Hennessy) Construction at Confluence is a little behind schedule, but contractors are working ahead in other areas, and feel confident. One agency concern is a lack of funds to fabricate exhibits. There will be a meeting Nov. 6 in Williston with the inistratical society to discuss this and strategize.
- C. State Historical Society (Johnson) At Fort Bufbrd, arcbeologists have dug 20 of th3 planned 40 Ix1-meter pits. They have uncovered a portion of the wall connecting barracks to mess hall, and located the south wall with broczeway. They have located all four corners of the barracks. Artifacts of interest include lead type, which may indicate the prosence of a printing press. Have also found hundreds of spent primers for 45/70 c articles. Randy Kans was shown a piece of Sixth Infantry insignia.

Lead barracks architect Frank Kratky has some preliminary sketches, which he will show at Sept. 30 meeting in Bismarck.

Insurance issue regarding Friends groups was discussed. The Friends of the Former Governors Manaion had questions regarding insurance needed while doing a fundraiser. The attorney general's office deems this unnecessary, if this is a one-time annual event. Hemessy requested the attorney general's opinion.

Chuck Stalnaker reported that a man in Spokase, Washington, has offered to give the Historical Society a 275-page journal from Leighton and Jordan, which is a daily listing of expenses. It beloaged to his grandfather, who moved one of the houses off the military reservation after the anction, and found it in the attic. Owner requests that journal be made available to scholars. Randy Kane wanted to know about progress on interior of Brotherton House. Chris said agency has approved more finish work inside, but that exhibits and furnishings are in the planning stages.

D. Confluence Fature (Bants, Hannessy) -- Landowners on the Missouri and Yellowstone seem to be cooperating with conservation groups socking to preserve the visuals of the area from eucroachment. A Montana conservancy group is leading the way now, which is both acceptable and encouraging to the Friends, who are willing to supply some nominal fixeds to project. Looks like a good situation for all. Friends participation is conditional on a willing soller, and public hunting and fishing access. P.4GE 02
