Now I don't believe we have the highest umemployment rates in the nation, the problem is on how we calculate those rates. What we need to do is study this and determine a different way that we can calculate this, right now they are doing it on a percentage of the income, that is used for the tax. We have to change that. Can we do a revenue neutral change on our unemployment rate to bring these rates down as far as the recording is going on we are the highest in the nation.

Representative Berg: I encourage Representative Weiler to address this, we look at Job service there are three areas that should be discussed really on the future, one is the positive balance employers and the negative balance employers, I don't know what has been said about that but the escense of that is the people that have seasonal workers generally have more claims paid out of their account then they put premiums in so they have a negative balance from the start to the present. Positive balance employers generally have fewer claims then the premiums they paid in and from their individual accounts they would have a positive balance. It's O.K. for the positive balance employers to pay a little bit more to help off set the negative balance employers if they were not doing that then we may have to bring people out of state to do those seasonal jobs. Should the negative balance employers cover everything or should the positive balance employers cover part of that, and the other issue is what should the trust fund balance be? And this was a challenge for us back in 1999, because there are theories nationally that say you should have one years claim in a trust fund and so to determine what that is the current statute says that you take the worst year in the last twenty and two of the worst years in the last ten, and

What we done before is we just said forty million well as our work force grows and we have more people forty million is not the right amount, so again that is a floating number based on three of the worst years in the past twenty. I think that ought to be reviewed on an on going basis. The third is the rate system about 80 % of the people are in the lowest rates the rate system is like grading a paper it creates 10 rates with 10% of the people in each rate, so those who have a higher positive balance pay a lower rate, and those who would have a lower positive balance will pay a higher rate and so again that is something that is appropriate for us to look at and examine and question is that appropriate now, does it make sense to have some sort of citizens or business group like we have with Workers Comp. An advisory group would have been good the last four years.
