

Sandvig, on lines 20, 21 & 22 (justice resolution) the whole meat of the study is whether or not the Legislature should require someone to report an already reportable crime. How would we go about making it that someone would report abuse or suspected abuse of a vulnerable person more so than it already is by law?

Answer: They are not nearly as strict as they are in MN and I wanted to make it more like the recording for child abuse and neglect.







It is my understanding that most money used in the Vulnerable Adult programs is from the Older Americans Act, and does not focus on young and middle aged adults. All of these vulnerable adults could benefit from earlier reporting. P&A will cooperate with other agencies in reporting and protective services.
