Senator Holmberg, chairman called the hearing open on SB 2020. Appropriations for the State Historical Society of North Dakota.

Merl Paaverud, Director of the State Historical Society testified in behalf of SB 2020. Testimony attached (Exhibit #1)

He gave some history including that on January 9, 1901 outgoing Lt. Governor Joseph Devine filling in for the ailing Governor Frederick Fancer recommended appropriating only \$797,900 for the operations of state government for the biennium. Mr. Paaverud recommended that we return to that level of spending.

The State Historical is the state's collector for history. Several articles were shown that have been found recently in the state. (#1250).

Some statistics for the biennium:

Projects in progress included Sakkakkawea Statue Project, Era of Change, Missour-Yellowstone Confluence Interpretive Center at Fort Buford, Lewis and Clark projects, and others as outlined in Exhibit #1

Optional adjustments in their budget: They would like \$62,210 for 2 more additional half time FTE positions to convert two longtime temporary positions to regular status. The would also like almost \$61,000 to fund a portion of the agency's Information Technology plan, almost \$12,000 for expenses relating to the State Historical Commission and approximately \$30,000 for short term lease for storage during the biennium. Capital assets included \$250,000 additional authority to allow for the expenditure of federal and other funds for renovation of the Carriage House associated with the former Governor's Mansion State Historic site. \$87,000 additional general funds to repair the Chimney Park portion of the Chateau de Mores State Historic Site. Another \$40,000 additional general fund authority for interpretive signage at state historic sites .\$225,000 in additional general fund authority for Fort Buford Officer's Quarters exhibits. This was a section of their budget that they would like to have further discussion involving flexibility and use of funds to further address their permanent storage problems.

They would also like \$1,025,295 for Lewis & Clark funding as outlined in the Lewis & Clark Advisory Report Update.

Questions/clarifications: (#2951)

Senator Holmberg clarified that the Optional Adjustments that you are talking about are already in the budget, they are not an enhancement. The only thing you would like this committee to look at would be some discussion involving flexibility and use of funds to further address their

permanent storage problems. Answer: Yes that is correct.

Further questions:

--Bag farm, volunteers, potential for more exhibits in the Capital during the sessions (the reason that more can't be done is that there is concern about temps, security, etc.); Is there still interest in expanding the Heritage Center--it is about a \$30 million dollar project, there is support for an expansion. Questions regarding the Renaissance projects and if any friction between locals and Historic department. Any conflict with modern day fire codes, and building codes? Answers to these included everyone is working together to make these projects work, there are some code restrictions, but we try to make them and there are different rules for historical work. Senator Holmberg stated that the subcommittee would be meeting to make recommendations to the full committee. They are: Senator Andrist, chair; Senator Schobinger, and Senator Tallackson.

(#4060) Virginia Nelson, Executive Director of the State Historical Society of ND. Her testimony is Exhibit #2. Ms. Nelson stated that our history is one of the most important resources of North Dakota for tourism. This information needs to be marketed. We need to market what we have. They have been asking people across ND what they want from the State Historical Society? They want day trip tours, partnership and development in schools, regional brochures, Lewis & Clark issues; Web Site link; Signage, Events; programming; communications; Community training and visitor centers. These are things the Historical Society is doing these things now, but we need to do more. Any town can build a mall but every town's history is different from its neighbors and difference is becoming increasingly important in the competitive tourism market. The key attraction here is nature and the natural environment.

Minutes: Chairman Holmberg opened the hearing to SB 2020. A bill relating to appropriation for the State Historical Society of North Dakota. Senator Andrist presented the committee with amendments (38043.0103) and explained them. (Meter 795) There was a voice vote for the amendment with a motion from Senator Andrist and a second by Senator Tallackson. (Meter 754) Senator Christmann asked Senator Andrist a question: the hundred thousand dollars from Lewis and Clark Bicentennial, does a million twenty five thousand in the bill appropriated for that, that is a half a million dollars less than what they asked for. Chairman Holmberg clarified that was a one time spending. Allen Knudson also verified that amount as did Sandy Paulson. (Meter 903) Senator Andrist continued to detail the expenses. Discussion continued about the appropriation about the Lewis and Clark Bicentennial that would or would not affect the appropriation. None of the projects were bad but some money could be cut. The voting went as follows for a Do Pass as amended, 12 yeas, 2 nays - the amendments passed. A motion was made

He discussed the value the book "A Traveler's Companion to North Dakota State Historic Sites, 2nd Edition" is to North Dakota tourism to bring money into North Dakota we never had. He stressed the need for support to sell North Dakota's history because there will be many returns. He characterized North Dakota as "the next destination" and stated that the money is a small investment in what it could bring.

Virginia Nelsen, Executive Director of the State Historical Society Foundation, testified in favor of SB 2020. See testimony attached. She stated the foundation board believes that tourism and the State Historical Society is a resource for North Dakota that needs to be enhanced and funded more adequately, and needs to fall into a planned format to make a difference for North Dakota in tourism and all the resources that we have.

<u>Rep. Gulleson</u> I know you had a relationship problem with some folks up in the Northwest corner regarding the naming of that historical site there. What are doing to meet with those local people and come to a consensus?

Meri Paaverud We are very aware of that and we are working with the local folks trying to find out what caused it and why it went that way. The problem we are having is it was named two years ago and we have been using that to promote the center. To change that now would really derail some of our marketing efforts. There are many people that are very concerned about that and are working with us. We are in communication with folks trying to find a solution for that because it is a great project.

Rep. Gulleson When you say you are in communication and working on it, have you gone up there and had a local meeting and had them all come in and express their concerns?

Paaverud Not at this point because when this came up we were not aware of it until a resolution was brought up that this was going to be brought here to the session. We have been writing information back and forth trying to be in contact with the folks that are involved and ultimately we will have to go up there and do this, but it is a hard situation.

<u>Rep. Gulleson</u> I would recommend that as your first course of action. I just don't believe in letters or electronic communication and I think you need to get them all in a room and try to work it through.

Rep. Rennerfeldt Speaking of this resolution that came up, I didn't realize there was a problem up there. I know early on there was discussion about selecting a name but I didn't hear from anyone up there. In visiting a lot of people there, I gather it is just a small group that is pushing this issue and a majority of the people think the project needs to go forward with the help of the State Historical Society. It was news to me when this came about and a lot of other people were very upset and curious as to where this resolution came from and the need for it. Hopefully we can get this resolved and move forward. I think the name is the one that is most fitting for that site.

Rep. Aarsvold I was appointed to the commission that dealt with the space concerns of the historical society and I have to say it was a wonderful education for me. It was a great experience to work on that commission and they do indeed have a real need out there. The second thing that I want to mention is I drive by two historical sites twice a week. Fort Arnold north of Oriska and Sibley Crossing at Buffalo Creek. Those have not been well kept. It concerns me that a tourist coming to North Dakota and having a bad experience like that when they enter the state discourages them from staying on longer. I don't know how we can adjust

our priorities in terms of maintaining those sites, but I would hope that we would make an effort to do so because I think that it does discourage tourism, activity and historical interest.

Paaverud You are exactly right and this has been a concern for us for years. One of the efforts with this book was to provide to people so they can read about it and see what they would see out there, but our signage situation has been very challenging. We are making some headway thanks to the support we get here and from other places. We are putting signs up on those sites so that people can see what is going on out there. Department of Transportation has also been very receptive in helping us out with signage. We have a signage committee now that extends from the park service through our agency and Department of Transportation. We are getting something that we can go forward with and have a way to respond out there. We are putting up signs at some of the sites and we want to continue that. We are asking for \$40,000 to continue that effort so that we can provide that service.

Rep. Aarsyold I don't intend this to be a criticism of the society because I know the problem has to do with resources. You maximize the resources you do have and I do appreciate that. I do think we can do better as a state.

Paaverud I agree.

<u>Chairman Martinson</u> I have to applaud you for moving in the direction that you are moving. I think it is absolutely wonderful that you are proactive and getting into the areas that you are getting into now. I personally appreciate that attitude. You are absolutely right, that's what people want to do. Rather than just go over and go through your wonderful building, to be able to go up to Pembina and take part in a dig. Keep it up.

Testimony by Merl Paaverud, Director State Historical Society of North Dakota

Introduction

Mr. Chairman and members of the Committee, my name is Merl Paaverud and I am the Director of the State Historical Society of North Dakota. It is a pleasure to be with you today to present the proposed budget for the State Historical Society of North Dakota.

As part of this presentation I would like to share a moment of history with you. During this week in history, January 9, 1901, outgoing Lt. Governor Joseph Devine, filling in for the ailing Governor Frederick Fancher who left the state in September, delivered his message to the Legislative Assembly. He presented a table of recommended appropriations that appeared as a forerunner to the later state budgets. He recommended appropriating only \$797,900 for the operations of state government for the biennium so that the state could cope with accumulated deficits from the previous decade.

Our general recommendation would be that we do not return to that level of budget for state operations.

We have also brought several items from our collections to show you. They are:

- 1. List of supplies distributed to troops stationed at Fort Abercrombie during 1863.
- 2. Two Peace Medals distributed by the United States Government in 1829 and 1837 to Native American Peoples.
- 3. A Mandan Pottery Vessel dating to 500 years ago.

Agency Overview

The State Historical Society of North Dakota was established in 1895 to serve as a statewide repository of artifacts, archival materials and historic sites important to our history. The mission of the state's history agency is to identify, interpret, preserve and promote North Dakota's heritage. We have worked to fulfill this responsibility for the past 108 years into the 21st Century, and into the new year of 2003 and the official beginning of the Lewis and Clark Bicentennial.

Fifty-five full time staff, 35 seasonal staff, and 180 volunteers have pulled together to make a dynamic Society. We are responsible for 56 state historic sites, the Pembina State Museum, the State Archives and Historical Research Library, the State Museum Collection, the State

Archeology Collection, and operation of the North Dakota Heritage Center.

We are a leader in preserving state history, historic preservation and supporting educational activities that benefit our schools, our residents and visitors to North Dakota. We look forward to opportunities for improving management of our collections, developing museums and historic sites, providing preservation opportunities, enhancing outreach and field services, and initiating a North Dakota history curriculum for our schools.

In the past two years, the Society has made considerable progress in many areas. We have focused on providing services and outreach as this map portrays. Our state historic sites development include a new interpretive center and even a historic inn for the public to experience an overnight bed and breakfast adventure. We continue to work hard to forge partnerships with local, state, and federal entities. We have provided funding for restoration of buildings that are important parts of our state's history and have assisted in the Renaissance Zone program as they develop in our communities. We have published books on North Dakota's history, installed new educational and interpretive materials on state historic sites, provided educational materials to teachers and schools, held programs, conferences, provided technical assistance to the 110 history organizations in the state, and traveled around North Dakota to visit with people about services they would like to receive.

Some statistics for the biennium:

- Over 470,000 people visited our museums and historic sites.
- 3,600 students from around the state had access to our SEND Trunks program (Suitcase Exhibits of North Dakota).
- 48,275 people throughout the state viewed the TIES Exhibits (Traveling Interpretive Exhibits).
- 26,000 researchers used the services of the State Archives and Historical Research Library.
- Agency staff provided reference services and access to the state's extensive collections of over 50,000 artifacts and 1.5 million archeological items, and to the State Archives and library.
- Maintained the State Historical Society WEB page that averaged 1,073 visits per day.
- 1,791 people participated in the Guinness World Record Snow Angels event on the Capitol Mall. (This is an event heard around the world, in news reports from Hawaii to New York and Siberia to Lebanon. The "Angels" event was even part of Jay

Testimony by Merl Paaverud, Director State Historical Society of North Dakota

Introduction

Mr. Chairman and members of the Committee, my name is Merl Paaverud and I am the Director of the State Historical Society of North Dakota. It is a pleasure to be with you today to present the proposed budget for the State Historical Society of North Dakota.

As part of this presentation I would like to share a moment of history with you.

March 3, 1903, was a Tuesday and the 57th day of the session with only 3 days left in this session. The session ran 60 days consecutively including Saturdays and Sundays. The legislature adjourned on Friday, March 6, 1903.

During the session there were only 4 joint sessions: 1. To receive the Governor's message, 2. To formally declare that Henry Hansbrough of Ramsey County should serve 6 years in the U.S. Senate beginning March 4, 1903, 3. To hear an address on the Lewis and Clark Exposition (World's Fair) to be held in St. Louis, 4. And to join in the celebration with special festivities on the birthday of Abraham Lincoln.

Out of the 100 male members of the house:

91 were married

86 were Republicans, 12 Democrats, and 2 Independent Democrats. The youngest member was 28 years old and the oldest was 62 years old.

There were 289 bills introduced during the session, and by March 3, the Representatives listened to and acted upon most of them including HB 18 to regulated the practice of optometry, and on HB 221 to authorize a trolley line to the capitol from the Northern Pacific Depot. During the last days of the session, both houses scheduled night sessions in order to adjourn in the afternoon on March 6 so they could still catch the train to take them home.

Agency Overview

The State Historical Society of North Dakota was established in 1895 to serve as a statewide repository of artifacts, archival materials and historic sites important to our history. The mission of the state's history agency is to identify, interpret, preserve and promote North Dakota's heritage. We have worked to fulfill this responsibility for the past 108 years into the 21st Century, and into the new year of 2003 and the official beginning of the Lewis and Clark Bicentennial.

Fifty-five full time staff, 35 seasonal staff, and 180 volunteers have pulled together to make a dynamic Society. We are responsible for 56 state historic sites, the Pembina State Museum, the State Archives and Historical Research Library, the State Museum Collection, the State Archeology Collection, and operation of the North Dakota Heritage Center.

We are a leader in preserving state history, historic preservation and supporting educational activities that benefit our schools, our residents and visitors to North Dakota. We look forward to opportunities for improving management of our collections, developing museums and historic sites, providing preservation opportunities, enhancing outreach and field services, and initiating a North Dakota history curriculum for our schools.

In the past two years, the Society has made considerable progress in many areas. We have focused on providing services and outreach as this map portrays. Our state historic sites development include a new interpretive center and even a historic inn for the public to experience an overnight bed and breakfast adventure. We continue to work hard to forge partnerships with local, state, and federal entities. We have provided funding for restoration of buildings that are important parts of our state's history and have assisted in the Renaissance Zone program as they develop in our communities. We have published books on North Dakota's history, installed new educational and interpretive materials on state historic sites, provided educational materials to teachers and schools, held programs, conferences, provided technical assistance to the 110 history organizations in the state, and traveled around North Dakota to visit with people about services they would like to receive.

Some statistics for the biennium:

- Over 470,000 people visited our museums and historic sites.
- 3,600 students from around the state had access to our SEND Trunks program (Suitcase Exhibits of North Dakota).

- Agency staff provided reference services and access to the state's extensive collections of over 50,000 artifacts and 1.5 million archeological items, and to the State Archives and library.

Building Partnerships with History Trustees

The State Historical Society of North Dakota (SHSND) Foundation continues to build alliances with its History Trustees, a special committee established by the Foundation to forge partnerships with businesses, organizations, and individuals who care about and are committed to North Dakota's history and the State Historical Society.

Nearly 100 History Trustees, both individuals and businesses, are busy hosting major events for the Society, providing financial support, and assisting with fundralsing efforts. A good example, said Foundation Executive Director Virginia Nelsen, is the History Trustee partnership with Hornbacher's Foods of Fargo.

This North Dakota mainstay was founded in the Fargo-Moorhead area in 1951 by Ted Hornbacher and James Custer. In the mid-1960s, Hornbacher purchased the business rights from Custer. The business was sold to Super Valu in 1975, but the founder's son, Dean Hornbacher, remains at the helm.

Hornbacher's has helped the SHSND Foundation support the state's history agency by distributing 10,000 SHSND event calendars to its customers, serving a lunch for Trustees and guests at the June 2002 Fort Abercrombie dedication, and providing food for the Theodore Roosevelt Medal of Honor Summer Tour in 2001.

"We will continue to support the important efforts of the State Historical Society in the Fargo-Moorhead area by providing in-kind contributions for future events," said Hornbacher.

Dan's SuperMarket of Bismarck and Economart of Williston are two more North Dakota-based grocers among the growing number of History Trustees aiding the SHSND Foundation through distribution of marketing materials and in-kind support.

Society Reissues 1896 Version of Christmas Classic

An 1896 edition of the classic, *The Night Before Christmas*, or a Visit of St. Nicholas, has been reprinted in its original form by the State Historical Society. It is the first in what is hoped will be a series of reissues of classic works in the collections of the state's history agency.

State Historical Society of North Dakota Impact of Information Technology Reductions

Total current direct costs for IT services - \$66,000.00

- Current direct costs for telecommunication \$82,100.00
- House reduction recommendation 38% or \$56,546.00
- The agency has no full time IT personnel although portions of other staff time were used in the reduction calculation resulting in the 38% reduction. Because the agency does not have a full time IT staff person, it must rely on ITD for all email and network maintenance. Our desktop support and maintenance is provided by an outside vendor who has a contract through ITD for these services. These services are provided at a per hour fee.
- Assuming the agency MUST maintain its telecommunications services if at all possible, the reduction ti IT services would then amount to 86% (\$56,546 or \$66,000) and be catastrophic to the agency's computer and information technology systems.
- IT Services and systems that would need to be eliminated or reduced include Web Page access and maintenance, e-mail services, collections inventory maintenance, graphic services for exhibits and educational programming.
- Elimination of IT services destroys any prospect of expanding opportunities for telecommuting and will diminish capabilities on historic sites where outlying services already exist.
- Reduced IT services will diminish public access to the library and archives collections and the museum and archeological collections.
- Reduced IT services will create problems for the maintenance of the museum store inventory, the fixed asset inventory and may require that we revert to manual systems.
- General availability of e-mail and word processing capabilities to all employees will need to be evaluated. Available computers may need to be pooled to allow multiple employee access. This will certainly lead to inefficiencies.
- The current file servers controlling the agency network is due and in need of replacement and may literally cease to function. In that eventuality all computer services would stop until alternate arrangements could be made.

Testimony of Tracy Potter, Executive Director, Fort Abraham Lincoln Foundation on Lewis and Clark Budget Enhancements

It is now generally recognized that the Lewis and Clark Bicentennial commemoration is the best tourism opportunity for North Dakota for a generation. The best chapters in that story were written here.

If I recall correctly, you appropriated \$3 million to Parks, Tourism, the Historical Society and the Arts Council in the last session. You have another \$3 million Lewis and Clark enhancement before you, spread out through those same agencies. I have had the opportunity to review the enhancement budget and it is filled with worthwhile projects.

I am here today to add my voice to a request for an additional Lewis and Clark enhancement in the amount of \$500,000 to be placed, in the words of the old TV commercial, "where the rubber meets the road."

Next week the kick-off Signature Event of the National Lewis and Clark Bicentennial takes place at Monticello. To every thing there is a season, and now is the season for the commemoration. We've already built the attractions. On-a-Slant Village, with a \$1.9 million federal facelift is ready for visitors. Fort Mandan and the Lewis and Clark Interpretive Center are ready for visitors. Now, it's time to show them off.

North Dakota was extremely fortunate to receive designation for two National Signature Events, one for ten days in Bismarck and surrounding areas in October, 2004, coordinated by the Fort Abraham Lincoln Foundation and another for New Town and the Three Affiliated Tribes in August, 2006. These are chances to showcase for an international audience the fine tourism facilities and the rich history of North Dakota. These are the best chances we will have for a long, long time.

When I approached the cities of Bismarck and Mandan, the Congressional delegation and private sector businesses, I was asked the same question: "What is the state doing to support the Signature Event?" My answer is that the Tourism Director gave us our first grant, a \$10,000 grant to start planning the event. That's compared to the \$175,000 pledged by the City of Bismarck, the \$50,000 we just received from a private business or the \$50,000 we got as a first installment from the National Park Service. Altogether, we hope to be able to raise and spend nearly two million dollars on this event, not blowing it all in a ten day period, but leaving behind an international reputation and tourist-attracting legacies: a state-of-the-art high tech "Virtual Village" developed by NDSU, in the museum at Fort Lincoln, and earthlodges to replicate the Mandan village of Lewis and Clark's time, which will go to New Town and Mandan to aid tourism and cultural development for decades to come.

If the state does have \$3 million in a budget for the Lewis and Clark commemoration this
