

Minutes: Chairman Holmberg opened the hearing to SB 2028. Attendance was called, all members present, a quorum was established. Chairman Holmberg discussed the committee's responsibilities to move bills out of committee and assigned some bills to subcommittee work and/or to individuals to research a particular bill. Secretary of State's budget to Senator Andrist; State Auditors and Insurance commission to Chairman Holmberg; Labor commissioner, SB 2005 and State treasurer's budget, SB 2007 to Senator Mathern; SB 2011 for Senator Tallackson; SB 2024, PERS and RIO to Senator Grindberg; SB 2023 Worker's Comp assigned to Senator Robinson. committee who is here also. (Meter 510) Paul Bollinger, Director of the State Racing commission: Gave an history of this bill with his full support. His budget is ½ general funds and ½ special funds. (Meter 880) Chairman Holmberg: Give us a just briefly the big picture. This reduces the general funds by twenty eight thousand dollars (\$28,000) so what other bills out there are going to impact the bottom line to the general fund? (Meter 947) Paul Bollinger: There are about 3-4 bills out there. SB 2285 is one bill is to reduce the take out from 2 1/2 down to 1% to the general fund. If that bill happens to pass, from OMB perspective is there will be a 1.9 decrease to the general fund. Gave the racing history of this racing system. Another bill HB 1282, which mandates that the racing commission adequately licenses anyone who applies to it and adequately fund it. I do not support this bill. (Meter 1183) Chairman Holmberg: what number of people are causing the increase. (Meter 1235) Paul Bollinger: ND does 40% as much as Las Vegas. The beneficiaries of that money has been the state of ND and the horsemen. (Meter 1319) Senator Christmann: Clarify money going to the special funds. (Meter 1350) Chairman Holmberg replied to Senator Christmann's question explaining what was done to this agency two years ago. We took some money out of the special funds rather than funding through the special fund, then there was an uproar from the industry, and then the interim sturdy went out and that study concluded we should go back to the way we did it before last session because times are good this session. (Meter 1406) Paul Bollinger: If the horsemen would be here, they would say, don't take anymore out of the special funds, they are already getting the lion share of the money. What I would not like to see, is this bill become merely a set off. That we get ourselves thirty thousand dollars (\$30,000) out of what we collect but then decrease it out of the general fund. So therefore, I get no impact in my office. I've got no more ability to track down the regulatory

problems. (Meter 1489) Senator Bowman: Where does your salary come from - what fund? (Meter 1500) Paul Boltinger: Come out of the special funds. (Meter 1519) Senator Bowman: The special funds are what you collect in fees? (Meter 1522) Paul Bollinger: No, there are two revenue sources from simulcasting. Only in horse racing do you tax out the gross handle, no other business gets taxed off the gross handle, others get tax. I off of the nct. If you were to go a large volume bet, to bet a dollar (\$1.00), 2 ½ cents (\$.025) the general fund gets immediately, 1 ½ cents (\$.015), comes to one of my three funds, the promotion, purse, and breeder's fund. Those are the two revenue sources. (Meter 1622) Senator Bowman: What the bill allows you to do charge a fee for licensing and that fee goes into your fund instead of the general fund, is that correct? (Meter 1634) Paul Bollinger: That is correct, it would go into a special operating budget. (Meter 1644) Senator Bowman: What is to stop you from raising the fees to \$50 within two years to collect a whole lot of money and lose half of your customers? There is nothing in here to stop you from doing that is money is driving this bill. (Meter 1672) Paul Bollinger: yes, I think I would quickly be back here next session. I understand your concern, we have talked about putting a cap on it. (Meter 1700) Senator Bowman: I think we would need a report. My personal feeling is that would be satisfactory. Most of our special interest groups have a reporting mechanism built into their fees scales. We just need to know where you are at every two years. (Meter 1735) Paul Bollinger: Most of our fees are set by administrative code so the license for an owner is twenty-five dollars (\$25.00). Chairman DeKrey: We will open the hearing on SB 2028.

Paul Bollinger, ND Racing Commission: Introduced the bill, support. One of the concerns from the study conducted by the Interim Committee, was that prior to the 2001-2003 biennium, the ND Racing Commission operating budget was funded in total by the General Fund. Essentially, we are talking about salaries for myself and my one staff member, and the costs of hiring stewards and doing regulating of the industry. All of that money had previously come from the General Fund. However, as a result of the 2001-2003 Legislative session, monies were then split, ½ of our budget was taken from the General Fund and ½ of the budget was taken from our Special Fund. The horsemen, of course, complained about that saying, you're taking a lot of money out of our special fund that was meant to be going back into the industry, why is that going to the operating costs. The Racing Commission took the position, we understood the budget constraints, we understood in these tough fiscal times, that decision had to be made.

However, the comment was made specifically to myself and the Commission, well, Mr.

Bollinger, you understand that many times, regulatory agencies have to be somewhat self-funded. The problem which we encountered was that the ND Racing Commission has no ability to be self-funded because all the fees we charged, we're not talking about the special funds, the taxes on the Simulcast handle, we're talking about granting license to a jockey, register a foal, etc. by statute that money goes to the General Fund and doesn't come into my office. So what we attempted to do was draft some legislation language at the request of the Interim Study Commission to allow at least the amount of money that we generate in our own operation and our regulatory procedures, to allow that to come back to our office to defray the cost of our office. I heard no opposition to it and I stand ready for questions. The fiscal note is about \$25,000 and is based on historic levels of what we believe the income will be.

Rep. Delmore: That's a pretty firm number, with the \$25,000 dollars.

Mr. Bollinger: Yes, the only thing that may change, was that I was told that it might go up slightly, that was based on 6-8 racing days. If we go up to, as our plan was to go in 2 years, might be to 20 racing days. We would be licensing more horses. It might go up to \$30-35,000. It is not a panacea for solving our budget, but it is step in the right direction. I believe it is pretty accurate.

Rep. Kretschmar: Does the Racing Commission then have the authority to increase fees.

Mr. Bollinger: Yes, we would.


