Senator Holmberg, chair, opened the hearing on SB 2064, Wireless access lines. This bill has already been heard in IBL committee. This committee is focusing on the fiscal impact of SB 2064.

Rick Hessinger, interim Director of North Dakota State Radio Communications. (#1949) Written testimony is attached (Exhibit #1). He testified in favor of SB 2064. He gave some history regarding wireless radio dispatch which was in NDCC 54-23.2-09 which included payment from political subdivisions to North Dakota State Radio for 9-1-1 wireless dispatch services, however the amendment did not consider the effect of North Dakota Century Code 57-40.6-05 which encumbered the use of the 9-1-1 wireless revenue collected by political subdivisions. That code provides that the governing body must hold revenues collected from wireless service fees (9-1-1 cellular phone tax) unexpended in a separate fund until the governing body has entered into agreements with wireless service providers for procurement of enhanced 9-1-1 service (Phase I &

II). Phase I service is the location of the cell tower site processing the call and call back number of the cell number of the cell phone making the 9-1-1 call. Phase II service is the call back number of the cell phone making the 9-1-1 and the location (Lat/Long) of the cell phone making the 9-1-1 call. Simply stated these two North Dakota Century Codes conflict with each other, one code directs North Dakota State Radio to charge counties or political subdivision for wireless 9-1-1 dispatch services and the other code prohibits the counties from expending the collected wireless tax revenues until certain service agreements are entered into with wireless telephone companies for enhanced 9-1-1 services. This bill clarifies the date at which political subdivisions shall begin payment to North Dakota State Radio for 9-1-1 wireless dispatch services. The bill specifies the date payments begin must coincide with the date the political subdivisions enter into agreements with wireless service providers for enhanced 9-1-1 wireless services.

Senator Holmberg clarified the bill stating that this was not adding to the tax, just to make what is already in the law workable. Mr. Hessinger replied that, that was correct.

(#2240) Senator Holmberg stopped the meeting to introduce the students from Ellendale.

Questions regarding Wireless Access Lines (#2272)

Senator Bowman: He noticed there is a charge of at least 20 cents per wireless access line, he wondered if that was being collected right now? Mr. Hessinger replied that 20 cents per wire line, standard telephone, stationary phone in rural residence or home. This law would allow State Radio to collect for the wireless, cellular, phone. We will begin to collect 20 cents for cellular phone.

Senator Christmann: He thought they were charging a \$1.00 a line and the counties had to hold that money to use it to develop this, is there any place in the state that Phase II is complete? He thought the counties had to hold the money until this was all done and that was the point why the charging of the \$1.00 a line. Rick Hessinger; This is correct, statues allow counties to collect up to a \$1.00, if they so choose. We have contracted for Phase I and II service. Senator Christmann continued, he wanted to know why there is a fiscal effect on this? It is several years away, I thought the money was to stay with the counties, to get this done, so that there is 9-1-1 available on your cell phone, how come we are sending money to State Radio? Rick Hessinger replied that once the contract is in place and the service has been requested the counties can use that money that is not obligated because of the contract, for running their own dispatch, doing rural signage as well as contracting for dispatch for those small counties that don't have their area. So since we have achieved the contract, and we are on the verge of requesting the service, we feel it is appropriate that those counties that are contracting with State Radio for dispatch have the ability to make the appropriate payment to them for that service. Senator Lindaas (#2728) Are most of the counties on board with this now? Rick Hessinger replied that all 52 counties that have 9-1-1 have signed a joint powers agreement to contract as one unit for implementation. Senator Lindaas continued that he believe that his county had a vote for the 20 cents 9-1-1 line charge, he wanted to know if that will have to be done again (another vote)? Rick Hessinger replied that all

of the counties have voted to allow up to \$1.00, all this deals with is that some of that \$1.00 can pay for dispatchers, equipment and in the case of 22 small counties they don't run their own, they contract with State Radio, and State Radio currently charges at least 20 cents for that service. Senator Hormberg, (#2832) stated that one of the reasons there were so many questions was that when you read the Fiscal Note, and then the bill, they don't necessary, to many people, be talking about the same thing. Senator Holmberg wanted to know what would happen if this bill was not passed. Rick Hessinger: If this bill does not pass, he felt that it becomes mute once that letter of request is made, because the contract has been signed. Senator Holmberg continued, going back to his original question, when you read the Fiscal Note, the State Radio will charge at least 20 cents to any political subdivision and it sounds as if as though this is authorizing this tax, you are saying it is already there. That being the case, why is there \$102,000 Fiscal note if the tax is already there? Rick Hessinger stated that he had not seen the Fiscal Note, but he would assume that because that money is sitting in a bank accounts of all of the counties, and although State Radio has a contract with all of these counties, all they are collecting is the line charge (#3003), the traditional phone lines right now, then they would be able to ask those counties for the wireless device in the future. Senator Holmberg asked Alan from LC if he had any comments on the fiscal note? Alan: He agreed with Rick about the reason. Senator Christmann: Did you say that Dunn and one other county are this far along and at 20 cents a piece there would have to be ½ million cell phones in those two counties to come up with kind of money. Just because those two counties are ready, does every county have to start paying on this or what? Rick replied that first of all Stark and Dunne counties are not dispatched by State Radio, they are dispatched by Stark county and currently the Cell companies are front ending the cost of upgrading that as a

Good Morning Mr. Chairman and members of the Industry, Business and Labor Committee. My name is Rick Hessinger and I am Interim Director of North Dakota State Radio Communications. I am here today to testify in favor of Senate Bill 2064.

Last Session North Dakota Century Code 54-23.2-09 was amended to include payment from political subdivisions to North Dakota State Radio for 9-1-1 wireless dispatch services. However, the amendment did not consider the effect of North Dakota Century Code 57-40.6-05 which encumbered the use of the 9-1-1 wireless revenue collected by political subdivisions. North Dakota Century Code 57-40.6-05 provides the governing body must hold revenues collected from wireless service fees (9-1-1 cellular phone tax) unexpended in a separate fund until the governing body has entered into agreements with wireless service providers for procurement of enhanced 9-1-1 services (Phase I & II). Phase I service is the location of the cell tower site processing the call and the call back number of the cell phone making the 9-1-1 call. Phase II service is the call back number of the cell phone and the location (Lat/Long) of the cell phone making the 9-1-1 call.

Simply stated these two (2) North Dakota Century Codes conflict with each other.

One Code directs North Dakota State Radio to charge counties or political subdivisions for wireless 9-1-1 dispatch services and the other Code prohibits the


