### TESTIMONY BEFORE THE GOVERNMENT AND VETERANS AFFAIRS COMMITTEE REGARDING FILLING STATE EMPLOYEES COMPENSATION COMMISSION VACANCIES - SB 2108

# JANUARY 10, 2003 CENTRAL PERSONNEL DIVISION SOLUTION LAURIE STERIOTI HAMMEREN, SPHR, DIRECTOR

Chairman Krebsbach and members of the Government and Veterans Affairs Committee, I am Laurie Sterioti Hammeren, Director of the Central Personnel Division. I am here to discuss Senate Bill 2108, a Bill to amend the method used to fill state employee compensation commission vacancies.

The State Employee Compensation Commission (SECC) is based on NDCC 54-06-25. Paragraph 2 provides that there are 4 members of the legislative assembly appointed by the chairman of the legislative council, and four state employees are elected members; 3 must be members of the classified service and one must be a member of the non-classified service.

The current method of filling a vacancy on the SECC is to place the person with the next highest vote total from the previous election in the vacant position. Senate Bill 2108 amends this method to include allowing the chairman of the commission to call a special election if the next available vote getters are no longer available to serve on the commission.

Because of the current wording of NDCC 54-06-25, the SECC has only two members (instead of four) serving classified and unclassified state employees. There were no available vote getters to replace the members who have resigned:

- Sharon Heap, elected in 1999, resigned from state employment shortly after her election.
  - Barb Schaan, the next highest vote getter, replaced Sharon Heap and then later resigned from state employment.
  - The next two highest vote getters were no longer eligible to serve on the commission due to the August 1999 statute change removing all university system employees from the classified service.
  - The last vote getter was no longer available because he left state employment.
- Mike Sandal, unclassified employee elected in 2001, left state government in 2002. He was the only person on the ballot so there was no next highest vote getter to replace him.
- Central Personnel was advised by the Attorney General's Office that the statute expressly provides replacement by the person with the next highest vote total in the previous election, and that it would not be advisable to use a different election to fill the position.

Please provide a do pass for Senate Bill 2108 so that state employees may be adequately represented through special elections, if necessary, on the SECC when vacancies occur.

This concludes my formal testimony. I am available to answer your questions.
