**Senator Dever:** Does the maintenance board only involve itself with the politically sub owned buildings or maintain otherwise.

**Major General Haugen:** The board has not met. My committee handles all the armories.

**Senator Dever:** So in absence of the board you are able to do what needs to be done anyway?

**Major General Haugen:** Yes

**Senator Krebsbach:** Is there a established board now?

**Major General Haugen:** No, the board now must consist of myself and another board member.

**Senator Brown:** What are the conditions of the buildings?

**Major General Haugen:** We are putting money that we have some maintenance funding for.

The last biennium we had an excess of \$250,000. It is a matching fund budget so last year we put about \$500,00 into these buildings. There is a separate budget for the state owned buildings, some are old but very well taken care of. The roofs are the most important part. The cities use them for a lot of city held events, and some are used for many joint reasons.

**Senator Wardner:** I feel the joint use is a co-op type partnership.

**Major General Haugen:** Yes, we work closely with the cities in partnership of the buildings.

**Senator Krebsbach :** 18 are owned by cities and 5 are owned by the state so there is a total of 23.

**Major General Haugen:** Yes and we are just opening a newer one in Wahpeton to replace the current one.

Madam Chairman, Members of the Committee,

The Office of the Adjutant General asks you to pass this bill. This bill repeals Section 37-10-03.5 of the North Dakota Century Code. In its present form, this statute adds an extra layer of bureaucracy to how the Adjutant General's Office manages the maintenance of armories.

The current statute establishes an Armory Maintenance Board which is to meet annually and determine which National Guard armories are in need of maintenance and/or repair. This board determines priorities and sets contribution levels for the National Guard and each political subdivision.

The last time this board met is unknown. One reason for this is because historically, there has been a relatively small amount of State funds available for the maintenance of armories. Over the years, the membership of the board has been reduced to the point where it is comprised of the Adjutant General and one individual from a political subdivision. This arrangement may create a perception of bias by the board member for any armory projects in their political subdivision or region. Eliminating this board would guard against this perception.

We suggest the Armory Maintenance Board be replaced with a matching grant program similar to the one followed in the 2002-2003 biennium when funds were appropriated for maintenance and repair of political subdivision-owned armories. In this program, equal matching grant funds were provided by the legislature for use by political subdivisions. The Adjutant General's Office conducted a major repair and maintenance needs survey of all political subdivision-owned armories. Priority was given to those major maintenance and repair projects for which the local political subdivision contributed the highest ratio of political subdivision funds for each dollar of State funding

Mr. Chairman, Members of the Committee,

The Office of the Adjutant General asks you to pass this bill. This bill repeals Section 37-10-03.5 of the North Dakota Century Code. In its present form, this statute adds an extra layer of bureaucracy to how the Adjutant General's Office manages the maintenance of armories.

The current statute establishes an Armory Maintenance Board that is to meet annually and determine which National Guard armories are in need of maintenance and/or repair. This board determines priorities and sets contribution levels for the National Guard and each political subdivision.

The last time this board met is unknown. One reason for this is because historically, there has been a relatively small amount of State funds available for the maintenance of armories. Over the years, the membership of the board has been reduced to the point where it is comprised of the Adjutant General and one individual from a political subdivision. With representation from only one geographical area of the state, there may be a perception of biased decisions, favoring the political subdivision that currently sits on the Board. Eliminating this Board will help insure that the needs of the entire state are equitably weighed.

While we have not convened this Board in years, I would like to assure this Committee that the mandate of this Board has been met by the Adjutant General's office. During the last legislative session, the Legislative Assembly approved a matching grant program for the maintenance and repair of political subdivision-owned armories. The Adjutant General's Office conducted a major repair and maintenance needs survey of all political subdivision-owned armories. Maintenance priorities were set based on the needs of the individual armories and the amount of matching funds contributed by the political
