**CHAIRMAN COOK** called the Committee to order.

Roll call was taken with all members (6) present.

**CHAIRMAN COOK** opened the hearing on SB 2168 which is relating to the assumption of lost property or money by a finder.

**SENATOR COOK**, District 34, Mandan ND, introduced SB 2168. The background on why he introduced the bill was because of a situation that happened about a year ago. A couple in the mall in Minot ND found a bag with three thousand dollars (\$3000) in it. They were very honest people so they turned the money into the police. The police department in Minot held the money for two years in an attempt to find the rightful owner. If after two years, they couldn't find the rightful owner, their intent was to give the money back to the individuals that found it. There were some question whether they could do that legally. The Attorney General's opinion referenced to the statue that says any property with no known owner belongs to the state.

Therefore that \$3000 in cash was sent to the unclaimed property division of the state of North Dakota. It will sit there probably forever. The interest generated off of the money will go into the school trust fund to help pay for education. Senator Cook's concern was that this was not right and he felt this discourages people from being honest. The attorney general also encouraged Senator Cook to introduce a bill on this as this just wasn't right. The bill will put in some language that in situations like this, after two years if the owner can not be found the money could go back to the finder.

**SENATOR CHRISTENSON** asked if this would be retroactive so the couple could get their \$3000.

**SENATOR COOK** felt this is something that should be looked into.

**SENATOR GARY LEE** asked a question for Senator Judy Lee who had to step out of the meeting for a few minutes. The question was, can an amount be limited to below a certain amount, like five thousand dollars?

**SENATOR COOK** said yes, but do we want to?

**SENATOR SYVERSON** asked how two years was arrived at.

**SENATOR COOK** thought two years was a long enough time to find the rightful owner.

**Linda Fischer**, Unclaimed Property Administrator, not for or against SB 2168, clarified that this situation is the only one that she is aware of. The police department actually held the \$3000 for three years. The people that turned in the money did get a \$300 reward, which came out of the \$3000. There is a section in the statute that says the reward is limited to ten percent. The intent of the unclaimed property law is if the real owner can not be found then everyone should benefit,

and in this case it would be the schools. She feels the bill does encourage people to be honest and it is a good piece of legislation.

**Wade Moser**, ND Stockmen's Association, felt there should be a clarification on Line 9, which talked about Section 47-30.1, the unclaimed property act . There is also a similar law in Section 36-22 that deals with livestock. If livestock are lost or stray there is a provisions for law enforcement and for the association on how we notify people, how we advertise and how long we handle the money, basically the whole system is in place for livestock . He would like to see amendments to that section, on that line, so that attorneys or law enforcement officials know that if it happens to be livestock, there is a provision already in place to take care of that.

**SENATOR COOK** closed the hearing on SB 2168.

**Discussion:**

**SENATOR COOK** had questions of Inter TeLis Nemec on the definition of lost, misplaced and abandoned;

lost property - a finder has the right to that property except for the true owner after two years  
mislaid property - its not the person who finds it that would have the right to the property but the person who owns the land where the property was found  
abandoned - would be similar to lost property

**SENATOR JUDY LEE** asked if there are states that have more than two year.

**TeLis Nemec** answered that the time period is one to three years usually.

**SENATOR SYVERSON** asked how it would work if insurance had been collected on the property.

**TeLis Nemec** answered that being reimbursed by insurance would have no bearing on it.

explained the problem that had risen and found a solution, however, we do have an amendment we would like you to consider, since personal property is lost and found from time to time and there is a provision in state law called the "estray law" that handles how you dispose of property. There is a provision in there that talks about where the ND Stockman's Association actually received that estray money and we put it in with the State Treasurer, goes into an estray fund, the owner has up to six years. We're bound to hold that for six years, however we have paid money to people who have proved ownership at a later time after the six year period. For various reasons they don't come forward or have lost their records that prove ownership. The proposed amendment is referring to chapter 36-22, under lines 10 and 11. In order to make sure that it's clear, that there is already a provision to handle this, we would like that part of it to be included right after the unclaimed property tax.

**(5.0) REP. BRUCE ECKRE:** On line 9, it says "or any other provision of law"...

**(5.2) WADE MOSER:** We want to make sure when an attorney or someone sees this that they understand that there's other provisions that may cover this, since the unclaimed properties specifically says that unless it's under this provision, this is enforced. We want to make sure that we're recognized unless it's an estray animal law, we want to follow the estray law provision.

**(5.7) CHAIRMAN GLEN FROSETH:** Has Sen. Cook seen this amendment?

**(5.8) SEN. DWIGHT COOK:** I'd be OK with it.

**(6.1) CHAIRMAN GLEN FROSETH:** Further testimony? Seeing none, I will close the hearing on SB 2168. We will wait to hear back from Wade Moser on that amendment, then we will take action on it. (6.5)

They either notify the Sheriff's Dept. or notify the ND Stockman's Association. We work together. We allow them to hold that animal on their property for up to 30 days so we have an opportunity to contact the surrounding communities, neighbors and find out if we can locate the owner. If that doesn't happen then we require or request that they haul that animal to the nearest auction market where it's sold and then the money is deposited in the State Treasurer's office that goes into the (tape ended)

**(4.0) WADE MOSER:** We have field men that investigate these strays and try to find the owner. That money stays in that account until we find the owner. Sometimes it takes several years for someone to come forward and claim it. If we do not find the owner's, that money stays in that account and is used to help defray some of the expenses for the investigation that goes on. We will get somewhere between 75 to 100 stray claims coming in and of that solve 80 to 90 percent within a year. But there are those that do go on. It usually takes three years and the reasons why they don't come forward is they're waiting for a bank to disappear on them, for a divorce case, family members feud's to go away. They know the money is setting there and they know it's going to be there for a long time and then they'll bring forward their paper work and collect the money. This procedure has worked well in the past and we want to make sure that if someone comes around and that they know this is the procedure and there's a way to resolve it.
