Leon Samuel answered that they did. The bill that was introduced last year said that they had to own land within the township and there was no mention as to where they had to live. In this bill we are saying that they still have to live within that fire district.

SENATOR O'CONNELL, District 6, introduced the bill. This bill would simply allow fire district boards up to two directors from one township. Under current law right now any district that has more than seven townships may elect as few as seven members but there can be no more than one member from any given township. SB 2243 would allow up to two rural fire district board members to come from one township if the district represents more than some townships.

Joel Boesplug, North Dakota Fire Chiefs Association, spoke in support of the bill and the amendments, simply for promoting interest in the fire district and in the fire service leadership.

They have seen some cases where it is very difficult to get persons involved on the board and persons who really have that strong desire are sometimes excluded. They see this bill as a positive move for the fire service.

Ray Lambert, State Fire Marshal, spoke in support of SB 2243 with the amendments. They see first hand on a day to day basis the difficulty in getting good quality board members in these rural fire protection districts. The numbers have decreased in population. He sees no concern with adding a second member from a particular township.

No testimony in opposition of SB 2243.

CHAIRMAN COOK closed the hearing on SB 2243.

SENATOR JUDY LEE she would feel more comfortable if she could ask some one from the township association about the amendment.

CHAIRMAN COOK set SB 2243 aside until time to visit with township people.

(23.1) REP. MARY EKSTROM: In a situation where you have multiple townships, is it possible that someone who is in township A, talk to township B, serve on both boards?

(23.3) LEON SAMUEL: My understanding is basically in New Salem. We'd like to see someone from each township to be on the board. Next month we're having our membership meeting again and there's going to be six board members that will be up for renewal. The problem is as the farmers retire they move into town. They would like to stay on the board and still live within the city. He owns land out there yet but according to the statute the way it is, he's not supposed to be serving on the board and that's where the situation comes from.

(24.3) REP. GIL HERBEL: What are the duties of the person that deals with the Fire District?

(24.4) LEON SAMUEL: Just like any board member, their biggest duty is the budget. We're in a taxing district, we have property tax dollars that come back, insurance fund dollars that come back, and they're there to oversee those funds are spent properly.

(24.9) REP. DALE SEVERSON: I live and reside in Bridge County and have a home in Cooperstown, but yet I have lake property in Barnes County. Fire protection is an issue for me. Could I in fact become a board member of that rural fire district in Barnes County if I reside outside the county?

(25.4) LEON SAMUEL: On the bill it says in line 7: (goes on to read it) You would still have to reside within the boundaries in the district to be a member. You wouldn't have to live within that township, but you would have to live within the boundaries of the district.

Would a district of that type be affected by this legislation which have like 17,000 people within the city limits and they do some rural as well?

(27.5) LEON SAMUEL: A fire district is made up of from 1 to 20 townships. In the city of Mandan, they have their own fire district and a rural fire district around the city of Mandan. So I'm assuming that all of the people that are on the fire district of Mandan are from the city of Mandan.

Am I to understand that if they had a five person district that they would be required to have one person from the city and the other four, they had four more townships involved that they would have to have one from each township.

All we're saying is, you might have a township where no one is living, so if you own land then you would have the ability to serve on the district. This is the only change.
