Senator Karen Krebsbach, Chairman opens SB 2294. All senators present.

Senator Bercier introduces and explains SB 2294. The emergency committee ends up doing legislative work in the even-numbered years, the bill would not bring it any longer than 80 days. If in fact I think we could even get it down to 20 days and sometimes less.

The alternative to this is the special session where the 80 day limitation does not apply when called by the governor but, when we call ourselves back into session then the 80 days does apply.

Senator Bercier: continuity is a big thing.

Senator Krebsbach: Do you think doing annual sessions would be easier to attract people to

run for office?
