Chairman Flakoll opened the hearing on SB 2385. All members were present.

Senator Taylor introduced the bill. It updates requirements to federal standards. 'The organic food industry serves an important niche and is good for smaller operations in North Dakota. The bill further defines the role the state plays in organic food certification, which is very minimal. Senator Flakoll asked if someone will provide us with the federal regulations? Does this apply to all foodstuffs?

Senator Taylor said yes.

Pat O'Neil, Organic Coordinator for the Department of Agriculture, testified in favor of the bill.

The bill primarily housekeeping to clean up our existing organic farming law. (written testimony)

North Dakota is second only to California in number of production acres for organic farming.

Senator Flakoll clarified that we do not need the FTE because we are not certifying the organic agents?

Mr. O'Neil said yes.

Senator Flakoll asked about the repealers.

Mr. O'Neil said the portions being repealed are related to proving to their personnel are qualified.

Now that there are federal standards in place, we are not allowed to make those distinctions. If we try to have anything to say about their qualifications, we have to enforce the federal regulations and, as a practical matter, we are not qualified to do so.

Senator Urlacher asked if the organic certifying agents go into the field?

Mr. O'Neil said yes, they have field personnel. Organic farms are inspected once a year. Some of their products are very unusual and it is a very difficult process. Throughout the handling process, the products are tested, sometimes more than once.

Senator Urlacher asked if it is difficult for a producer to get approved?

Mr. O'Neil said it is difficult and expensive to get approved. The federal program provides hand out funds for certification fees, up to 75% or \$500, whichever is greater. North Dakota producers should qualify for \$90,000. This will cover their certification fees for one or two years. This is helpful and the Agriculture Department hopes it may attract some new producers.

Senator Klein asked about the certification company in Medina. Do they do certification on a fee-for-service basis?

Mr. O'Neil said yes.

Senator Nichols asked what our organic farmers raise and where is it marketed?

Mr. O'Neil said primarily small grains that are marketed in Europe and the Pacific Rim. We may get into onions, carrots, wines.

Chairman Flakoil closed the hearing on SB 2385.

Senator Urlacher said there seems to be quite a potential for organic farming in North Dakota.

Organic flax can go up to \$40/bu and screenings can go for \$7/bu.

Senator Flakoll said this will unify the definitions of organic so producers and consumers know what the product is.

The motion passed on a roll call vote. Voting yes were Senator Flakoll, Senator Erbele, Senator Klein, Senator Urlacher, Senator Nichols and Senator Seymour. There were no negative votes cast. Senator Seymour will carry the bill to the floor.

One of the problems is that there has been to many certification procedures and each time. The producer pays another fee. The National rule requires that all certifying agencies recognize all other certification. We don't have this step by step process that nickels and dimes the producers.

REP. FROELICH: Don't you feel that the civil penalty up to \$5000.00 for each violation is quite stiff?

PAT O'NEIL: I am in the process of working on the second violation that I have had since I took over. The first one was pretty bad. We fined him a substantial amount and then suspended It under condition of no future violations We have a registration violation going on right now. We are proposing that we fine him \$5000.00 for each violation or \$10,000.00 and suspend all but \$8,000.00 of it. They will pay a fine of \$2000.00. We like the fine to be so that it will get there attention. It keeps there attention also while they are on probation. I don't anticipate collecting more then 1,000.00 from any violator. We are really looking at a thousand dollar fine for not registration. We want to keep this at the misdemeanor level because at the infraction level we just don't have any authority and they would have a tendency to laugh at us. We do want to get there attention.

How long dose it take to get into it?

PAT O'NEIL: If we have 20 crops that we can raise organically we will be lucky.

Chairman Flakoll and members of the committee. My name is Pat O'Neil and I am the Organic Coordinator in the Department of Agriculture. I am here to testify in support of SB 2385. This is a housekeeping bill to clean up and clarify North Dakota's organic laws.

There are approximately 177 certified organic farming operations in North Dakota.

Under the current law, the North Dakota Department of Agriculture registers private organic certifying agents, and we take enforcement action if someone violates the organic laws in North Dakota.

On October 21, 2002, an new National Organic Program rule became effective. It defines and regulates all organic production, processing, handling, labeling and certification activities. The primary effect upon our state was it invalidated all of the organic provisions in the Century Code except those relating to the registration of organic certifying agencies. The new rule supercedes all previous and existing national and state organic laws, rules and regulations.

The new federal rule provides that any state which has an organic program must enforce the federal rule. The enforcement of the federal rule would require, at a minimum, one FTE. There are two certifying agencies registered with North Dakota and both have been accredited under the new federal program. We do not have a state organic program at this time. It would require one to one and one-half FTEs to prepare and administer a state program.

Some of the existing language in our law does not comply with the new federal regulations. The provisions relating to the registration of certifying agencies have been refined and retained in this proposal. The result is that North Dakota will comply with the new federal rule and will not be responsible for the enforcement of the same rule. There will be no fiscal impact as a result of this new law and the existing organic operations will continue to operate as in the past.
