Mr. Merl-Paaverud and Robert Schlobohm spoke for the State Historical Society. (handout #3-14, attached) (meter Tape #3, Side A, #46.8). Mr. Schlobohm discussed variances described in handout and noted that their only carry over authority was in capital assets within Lewis and Clark. The decrease is due to the fact that the project is complete. Mr.. Paaverud noted that services were needed throughout the state and that funding is being sought for FTE positions.

Mr. Wayne Stenehjem Attorney General, distributed handout #3-15 and discussed the 7 variances listed on page 2. (meter Tape #3, side B, #3.8) While discussing these, it was determined that the figures in the handout were in the wrong columns and would be corrected for the committee. (corrected version of handout is attached). Discussion ensued regarding "off Budget" positions in budgets and information was requested from Legislative Council concerning all agencies with off budget employees and whether or not these funds were included in the budgets and where.

Ms Teresa Larson spoke for Protection and Advocacy. (handout #3-16, attached) (meter Tape #3, side B, #15.5) Ms Larson read her written testimony and explained that this is the first time they have ever seen a decrease in federal dollars (mental Health Grant) which means an increase in operating expenses. Ms Larson continued by explaining their performance measurements listed on page 4 of handout.

Mr. Paul Shadwall from the Game and Fish Department reviewed the 8 variances listed on distributed handout #3-17 (attached). (meter Tape #3, side B, #33.2)

Mr. Sparb Collins from Public Employee Retirement System Distributed and reviewed handout #3-18 (attached). (meter Tape #3, side B, #44.7) Mr. Collins explained that the increase in Health Insurance is found in each agency's salary line and that the \$3000,000 increase is all

Chairman Carlisle called the hearing on HB 1018 regarding the Game & Fish Department to order.

Mr. Dean Hildebrand, Director Game & Fish, introduced Kim Molesworth, a new staff member, and Paul Schadewald, who's been with the Department for a long time. Dir. Hildebrand submitted various exhibits for the Committee's consideration: the *Plots Guide* (See Handout #1); a brochure entitled "Aquatic Nuisance Species" (See Handout #2); and the Dept.'s award-winning magazine, *North Dakota Outdoors*. He called attention to the article about cougars and information landowners might need should one be sited. He also submitted a series of maps (See Handout #4), which include a graph which estimates the smelt biomass and cold water habitat on Lake Sakakawea. He pointed out that the map of Sweetbriar Dam because the lake level is being dropped five feet. The Director is opposed to this action because of the

negative effects on fishing. The Dept. has just made some repairs, but they have found some leakage and they're worried about I-94. In answer to a question about how long that would take, the Director estimated a month or a month and a half. Making repairs is an unforeseen expenditure and the Director has no idea how much the process will cost. When asked whether it was a concrete spillway, the Director confirmed and explained that it's actually a box drop in the reservoir itself. The gate can be lowered to allow the water to come over the top of that, under the road, and onto a concrete spillway.

Director Hildebrand explained that the map was drawn by some very sophisticated equipment, which is placed in a boat that runs the contour of the lake so many feet from the shoreline repeatedly until the computer has gathered enough data to print out a map which plots the water levels. Maps like these are available on the web site and at the Dept. This is one of many new technologies that are out there, including the all-terrain vehicles, optics, and GPS. An extreme example comes from Michigan. Because big bucks are a premium, up to \$10-15,000 to some people, entrepreneurs like one in Texas can advertise a hunt on the web. He bates the deer, films them, and when one comes that's the right size, he puts it on the web site. An executive in New York who wants to shoot it, can do so from his desk.

Rep. Thoreson asked how many lakes in N.D. had been mapped. Dir. Hildebrand said fishing lakes in N.D. have grown with high water levels, from 125-130 lakes that the Dept. intensively managed to about 335 lakes. The Dept. has mapped about 150. Lake Sakakawea will be a major undertaking and that's not done yet. Rep. Thoreson asked if lakes are re-mapped when they change. Dir. Hildebrand explained that once mapped changes can be done with the computer by inputting new elevation levels. He invited Committee members to remind him on the day of the

game feed (January 31) to give a demonstration of how the software works. One very interesting feature is the seeing the lake from the viewpoint of a fish. (Meter #1037)

Dir. Hildebrand informed the Committee that the Dept. issued 145,250 deer licenses this past year. Processing this information requires a great deal of paper work. The Dept. is asking for five additional FTE's with one to dedicated to licensing. By all reports, it appears the first season was a success with an 80% kill. The Dept. is trying to improve hunter/landowner relationships so that more land is opened up for hunting. This issue is brought up a Hunter Safety classes and another way is sponsoring 8 dinners around the State in places like New Salem. There's a bill coming up this session to have lands automatically posted in N.D. Theresa a lot of land owned in absentia; if it's not posted, hunters assume it's open to hunting. Automatic posting takes lots of hunting land out of play. North Dakota has 738,000 acres of land open to hunting under the Plots Program alone. There has been a request to open State school lands to hunting, which amounts to about 700,000 acres. (See p. 6, Handout #1).

Rep. Kempenich asked about leasing land where the deer population is too high and Dir.

Hildebrand said the Dept. has initiated a new program called the Working Lands Program which visits a site and evaluates the value for the hunting land with regard to habitat, etc. and draws up a contract with the landowner to lease the land for a short-term contract.

Chairman Carlisle reported that he has come upon leased land that has been tilled up. Dir.

Hildebrand said this will occur now and then, but the Dept. is constantly checking and is required by law to meet in those advisory districts twice a year.

**Dir. Hildebrand** stated the pheasant hunt was good with the exception of the Mott & Hettinger area. The cool spring affected the hatch. In 2003, 600,000 birds were shot. This year the reports

aren't back in but the average is up. With regard to prairie chickens, there were two hunts in eastern N.D. for the first time in almost 60 years. The Dept. offered 100 licenses for 2 birds a piece. The hunt totaled 138-139 birds.

With regard to CRP, **Dir. Hildebrand** said N.D. has 3.2 million acres, which is the reason N.D. hunting is as good today as it was when Lewis & Clark were here. **Rep. Timm** asked what would happen if the federal government ended the program. A new committee is forming in Valley City regarding renewable resources. The membership is \$500. There's a possibility that N.D. will lose 1.7 million acres by 2007. There was a sign-up one or two years ago and there were 3,000 farmers who wanted to get into the program and only 300 were able to re-enroll.

**Dir. Hildebrand** suggested that maybe North Dakota should consider current research on switch grass and maybe when CRP funds phase out, landowners could reapply by planting switch grass. It's native to N.D. and produces more biomes than corn. It takes two years to harvest. One year it could provide habitat for wildlife and the second year material for processing ethanol. The seed is currently available in Minnesota.

(Meter #3502) Chairman Carlisle asked about the 5 FTE's and Dir. Hildebrand stated that two of them are wildlife biologists for a federally subsidized program to assess all the wildlife in the U.S. to determine which species are becoming endangered. The Program requires every state to write a satisfactory state plan otherwise no federal dollars will be granted. The other FTE will be a fishery technician who will cover the additional work covered by the creation of a new district in central N.D. and to help manage lakes, the number of which has expanded from 130 to almost 350. The other FTE is a license clerk for the increased licensing demands. A breakdown of this

information can be found on p. 10 & 11 of the 2005-2007 Appropriation Request, N.D. Game & Fish Dept. (See Handout #5).

**Dir. Hildebrand** has been working on a state plan to deal with nuisance species (See Handout #2) and when the Governor approves that the Dept. will be eligible for some federal funding to prevent the nuisance species from coming into N.D. There is a good possibility that carp are coming down from Canada into Devils Lake, which may require an expensive diking project. **Dir. Hildebrand** talked about the S.O.L., Save Our Lakes Program, which cost about \$1 million per year. Through this program, the Dept. is cleaning out debris, putting in fishing piers, and

**Dir. Hildebrand** mentioned the Minnesota hunting lawsuit, which may go before a judge in January. There's federal legislation pending which addresses these issues, so a delay would be in the Dept.'s favor.

Dir. Hildebrand also mentioned how costly the chronic wasting disease is for the Dept. and that the Dept. could incur significant costs in the future. It's one of the reasons why the Department likes to keep \$24-25 million in reserve. The Dept. is required by law to keep a minimum of \$10. Chairman Carlisle asked the Director about Eber's Ranch and the Director stated this has been in the works for the past 3-4 years. There is a law that says the State cannot use federal money to pay the bills of the State Legislature. S.D. got into major trouble for doing that. He also questions whether purchasing the ranch is a good investment of sportsmen's dollars. The Dept. hired a Montana firm to evaluate the hunting rights which came out to \$100 an acre for perpetuity, which isn't a bad deal. The Director is not interested in owning the land and having to maintain it. He will certainly work with Parks & Recreation to support hunting.

Rep. Timm stated that he thought the Game & Fish Dept. generally kept \$20 million in reserve.

The Director said he feels uncomfortable when the reserve dips to \$20 million. This current budget has deficit spending of \$3 million. It can change so fast.

Paul Schadewald, Chief of Administrative Services Division, N.D. Game & Fish, informed the committee that Rep. Porter introduced a bill that provides \$1 million for a local match for a Private Land's Fund, another Plots Program. That's the only legislation the Chief knows of that has appropriations out this fund.

**Chairman Carlisle** asked the Chief to provide a memo if they've included any equity raises in the budget. The Dept. has done a number of them using the Administrative Law Authority and will provide a report.

**Chairman Carlisle** asked if the FTE's were under continuing appropriations and the Chief responded in the negative.

**Rep. Kempenich** asked about SB 2113. He noted that N.D. licensing fees are cheaper than surrounding states. **Chief Schadewald** confirmed that our fees are a bargain.

Rep. Timm asked if the Chief could brief the Committee on what's happening with the Emergency Commission. Chief Schadewald said the Emergency Commission authorized funding, both federal and Game & Fish Funds, for boating access on Lake Sakakawea because it couldn't wait until July 1. There hasn't been much funding from the Corp of Engineers.

**Rep. Timm** asked about the new marina south of Garrison and whether or not that is a Game & Fish project. **Chief Schadewald** said the N.D. delegation worked with the Corp of Engineers for those facilities; it's not a Game & Fish project.

Rep. Kempenich asked about the extra ordinary repairs in the budget and asked for an explanation. Chief Schadewald stated that one item is for the facilities. Using the formula developed by the OMB, the Dept. determined an amount needed to maintain the facilities over the years. The other major items are for boating access and dam repair work which is done with the Water Commission.

**Rep.** Kempenich asked about the plane and Chief Schadewald explained that the Dept. uses a two-seat tail dragger used for wildlife surveys, a Scout aircraft, and it needs replacing. The Dept. has received a bequest to pay for half the cost. The cost will be \$250,000.

Rep. Timm wanted to know how the Dept. gets its federal funds. Chief Schadewald explained that there are two categories. The larger amounts are federal aid in fish and wildlife which are excise tax monies that come from fishing and hunting equipment. There's a formula based on the size of the state, licensed hunters and fishermen, and the Dept. gets an allocation, which is noncompetitive; The State receives \$5-6 million per year. There's a new program that deals with non-game species and the Dept. expects to receive \$1.5 million over the biennium. In addition to funding two positions, this money provides grants to nature conservancies and N.D. Parks & Rec, and other groups. The Dept. gets the match from other organizations and 100% funding for the Lone Tree area, over a \$1 million. Also, there's some Coast Guard funding for boating work, 50-50 work, where the Dept. works with sheriffs for boating law enforcement.

**Rep. Timm** asked if the federal funds are tied to special use and the Chief confirmed.

**Dir. Hildebrand** asked the Committee to look at the map of Horsehead Lake (See Handout #4). He pointed out that there were access problems and the Dept. built a road on the section line. That's the type of project funded by federal dollars.

Chairman Carlisle called to order the Committee work meeting re: HB 1018. For the record,

Chairman Carlisle noted that Rep. Kempenich is at an agriculture meeting in Missouri. He also informed Committee members that the Proposed Amendments to House Bill No. 1018 is ready for their review.

Mr. Paul Schadewald, N.D. Game & Fish Department, submitted a Memo dated 1/26/05 to the record (See Attachment #1), which reviewed some of the current legislation which may require additional budget dollars. The memo references to HB 1189 regarding a local match Private Land Access Improvement Program and Mr. Schadewald stated this has a separate appropriation from HB 1018 even though the money comes out of the Game & Fish Fund. Rep. Kroeber asked when that appropriation gets rolled into the budget and Mr. Schadewald said that at the end of the session any bill that affects the agency would be rolled together. The

Department's total appropriation authority would be combined. Next session comparison would be to the total appropriation that was contained in all bills. **Chairman Carlisle** pointed out that it would be a match appropriation and **Mr. Schadewald** added that the local match would never come into the Game & Fish Agency budget.

The Memo (See Handout #1) also references SB 2145, which appropriates \$424,720 for the Ebert Ranch purchase. **Mr. Schadewald** said the bill is still in the Senate and the status of this bill is uncertain at present.

The Memo (See Handout #1) also references HB 1423 regarding signage to identify state school lands. **Mr. Schadewald** said this does not address Game & Fish funds at this time, but if the job of posting signs falls on the Dept., there could be costs of \$700,000 to \$1,200,000. The Dept. provides a Plots Guide and feels that information is adequate. The Dept. is not in favor of this bill.

Also referenced in the Memo (See Handout #1) are three items that have come up recently and the Game & Fish share in those costs are as follows: Sweet Briar Dam Repair, \$50,000 in grants and \$200,000 in capital improvements; Grahams' Island road improvement at Devils Lake, \$500,000; and Devils Lake carp control dam construction, \$100,000. These items were not included in the budget. **Rep. Kroeber** asked what's expected of the Committee and whether or not these items will be dealt with later on in the session after the numbers firm up. **Mr. Schadewald** confirmed that would be a possibility or the Dept. could wait until later on and go through the Emergency Commission.

**Chairman Carlisle** requested that **Mr. Schadewald** write a memo by Friday, to justify the five FTE's the Dept. is requesting, which could be used before the Full Committee.

**Rep. Kroeber** asked about the Sheyenne River Valley and **Mr. Schadewald** said the Dept. has received the appraisal and there is adequate funding to cover that project.

Chairman Carlisle asked about the Mountain Lion Study and Mr. Schadewald said they can handle that with the current budget, too.

**Rep. Williams** referred to SB 2145 and asked what stance the Department would take with regard to purchasing the ranch. (Meter #8.7) **Dir. Hildebrand** stated that Game & Fish is interested in the hunting rights only. The Dept. hired a Montana firm to appraise the hunting rights and they said the hunting on that land for perpetuity is worth \$100 per acre. If they sell off the outlying acres, the Dept. is looking at 4,200 acres, so the Dept. of Game and Fish will be responsible for \$420,000 to secure hunting rights.

Dir. Hildebrand referred to the earlier discussion regarding the Sheyenne Valley project and added that this is a joint project with water boards that planned to buy flooded property and sell it to Game & Fish at a fair appraisal. Unfortunately, the owners want 50% higher than the appraised price. Game & Fish won't do that unless the water boards want to come up with the extra funds.

Rep. Ron Carlisle explained that in section 8 there is a bylaw that does not allow the Game and Fish balance to fall below \$10 million. We changed this to \$15,000 to protect the fund in case we get into periods where license sales are down due to low water levels. We put \$800,000 and an emergency clause in for the 23 projects they listed including ramp improvements and marina developments. They are requesting the addition of 5 FTEs. 2 of these would be for non game wildlife staff, 1 is for a fisheries technician, 1 license clerk, and 1 for a wildlife technician. HB1189 is covered here and we are not sure what will happen with the \$400,000 for the Ebbert's ranch, and there may be need of moneys in the Devil's Lake area, but basically these are the changes to this budget.

All income of the state game and fish department deposited by the director with the state treasurer must be credited to the state game and fish fund and the fund may be used only by the department. All money derived from the investment of the fund or portions of the fund must be credited to the game and fish department private land habitat and access improvement fund. 

Chairman Carlisle opened the Conference Committee on HB 1018 concerning the budget for N.D. Game and Fish Department. He deferred to Sen. Krauter to explain the Senate changes in amendment .0204, beginning with the pheasant season. Sen. Krauter noted the issue passed unanimously in the Senate and a concept similar failed in the House. There's strong support in the Senate for this issue and they have addressed those concerns expressed in the House. The first concern was opening on a school day. This amendment changes the opening to Saturday and Sunday. The second concern is "shall" and this amendment has more permissive language, using "may." He pointed out there is nothing in statute regarding the opening for waterfowl; That is regulated by federal waterfowl. There is nothing in statute about deer. Last session the start of the pheasant season was set in statute, so this is written to identify the Saturday and Sunday before that.

Rep. Kroeber asked whether or not Game and Fish could do this, if they chose to, with or without this amendment. Sen. Krauter said that if they wanted to do it, they could. The reality is that it hasn't been done. Rep. Kroeber said that the idea of youth seasons is relatively new and it might be under consideration. In any event, seasons should be set by Game and Fish. Chairman Carlisle said this idea is shared by the Natural Resources Committee. Sen. Christmann noted that this version is for two years. Rep. Kempenich said appropriations members get chewed out for dabbling in policy. If something passed and needs correcting, it wouldn't be such an issue. He asked if there was an amendment offered before it was voted on and not accepted. Sen. Krauter said Rep. Hanson came with these amendments that were to be added, but it didn't happen. Chairman Carlisle said they all understood about the health insurance. He referred to the \$500,000 appropriated for the Graham's Island. He explained that when the wind comes up, the water comes over the road and cuts off the park and fishing. He gave Rep. Dennis Johnson an opportunity to describe the situation. Rep. Johnson gave the Committee two handouts generated from Doug Prchal, Parks and Recreation (See Handouts #1 & #2). He said Handout #2 outlines economic impact over the years. Handout #1 has a picture of Graham's Island. The State Park has 1300 acres and there's 5-6 sections of farm land and woods. The road is at 1450 and the Lake has risen to 1449. Building up the road will cost \$9 million, which requires \$2 million of local match. Sen. Grinberg said he understood this was a \$2.4 million project. Rep. Johnson said that's the local match. Handout #1 indicates that \$600,000 has been committed locally already. The bids will be submitted in May. Game and Fish has earmarked \$500,000 and DOT has \$200,000. They had planned to get \$500,000 through Parks and Recreation, but the money is not there. He said that if the bids come under, Game and Fish would get the first money back.

Chairman Carlisle suggested that since the Ebert's Ranch is gone, which frees up \$500,000 in Game and Fish; maybe there could be an additional appropriation for this project. Sen. Grinberg said he was perplexed with the \$9 million amount and that some time for consideration was needed. He supports keeping the Island open, but "the million dollar meter just continues to climb and climb." He thought this was a \$2.4 million project with \$800,000 to black top it. If the black top is held off for settling, there would be some wiggle room. This requires more information. Chairman Carlisle asked if Rep. Johnson could get that information readily and Rep. Johnson said he would do that.

Rep. Johnson concluded by telling the Committee that there are three state parks in the D.L. system. Two are completely flooded out, so resources are being funneled into Graham's Island. It's rated in the top four with regard to parks generating revenues for the park system.

Construction will bring this road to 1460, so this process doesn't have to be done again.

Rep. Kroeber said they've invested in a new ramp and they moved the entire campground to higher ground.

Chairman Carlisle asked Mr. Phil Mastrangelo, Wild Life Services, about the beaver problem and how his agency is going to take care of it. Mr. Mastrangelo said that managing beaver dams is a large part of their program. They've gone from 10 FTE's to 9. Chairman Carlisle asked if the decrease was from federal funding and Mr. Mastrangelo confirmed. Sen. Krauter said this ties in with the Ag. Department and how to replace those federal dollars that are projected not to be there and that's why the amendments are written as they are. If the dollars don't come through, then Game and Fish would supplant that with \$65,000 a year or \$130,000 total for the biennium. This would provide the salary for that FTE. Sen. Christmann confirmed the Senate's

position and the need for this work. Rep. Kroeber voiced concerns that the amount has come from about \$25,000 up to \$75,000 and then from \$300,000 up to \$550,000. This is an absolute mushroom. Sen. Krauter said the Senate is concerned with this also, but the only other funding source is to raise licenses and fees, which didn't seem appropriate. Rep. Kempenich said they had discussed getting people out to train landowners to control the problem. He asked Mr. Mastrangelo how much money comes in from the federal grant. Mr. Mastrangelo said the overall federal budget is over a million dollars, but not all of that is used with these cooperative funds. There are twice as many federal dollars as state dollars. Sen. Christmann said they talked about training landowners. He said that last weekend he got two of them, but it's a huge problem which he compared to snow removal on the highway. It's not that they can't figure out how to move that snow, but we need the state to come in and do it because we aren't going to quit our jobs and go out there an start moving the snow. If beaver move in, it's not like a pheasant sitting on a hay pile, easy to shoot. It may take many evenings before a person gets off a good shot. In the meantime, the beavers are clearing the area.

Chairman Carlisle said they would talk about the pheasant season. He asked them to review the materials which Rep. Johnson will provide. The last issue to consider is the Game and Fish increase to the Wildlife Services.

Chairman Carlisle opened the Conference Committee on HB 1018 concerning the budget of Game and Fish. He distributed a memo regarding the Graham's Island road, dated 4/7/05, from Mr. Dave E. Leftwich (Handout #1).

Chairman Carlisle commented that there seems to be consensus on the wildlife services. The point of contention is the amendment on the pheasant season opening. Also, the \$250,000 from the Game and Fish fund for a total of \$750,000 to help out at Graham's Island. He asked if there were anything else to consider. Sen. Grinberg added that the additional \$250,000 was money that was committed to Ebert's Ranch and Chairman Carlisle confirmed. Sen. Grinberg suggested that the Senate accept the House request for \$250,000 and the House accept the early season opening for pheasant. Rep. Kempenich said he doubted it would fly in the House. They will ask why it wasn't amended earlier even with the language that gives an option. Rep.

Kroeber said the Natural Resources Committee is a real tough committee. When they have a hearing there's usually a room full of adamant people. He questioned whether or not it could be added to an appropriation bill after the concept was killed on the floor. Chairman Carlisle said he did some checking and got the same reaction. Sen. Krauter asked the reason the House defeated this. Rep. Kempenich said he thought that even though it may have nothing to do with pheasants, there's a general feeling of resentment that prime spots are opened up early. He said there's a whole range of issues and it's volatile. Rep. Kroeber said the major issue was the Friday, because of school. The other problem is that Game and Fish should be setting seasons and zones, not the disgruntled hunter, the guide or the chamber of commerce. Sen. Krauter said that right now, the pheasant season is set by law and Game and Fish cannot issue a youth proclamation. To be true to that, the law needs to be changed. Right now it's locked in and this gives the Game and Fish the option of making the proper decision. Rep. Kroeber asked if they had the authority to take the youth season and move it to the opener and move the other opener back a week. Sen. Grinberg asked if the opposition from the House Natural Resources Committee was urban or rural. Rep. Kempenich said that's too hard to say, but they have told him to stay out of policy. Rep. Kroeber brought up the school posting land, the bill for which he carried. "I got eaten alive by the Committee because we were now into policy and we weren't into numbers like we were supposed to be." He informed the Committee that if this amendment is on it, he wouldn't carry this one. Chairman Carlisle thought there wasn't a lot of room for compromise. Sen. Grinberg said perhaps this should be given time to percolate. He said they've had the same debates on the floor of the Senate. He quoted one of the stewards from the Senate, "Well, you've got the votes, doesn't matter what you do." He also pointed out that Council has

Christmann said it's important to remember that when carrying bills out of conference committees, there needs to be some give. They have to argue why they need to spend another \$250,000 for Graham's Island; his constituents don't care about that. There's a lot more people who think that money should be spent on Lake Sakakawea, which has access problems, too.

Chairman Carlisle said that's a point well taken. He noted that there are 23 projects for \$800,000. Sen. Grinberg restated that when they were given information, there was no mention of \$9 million and when you do the math, it's for one mile. He asked what if three years from now the water goes down three feet or goes up six feet. Rep. Kroeber said the water is going to go down. It's a cycle. With regard to the Lake Sakakawea issue, the House worked hard to get the money for Game and Fish and the emergency clause, so they could get started right away. He agrees that work must be done. He said that if they don't put the \$250,000 in, he doesn't have that big a problem with it.

Chairman Carlisle said they would meet later after there has been time for further consideration.

Chairman Carlisle opened the Conference Committee on HB 1018 concerning the budget of the Game and Fish Department. He reviewed previous work. They agreed on Item #3 for \$130,000 for wildlife services. Another issue is the \$250,000 for Graham's Island. He noted there's a caveat that he asked the Dir. Dean Hildebrand, N.D. Game and Fish Department, to explain. Dir. Hildebrand said they would like to have \$350,000 back. According to the original agreement, Game and Fish would put \$500,000 into it, but if the bids came in low, they would reduce that by \$100,000. Their commitment was \$400,000 had they come in lower. By raising this to \$750,000, he wants to reduce that proportionately, so that his commitment is still not more than \$400,000. Sen. Grinberg said that Council would have to draft that to insure that Game and Fish is first in line. Rep. Kroeber said the bill reads: "It is the intent of the 59th Legislative Assembly that if bids for Graham's Island road construction project are less than the budgeted amount..." He

added, "then, by our change, it would be \$350,000 of the \$750,000 provided...must be returned to the state game and fish fund." **Chairman Carlisle** said this refers to section 8. **Sen. Grinberg** asked if the Director were comfortable with that and **Dir. Hildebrand** confirmed.

Chairman Carlisle said that Sen. Grinberg said he would go along with the \$250,000. He said the other issue is the pheasant season opening. He said he conferenced with several members of Natural Resources and there's some support for this. They understand that since this is in Code, changes can't be made without this language. He offered to carry this if the Committee adopts it. There needs to be a large enough house vote to hold the emergency clause because of the \$800,000 for the Game and Fish boat projects. Rep. Kempenich said he didn't expect much resistance on the floor. Rep. Kroeber said that members of the Natural Resources Committee were under the same impression he was that if Game and Fish wanted to make changes, they could do it. Because the date is set in Code, they can't. Once this was confirmed, they agreed to support it or not start a big debate on it. Chairman Carlisle said there's a sunset clause on it, too.

**Rep. Kempenich** moved the House accede to the Senate amendments and further amend to add the \$250,000 and the language the Commissioner needs to recoup the \$350,000; seconded by **Senator Krauter.** 

Chairman Carlisle asked for discussion. He said he would carry the bill.

**Dir. Hildebrand** asked about the sunset clause. He wanted confirmation that the Committee is asking his Department to try this for two years. **Sen. Krauter** said this says the Governor may by proclamation do this. This provides the flexibility. **Dir. Hildebrand** said there is a consensus here that Game and Fish will have this program for two years and then reconsider.

Rep. Kroeber said the key to this is that it is definitely restricted to a certain age group, so that it doesn't become a total new pheasant opener. Dir. Hildebrand noted that parents can't carry a gun when they take a child out to hunt. He said waterfowl season opens that same day, too.

Chairman Carlisle called for a roll call vote. Motion passed 6-0-0.

Hearing adjourned.

[Note: Ms. Stephanie Johnson, Legislative Council, said the motion needed to be rephrased to properly state the intent. It should say: "Senate recedes from it's amendments and further amend..." She told the clerk to read the language at the top of the amendment for confirmation.]



- This amendment adds \$750,000 of special funds spending authority to the grants line item for the Game and Fish Department to provide a grant toward the construction costs of the Grahams Island road. This amendment also adds a section of legislative intent that if the bids for the road construction project are less than the amount budgeted, then \$350,000 of the \$750,000 must be returned to the game and fish fund. The Senate version added \$500,000 to the grants line for the Grahams Island road, with legislative intent that \$100,000 of the \$500,000 be returned to the game and fish fund if bids were less than budgeted.
- This amendment adds \$130,000 from the game and fish fund for wildlife services, for a total of \$680,000 available to provide to the Agriculture Commissioner to pay for services provided by the United States Department of Agriculture Wildlife Services Agency to alleviate wildlife depredation and damage in North Dakota, the same as the Senate version.

This amendment also amends North Dakota Century Code Section 20.1-04-15 relating to the opening of pheasant hunting season for youth and provides an expiration date, the same as the Senate version.

Engrossed HB 1018 was placed on the Seventh order of business on the calendar.

### HB 1018 Variance/Enhancement Information

Salaries – This is increased by \$1,496,565. This includes \$412,000 for five new positions, \$618,000 for salary increases and \$103,654 for benefit increases.

Operating Expenses – Increased by \$245,000 that includes \$88,000 for IT-Telephone costs, \$26,000 for utilities, and \$116,000 for IT-Contractual Services. The Department is using 1-800 telephone systems for hunter registration and is incurring higher costs for this. We are also incurring programming and software costs to go along with our expanding programs.

Capital Assets – Increased by \$701,172. This includes \$453,000 for boating access work and \$300,000 for land acquisition.

Grants – This line has an increase of \$1,812,072. \$1,000,000 is for the new State Wildlife Grant Program that deals with nongame wildlife species. Funds are being passed on to other agencies and organizations for this work. The remainder is to fund the work the Department wants to do to provide fishing and boating access on Devils Lake, Lake Sakakawea and other waters.

Private Land Habitat and Deer Depredation – Increased by \$50,000 for inflation increases.

Noxious Weed Control – Increased by \$50,000 to offset higher weed control costs, mainly along Lake Sakakawea and Lake Oahe.

Grants, Gifts and Donations – This is increased by \$550,000. A major portion of this is to allow the Department to spend a large bequest(\$400,000+) for the work that the donor wants. This is to provide funds for fishing programs dealing with youth and partial funding for a replacement survey aircraft for our wildlife division. We are also anticipating some additional donations.

Lonetree Reservoir – increased by \$193,507 to match the level of 100% federal funding that will be provided by the Bureau of Reclamation for operation of the Lonetree Wildlife Management Area near Harvey.



## Items of Special Interest

Brief details on the budgets for the Department's five divisions are presented below.

- 1. Administrative Services Division Budget Costs in this Division include the following:
  - \*Secretarial support for all Divisions
  - \*Licensing section costs including lotteries
  - \*Accounting costs
  - \*Information Tech. Division Data Processing \$520,000
  - \*All Department utility, telephone, office rental, janitorial, office supply, insurance, postage, air craft costs, office machine rental, and other similar costs.
  - \*Legal services from Attorney General's office
  - \*Costs for the Game and Fish Advisory Board
  - \*In Lieu of Tax payments for all Department lands-\$900,000
  - \*North Dakota Risk Management fund \$32,000
  - \*Costs for the Director, Deputy Director, Administrative Services Division Chief, Data Processing Coordinators and Planner.
    - \*Capital improvement funds for office and shop facilities-\$416,116 for regular maintenance statewide.
    - \*The Department Donation account-\$700,000
    - \*Statewide Cost Allocation payment to OMB -\$250,000
    - \*Storage building construction at the Bismarck shop facility \$400,000 in the Capital Assets line.
  - \*Boating Safety Program grants to Counties \$100,000
  - \*Cooperative Grants Garrison Diversion, + others \$318,963

The Administrative Services Division budget is increased 10.6% from 2003-2005. Inflationary increases are included in the operating expense line for postage, telephone and IT-Software/Supplies.

2. Fisheries Division Budget - This program includes fish production and distribution, fishery research and surveys, and fishing area and boating facility development and maintenance and a Save Our Lakes program. This division budget is increased by 2.9%. The increases are in the capital assets and grant lines. Grants are used for cost sharing with local governments on fishing and boating facilities and to pay the department's share of costs for the Garrison Dam National Fish Hatchery. Grants are also used for creel survey and other fisheries management work. \$122,000

is included for boating facilities at state parks. Capital improvements are used for fishing and boating facilities on Department managed lands. High and low water conditions at Devils Lake and Lake Sakakawea have been major challenges for the boating access program. The Department receives 75% federal funding for most of the work in this division. In some cases the 25% match comes from local partners such as park boards.

#### SAVE OUR LAKES PROGRAM

During the 2003 - 2005 biennium the Save Our Lakes Project worked a total of 38 projects on 20 lakes. These projects included sediment dams, shoreline enhancements and building of earthen piers, establishment of buffer zones, building of rock weirs, building of wetlands, waste management systems, active hypolimnetic pumping systems, passive low water draw downs, fencing projects, alternate water sources (well), planting of trees and grasses in riparian areas, sediment removal, purchase of equipment for cooperating agencies, gravel spawning substrates, establishment of wave breaks and underwater boulder habitats. Similar work is planned for the 2005-2007 biennium.

\$600,000 is budgeted as regular line items for work on public lands. Much of the land where lakes and reservoirs are is publicly owned. \$400,000 is budgeted in the private lands line item. Dollars from this line item can be spent only on private land. A significant portion of our watershed work will be on private land.

- 3. Enforcement Division This budget supports a staff of thirty-five law enforcement employees. This program is increased by 5%. Most of this increase is related to salary adjustments and a \$44,000 increase in travel. The budget includes operating expenses mainly for State Fleet and travel costs. Game wardens are very dependent on vehicles to do their work. Replacement boats, snowmobiles and all-terrain vehicles are budgeted in capital assets.
- 4. Conservation and Communication Division Programs include aquatic and hunter education, nongame wildlife program, ND Outdoors magazine, ND Outdoors weekly television program, boating education, web page management, environmental review and supplying general information to the public. This Division's budget request is a 35.7% increase from 2003-2005. The increase is mainly in the grant line item to continue funding of the State Wildlife Grant program. This recent new federal program provides funds for monitoring and managing wildlife species that traditionally are not hunted. The major focus is on birds. \$600,000 is included for shooting range projects throughout the state. Federal funding is passed on to local groups that provide shooting facilities for public use and for hunter education.

Printing costs have increased and are needed for the ND Outdoors magazine and other publications. Funds are needed to replace and enhance computer systems and video production equipment. Grants are increased to provide funding for local shooting range projects.

Natural resource related reviews and recommendations are provided to private and government entities. This division also includes the nongame wildlife program. It is supported by an income tax check off and federal matching funds.

5. Wildlife Division - This budget includes private land habitat and deer depredation programs, operating costs for Department managed lands, and wildlife surveys and investigations. This Division's budget it increased by about 5.9% from 03-05. The Private Land and Depredation Program is increased by \$50,871 to enhance the regular habitat and access programs that we increased significantly in 2003. Salaries are increased to support current staff. \$550,000 is included to support Wildlife Service's animal damage control work. \$350,000 is requested for noxious weed control on Department lands. \$150,000 is included in grants to reimburse the State Veterinarian for game and fish related work.

Lonetree Funding - A \$1,531,060 appropriation(+\$193,507) is requested to operate the Lonetree area. The Lonetree area consists of over 30,000 acres of land managed for wildlife purposes. The North Dakota Game and Fish Department provides technical services for this area for the State of North Dakota as laid out in the Garrison Diversion Reformulation Act. 100% of the funding for these services comes from the Bureau of Reclamation. This is the amount of funding anticipated for 2005-2007.

#### Department Appropriation Increase (9.2% or +\$4,067,403)

The Game and Fish Department's budget request is a 9.2% increase over 2003-2005. Department funds and anticipated revenue are adequate to support this increase. Some key items follow:

## FTE Request Details

Five new full-time positions are included in this budget request.

Nongame Wildlife Program Staff(2 FTE's) - Two biologist positions are requested to organize and run a program for managing the state nongame wildlife program. A recent federal program makes approximately \$1.6 million available for work related to wildlife species that are not traditionally hunted. This staff will work with contractors to gather data and determine the status of species populations and what management work should be done. These two staff persons were funded with temporary salary dollars for the 2003-2005 biennium. The federal funding seems to be solid and there is plenty of work to be done. It is time to make these positions regular FTE's.

Fisheries Biologist I(1 FTE) - Fisheries work and funding have increased tremendously in recent years. The number of lakes managed has increased significantly and so has the work related to managing the fisheries at these lakes. Fortunately there has been a significant increase in federal funding from fishing tackle and boat gas taxes. This funding will pay for 75% of the costs for this position. We need to work on water quality, angler access and fish population management to keep the excellent fisheries that we have. This person will work, initially, as a fisheries technician in the south central North Dakota fisheries district.

License Clerk(1 FTE) - The Department's licensing volume continues to increase and a new point of sale web licensing system is ready to install for local license agents. Currently license agents around the state issue paper licenses from license books that are distributed via the county auditors. The sold and unsold license books are returned at the end of the year. There is major accounting work related to this process. The new internet licensing system removes the need for most of the paper license books and makes licensing information readily available. It also helps customers who lose licenses. All they have to do to get another copy is to go online and print another copy. The online licensing system for license agents collects data, tracks sales and accounts for money that is to be remitted to the Department for license sales. It is anticipated that larger license agents will be the first to start to use this new system.


Use will gradually increase as agents become more comfortable with it and as high speed internet access becomes more common.

The addition of an FTE to assist in licensing work, especially web sales is key to the success of this system. The Department will have to provide training and telephone support for the license agents. Additional staff is needed to handle this work load.

Wildlife Technician (1 FTE) - A technician position is requested for the Department's Wildlife Division. This work has been done for a number years by a temporary employee. There has been steady turnover in this job and it is hoped that making it a regular position will provide some stability for the position. This employee will work with biologists on a variety of tasks. These will include assisting migratory gamebird biologists, chronic wasting disease deer head collections, big game check stations, data entry, salt cedar surveys, process upland bird wings, process harvest questionnaires, conduct population surveys, assist on banding projects, and assist on study reports. Federal Aid in Wildlife Restoration funding is available to fund 75% of this position.

## **GENERAL GAME LICENSE SALES**







The Fisheries Division planning objectives are listed below. These are reviewed periodically and compared to actual values based upon questionnaire results.

Fishing regulations are provided for over 170,000 anglers annually. These anglers spend over \$250,000,000 annually for angling and fishing related activities. State fishing waters are stocked with 5 million northern pike, 12 million walleye, 1 million largemouth bass, 850,000 trout and salmon with supplemental stocking of crappie, bluegill, perch, smallmouth bass, channel catfish, fathead minnow, and hybrid muskie. Trap and transport(fish relocation) is provided where beneficial. Over 56,000 adult fish are moved from overpopulated lakes. Fish removal is performed across the state. Over 80 tons of undesirable fish are removed from state lakes each biennium in order to provide better conditions for the more desirable fish species. Fisheries management work is done for over 300 lakes. Coordination with state, federal, and local entities is required to accomplish the goals. This program provides improved boating access statewide through cost share grants to political subdivisions and directly contracted projects. Enhancements or new developments are provided on 30-40% of the lakes annually. This portion of the program provides facilities for our 50,000+ registered boat owners and facilities for over 170,000 anglers.

Private Lands Special Line - Renovate prioritized lakes statewide to provide sustainable quality fisheries. Salary funds are included for the Enforcement Division's 32 regular employees plus seasonal temporary workers. One additional game warden is requested to handle additional hunter, angler and boater traffic.

OPERATING EXPENSES - Travel is the major expense category for this budget. District game wardens essentially live in their vehicles. They are especially active during fishing and hunting season openers. They respond to law violation complaints throughout the year. Professional Supplies and Materials includes depth finders, binoculars, lights, firearms, cameras, alert machines, boating related items, and numerous items costing less than \$750. Clothing includes uniforms and other job related clothing.

Capital Assets - Equipment over \$5,000- An equipment replacement schedule has been established. This provides an organized, efficient way to schedule replacement of boats, motors, computers, all-terrain vehicles and other items. The amount budgeted here is required to provide reasonable quality equipment for the Enforcement Division.

SALARIES - Salary dollars are requested to meet pay plan projections for the biennium. Temporary salaries are for the state fair, hunter education and for special projects. There are two full-time temporary workers handling the State Wildlife Grant work with nongame species. They are developing a plan for the management of nongame species in North Dakota. They have been on staff as temporary workers for about three years. It is time to convert these employees to regular FTE positions. The federal funding program provides 75% reimbursement for their work. It is a regular program now that is here to stay.

#### PROGRAM STATISTICAL DATA

Over 150,000 user days are spent hunting big game, resulting in annual expenditures of over \$6 million. About 80,000 deer hunters will harvest over 100,000 deer. About 130 moose permits, 200 elk permits and 4 bighorn permits will be issued annually. The pronghorn season involves about 1,600 permits. In 2003 nearly 60,000 waterfowl hunters spent 422,000 days and over \$13 million harvesting 300,000 ducks and about 200,000 geese. About 80,000 upland bird hunters will spend over \$6.5 million and over 360,000 days harvesting an estimated 80,000 gray partridge, 150,000 sharp-tailed grouse and about 500,000 pheasants each year. In an average year fur sales total about \$4 million, but prices are low and this number is expected to continue to decline. Full and aggressive implementation of the private land initiatives will help maintain or increase recreational opportunities. About 1,315,000 days are spent hunting each year, generating direct expenditures of \$27.9 million annually.

This program includes habitat development, management and enhancement of state-owned or leased Wildlife Management Areas totaling 220,000 acres. The land is managed for optimum wildlife production, particularly for game species, and provides high quality habitat for game and nongame species. The program includes staff who conduct wildlife surveys and make recommendations for hunting seasons and conduct research to determine management methods to improve recreational opportunities. Staff make contacts with landowners, conducting an evaluation of each farm or area as requested by the landowners for suitability as wildlife habitat. Technical assistance or financial agreement terms are negotiated and established. Short-term agreements are developed that provide annual compensation or one-time payments for use of private land to produce wildlife. The deer depredation fund is used to construct "deer-proof" hay yards and feed deer that are causing depredation problems on private lands.

#### **EXPLANATION OF PROGRAM COSTS**

SALARIES - Includes salaries for regular staff and for seasonal temporary workers. A wildlife technician position is requested to assist wildlife biologists on field work and data analysis. This is more cost effective than hiring another biologist.

#### **OPERATING EXPENSES**

Travel - State Fleet and travel related expenses are the largest operating expense item for this division. Staff does many wildlife population surveys from motor vehicles. They also travel to and work on department lands throughout the state.

Lease/Rental-Equipment - Consists mainly of rental costs/hiring of aircraft for aerial wildlife surveys. Some construction equipment is also rented.

Dues & Prof. Development - To provide staff training in supervision, performance appraisals, fire management, safety, computer use and other items.

Operating Fees and Services - Freight, research and special contract fees such as payment for bird production.

Professional Services - Veterinary services, laboratory services and misc. professional services.

Printing - Costs for division related publications including information materials for the public and special professional publications.

Buildings/Vehicle Maintenance Supplies - Trees, gravel, lumber, seed, feed and other supplies. Equipment repair parts, paint, fuel and oil.

Miscellaneous Supplies - Fencing materials and expendable tools.

Equipment under \$5,000 - Mainly replacement computes, mower, farm equipment and misc. items.

Capital Assets - Equipment over \$5,000 - Replacement farm equipment, snowmobiles, trailers, mowers and other items.

Land acquisition - For the purchase of the remaining land value for lands enrolled in the Emergency Watershed Protection program along the Red River. This will provide areas for public access along the Red River. Also one or two small forest tracts may be purchased.

GRANTS - For work with wildlife groups and other organizations on cooperative projects. Also wildlife research at universities. These include chronic wasting disease work, North American Wetland Conservation Act waterfowl habitat projects, salt cedar census work, plus others as needs arise. This budget also includes \$150,000 for State

Veterinarian costs related to work on wildlife species including the handling of propagation permits.

PRIVATE LAND HABITAT AND ACCESS IMPROVEMENT PROGRAM - This program is funded with interest earned on game and fish funds and from habitat stamp sales. Funds are used to cost share with landowners on trees, food and other wildlife plantings. Wildlife habitat plots are leased, big game and furbearer depredation programs are funded, and water quality work is done. Hunting access agreements are made with private land owners. Total acres in this program currently is 540,000 and this is expected to increase to 750,000 by 2007.

NOXIOUS WEED CONTROL - Funding is requested for control of noxious weeds on department managed lands in compliance with state law. An increase of \$50,000 is requested to handle anticipated higher weed control costs around Lake Oahe and Lake Sakakawea.

LONETREE SPECIAL LINE ITEM - The Lonetree line item is 100% federally funded. The U.S. Congress, through the Garrison Diversion Reformulation Act, established that the State of North Dakota should manage the Lonetree area for wildlife purposes. The Department receives funding for management of the area from the Bureau of Reclamation. This funding is for operations, maintenance and development on this 33,000 acre area. Five regular staff positions are funded from this line item. The budget request is increased by \$162,447 because federal payments, by formula, will be higher next biennium.

WILDLIFE SERVICES - \$550,000 is provided for the state share of the Wildlife Services animal damage control work through the ND Department of Agriculture.

#### PROGRAM GOALS AND OBJECTIVES

This program includes Department responsibilities for the management of wildlife in North Dakota. The manipulation and distribution of wildlife and their habitat on Wildlife Management Areas(220,000 acres) are accomplished to maintain acceptable populations of these species to provide optimal recreational opportunities for both consumptive and nonconsumptive users. There are about 100,000 hunters in North Dakota. This program includes the Private Lands Initiative. It is designed to improve wildlife habitat and foster better working relationships between the agricultural and wildlife communities. The goal is to have 750,000 acres of public hunting access on private land by 2007.


Re: Game and Fish Department Funding

The executive recommendation for the Game and Fish Department for the 2005-07 biennium is \$48.5 million, which consists of \$18.2 million (or 38 percent) federal funds and \$30.3 million (or 62 percent) special funds.

Federal funds come primarily from the Department of the Interior for managing state wildlife and fisheries resources or for managing lands owned by the Bureau of Reclamation.

Special funds are primarily derived from sport fishing and hunting license fees. The majority of these fees are deposited in the Game and Fish Department operating fund. A copy of the analysis of this fund for the 2003-05 and 2005-07 bienniums is attached.



The Game and Fish Department is a special fund agency using only hunting, fishing, and boat license revenue and federal funding. The total budget request is \$49,195,054. This is an increase of about \$4 million from the 2003-2005 appropriation. Department accounts will support this level of funding. This request includes the following amounts:

Printing costs have increased and are needed for the ND Outdoors magazine and other publications. Funds are needed to replace and enhance computer systems and video production equipment. Grants are increased to provide funding for local shooting range projects.

Natural resource related reviews and recommendations are provided to private and government entities. This division also includes the nongame wildlife program. It is supported by an income tax check off and federal matching funds.

5. Wildlife Division - This budget includes private land habitat and deer depredation programs, operating costs for Department managed lands, and wildlife surveys and investigations. This Division's budget it increased by about 5.9% from 03-05. The Private Land and Depredation Program is increased by \$50,871 to enhance the regular habitat and access programs that we increased significantly in 2003. Salaries are increased to support current staff. \$550,000 is included to support Wildlife Service's animal damage control work. \$350,000 is requested for noxious weed control on Department lands. \$150,000 is included in grants to reimburse the State Veterinarian for game and fish related work.

Lonetree Funding - A \$1,531,060 appropriation(+\$193,507) is requested to operate the Lonetree area. The Lonetree area consists of over 30,000 acres of land managed for wildlife purposes. The North Dakota Game and Fish Department provides technical services for this area for the State of North Dakota as laid out in the Garrison Diversion Reformulation Act. 100% of the funding for these services comes from the Bureau of Reclamation. This is the amount of funding anticipated for 2005-2007.

#### Department Appropriation Increase (9.2% or +\$4,797,291)

The Game and Fish Department's budget request is a 10.8% increase over 2003-2005. Department funds and anticipated revenue are adequate to support this increase. Some key items follow:

#### FTE Request Details

Five new full-time positions are included in this budget request.

Nongame Wildlife Program Staff(2 FTE's) - Two biologist positions are requested to organize and run a program for managing the state nongame wildlife program. A recent federal program makes approximately \$1.6 million available for work related to wildlife species that are not traditionally hunted. This staff will work with contractors to gather data and determine the status of species populations and what management work should be done. These two staff persons were funded with temporary salary dollars for the 2003-2005 biennium. The federal funding seems to be solid and there is plenty of work to be done. It is time to make these positions regular FTE's.

Fisheries Biologist I(1 FTE) - Fisheries work and funding have increased tremendously in recent years. The number of lakes managed has increased significantly and so has the work related to managing the fisheries at these lakes. Fortunately there has been a significant increase in federal funding from fishing tackle and boat gas taxes. This funding will pay for 75% of the costs for this position. We need to work on water quality, angler access and fish population management to keep the excellent fisheries that we have. This person will work, initially, as a fisheries technician in the south central North Dakota fisheries district.

License Clerk(1 FTE) - The Department's licensing volume continues to increase and a new point of sale web licensing system is ready to install for local license agents. Currently license agents around the state issue paper licenses from license books that are distributed via the county auditors. The sold and unsold license books are returned at the end of the year. There



Topic: Possible Additional Budget Items Related to HB 1018

House Bill 1189 appropriates \$1,000,000 for a local match Private Land Access Improvement Program.

Senate Bill 2145 appropriates \$424,720 for the Ebert Ranch purchase.

HB 1423 deals with signing to identify state school lands. It does not appropriate funds to do so. The ND Game and Fish Department could be taped for this cost which could be \$700,000 to \$1,200,000. The Department shows state school lands on the plots guide maps that are distributed to the public. We do not recommend spending this large amount of money to put signs on these areas.

Sweetbriar Dam Repair - \$50,000 in Grants and \$200,000 in Capital Improvements.

Graham's Island road improvement at Devils Lake to access this state part - \$500,000 in Grants.

Devils Lake carp control dam construction - \$100,000 in Grants.

A location map is enclosed providing an enlarged aerial that better portrays the road alignment than the maps in the report.

Finally, I included a visitation work sheet noting history of visitation to Graham's Island from 1995 to the 2004 season.

#### Senator Traynor:

The notes below include an overview of Graham's Island State Park facility values and investments by FEMA and the state since 1995. The report previously provided to you presents a overall economic picture of all activities on the Island. These documents are intended to support the additional road raise to Graham's Island.

Current value of Grahams Island State Park

Land value - \$1,609,772 - Costs are 1985 and prior basis

Facility Development - \$4,087,755

Total Land and Facility value - \$5,697,527

FEMA and State/C-District expenditures for flood recovery FEMA expenditures - 1995 forward \$1,523,306 Department/C-District expenditures - 423,823 Total Flood Recovery Expense - \$1,947,129

Additionally, a data sheet is attached on 2003 Grahams Island State Park Economic Impact along with additional visitation data for this season's trends to date. A summary of the past three years visitation to the park provides that historic use record for comparison. As you know our intent is to provide current data to support the access road to Graham's Island on the Federal Highway priority road list.

Following Memorial Day I traveled to the park with the Field Manager to assess current conditions. The lake elevation, as you know, is only 1.5' below the top of the access road. A recent 6" rainfall in the basin did not help matters but this elevation places the park and park users in peril. Park staff informed me they have plowed debris off the road numerous times through the season following high winds. The reason for the visit was to establish criteria for visitor awareness, visitor safety and probable closure conditions along with staff evacuation. We hope it does not come to the latter two.

The visit was very revealing and the essence of note. On a Wednesday morning we found a vibrant, active park in the middle of the week. The boat ramp parking area was full at 10:30, roughly 40 trailers parked and the campground at 1/3 occupancy. Visitors were from Minnesota, Wisconsin, Iowa, Illinois, Florida and also North Dakota. The fish cleaning station was busy during the entire 4 hour stay. As day use fisherman were leaving others were entering. It was a steady stream of activity. You and I know this activity is directly related to the quality fishery and public interest in that outdoor recreation pursuit. That trend has continued throughout the summer noted by attached data.

Graham's Island is a key contributor to the tourism economy of the region, state and of course to the viability of the entire state park system. The data included in the attached documents attests to that.

The economic data provided will indicate that we can demonstrate a cost benefit to support the project.

This 2004 data trend would indicate significant increases in the economic data presented for 2003 season. Shelvers Grove, the campground east of Devils Lake, on Highway 2 was closed this spring due to rising water taking it out of service. Graham's Island remains as one of the major recreation resources to the region as well as the state. This status is in jeopardy with the projected lake elevation predictions. Safety of visitors is currently at issue with only 1.5' freeboard. Staff have had to plow the debris from the road on two occasions already this spring after high winds moved material on the road.

This information is presented to provide background toward support to raise the access road to Graham's Island State park. We are aware that Federal Highways has removed that road from funding eligibility but believe the above data support adding this road on eligible listings. If we don't work collectively toward maintaining access to this tourism destination the impact will not only be felt in Devils Lake but reach across the agency and across the state of North Dakota. Roughly 35% of the visitors are from out of state with Minnesota comprising 1/3 of that out of state total.

# **Executive Summary**

The total estimated benefits of Graham's Island and the Graham's Island State Park may be in excess of \$70 million not including the sunk costs of the flood mitigation and previous road improvements. A conservative estimate of total assets is almost \$8 million and the total income streams are estimated to be \$64.8 million if 20 percent of the anglers were displaced from the Devils Lake Region. This compares to the \$8.9 million cost estimated to raise the Graham's Island roadway. Therefore, it is vitally important for the Federal Highway Administration to add the Graham's Island road to its critical road list so the roadway grade can be raised with ER funds before it is completely inundated and Graham's Island becomes isolated.

# **Background**

The 2004 trend at Graham's Island State Park indicates an increase in visitors when compared to the 2003 season. Shelvers Grove, a campground east of Devils Lake on Highway 2 was closed this spring due to rising water. Graham's Island remains as one of the major recreation resources to the region and the state. Access to Graham's Island is in jeopardy with the projected increased lake elevations. Safety of visitors using the roadway is currently at issue with only 1.5 feet of freeboard. Debris has been plowed from the road on two occasions this spring after high waves deposited material on the road.

- Attachments A is an aerial photo of the Graham's Island area showing the location of the Grahams's Island road and the boat ramp located on the island.
- Attachment B is a map showing the location of the island in proximity to the Devils Lake area.

This information is presented to provide background information to support raising the elevation of Graham's Island road connecting State Highway 19 to Graham's Island and Graham's Island State Park. Devils Lake is one of the prominent fisheries in the region and limiting this tourism destination will impact not only Devils Lake but reach across the region and the state of North Dakota. Roughly 35 percent of the visitors are from out of state with Minnesota comprising over 30 percent of the out of state total.

It is difficult to determine the value of allowing access to continue to Graham's Island located in Devils Lake. Visitation to the Graham's Island State Park is shown to be growing. The island contains a sheltered boat ramp with limited wave action that is the premier boat ramp for providing a central location for access to Devils Lake. The boat ramp area also provides access for ice fishing during the winter months. There is also a 100 unit campground on the island, which is the largest campground in the Devils Lake area. Other facilities include a bait shop, cabins, and the Siebert Thompson Activity Center which are used year round. During the winter months skiing and snowmobiling trails are used extensively. The island is also used by birdwatchers throughout the year and turkey and deer hunters inhabit the island in the spring and the fall.

Several factors need to be included to arrive at the actual costs associated with abandoning Graham's Island. There are farming acres, pasture land, farmsteads with houses, other residences, and the value of the park assets. The income streams include the rent from farming and ranching, the park and camping fees, the bait shop and if the highway becomes impassable because of water issues some or all of these assets along with the income streams may be lost. This analysis will provide estimates of the economic benefits of Graham's Island to the Region and the State.

# Fishing Expenditures

Bangsund & Leistritz from North Dakota State University have gathered information to determine the expenditures of resident and non-resident hunters and anglers. Their extensive work is used to evaluate trends and economic effects associated with hunting and fishing in the state. Through survey, Bangsund and Leistritz estimated the seasonal and daily expenditures for hunting and fishing for residents and non-residents. The average resident angler spent some \$2,597 per year, while the non-resident spent an average of \$884. The average daily variable and

fixed expenses were found to be \$43.23 and \$177 respectively for residents. The average daily expenses for non-resident anglers were estimated to be \$136.47 each for variable expenses and \$42.20 each for fixed expenses. These numbers are much higher than the AAA projections for a vacationing family's average daily expenses. AAA estimates daily expenses to be \$41 per person.

It could be argued that if access to Graham's Island was limited or denied, fisherman would find alternative access. However, congestion and other issues may cause anglers to pursue other fisheries if there is uncertainty or long waits in accessing boat ramps and other facilities. The expenditures for displaced anglers would be lost at least to the Devils Lake region and possibly the state as it is estimated that 35 percent of the anglers are non-residents of North Dakota.

This analysis draws on Bangsund and Leistritz work in estimating the daily and annual expenditures of anglers. The method used to estimate the net present value of the use of Graham's Island is to estimate the income stream for anglers using the Island and estimating the number that would be displaced without the resource. Table 1 shows the estimated income stream for anglers over a 20 year period. Bangsund and Leistritz (2002), showed a growth rate of 1.14 percent increase in annual fishing expense for anglers in 2002 dollars.

The Net Present Value (NPV) formula is used to estimate total net present values of an income stream or expense by using a discount rate and a series of future benefits. In this case anglers or

visitors' expenditures. The NPV investment begins one year before the date of the first value cash flow. The NPV calculation is based on future cash flows. The NPV formula can be expressed in:

$$NPV = \sum_{i=1}^{n} \frac{Visitors' \text{ Expenditures}_{i}}{(1 + \text{rate})^{i}}$$

Using the income stream from Table 1 and the NPV formula based on a 20 percent displacement factor the NPV is estimated to be \$42.6 million. The costs to the region increase dramatically as the number of anglers are displaced (Table 2). It is difficult to estimate the number that would be displaced. For the purposes of this analysis it could be assumed that 20 percent of the anglers would be displaced as there are limited boat ramps and camping facilities available in the area.

# **Farming**

There is also farm and ranch land on the Graham's Island. If access to the island was cut off there would be no way to transport the inputs to the island or the commodities raised from the island. In evaluating the economic impact again the NPV is used. First an income stream is estimated and then the NPV is used to calculate the economic impact. It could be estimated that land rents, or income would be conservatively \$20 per acre for farm land and \$10 per acre for pasture land. Using these assumptions and an inflation factor of 3 percent an income stream can be derived. The average income for the land would be \$15 per acre for the first year and reflect the inflation rate of 3 percent thereafter. The NPV for the farmland for a 20 year income stream is estimated to be \$897,644.

# **Assets**

Property losses will also be incurred if access is eliminated to the island. Park assets include land and net improvements that would be abandoned. Table 3 shows these assets and their values along with the improvements.

FEMA has also invested in Graham's Island State Park by providing funding for flood recovery and mitigation. This includes moving facilities and other mitigation efforts. These improvements are listed in Table 4. Table 4 also shows that the Graham's Island road has been the recipient of ER funding in the past. In 1995, \$3.1 million was expended on the route and in 1999 approximately \$595,000 was expended.

The above estimates provide a picture of the value of assets on the island. The total estimated value of the fixed assets are estimated to be \$7,975,527 and when the sunk costs of flood mitigation and recovery along with previous road investment, the estimated value is \$13,693,656. Not included in the estimate are a bait shop and two cabins.

### Construction

In addition to the possibility that the Devils Lake region may lose fishermen and assets because of lost access to Graham's Island there is also the benefit that construction brings to the area. Similar to Bangsund and Leistritz's work the North Dakota Input-Output Model is a tool for describing the economic linkages and interrelationships of North Dakota's economy. The model can be used to estimate the impacts of various types of project developments in the State. In this case, the model provides a good basis of economic analysis in the construction of a road to Graham's Island. The Input-Output Model uses interdependence coefficients of 17 statewide sectors based on technical coefficients for the construction sector in North Dakota. The coefficients are an estimation of each sectors gross income from one dollar of construction in the state. The number for the Gross Receipts Multiplier for the construction industry is 2.44 which implies that for every dollar spent, it turns over, or is spent, 2.44 times within the state's economy.

The impact of the construction of the Graham's Island road would provide economic activity to the area. The estimated cost for the road construction is \$8.9 million. Using the multiplier provided by the I/O model, the economic benefits to the region because of the construction are estimated to be \$21.36 million.

### Conclusion


The benefits of accessing Graham's Island and Graham's Island State Park located in Devils Lake are estimated to be very beneficial to the local economy. Visitation to Graham's Island State Park is shown to be growing. The island has a protected boat ramp providing access to the western part of the lake, a 100 unit campground, a bait shop, cabins, ski and snowmobile trails, an activity center, and hunting opportunities. Other assets included on the island are farm land, pasture land, farmsteads with houses, other residences, and the value of the park assets. Using Bangsund and Leistritz estimated angler expenditures to estimate the impacts to the region provides insight into the value of the fishing resource of Devils Lake. Income streams include the rent from farming and ranching, the park and camping fees, the bait shop and if the highway becomes impassable because of water issues some or all of these assets along with the income streams may be lost. Table 6 provides a summary of the costs and benefits of Graham's Island and Graham's Island State Park to the Devils Lake region and the state of North Dakota.





Lake Sakakawea, 1995-2004





# Estimated Smelt Biomass and Coldwater Habitat Lake Sakakawea, 1999-2004





ANS prevention takes only a few minutes. It is simpler and more effective to prevent ANS than to control an infestation once it is established. Clean your equipment after each use, and again, before your next, outing. LOSE THE HITCHHIKERS or LOSE THE LAKE... it's YOUR CHOICE!

These exotic fish species outcompete native fish and desirable fish populations, by eating plants or food items needed by game fish. A waterbody's recreational fishery quickly deteriorates once exotics are introduced. Waterbodies infested with ANS provide little enjoyment.

To prevent infestations, use only "clean" bait, do not dump your bait bucket, and do not stock fish into any waterbody. Anglers often illegally stock fish in hopes of bettering a lake's fishery, but this causes more problems than improvements.

Both of these plant species grow under the water's surface and form thick mats. The dense vegetation is too much cover, which leads to stunted fish. When the plants die off in the fall; decomposition causes lower dissolved oxygen levels in the water.

Plants can be spread by individual seeds or seed pods hidden in the mud, as fragments entangled on trailers, boat propellers or other equipment. A single plant fragment can create a new population in a new location.


### PURPLE LOOSESTRIFE SALTCEDAR

These aggressive plants grow along the shorelines or in shallow water. The plants form thick stands and native plants are crowded out. The habitat modification creates problems for fisheries and wildlife populations.

The plants produce thousands of small seeds that drift on the water and lay on the lake shore. Seeds can be moved in the mud, on equipment, or from being picked up by people or pets. Vegetative material lodged on a boat or trailer can be moved to a new area and start a new infestation.

#### INVERTEBRATES of CONCERN







SPINY WATER FLEA

These invertebrates outcompete desirable zooplankton for food and living space. They eat food items used by desirable fish. This can reduce game fish populations. They reproduce in large numbers and can quickly take over a waterbody.

These invertebrates hitchhike on equipment, on boats and trailers, on motors, in livewells or in bilge water. If kept damp, they can live for a long time. When released into a waterbody, they can produce new infestations.

# The guidelines or cleaning equipment are simple:

- Remove plant fragments from your boat or other watercraft, the trailer, and fishing, hunting or scuba gear when leaving the waterbody.
- Drain water from the boat motor, livewell, bilge, and behind the transom before leaving the waterbody.
- Power wash your boat and trailer.
- Clean and disinfect all fishing tackle, hunting or scuba gear or other equipment after an outing.
- Disinfect the boat, livewell, bilge and sporting equipment by:
- Power washing using water that is 110° or hotter; or rinse with a bleach solution (one part chlorine bleach to 20 parts warm water).
- Do not release bait or bait water into a lake, or move fish from one lake to another.
- Place excess bait in a fish grinder, appropriate garbage receptacle, or bury it at home.
- Only release fish into the waterbody from which they came.
- Do not transplant fish to other waterbodies.
