

Minutes: HB 1128 Appointment of a county veterans' service officer. 13 present, 1 absent.

**Bob Hanson, Commissioner-For-Testimony Attached-Language in the law that just allowed counties to have a County Service Officer, but didn't require them, that is one of the major changes and the counties that have smaller numbers of veterans, asking counties be allowed to have Service Officer for more than one county, so they can start consolidating. Make them more affective in the areas they are not full time. What they generate in dollars for veterans, because all of these dollars that you see their that go back to veterans by counties are generally the result of work of the county Service Officers in our department. Better training and closer training with our group and their group to insure the veterans can receive the kind of service they deserve.**

**Rep. Grande:** Could this not be accomplished under tool chest law.

**Bob:** Yes it can, in fact we have a service officer here who has another county.

**Rep. Grande:** If it can already be done, is there a reason we are putting it in here then.

**Bob:** We put it in there, because what we have in mind when we changed may to shall, that sort of in a lot of peoples mind threw up a red flag and we want to make sure we weren't opposed.

**Rep. Froseth:** Are there any qualifications necessary as far as education and also do counties receive grants from the veterans affairs to partially fund the program, what is the salary of Veteran Service officers receive.

**Bob:** There isn't really any qualifications, basically what we have been trying to do with them they must be knowledgeable in veterans laws on both the state and federal level. Work with the federal agency that may not have veterans things, but human services, so they can help these veterans get into veterans programs, but other programs that maybe assistance to them. On the number of dollars, there are 20 some officers that make less than 500 hundred dollars a month. Some of them don't have office hours, some don't have offices. They work out of their house, don't have computer access. We are concerned about all of this. Funding post war trust earnings, it is not a grant through a county, it is a grant to help individuals.

**Rep. Froseth:** The grant money is used for individual services, not for funding the veteran service offices. Is there usually a preference given to a veteran for these positions, if possible.

**Bob:** Yes, we uphold the veterans preference law, so if there is a veteran that applies and there is no others, the veteran will get the preference. If it is a disabled veteran applies he will get the job.

**Rep. Kasper:** Looking at the number of counties on your list for the loans and the grants, I just quickly counted up under the grants by counties, there is 23 counties that have 0. I am assuming that every county in North Dakota has veterans. I am wondering why there are zero's in some of these columns are some of these counties not having service officers who are working or are

veterans not aware of these programs, because it seems to me that this is a program that be more acceptable or should be more used by the veterans of our state.

**Bob:** You hit on two of the reasons and that is part of the audit that came out. The department was not adequately getting information out into the hands of veterans and that is part of our program now that we need to get this information out, so veterans know that they have this. The more active service officers, they use the program extensively, the amount of grants in 2004 went from 71,000 to 99,000. I anticipate that to be even more, because of the returning veterans and this kind of goes into another area, we were always looking at this bubble moving through the veterans population moving through veterans of World War Two, Korea and Viet Nam. Now we are dealing with teenagers who are coming back and with the guard people who have been activated and who the military wasn't their life. Some are coming back and had business', we need to take a look at how do we get these people back on their feet. If you are getting 500 dollars a month how much time are you going to put in and if you have another business that they roll in as a part time business service officer with that, it is all at the disgression of the county, how much they want to pay and so forth.

**Rep. Kasper:** So the funding from the veterans affairs comes from the county budget, how about the funding for your department where your at and are you adequately funded, do you have funds available to help those counties do better advertising to the veterans in those locations, services that they have available.

**Bob:** Our funding has been both general fund, funding Post War Trust fund, from the loan program, we have tried for several sessions to say that the Post War Trust fund, and the loan fund dollars are limited and they shouldn't be used run the administrative office, so Governor Hoven

has put those dollars into our budget, as general fund dollars this time, so yes that has helped and that will help if we can get that. Quite frankly there is more we could do, if we had more dollars, but it is going to take time to build that up at this point. We do have two people on staff that are training officers, who we do put out into the counties to help them when they have problems. Are we adequately funded. We need time to build up.

**Rep. Conrad:** How many counties do not have a Service Officer.

**Bob:** They all have a county service officer, but there are two service officers that have more than one county.

**Rep. Conrad:** This language saying that they shall, it is to make sure they continue to have them.

**Bob:** That is there because, as we see it not only do service officers take care of veterans, but they take care of their dependents and I thought we would not have any more veterans after Viet Nam, we had the Gulf War and now we have this, so we just want to make sure that the apparatus is there, some counties have around 100 veterans left.

**Rep. Conrad:** If some one is from McHenry county, they can go to Ward county and get the services, they can go into that office and get the services or must they go back to McHenry county?

**Bob:** There is nothing that requires them to go to their own service officer, however most of them do that and most service officers will accept veterans from other counties.

**Rep. Conrad:** Should we put a mill levy in hear of a half of mill or something to designate, so the county would have the understanding that they are to spend dollars on this.

**Bob:** There is a mill levy currently in the law 1.25 mill, I believe Rep. Metcalf of Valley City is introducing a bill that will increase that will bring it up to 2 mill, but the counties don't have to levy that.

**Rep. Froseth:** I am just wondering if that wasn't increased just a half a mill. Your department agency is one that we here from very seldom, during the legislator maybe one or two bill and maybe we lose track of what the State agencies do, we have a bill in the legislature that its time to appropriate bonus money to veterans and so forth from the State, so I imagine there will be money coming from the federal government, is all the money from all those programs channeled through your department?

**Bob:** No, the bonuses always go through the Adjutant Generals office, one thing, that is a pretty big job to do, we have a staff of six people including myself. There is no way that we could handle it. We work hand and hand we the Adjutant Generals office in various areas with the discharge papers. We have been in contact with Colonel Feelie on numerous occasions, there is communication going on.

**Rep. Galvin:** You are made aware of veteran service officer because you belong to the American Legion or the VFW, like right now I am sure the veteran service officers, much to their time is taken up with the no drug benefits that they are eligible for, I wondered if their are people that don't belong to these organizations that are falling through the cracks, because they are not aware of the services available, by veteran service officers.

**Bob:** That is exactly one of the points that was made in the audit, how do and why aren't isn't information gotten out to every veteran and that is what we working on now, to try and get it out

more broadly, we would like to see all of the veterans to know exactly what is available and taking part in it.

**Rep. Potter:** With the change from may to shall, I am not quite clear what all the implications mean for counties, does it mean they may appoint or they may employee, so changing to shall does it mean, OK you are going to do this now and in the past you haven't and by george your going to do it and you are going to pay them, let me know exactly what that means.

**Bob:** That is what could happen, but I think what it is now, every county has a service officer in some capacity or another, so we are not required to do any more than what is being done right now. What we are looking at is looking into the future and insuring that everybody that becomes a veteran or their dependents are covered when something happens, because we want to make sure, lets say a county there is no more veterans or dependents in that county, well I think they could have a service officer. We are trying to get more and more young people back and I think there is a great work force out there with the veterans that are coming back, so I see us locating veterans at all counties. We want to make sure there is someone their that they can go to that will help them.

**Rep. Conrad:** I understand that the counties share at times this person and with this mill levy that the counties can assess, or they do assess it, maybe you can help me with that, that would go into when we actually would pay the person and maybe that is what the shall gets to also and maybe there is someone there that maybe they expect to do it for free or something. I am just not clear on that.

**Bob:** The documents that I have seen on this is there is a lot of counties who don't levy the maximum mill levy right now and some of the larger counties don't have to because that would



generate a whole lot more money than they would need for these agencies. There are a lot of counties that, quite frankly that don't levy a lot, we just heard of a situation in a county where they hired a person to be county service officer, the person is to work two days a week at minimum wage and that person is to cover a whole county, so this is in the hands of the counties and it is their decision. One of the auditor's recommendation that relates to this sorda indicated, maybe, all the county service officers should come under the State Department of Veterans Affairs. I am not here to say that I am proposing that or supporting that, it is proven that it can run well in county and counties pay them and counties do have control of that.

**Rep. Conrad:** Is there a summary of this audit? Could we have a copy of?

**Bob:** We can get to the state auditor and they can make copies available.

**Rep. Kasper:** The source of the grants and the loans are funded through the Post War Trust Earnings.

**Bob:** The grants are.

**Rep. Kasper:** So there is another trust fund.

**Bob:** Veterans paid loan fund.

**Rep. Kasper:** Are they controlled by your department, where are they controlled and how much money is in their?

**Bob:** The loan fund is by law in the Department of Veterans Affairs, it is out of a seven hundred thousand dollar loan fund, that was suppose to be a revolving fund, trust fund throughout time that seven hundred thousand was taken out of the log, trust fund was taken out of the log and the department paid for administrative expenses out of that. Right now that fund has about five hundred thousand dollars, if you include the loans that are outstanding, that are active and then

we have several that are in collections. This loan fund is a fund that is for veterans is the last resort to get money. We don't want to compete with banks, the maximum allowed is five thousand, so that comes out of there and we have control of that. The grant program, the moneys for that comes from Post War Trust Fund earnings, that is a constitutional measure where the administrative committee on Veterans Affairs has the authority on a continuing basis to use that money, for programs that benefit veterans. The department has the program for the grants, we ask them for money, they approve or disapprove of the grant. It has been a good program to help veterans. The interest in that fund obviously fluctuates, the interest rates are not as good. I think the projected earning for this current biennium is around four hundred thousand dollars, for earning for that. On the grant program they also have transportation program that we buy vans for the disabled veterans trust fund, the vans get put out into the counties where they transport veterans to the VA. It also funds the current administrative costs, also.

**Rep. Kasper:** The amount of money in the Post War Trust Fund is about eight or ten million?

**Bob:** No it is a four million dollar fund. Roughly four million.

**Rep. Klemin:** On your performance audit, you say the state auditor made a formal recommendation that Department of Veterans Affairs work with the association of counties and county commissioners to improve county services to veterans by consolidating county veteran service offices. This bill on line seven you shall appoint service officers, this may preclude them from not doing it in the future. Line nine and ten, a person to serve in more than one county, they are doing that now in some cases. I guess I am wondering how this bill really implements the recommendation made by the state auditor that these service offices need to be consolidated, it seems to me what you said, some of these counties are getting pretty token service through the

veterans here and even if they have the authority to fund the position they are choosing not to do that. What is this bill doing to implement this recommendation?

**Bob:** There is another bill coming, in current law, you really can't supervise if you don't pay, if you don't have that control there and it wasn't being done anyway, so either take that language out, you need some control over the county service offices. The administrative committee has decided to take that language out, put in other language that says that the commissioner will be able to help them and give them recommendations to them on qualifications and so forth. It is a tough situation to be in when you don't have control to hire and fire. We want to make sure that every county has a service officer. They can have one service officer serve more than one county. If you go out into the general population, you say tool chest bill, not many people recognize what that means.

**Rep. Klemin:** The other bill you are talking about actually, where the current law say you are suppose to supervise it takes that language out? So how does that help this?

**Bob:** Yes, because there is no way that the department and the commissioner can ever supervise all 53 counties with the size of staff it has with the realities of where the budgets are and maybe that is something to be working on as time goes on.

**Rep. Klemin:** I don't want any misunderstandings here, I am very supportive of veterans programs and I am a veteran myself, I don't have a problem with this bill, except I don't think it does anything. I am not sure what exactly it would accomplish.

**Rep. Kasper:** The service officers had three day training seminars and you could tell by talking to them that they were excited about doing their job and this maybe was about ten or eleven years ago when my father would take me to these seminars with him, when he was a service officer,

what has happened. It seemed to me that the training was great, the excitement was great, things were going on and now all of a sudden it appears it was here, what's happened?

**Bob:** There still are two training sessions a year, one in April and one in September, we are still working on bringing in the best kind of training we can, they brought in actual National Service officers in the September meeting I was involved in, that really ignited a fire in them to do more. We have a group of county service officers that indicate the kind of training that would be beneficial.

**Rep. Grande:** This bill is not accomplishing what we are trying to do here and I just really quite understand and it just kind of counterdicts what we are trying to do, in that we are in first off make every county have this and then but by the way consolidate and if you want to and I beg to differ on the tool chest law, counties are very aware of the tool chest law and they utilize it, so I don't think that is the issue. Right now if we have this many, we can't supervise them, we can't get the information out, but by the way we are going to make you do it. You have contradicted yourself into what you are trying to do there, so is there a way that we should be doing this, where again we'll go back to what you were talking about, regional direction versus county direction, because we are not going to accomplish it by mandating it, there is no appropriation on this, so we don't have any way that it is going to take place, I think you have created more of a problem then you tried to solve in what the auditor has been asking you to do.

**Bob:** The general population needs help, if there is a consolidation of counties, I think that would help.

**Chairman Haas:** If you had 8 veteran service officers would that be a more effective system?

Try to make veterans aware, some are reluctant to seek services?



**Chairman Krebsbach** opens hearing on **HB 1128**

**Relating to appointment of a county veterans' service officer.**

**(Tape 1, Side B, meter #725)**

**Bob Hanson** - Commissioner of Veterans' Affairs - See attached handout. He said what they have found is that counties do not have to have a Veterans Service Officer and they want to make sure that everyone is served in their counties. All counties need to be represented. They can have service officers that serve more than one county. He talked of a study resolution introduced that says they want a study done by Legislative Council in the interim of how to best use the financial resources of counties and the state to provide the best services to the veterans of this state. He thinks that is a very important piece of this legislation. In support of this bill.

**Senator Nelson** - Are counties doing it now doing it under tool box or just doing it under nobodies authority.

**Hanson** - Replied they are probably doing it both ways, but probably under tool chest.

**Senator Nelson** - Asked about the handout.

**Hanson** - Explained the handout, what it means for support staff and hours.

**Senator Nelson** - In some counties they are no regular hours, do they get paid for no regular hours?

**Hanson** - He said that roughly half the service officers make less than \$500 a month. These people are dealing with extremely confidential records. There is concern with some of them having offices in their houses. Concerned with HIPPA violations.

**Senator Lee** - Thinks that services need to be provided so there isn't such a long distance that someone would have to travel.

**Hanson** - Yes, and in areas of consolidation service officers are on call for 24 hours a day. Whenever a veteran needs help they are there.

**Senator Krebsbach** - Asked if the counties and the service officers have a listing of veterans in their area that are eligible.

**Hanson** - Said no, most go through Veteran Service organizations. Another thing that came up is that there needs to be more outreach.

Good morning Chairman Haas and committee members. I am Bob Hanson, commissioner of the department of veterans' affairs.

House Bill 1128 was introduced at the request of our department and the administrative committee on veterans' affairs, which is the body that oversees the department.

The bill addresses a concern brought out in the performance audit of our agency by the state auditor this past year.

The state auditors made a formal recommendation that the department of veterans' affairs "work with the Association of Counties and County Commissioners to improve county services to veterans by consolidating County Veterans' Service Officers."

First, this bill requires all counties to have county veterans' service officer. All counties now have a service officer. However, comments have been made suggesting maybe a county could get along without a county veterans' service officer. Obviously, especially at this time in history, we believe veterans' and their dependents need to have ready access to an individual who can assist them obtain the services and benefits to which they are entitled.

Second, this bill makes it clear that an individual can serve as a county veterans' service officer for more than one county. This compliments current law allowing counties to join forces in other areas. There currently are a couple of instances in the state where one individual serves as county veterans' service officer for more than one county.

Veterans are important to the state's economy. North Dakota's veterans generated nearly \$140 million from North Dakota department of veterans' affairs programs for calendar years 2003 and 2004 and the Veterans Administration's programs for 2003 Fiscal Year. It is estimated the VA's programs for North Dakota veterans would bring that total to well over \$275 million for the two year period once their FY 2004 numbers are known. The county veterans' service officers across this state and our staff have played a major role in securing these benefits and services for our veterans and our state (see attached documents.)

Both the department and the administrative committee on veterans' affairs believe this is the proper approach to take at this time to ensure our state's veterans will have the access to a county veterans' service officer they need to help them obtain the services and benefits to which they are entitled regardless of what county they live in.

We respectfully request your favorable consideration and action on HB 1128.

Chairman Hass and members of the Government and Veterans Affairs Committee, I am Daryl Beard, member of the Administrative Committee on Veterans Affairs and Chairman, North Dakota Veterans Home Governing Board.

There are over 58,000 veterans in the state of North Dakota. These veterans receive over 79 million dollars in compensation, pension, education and rehabilitation from federal sources. These benefits start with county veteran service officers. Without these service officers veterans do not have proper access to these federal benefits.

Recently the veterans of one county had the county commissioners decide that they did not need or could not afford a county veterans service officer. This is unacceptable to the veterans of the state of North Dakota and to the veterans of this county.

Since the mill levy is capped many counties are having trouble finding a qualified county veteran service officer. The sharing of county veteran service officers should be encouraged in sparsely populated counties as many have no offices and no posted office hours.

This concludes my testimony. I would be happy to try answer any questions.
