Minutes:

Chairman Keiser: Opened the hearing on HB 1219. All committee members were present.

Representative Porter: Was a sponsor of the bill and appeared in support of HB 1219.

I own the ambulance service in Bismarck-Mandan, I also serve on the board of the Burleigh 911 Center, that makes up the police chief, fire chief, rural and urban 911 center, and dispatching and taking of emergency calls. As technology advances itself 911 centers, will have the capabilities with their 911 data base, to have a bank of phone numbers, names and addresses both published and unpublished numbers, so if you call 911 from your house and soon to be from your cell phone it will say on the screen, its says your name and address of where you are calling from. From your cell phone it will give your coordinance within a few 100 feet. the city of Bismarck was lucky enough to be allowed a grant from Basin Electric to purchase a product to have in their 911 Center, and the city of Minot, since the anhydrous spill also purchased a different version of the same product, but what it allows the Public Service Answering point to do it to draw a circle

around a area such as the anhydrous spill to have a pre recorded message that there has been an accident in the area and wait for rescuers to come to your house. What the computer does is grab the phone numbers in that geographical area and it just keeps making calls warning every home. I think it will be 23 calls at a time depending on the length of the message.

Representative N. Johnson: Who will determine the use of that system?

Representative Porter: Each jurisdiction has their own way to manage their public service answering point, in Bismarck-Mandan it is the 911 system.

Representative Ruby: Does it become the responsibility of the city if the people do not hear sirens?

Representative Porter: No, it's a notification system, a warning system, if you screen your calls and you see on your caller ID that it says Burleigh County, and you don't want to talk because its from Burleigh County, its not going to call you back, there is really no way to make sure that there is 100% notification in any of these areas, its just the next level of notification.

Mike Dannenfelzer, Manager, Combined Communications: I'm here in support of HB 1219 and provided written testimony (SEE ATTACHED TESTIMONY).

Representative Thorpe: I move a **DO PASS** motion on **HB 1219**.

Representative Vigesaa: **SECOND** the motion.

Minutes: Relating to use of unpublished names and telephone numbers for automated emergency notification.

Senator John (Jack) T. Traynor, Chairman called the Judiciary committee to order. All Senators were present. The hearing opened with the following testimony:

Testimony In Support of the Bill:

Mike Deannenfelzer, Mngr of Bismarck/Burleigh Combined Communications (meter 6100)

Gave Testimony - Att. #1.

Senator Triplett asked what the policy was that they used to use this in a "missing persons" case. **Senator Triplett** was concerned that if overused it would not have the impact it is meant to have. They discussed how agencies has a subscription service, such as banks are utilizing this when for instance a bank robbery has occurred. What is the request flow and who makes the decision to activate it (meter 416) Say the Fire Dept. makes a notification of a chemical release or fire-they fill out a form and submit it to us. We refer to the policy and see if it falls in the

guidelines. Then it would be activated. People on the board include the Sheriff, police chief, fire chief and others.

The committee discussed if a person could become "exempt" from the list like the "do not call" list? Yes, but they can not be partially taken off.

Rep. Todd Porter, Dist. # 34 - Introduced the bill. I am the chair person for this board. Sited who was on the board that made that makes the decision to use the process. They are elected officials and would not be reelected again if the public did not like how they were using it.

Senator Syverson asked what the guidelines were on using it

Sen. Nelson asked how the use of cell phones over home phones effect the process? Yes it would be bad.

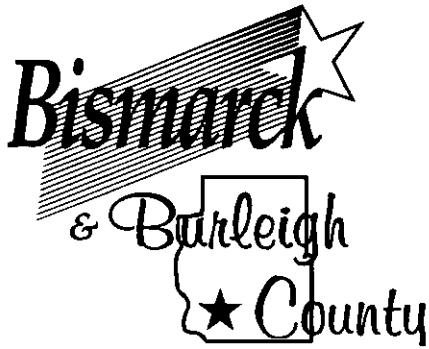

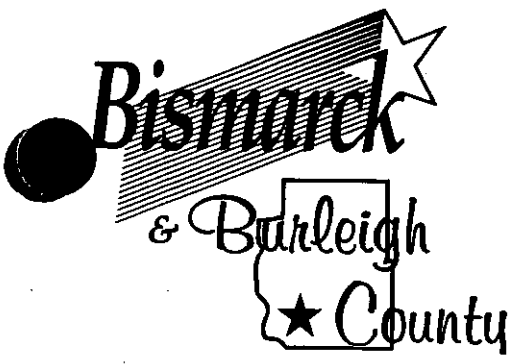
