Minutes: **Rep.Devlin, Chairman** opened the hearing on HCR 3007, A concurrent resolution declaring Monday, February 14, 2005, "North Dakota Close-Day".

**Rep. Weiler** representing District 30 was the prime sponsor on HCR 3007. Rep. Weiler asked for favorable support for this resolution and the fine work which is being accomplished with students in fostering a knowledge and hopefully an interest in participating in government. His main purpose for appearing was to introduce Rick Heidt, coordinator of the North Dakota Close-Up program.

Rick Heidt : A copy of his prepared testimony is attached.

**Rep. Herbel, Vice Chairman** (2.7) Would just quickly tell us how the kids a selected? **Rick Heidt**: It is a different process in just about every school -- sometimes they have contests where they write an essay, at other times they just select students, at other times name students who want to, --- one of the problems we have had this year is with the overlap of girls and boys atheltics --- and all the time that is taken. Dakota. So our enrollments are down a little bit. By the same token Mid-Dakota is sending twelve students. We normally limit to 2 students for schools that have enrollment of less than 300 students; and, 3 students for those with more than 300 students. I have never turned a student away -- we have always found room. The funding can come from fund raising. It can come from the local school district. We don't fund any of that. We charge an enrollment fee to the schools so that we can put the program on. Each year each school pays an \$50 enrollment fee.

Rep. Kretschmar How many schools participate in this?

**Rick Heidt**: forty schools this year -- last year we had 45 schools and we were down about 7 but when we started we were at 55 -- sports has really cut into the participation.

**Dr. Doug Johnson** representing the North Dakota Council of Educators appeared to praise and support the program. Dr. Johnson thanked the legislature for its support of the program.

**Rep.Devlin, Chairman** (6.0) recessed the hearing in the event that some of the committee who were attending the Evan Lips funeral might want to add to the testimony or to have more information brought before the committee -- the record would be open in that event.

Tape 2 side A (2.0) Rep. N. Johnson moved a 'Do Pass motion and to place HCR 3007 on the consent calendar'. Rep. Maragos seconded the motion. On a roll call vote the motion carried 12 yeas 0 Nays 0 absent. Rep. N. Johnson was designated to carry HCR 3007 on the floor. Rep.Devlin, Chairman entered into the record an E-mail from Sen. We want a date that works the best for the kids. The number of close-up participants have been diminished due to Class B district basketball tournaments taking place around that time. You can't compete with Class B in ND, we have a lot of Class B schools that participate in the program.

Senator Triplett- Who did you work through this year to make February 14 work?

Rick- We worked with Representative Weiler and the Capitol Facilities Committee.

Senator Triplett- Perhaps the legislature should authorize the facilities committee to designate close up day in February.

**Senator Dever-** This should have been given fast track consideration. Maybe we should adjust the resolution to congratulate the students on their participation in the program.

Rick Heidt distributed written testimony. See attached.

Senator David O'Connell appeared before the committee in support of the legislation.

Governor Sinner appointed him to the close-up committee in 1985, and has been involved with every close-up since then. Its a great program to show kids how their government works.
