**HCR 3028** directs the Legislative Council to study utilization of the state's abundant energy resources to attract energy-intensive economic development projects to the state.

**Rep. Chuck Damschen** introduced the bill.

**Rep. Damschen:** HCR 3028 is pretty self-explanatory. There is an abundance of resources in North Dakota with oil, coal and wind. The problem is transmitting that power beyond our state lines.
