Minutes: Chairman Mutch opened the hearing on SB 2111. All Senators were present.

SB 2111 relates to the notice of sale of abandoned property by the unclaimed property administrator.

Linda Fisher, Unclaimed Property Administrator for the North Dakota State Land

Department, introduced the bill. See attached testimony.

Senator Krebsbach: Once the sale is held, are the proceeds from that kept in the name of the person who had secured the safety deposit box?

Linda: Yes, they are. They turn from unclaimed property contents to cash.

Chairman Mutch: What do you usually find in that safe deposit box?

Linda: Ninety percent of it is paper, insurance policies, pictures, marriage licenses, birth certificates, death certificates, social security cards. We don't collect a lot of valuable, salable property.



Senator Klein: We don't look into those boxes until they have been delinquent for three years?

Linda: The law says that the bank holds them that long before we get them. So if they haven't been paid for three years, that's when the bank can go in and drill the box, remove the contents and send it to our office. That is when the names start showing up on our lists and Internet sites.

Senator Klein: You still have a name tied to that box, because whoever was renting it at that point because whoever was renting it at that point would certainly be the owner of that property. You just haven't found this person?

Linda: That's right. Sometimes, I think they don't claim them because they know that what was in there was really of no value.

Chairman Mutch: How long of a period will you hold the property?

Linda: The last time we actually disposed of property was in 1993. We are in no hurry to have an auction now. We just feel that the longer we can keep it in it's original form for the owner, the better.


Senator Klein: Does this happen often? Are you called by a bank a lot?

Linda: We are never called by a bank. The way the statute is written, the banks look through their inventory every year at a certain time and see which boxes are eligible to send to the state. Then they just package them up and send them to us.

Senator Krebsbach: You say that the last sale that you have had was in 1993. And yet the bill says, "not less than three years" you will sell it. Is that a workable situation for you?

Linda: Yes, we feel that we should hold it for at least three years to give the people an opportunity to claim it. The way the law would be, if changed, would say that we could hold it as long as we feel that it makes sense to.

Chairman Mutch: You can't get the property out of the box for three years, then you open it?



Linda: If we get the box on Monday and that person sees their name in the paper on Tuesday, you could claim it from us at any time. It's just that we can't sell it prior to three years of receiving it.

There was no opposition. Senator Heitkamp moved a DO PASS. Senator Espegard seconded. Roll Call Vote: 7 yes. 0 no. 0 absent. Carrier: Senator Heitkamp.

Linda Fisher, Unclaimed Property Administrator, ND State Land Department: Appeared in support of the bill and provided a written statement (SEE ATTACHED TESTIMONY).

Representative Nottestad: By not advertising this could that be construed by some as some that we are tying to sell the product without notifying the public?

Linda Fisher: I suppose it could if somebody wanted to make an issue of that, but when you put things on the Internet they are basically opened to the world at all times, and the question we had, is if you do put something on the Internet, where would you publish that and how would you publish it.

Representative Kasper: Do you ever make any effort to contact the original content owners?

Linda Fisher: We do make some personal contact, and a lot of times it depends what is in the box, if we opened the box and there are valentines cards, we might not, but if there are collectibles we do make an effort to contact the owners.

Representative Dosch: Couldn't you place an ad in the Bismarck Tribune, it kind of bothers me.

<u>Linda Fisher:</u> Absolutely, but then we couldn't limit it to the Tribune, because a lot of the property is going to be for people all over the state, we would have to advertise in every paper.

Representative Froseth: Your changing it, that in place of having to get rid of the property within three years, your holding it not less then 3 years, your opened ended there don't you think there should be signed limit to when you should dispose of the property?

Linda Fisher: We just feel that the longer we can hold the property in its current state, that is better for the owner. The criteria would be, once our little room that we hold the items in, once the room is full, then we would have a sale. Our last sale was in 1993.

Representative Clark: How much effort do you make to locate the owner of the property?

Linda Fisher: If you call our office and ask specific information on those companies, there is a high likely hood that you would find that claim forms have been sent to those places, for what ever reasons they don't claim them, there is another reason, lets say that insurance company, they will issue a check and it will be made out to the body shop and you, a lot of times those checks do not get cashed because the work doesn't get done, if there are two parties on a claim, we require that both parties make that claim because we don't know which party is entitled to the claim, sometimes they don't want to go through the trouble. We have to be the last resort for individuals that cannot be located. The last sale in 1993 was at the state fair in Minot.

Representative Keiser: What is the definition of a individual not using their box?

Senator Espegard: We have an amendment to our bill and I would ask for an explanation from the House.

Rep. Dosch: The purpose of the bill in the first place was to give the abandoned property, where if they are going to go online to sell the stuff, they wouldn't have to physically publish the sale. Our concern is that a lot of the stuff they are talking about is from safe deposit boxes, something other than cash. It's personal items, like birth certificates, wedding certificates, things like that that have more of a sentimental value than any other real value. So we thought that there would

be some value, if they are going to sell or get rid of the contents of some of these boxes, that they should put a notice in the paper. When they do have the sale, they have to publish where it is and when. If my box was abandoned, and we didn't know about it, and eventually they would sell the contents. We thought there should be some other notification for that.

Linda Fisher, Unclaimed Property Administrator of the ND State Land Dept., spoke to the committee to clarify the bill.

Linda: These all get listed. They are all posted in the publications in the paper. Some of these things we are talking about have already been advertised and on the web site. They don't get treated any differently than one with money in it. In fact, if we have a box that has a lot of valuable things, we do extra search efforts on that. So there are more efforts being made to publicize this property than I explained. The banks are also required to find them before we get it. All of the names are listed. The contents are not listed.

Rep. Dosch: I was under the impression that the box was a separate deal from the money. I didn't realize they were handled the same. They are published as much as those with money. With that verification, I would move that the House recede from our amendments. Rep. Nottestad seconded.

TESTIMONY OF LINDA FISHER Unclaimed Property Administrator North Dakota State Land Department

IN SUPPORT OF SENATE BILL NO. 2111

Industry, Business and Labor Committee January 18, 2005

When a safe deposit box held by a financial institution is not accessed by the owner, or is more than three years delinquent in box rental, the contents of the box becomes unclaimed property.

North Dakota Uniform Unclaimed Property Act in 47-30.1-22 provides for the disposal of tangible articles received by the Unclaimed Property Administrator via the means of public sale.

The current statute requires us to sell safe deposit box contents after holding it for three years. To properly comply with that statute, we would need to hold an auction every year to sell any contents that had a 3-year anniversary since the last sale. Simultaneous with the sale would be disposal of non-saleable items (i.e. pictures, baptismal certificates, birth certificates, military discharge papers, insurance policies, etc.)

We ask for a change to the statute for two reasons:

- 1) Auctions can be very time-consuming and costly.
- 2) Once property is sold or destroyed, potential for recovery by the owner is lost forever.

Since we receive a small amount of tangible property each year, it is not cost-prohibitive for us to hold these properties longer than three years, giving the owners additional time to make a claim. Furthermore, since the vast majority of items we receive are the non-saleable items mentioned above, there is also no significant revenue impact to the common schools trust fund.

Revising this statute would allow us to hold an auction when it became feasible instead of doing so on a pre-determined schedule.

I would also like to refer to the proposed changes on lines 14 -17 of the bill. The current statute allows us to conduct auctions at a specific, physical auction location, or, if we feel we could receive a better return for our owners in some instances, to offer property on the internet. The proposed changes on lines 14 -17 seek to clarify that publication of notice is required for sales that are physically conducted in a building or other appropriate location, but that notice is not required to be published when the article is offered on the web.

With those explanations, I respectfully request a "do pass" recommendation on Senate Bill No. 2111.

Any public sale held under this section must be preceded by a notice, published once a week for two consecutive weeks in advance of sale, in four newspapers of general circulation in the counties with the four highest populations. The notice must contain each available name of each owner of the property to be sold.
