Senator Syverson - Asked if individuals served in Europe for a year would they qualify for the bonus.

General Haugen - US Dept. of Defense will establish the territory on the overseas deployment that qualifies them for the Campaign Medal. (meter # 235).

Senator Syverson - Asked if an individual was deceased as a result of action would their family qualify for \$100 a month for the period of time they were alive and payment for a Purple Heart.

General Haugen - Said that it wouldn't be based on a monthly service but in one payment of

\$2500.

Senator Nelson - Asked if doctor's stationed in Germany would be paid \$50 per month.

General Haugen - Yes

Senator Krebsbach - Was very interested in some documentation of numbers of participation from ND from all of the wars we've been involved in and would like a copy of that.

Chairman Haas: We will open the hearing on SB 2146 and the clerk to read the title. Good Morning Senator Lyson.

Senator Lyson-District 1-Williston-Introducing SB 2146-Those of us that are veterans understand what it was like to be in the services and go over seas and do our duty. These young men and women that went this time were called away from their families, many of them their jobs and my nephews situation he had one semester to go in college. They went over and did there jobs and they did it well. I think it is time for us to step forward and give them some back. We went through things that weren't very nice. When we got back we didn't know what to do. The kids that are coming back now, they are already, they are doing a lot better job now, then when I went in a hundred years ago. This is important for them, we have got to show them that we care and want to help them. I think it is so great that we are doing this.

Major General Michael Haugen-Adjutant General-Testimony Attached-For

Rep. Amerman: Say we are still in Iraq in 2007 and 2008, if wanted those soldiers to be covered we would have to do this again in the 2007 session, is that right?

Major General: That is correct, we would appear before you in the next session.

Rep. Potter: Can you help me with, decisions made in administering this act made by the office of the Adjutant General, are not subject to court review with exception of residence determination, what is it about court review?

Major General: There are time limits, of duties and normal and administrative decisions.

Rep. Meier: How many National Guardsmen of North Dakota do you still have serving in Iraq?

Major General: We have currently 100 members from the Grand Forks, we have some individuals, one of our physicians is over there. Other that are in Afghanistan, so they are still in the war zone. We have a few from the Air National Guard, they are going in and out all the time.

Chairman Haas: Any further questions for General Haugen. Thank you very much. Additional

Affairs-For-We are a fifteen member committee, we are appointed by the governor, three members from each of the five major veteran organizations in the state. We would like to concur with the General and ask for a Do Pass on SB 2146.

Chairman Haas: The house appropriations committee, if there is any of this five million left over it would go veteran cemetery trust fund, is that correct?

Rep. Aarsvold: That is correct. There was a memo added in the appropriations committee and the intent is to make that fund self-sufficient to provide an on going resource for the veterans cemetery to run its operation.

Chairman Haas: If there is a need for additional funding for veteran bonuses beyond 2007, the legislature would be dealing with that. Would it make more sense to put that money in reserve or re-appropriate for additional bonuses.

Rep. Aarsvold: I believe the authorization extends through 2007 and I think that the anticipation is we will be able to deal with applications through the time period with the funds that are laid out in the bill.

Rep. Kasper: In General Haugens testimony he states that the amount is the same that was approved in 91 and 93 budget. We are almost 15 years beyond that point. The cost of living has gone up, was there any consideration to increasing those amounts or was it a budgetary restraint decision to keep it at this number?

Rep. Aarsvold: There was no discussion along that line in the appropriations committee.

Rep. Galvin: Does this cover everyone back to 1992, is there any group prior to that did not have some kind of compensation.

Rep. Aarsvold: It is my understanding that we have covered all eligible veterans for the campaigns, 1992 and prior, so this would be those from 1992 to the present.

Chairman Carlisle opened discussion on SB 2146 which concerns providing adjusted compensation for eligible resident veterans. Lt. Colonel Dave Thiele, Staff Judge Advocate for N.D. National Guard, testified in support of SB 2146 and to request an amendment. The payments are tax exempt. In order to insure that soldiers can use the short form, it must be referenced in 57-38-30.3 that it applies. He said Mr. John Walstad, Legislative Council, is preparing an amendment and that it will be delivered to the Committee before the end of the day. Rep. Kempenich noted that the bill didn't reference any place in the Code. Colo. Thiele said they would create a new section in 57-38-30.3 stating that payments, under whatever section this is ultimately titled, are also exempt. It has to be referenced in there. It's just a procedural thing to insure that they can pick that on their form.

Chairman Carlisle told the Committee that the money is in the budget. Colo. Thiele said his soldiers are anxiously waiting for their payments.

Rep. C.B. Haas, from Taylor, testified in favor of the SB 2146. He told the Committee that the bill is similar to the one used after the first Gulf War in 1991-1993. It includes costs for the upcoming two years. The \$3.9 million will be dispersed to those the Agency knows about right now. The balance of the \$5 million will take care of the people they anticipate will receive benefits for the next two years. Any money left over will go to the Cemetery Trust Fund to help with its maintenance. Chairman Carlisle noted this is a one-time shot. Rep. Haas confirmed and went on to say that the Cemetery Trust Fund is a permanent trust and only the interest is used.

Rep. Haas also told the Committee this bill covers those people who were involved in conflicts in Somalia, Bosnia, Kosovo, Afghanistan, Haiti, and much of the Persian Gulf Region. So far, North Dakota has had seven National Guard soldiers who have been killed.

Rep. Timm asked where it states in the legislation that the excess money will maintain the cemetery. Mr. Joe Morrissette, Legislative Council, said the language is contained in the Adjutant General's budget.

Chairman Carlisle closed the discussion on SB 2146 until Fri. a.m. when the Amendment would be finished.

This provides additional compensation for resident military members mobilizes after December 5, 1992 and carries through June 30, 2007. There is \$100 per month for overseas duty not to exceed \$1800, \$50 per month for stateside duty, not to exceed \$900, \$2500 to purple heart recipients and \$2500 to the beneficiaries of those who died in service. This \$5 million is in the Governor's Budget and the purpose of this bill is to help elevate financial hardship for those who have served and their families and to serve as an incentive for future military service people. Section 2 is a long list of definitions for this bill, section 5 deals with the application process for this, section 6 deals with the bonuses, section 7 is the exemption from state taxes and section 10 carries an emergency clause because this bill goes back to December 31, 2004 as far as the taxable year. This was amended at the direction of the legislative council because there were no direct references in

regards to the tax code. Rep Williams moved to adopt amendment #0101 written by Rep DeKrey to SB2146.

Rep. Ron Carlisle seconded

Rep. Ken Svedjan, Chairman called for a voice vote on the motion to adopt amendment #0101 to SB2146. Motion carried

Rep. Clark Williams moved a Do Pass As Amended motion to SB2146

Rep. Ralph Metcalf seconded

Rep. Jeff Delzer commented that the fiscal note has the current estimated cost at \$3,953,700 and yet they have \$5 million. Is this because it goes through to June 30, 2007

Rep. Clark Williams answered yes, the estimate approximates an additional \$120,000 for each additional 100 soldiers, so they put the figure at \$5 million for the total.

Rep. Jeff Delzer asked what would happen if there is not enough money to get through to the end of 2007

Rep. Clark Williams answered that the program would end when the money runs out **Rep. Jeff Delzer** asked if this covers all branches of the active military.

Rep. Clark Williams answered yes.

Rep. Ken Svedjan, Chairman called for a roll call vote on the Do Pass As Amended motion for SB2146. Motion carried with a vote of 21 yeas, 0 neas and 2 absences. Rep Klemin will carry the bill to the house floor.

Rep. Ken Svedjan, Chairman closed the discussion on SB2146.

SENATE BILL 2146

Madame Chair, Members of the Committee,

The North Dakota Legislature first approved additional compensation for veterans in 1919 and authorized \$25 per month for each month of service during World War I. Since then additional compensation has been provided to North Dakota veterans of every significant conflict; World War II, Korea, Vietnam, and the first Persian Gulf War. Senate Bill 2146 continues the tradition of recognizing the personal and financial sacrifice of our resident veterans and their families.

Senate Bill 2146 authorizes the payment of \$100 for every month of qualifying overseas service not to exceed \$1,800, and \$50 per month for stateside service not to exceed \$900. A combination of the two may not exceed \$1,800. Heirs of veterans who died while in active service and those receiving a purple heart will receive \$2,500. These amounts are the same as those approved for payment in 1991 and 1993 by the North Dakota Legislature for service in the first gulf war. The service period covered by this bill is the beginning of the Somalia conflict (December 5, 1992) through June 30, 2007, the end of the biennium.

Payments for foreign service will be made to those resident veteran's who received an Armed Forces Expeditionary Medal or Campaign Badge which includes

service in Somalia, Bosnia, Kosovo, Afghanistan, Haiti, and much of the Persian Gulf region. The stateside service will be any active duty activation for service greater than 30 days. Such service will not include state activities such as Operation Snowball (blizzard of 1997) and Operation Good Neighbor (Grand Forks flood relief).

As in the past, the program will be administered by the Office of the Adjutant General and we have already begun the process to ensure that payments can be made quickly and efficiently to all military personnel should this bill pass. The bill has an emergency measure clause to further ensure our eligible resident military members receive the funds as quickly as possible. Payments will be exempt from state tax and will not be subject to debt assignment with the exception of any sums owed the veteran's aid fund. Decisions made in administering this act made by the Office of the Adjutant General are not subject to court review with the exception of residence determinations.

The executive budget for the Office of the Adjutant General includes a request for \$5,000,000 to fund the bonus program. Our current projected cost is approximately \$3.9 million dollars but that represents an educated guess regarding active duty component members and obviously does not include potential costs in the upcoming two years. We do believe that the \$5.0 million will adequately cover the cost of the program. The House Appropriations Committee is considering an amendment to the executive budget that will direct that any unused portion of the bonus program, if any, will be transferred to the state Veteran's Cemetery Trust Fund. We support that amendment.

The personal sacrifice, commitment, and bravery of our men and woman in the North Dakota National Guard and all military components has been exceptional, but it has also come at a high cost as we have had seven National Guard soldiers killed in action and another two that died while in service due to non-combat related injuries. An additional twenty-six soldiers have sustained combat related injuries in the last two years resulting in twenty-four purple hearts with several pending approval. The reserve and active component veterans have also served with distinction and bravery and we are aware of at least three North Dakota resident active component soldiers killed in action.

As we look back at the accomplishments of our resident veterans we do so with pride in not only the individuals who have served, but we also recognize the families and communities whose sacrifice and support has made this effort possible. SB 2146 recognizes that personal and financial sacrifice and is deeply appreciated by our resident veterans and their families not just because of the financial contribution but also because it is a way for the public to again say "thank you".

In conclusion, the Adjutant General's Office strongly supports this bill and, on behalf of all our resident soldiers, airman, sailors, and marines, we request your favorable consideration.
