Al Jaeger - Secretary of State - See written testimony - Gives an overview of the bill and talks about the amendments.

Senator Syverson - Asked if there are any requirements for the absentee to keep a hard copy.

Senator Brown - Asked if someone is gone for 30 years can they only vote for president.

Silrum - Replied no, you are allowed to vote the full ballot as long as you have maintained your citizenship.

Senator Brown -Told of his brother-in-law who lives out of the states and maintains citizenship and is very up on all the politics because of the Internet, he should be allowed to vote.

Silrum - Said should an individual that has lived abroad so long be allowed to decide on local issues.

Senator Brown - Told of working election and having to turn away students who lived in Moorhead that just wanted to vote for president. Unfortunately they had to send them back to Minnesota. They only wanted to vote for president. Said its very difficult to put in limitations. Silrum - The question is someone who does not maintain their residence in ND any longer but has their ties to ND because this is where they last lived. Do those people have a right to vote on local issues.

**Rep. Klemin:** If we are sending somebody a form electronically and fill out electronically and to return electronically, how do you get a an original signature?

Jim Silrum-Assistant Secretary of State-We would ever to get to a point where the form would be completely or the ballot would be completely filled out on line, without it ever being printed out, because in printing it out that is where we are actually going to have a voter sign it and then they will be able to scan it back into the system, where it is a picture image of there work and then send it back that way. **Rep. Klemin:** We do this on the income tax forms now, they can be filed electronically, also with a notary. I feel that we are taking a step backwards.

Secretary of State: I understand where you are coming from on this, I think what we need to do is take some baby steps on this, I think we are opening up an avenue, we are not quite there, for the moment we would just like to take this step. Right now to do what we were doing is a disservice to the process and the people that are in those situations.

**Rep. Klemin:** Just to follow up, the fax machines are not there, but now we have to make sure they have a printer and a scanner.

Secretary of State: Those types of things we discovered were there, it is they just don't have fax machines. They did have the other type of technology available to them.

**Rep. Klemin:** If I don't have time on my paper ballot, I am going to have to track down a printer and scanner?

Secretary of State: No, you can still do the paper ballots.

Rep. Klemin: Timing was the issue?

Secretary of State: The timing was strictly the issue. If everything goes and some of the legislation that you have already passed, if we can get everything sooner if we can transmit, are preferred method would be to convey it by mail.

**Rep. Klemin:** If I am this list today I would be sitting out there and I could download this from my blackberry Tva from a satellite that is overhead and it would be transmitted via e-mail directly to your office. I don't need to have a scanner.

Rep. Meier: How many service men voted absentee ballots in this last election?

Secretary of State: In the survey they were expecting well over 50% of the troops. We have that information in our office, we can get that for you.

Chairman Haas: Further questions for Secretary Jaeger.

Secretary Jaeger: I did pass out the amendment, our concern at this point is that subsections 1 and 2 are intended for two different purposes and we feel we should have the change made there in subsection 2.

**Rep. Froseth:** There is no way that you can tell if that 18 year old, who moved to Canada, has voted in Canada and absentee in the US, can you.

Secretary Jaeger: I would have to say that you are right. There is an unknown factor there, we don't have you send in citizenship papers. The only thing we can go by is that they are signing affidavits. We are trying with this bill to make things a little bit better, work out better then it now.

Jim: In the process, when we have our central voter file in place, there are going to be times when someone will have there residential address here in North Dakota and there mailing address will be some other state or some other country. It will be the process that to safeguard the election process, that we will send the list to the other state or other country to people who have indicated that they voted here in North Dakota, will you check your records to see if they voted in California. That will be a safeguard to help to protect that. Perhaps there is a situation out there, who lives in North Dakota and moves to Minnesota, but never registers or votes in Minnesota, then leaves the United States, what are there voting rights there. In previous years we said that was a possible, possible situation where a person would be limited through a federal ballot only from North Dakota. applied for an absentee ballot, how do you know that track record of that person residency without a whole lot more questions then what we are presently allowed to ask on the application. **Rep. Secretary Jaeger: We struggled through this, if we could be allowed to research this a little further with our legal council, what we are trying to do is, with the changes the Senate made, we are thinking this is something we have to deal with and we if we can have a little latitude to just come back. I think we are making a step forward.

RE: SB 2336 – Absentee Voting

During the 2004 General Election, several of the state's county election officials and the Secretary of State's office received a number of requests for absentee ballots from individuals who were citizens of the United States and who had previously lived in North Dakota. In some circumstances, individuals wanting to vote had lived in Canada for 30 plus years and yet retained their United States citizenship.



Under federal law and state law, an individual who retains his or her citizenship is eligible to vote in federal elections. However, under current North Dakota law, many of these same individuals (even though they had not been residents of the state for many years) were also eligible to vote the entire ballot including statewide, district level, local offices, and measures.

While still allowing North Dakota citizens living outside the United States to vote for federal offices, Sections 1 and 2 state that only in the first four years away from North Dakota may one of these citizens vote the entire ballot in the North Dakota precinct where they last lived.

It was also learned in 2004 that current North Dakota law needed to be updated to provide uniformed and citizens living outside the United States with the necessary technological options (other than facsimile transmission allowed since 1991) to allow absentee ballots to be transmitted back and forth in a timely manner. In Section 3, these options, along with the appropriate safeguards, are addressed.

The change in Section 4 requires additional information from those individuals wishing to vote via facsimile or electronic mail. This change means that all persons desiring to vote by absentee ballot must apply for an absentee ballot on a form requiring their signature. This is to allow a crosscheck of the signatures for security reasons and ballot integrity.

The change in Section 5, page 7, line 9, makes it clear that the printed statement on the envelope returning the absentee ballot is a voter's affidavit. Therefore, subsection 3 in that section of law is being eliminated because it duplicates the affidavit requirement in subsection 2.

Section 6 allows the expanded use of a federal write-in ballot, which is a recommendation of the Federal Voting Assistance Program.

Section 7 updates text to reflect new ballot processing procedures and provides that any rejected ballots are given to the county canvassing board for final determination of eligibility.

On page 3, beginning on line 15, the words "Uniformed and overseas citizens applications and voting" are to be replaced with, "Applications and voting for uniformed citizens – Applications and voting for citizens living outside the United States"

On page 4 of SB 2336 beginning on line 17 everything after the word "may" in subsection 4 is to be replaced with the underlined text beginning with the word "receive."

4. An applicant who is a member of the United States armed forces or the United States merchant-marine living outside the United States or is a gualified elector living outside the United States may apply for and vote by facsimile if otherwise gualified to apply for and vote by absentee ballot. An auditor, clerk, or business manager may send and receive facsimile absentee ballot applications and facsimile absentee ballots to any individual eligible to apply for and vote by facsimile under this section. receive an absentee ballot by mail, facsimile, or electronic mail. In the event that returning the voted ballot by mail is not practicable, gualified electors meeting the stated criteria of this subsection may return a voted ballot and other required documents to the county auditor by means of facsimile transmission or electronic mail. To return a voted ballot and other required documents by electronic mail, the eligible voter must have access to the technology to scan the documents, save them in a secure format approved by the secretary of state, and return them as an electronic mail attachment directly to the electronic mail address assigned by the auditor, clerk, or business manager for that purpose prior to midnight in the voter's county of residence on the day before the election. The secretary of state shall develop written guidelines relating to security measures for voted ballots returned by electronic mail.

The following is a clean version of how subsection 4 would read if the amendment is passed:



In the event that returning the voted ballot by mail is not practicable, qualified electors meeting the stated criteria of this subsection may return a voted ballot and other required documents to the county auditor by means of facsimile transmission or electronic mail. To return a voted ballot and other required documents by electronic mail, the eligible voter must have access to the technology to scan the documents, save them in a secure format approved by the secretary of state, and return them as an electronic mail attachment directly to the electronic mail address assigned by the auditor, clerk, or business manager for that purpose prior to midnight in the voter's county of residence on the day before the election. The secretary of state shall develop written guidelines relating to security measures for voted ballots returned by electronic mail.



On page 6, beginning at line 11, the following underlined words are to be added to subsection 3:

3. The application for a qualified elector living outside the United States must include a facsimile telephone number <u>or electronic mail address</u> if the voter desires to vote by facsimile <u>or electronic mail</u>.

RE: SB 2336 - Absentee Voting

During the 2004 General Election, several of the state's county election officials and the Secretary of State's office received a number of requests for absentee ballots from United States citizens who had lived in North Dakota immediately prior to leaving the country. In some circumstances, individuals wanting to vote had lived in Canada for 30 plus years and yet retained their United States citizenship.

Under federal and state law, an individual who retains his or her citizenship is eligible to vote in federal elections. However, under current North Dakota law, many of these same individuals (even though they had not been residents of the state for many years) are also eligible to vote the entire ballot including statewide, district level, local offices, and measures.

The Senate removed the language from the bill that would have limited the voting rights to only federal offices for those individuals who have lived away from North Dakota and the United States for a period of more than four years. At our request, the Senate also added text that was needed to provide clarity and procedural continuity with other sections of the bill.

Since the action by the Senate, we realized their amendment might cause confusion between the remaining subsections 1 and 2 in N.D.C.C. § 16.1-07-01(1). Therefore, I am offering an amendment, which we believe will clarify the distinction between the two subdivisions.

The overseas deployment of North Dakota's Guard and Reserve troops created a challenge during the 2004 election cycle. Although the facsimile transmission of election information and ballots has been allowed under North Dakota law since 1991 for uniformed and other qualified electors living outside of the Untied States, it was quickly learned that newer technology had made the fax machine an obsolete piece of equipment in war zones. Therefore, in Section 2 of this bill, it allows other electronic options, along with the appropriate safeguards, to be used to transmit election information and ballots.

To provide continuity and additional safeguards, the changes in Section 3 requires additional information from those individuals wishing to vote via facsimile or electronic mail and requires a signature when they apply for an absentee ballot. This allows election workers a means to match the signature on the application with the signature on the affidavit when the ballot is transmitted back to the county election officials.



The change in Section 4, page 6, line 14, makes it clear that the printed statement on the envelope returning the absentee ballot is a voter's affidavit. On page 7, lines 1 through 9 are being deleted because it duplicates the affidavit requirement already covered in subsection 2.

Section 5 allows the expanded use of a federal write-in ballot, which is a recommendation of the Federal Voting Assistance Program.

Section 6 updates text to reflect new ballot processing procedures and provides that any rejected ballots are given to the county canvassing board for final determination of eligibility.
