Minutes:

Chairman Herbel called the meeting to order on HB 1103.

Following people testified in support of HB 1103:

Rep. Meyer: (See attached testimony #1)

Doris Ott, State Librarian of ND: (See attached testimony #2)

Rep. Vonnie Pietsch: Asked which one it would leave out since the change in the law will make 103 out of 104 public library taxing entities eligible for State Aid. I am concerned if it is mine.

Doris Ott: We believe it will be Nelson County that will be ineligible. They have to maintain an average the last three years of a dollar amount that they are to receive; if they fell below that average it makes them ineligible.

Rep. Kim Koppelman asked how libraries were funded and Doris explained it is a formula set by state law. Does it increase all the time or how does that work.

Doris Ott: It started out at full funding, but at the last session they had increased it to a One Million dollars package. So not only did the formula change so it became an 18% increase. It doesn't automatically go up.

Rep. Kim Koppelman: Discussed change that would make it more and more state funding over time. You now budget for every library over the state so if this bill is passes; as long as the local entity, where city or county, over time the local stays the same the difference will probably be made up by the state. Therefore more cost for the libraries is being funded by the state.

Doris Ott: The formula deals with mill levy and also with general fund dollars so local areas could make more of it up from the general fund. The appropriations at the beginning began at 1 million dollars at its inception; over the years it has also decreased. Last session was the very first time there was any increase and it was simply restored to the level at which it started 20 some years ago. So the state does not continue to increase. This bill is trying to make it more equitable so more libraries can qualify.

Kelly Steckler, Legislative Chair for the ND Library Association. (See attached testimony #3).

Beth Postema, Interim Director of the Fargo Public Library: (See attached testimony #4)

Rep. William Kretschmar: How much in dollars did the Fargo library get last year?

Beth Postema: It got approximately \$100,000 and \$204,000 and we typically got \$51,000 or \$52,000.

Bonnie Krenz, Library Director for Griggs County Public Library: (See attached testimony #5)

Jerry Kaup, Minot Public Library Board: (See attached testimony #6).

Rep. Kim Koppelman: On the second item of the bill; lines 14-18 under section 1 it appears by reading that some cities may still be under that and you could go through the vote of the people to change the mill levy. More discussion on mill levy.

Kirsten Baesler, President of the Mandan Public Library board of Trustees: (See attached testimony #7).

Tom Jones, Director, Bismarck Veterans Memorial Public Library: (See attached testimony #8). Want rural areas to get aid to keep those libraries.

Chairman Herbel I think it is also very noble that people who are getting excess funds because the others weren't eligible to come in and testify and say we are willing to give up these funds. It doesn't work that way in education. I am going to support it.

Minutes:

Chairman Cook called the committee to order. Four members present and one missing.

Chairman Cook opened the hearing on HB 1103 relating to public libraries' maintenance of local effort in order to receive state aid/relating to public libraries' maintenance of local effort in order to receive state aid.

Representative Shirley Meyer, District 36, Dickinson, ND introduced and testified in support of HB 1103. (Attachment #1) This bill changes the maintenance of effort part of the state aid to public libraries' law. It changes the requirement of the public library from having their mill levy be equal to or greater than the average in the last three years to having their appropriation in dollars derived from that mill levy equal or greater than the average of the last three years.

The purpose of this law is to make local communities maintain their support for library services. If a community is maintaining their dollars for their library they are meeting this purpose. The maintenance of efforts part of this law has been interpreted this way since its conception in 1979 to 2005. In 2006 the state auditor and the attorney general ruled that the law was being misinterpreted and as a result in 2006 only fifty seven public libraries were eligible for grants under this new interpretation. HB 1103 will change the law back to how it was previously

interpreted making most of the public libraries once again eligible for the state aid public library grant.

Doris Ott, State Librarian of ND testified in support of HB 1103. (Attachment # 2)

Kelly Steckler, Legislative Chair for the North Dakota Library Association and Director of the Mandan Public Library testified in support of HB1103. (Attachment #3)

HB 1103 changes the Maintenance of Effort part of the State aid to Public Libraries law. It changes the requirement of the Public Library from having their mill levy being equal to, or greater than the average of the last three years, to having their appropriation, in dollars, derived from the mill levy equal or greater than the average of the last three years.

The purpose of this law is to make local communities maintain their support for library services. If a community is maintaining the dollars for their library they are meeting this purpose.

The Maintenance of Effort part of this law has been interpreted this way since its inception in 1979 to 2005. My name is Kelly Steckler and I am the Legislative Chair for the North Dakota Library Association. I am also Director of the Mandan Public Library. I am here in support of HB1103, which changes the Maintenance of Local Effort part of the State Aid to Public Libraries law 54-24.2-02.2.

At its annual conference in September, the North Dakota Library Association drafted a resolution supporting this change in law. It reads:

WHEREAS, ND public libraries serve local citizens throughout the state;

WHEREAS, Public Library State Aid dollars are an essential part of the financial support of local library budgets;



My name is Beth Postema and I am the Interim Director of the Fargo Public Library, and I also currently serve as the President of the North Dakota Library Association. In both of these roles, I fully support the passage of House Bill 1103.

On behalf of the entire membership of the North Dakota Library Association, I would like to take this opportunity to convey the membership's full support of this bill. The North Dakota Library Association celebrated its centennial this past September. Throughout its first century and as it enters its second, the North Dakota Library Association's mission is to support and promote library services and librarianship throughout North Dakota. NDLA's membership, which includes over 300 individuals from all types of libraries, unanimously passed a resolution endorsing legislation that would address the situation that the State Librarian has outlined. House Bill 1103 which lies before you does just what NDLA's resolution supports. It reinstates a more equitable method of distributing the current State Aid appropriation. You will hear more from other librarians on just how important the State Aid dollars are to the communities they serve and how deep the impact was in this past year when libraries in 47 communities were declared ineligible for State Aid funds. The library community throughout the state is fully behind House Bill 1103.

In my other role as director of the Fargo Public Library, I also support this bill. Last year, the Fargo Public Library received additional State Aid dollars in comparison with previous years due to so many public libraries being declared ineligible. However, this is not a situation that the Fargo Public Library Board of Directors and administration wish to have continued. It is in the best interest of our library to have healthy, vital libraries throughout the state of North Dakota.

House Bill 1103 will assist in maintaining vital libraries across North Dakota. It recognizes that those communities, which despite tough financial circumstances have maintained a commitment to their local libraries in either real dollars or in maintaining the mill levy, are deserving of state support. Dear Chairperson and Members of the Committee:

My name is Bonnie Krenz and I am the Library Director for the Griggs County Public Library, a small rural library in Cooperstown. I am here in support of HB1103.

State Aid to Public Libraries changes dramatically this year due to a new interpretation of the State Aid Maintenance of Local Effort Law, NDCC 54-24.2-04 by the North Dakota Auditor's Office and the Attorney General's office. HB 1103 will allow State Aid to be distributed to libraries that maintain either their mill levy or the number of dollars generated by that mill above their three year average, instead of the present requirement of maintaining both their mill levy and the number of dollars generated by that mill levy.

Without the dollars our library receives through State Aid, programs or services would need to be removed. State Aid is approximately 10% of our tax-generated funds. If the law is not changed the Griggs County Public Library would not receive their State Aid this year, as our mill levy of 4.07 is lower than the three year average while the actually dollars we were levied was above our three year average.

The 10% cut in revenue would cause the Griggs County Public Library to cut back in many areas, while causing extreme hardship in two areas of service within our library. The first area would be in the audio books supply. The cost of books has risen in the past



years faster than the increase we have received in our budget dollars which does not allow us to expand our purchasing power. It is through the State Aid dollars that we are able to provide our patrons with audio material. The use of audio material has increased by 35% over this last year while the use of books by all facets of our community has remained level. Those who need to commute to other towns for work, those who are exercising, and our aging members who now find it harder to read are using audio books. There are patrons who were not readers but have now become readers as well as listeners. We also supply audio books for children to help improve their reading ability. Teachers from our school system have thanked the library for offering this service as they have seen a improvement in their students reading ability. Without the State Aid dollars this area of service would be cut back.

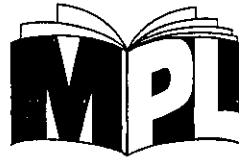
The second use of State Aid dollars is to expand funds for the children's programs in our library such as story time and a mommy and me program during the school year for children ages 5 and under and during the summer months reading programs for children in grades 1 through 8.

The Griggs County Public Library patrons would appreciate your consideration of this change in law, which will distribute the State Aid dollar to libraries in accordance with the original intent of the legislation.

Mr. Chairman and Committee Members:

My name is Jerry Kaup from Minot representing the Minot Public Library Board.

For 26 years the Minot Public Library was eligible for State Aid because State Aid to Public Libraries was awarded based on the meeting one of the following criteria:

- The Library mill levy on the taxable valuation below the average of the preceding fiscal years; or
- Appropriation for public library services below an amount equal to the revenue derived from the maximum mill levy for public library services under section 40-38-02.

When the legislation was developed for submission to the 1979 Legislature it was the intent of those developing the statute that a public library would have to meet just one of the criteria and not both. If the value of a mill increases by 8 – 10% it is very likely that the mill would go down since the budget would not increase in a like amount.

As the result of the Attorney General's interpretation that a public library had to meet both criteria, the Minot Public Library was ineligible even though the dollars appropriated increased 6% each year in 2005 and 2006. The shortfall in funding was \$26,000 each year. In order to avoid depleting the cash fund the Library reduced its 2006 budget accounts for books, online databases and equipment by \$33,000.

The Minot Public Library Board supports the proposed changes in the Maintenance of Local Effort part of State Aid to Public Libraries 54-24.2-02.2 and encourages passage so that 47 libraries will have state aid restored. Thank you for your consideration.

Dear Chairperson and Members of the Committee:

My name is Kirsten Baesler and I am the President of the Mandan Public Library Board of Trustees. I am here in support of HB1103, which changes the Maintenance of Local Effort part of the State Aid to Public Libraries law 54-24.2-02.2.

This past year, our Board took it upon ourselves to resolve a thirty-year discussion of merging libraries. In November, a vote of the citizens of Mandan and Morton County overwhelmingly supported a merger of the two libraries. Mandan Public Library and Morton County Library will become the Morton Mandan Public Library by July.

State Aid to Public Libraries significantly affects both of our libraries. By combining resources in to one joint library, we are making better use of our dollars. However, as a combined library, we will be ineligible for over \$20,000 if the Maintenance of Local Effort is not changed back to its original format. State Aid dollars are essential in providing print materials, online licenses in order to offer credible Internet resources which are not free of charge, kids' programming, and bookmobile services for rural residents.

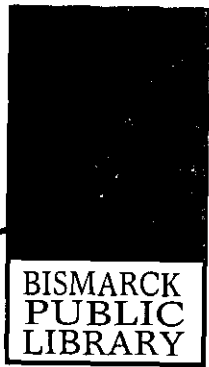

Members of the Committee:

I urge support of this bill which amends the original statute.

Bismarck Veterans Memorial Public Library, serving Bismarck and Burleigh County, was not eligible to receive the city-portion of state aid dollars (about \$40,000) in fiscal year 2006. While local dollars appropriated for the Library had increased, the actual mill levy had been reduced (due to growth in mill valuation).

By addressing dollars appropriated for library service, instead of mills levied, this proposed change would enable the State Library to distribute state aid dollars to eligible local public libraries as has been done for the past 25 years. My name is Kelly Steckler and I am the Legislative Chair for the North Dakota Library Association. I am also Director of the Mandan Public Library. I am here in support of HB1103, which changes the Maintenance of Local Effort part of the State Aid to Public Libraries law 54-24.2-02.2.

At its annual conference in September, the North Dakota Library Association drafted a resolution encouraging legislation to reinstate an equitable State Aid formula, worded correctly to distribute state dollars in accordance with the original intent of the legislation.

Public libraries across the state use these dollars to continue to purchase print materials. The cost of print material has increased dramatically at a higher rate than overall cost of living expenses. Therefore, every State Aid dollar is essential in the financial plan.

The Mandan Public Library moved in to a new location three years ago. Since that move, library usage has increased dramatically. We are proud to state that our patron count has doubled since the move and our circulation of print materials has increased by a rate of 25%. This means that our citizens are utilizing our library and we must maintain financial support in order to serve them at such a capacity.

NDLA would appreciate your consideration of this change in law, which would restore necessary funding.

HB 1103 Maintenance of Local Effort
State Aid to Public Libraries

Chairman Cook and Committee Members:

My name is Jerry Kaup, Director of the Minot Public Library, representing the Library Board in support of HB 1103. For 26 years the Minot Public Library was eligible for State Aid because State Aid to Public Libraries was awarded based on the meeting one of the following criteria:

- The Library mill levy on the taxable valuation did not fall below the average of the preceding three fiscal years; or
- The Appropriation for public library services did not fall below an amount equal to the revenue derived from the maximum mill levy for public library services under section 40-38-02.

When the legislation was developed for submission to the 1979 Legislature it was the intent of those developing the statute that a public library would have to meet just one of the criteria and not both. If the value of a mill increases by 8 – 10% it is very likely that the mill will go down since the budget will not increase in a like amount.

As the result of the Attorney General's interpretation that a public library had to meet both criteria, the Minot Public Library was ineligible even though the dollars appropriated increased 6% each year in 2005 and 2006. The shortfall in funding was \$26,000 each year. In order to avoid depleting the cash fund the Library reduced its 2006 budget accounts for books, online databases and equipment by \$33,000.

The Minot Public Library Board supports the proposed changes in the Maintenance of Local Effort section of State Aid to Public Libraries (54-24.2-02.2). This change will restore state aid to 47 libraries. Thank you for your consideration of HB 1103.

Chairman Cook:
Members of the Committee:

I urge support for this bill which amends the original statute.

Bismarck Veterans Memorial Public Library, serving Bismarck and Burleigh County, was not eligible to receive the city-portion of state aid dollars (about \$40,000) in fiscal year 2006. While local dollars appropriated for the Library had increased, the actual mill levy had been reduced (due to growth in mill valuation).

By addressing dollars appropriated for library service, instead of mills levied, this proposed change would enable the State Library to distribute state aid dollars to eligible local public libraries as has been done for the past 25 years. This bill will address the concern raised by the State Auditor and the Attorney General.
