WORKFORCE SAFETY & INSURANCE 2007 LEGISLATION SUMMARY OF ACTUARIAL INFORMATION

BILL NO: HB 1204

BILL DESCRIPTION: Presumption Clause—Volunteer Firefighters

SUMMARY OF ACTUARIAL INFORMATION: Workforce Safety & Insurance, together with its actuary, Glenn Evans of Pacific Actuarial Consultants, has reviewed the legislation proposed in this bill in conformance with Section 54-03-25 of the North Dakota Century Code.

The proposed legislation extends the presumption of compensability for certain conditions to volunteer firefighters.

FISCAL IMPACT: We do not have access to sufficient data to permit a comprehensive evaluation of the potential rate level and reserve impact of this proposed legislation. However, WSI anticipates that, if passed in its present form, the legislation will act to increase costs, possibly by a material amount, for class 7710, which is used in establishing premiums for coverage provided to volunteer firefighters. To the extent that such costs increase, local governmental entities could be faced with higher workers compensation premiums. The cost of such increases, if any, may in turn, be passed on to the community at large.

We cannot definitively predict how the claims environment may change under the proposed legislation. But, we believe that the exposure to loss presented by the proposed change could differ from that associated with paid firefighters. We understand that traditional fire fighting units have stringent standards regarding pre-employment screening, on-going health standards, training and equipment. We have no way to evaluate the degree to which such standards may differ for volunteer organizations, or the degree to which any difference that may exist would influence the cost of expanding coverage.

2007 House Bill No. 1204 Testimony before the House Industry, Business and Labor Committee Presented by: Tim Wahlin, Staff Counsel Workforce Safety and Insurance January 29, 2007

Mr. Chairman and Members of the Committee:

My name is Tim Wahlin and I am Staff Counsel with Workforce Safety and Insurance (WSI). WSI's Board of Directors has taken a neutral stance on HB 1204.

This bill seeks expansion of the class of employees eligible for coverage under a presumption clause contained in N.D.C.C. 65-01-15.1. Normally, an injured employee is required to prove that the injury arose out of and was sustained in the course of employment. However, the presumption clause <u>presumes</u> certain conditions found in law enforcement officers and <u>full-time</u> <u>paid firefighters</u> were caused by their employment and the burden of proof is placed on WSI and the employer to prove it was not. In other words, these conditions are presumed to be attributable to their employment unless WSI can prove they are not.

The conditions presumed compensable include lung or respiratory diseases, hypertension, heart disease, or exposure to blood borne pathogens. For full-time paid firefighters, it also includes occupational cancers which arise out of exposure to smoke, fumes, or carcinogenic, poisonous, toxic, or chemical substances while performing their duties.

HB 1204 seeks to expand the presumption clause to include not only <u>full-time paid firefighters</u>, but <u>volunteer firefighters</u> as well. Volunteer firefighters are currently covered by WSI in the same way other workers in North Dakota are covered. To the extent volunteer firefighters are injured in a work-related accident, they are entitled to the same benefits as other injured employees in North Dakota.

WSI believes it is important to point out that in order to qualify for the presumption, a full-time paid firefighter is required to undergo periodic medical examinations which are paid for by the employer. Additionally, the rates paid for this coverage by the employers of the full-time paid firefighter are substantially larger than those paid for volunteer firefighters.

Rates for volunteer firefighter coverage are charged differently than for every other rate class. Traditionally, rates are developed based on the risk the employment presents, the employer's loss history, and the payroll dollars generated. This mode of charging for risk is not available when the workforce is not paid. As a result, rates for volunteer firefighters are based upon the population of the fire district which they serve. Currently, the volunteer fire departments are supported by local and other taxes.

As noted previously, WSI's Board has taken a neutral position on this bill. Consequently, the following cost data is being provided for no other purpose than to assure that you are aware of the potential cost of any decision.

In 2006, North Dakota insured all of its volunteer fire districts for \$175,732. The total number of volunteer firefighters is unknown because the fire districts are not required to report each person to WSI and because volunteer fire districts have the power to designate citizens on the spot to assist when and/or where needed. Thus, in order to form a cost estimate, WSI relied on the U.S. Department of Homeland Security's website for U.S. Fire Administration Census data. Based on this reported data, North Dakota has 6,802 volunteer firefighters. (NOTE: A number of districts did not report their data.)

Even with this conservative estimate, North Dakota pays on average \$25.84 per volunteer firefighter per year to offer its coverage. A comparable base rate for one full-time paid firefighter would be \$1,784 a year –not including the cost of the required physical. If this cost structure was extrapolated to just the volunteer firefighters, the premium payments would rise from \$175,732 to more than \$12.1 million per year.
