Chairman Senator J. Lee opened the hearing on HB 1313 relating to criminal background checks for dentists and powers of the board of dental examiners; and relating to the regulation of dentists and dental assistants.

Representative Jim Kasper (District #46) introduced HB 1313 at the request of the dental association. He briefly highlighted each section. Section 9 is an important section being added dealing with criminal history and background checks. Section 14 is also a new section dealing with duty to report criminal behavior and activities.

Senator Warner asked Rep. Kasper to address section 14 and asked if this is the main

monitoring program for all the medical professions (meter 03:20).

Rep. Kasper stated that area will be addressed by Rita Sommers.

Rita Sommers (Executive Director, ND State Board of Dental Examiners) testified in favor of

HB 1313. She explained that the changes are minor. See attached testimony #1.

Senator Warner asked if there was a penalty for not reporting or if it is discretionary whether the board would choose to enforce any sanctions.

Modifications made to Chapter 43-28 and 43-20 do not challenge or change the meaning of the language that is in place. However these changes attempt to clarify or improve language that is in place. Many alterations would be considered "housekeeping" changes. The following modifications reflect situations the board has recently been engaged in.

Continuing education (page 4, number 4) is required for renewal of the dental, dental hygiene and dental assistant registration. With this amendment, a visiting (out of state) dentist or hygienist would be allowed to <u>participate</u> in a continuing education course held in North Dakota without holding a North Dakota license to practice dentistry. The participant would still be required to hold a license from another state. Some syllabi require the dentist to have "hands on" experience within the itinerary of a continuing education course. Patients may be involved to

demonstrate new techniques or procedures. It would be impractical to hold licenses in every state where continuing education was offered.

- <u>By changing the per diem</u> (bottom of page 5) amount to one established by the board, as many other statues do (medical examiners, optometry, nursing, abstractors, chiropractors, accountants, etc.) the statute allows the Board to modestly compensate the members as their budget permits in accordance with the duration and location of the examiners duties. Mileage is provided in section 54-06-09.
- The NDSBDE has addressed the <u>advertising</u> (page 9, number 10) issue on several occasions. This is an effort to make the statute more concise as it relates to public perception.

Dentist, scope of practice; (page 6 Section 10) Licensees may not perform any procedures for which appropriate credentials have not been provided to the NDSBDE. Many states recognize dental specialties in either their statutes or regulations, and base their definition of dentistry to encompass a broader scope of dentistry for specialists within the licensing process for state boards of dentistry. North Dakota, however, grants the same dental license to all qualified applicants and does not identify dental specialists. As an example, the scope of dental practice for the oral surgeon is much broader than that of the general dentist. The extended training and education is advanced 4 to 5 years following a general dentist's education. However, in North Dakota an oral surgeon receives the same license to practice dentistry as a general dentist or an orthodontist, or an endodontist, etc. The proposed scope of practice allows the Board of dentistry to recognize the advanced training received by any licensed dentist. The NDSBDE would be authorized to correlate during the process of licensure the level of dental education with the appropriate scope of practice. This amendment protects the public by addressing the fact that only those with

appropriate advanced education and training may announce as having such in areas of specialty treatment recognized by the NDSBDE.



<u>Definition, dentist;</u> (page 3, number 4) HB 1313 provides a definition for dentist, which previously was not addressed in administrative rule or statute. The definition relates to scope of practice in the fact that a person may not "practice dentistry" in this state unless that person is a dentist.

<u>Reporting</u>; Reporting statute (page 8-9, Section 14) encompasses a variety of issues that may affect a practitioner's ability to serve the public. Many lawsuits settled out of court where injury or harm has occurred may not otherwise become apparent to the licensing board particularly in instances of out of state licensees or applicants. Reporting does not require the board to take action against a licensee. Reporting allows the board to determine if any action is necessary.

Intent of HB 1313; protect the public by establishing statutory changes that have not been in existence and maintaining the statute that is in existence with minor modifications. The dental board has a unique perspective and thus a responsibility to make those additions and modifications, which reflect the ongoing activity of the Board and it's licensees, with the goal of public protection in mind.
