CHAIRMAN JOHNSON: Committee Members, we will open on HB 1341.

Representative Griffin would you like to start.

REPRESENTIVE GRIFFIN: House Bill 1341 is another bill I introduced. The bill would expand the scope of Agriculture disaster payments. In 1994 these programs were expanded. Currently the program is administered in ND can only be used if the farmer involved is in a dispute. They would like to expand it for some other purposes. One of them is rural housing issues.

The fiscal note on HB 1341 increases from fifty dollars to seventy five dollars.

I ask for your support on HB 1341.

TOM SILBERNAGEL: I am the Administrator for the ND Agriculture Mediation

Service. I am here today to support HB 1341, which will allow the Agriculture

Mediation Service to assist all ND citizens adversely affected by decisions of the

Have now and USDA paid me for my Map insurance and they have been doing that for years. All of A sudden this now two week ago the FFA representative called me and Rod, I got a notice from the head office they changed the rules and regulations and said they were going to pay us at a lesser rate. I said wait a minute, I have already got my money and spent it. There is going to be a lot of them are going to be effected.

My question is so by coming to you, you could help.

TOM: FFA will participate in mediation if a producer requests it.

REPRESENTATIVE FROELICH: So we get the mediation, does that preclude, say we can't come to an agreement, that doesn't stop me from going to court?

TOM: No it does not. Mediation over the years has been since 1989. We have a very high success rate.

REPRESENTATIVE FROELICH: Just for the committees information, the reason

I brought this up is USDA is changing the rules on land that I lease. The state does not get much of a payment on that. The land I own remains the same. It is ironic that a land owner, which one quarter is adjoined to another, is going to have a different situation.

CHAIRMAN JOHNSON: Representative Mueller, thank you Mr. Chairman.

REPRESENTATIVE MUELLER: It would seem that you are expanding the rolls of mediation in a pretty significant way. The question that I have is, do you have folks on board that are going to know about crop insurance conservation lesues, wet land seems like my question is, what do you know about this stuff?

TOM: We have a very experienced field staff that knows how to do the research. We never know when we step in to a financial problem; we never know what we are going to

be dealing with. Many times it could end up a family dispute as part of a program issue

with FFA. We are used to dealing with the unknown. We have done extensive training with FFA and other state programs, probably more then any other agency.

CHAIRMAN JOHNSON: Are there any other issues that are waiting out there?

TOM: Well, you know it would remove the uncertainty. Over the years there have been instances that I mentioned in he testimony where it has been difficult to determine whether we could really help the individual. This would remove the doubt. An example would be rural development homes. Rural housing loans, you might have a farmer that goes out to the farm and has a rural development loan. If he runs into trouble with that, technically he is not a farmer any more. Changing this allow to help him.

REPRESENTATIVE FROELICH: If you don't come to a conclusion with USDA now I go to an attorney and have to go through the legal system. Are you allowed, under statues to help us?

TOM: We are allowed to help you in preparation.

CHAIRMAN JOHNSON: Other to offer support for HB 1341?

WOODIE BARTH: I serve as the president of the credit review board and us. Six on the board voted for this. We support the changes to the laws presented to you. We think the expansion of mediation in the USDA program, this should have been done right after the federal rules were changed the law to help out in other USDA. I would like to add a couple comments as to what Tom said about the question Rep. Mueller asked. Mediators are certified. They go through 40 hours of training on a yearly basis, and every two years at UND. I have been part of some of these seminars, they are intense. Mediators are people the neutral third party; that help assemble the information. Bring it to the table, to assist the party that needs assisting, process that has been developed.

It works well, and we have had great success. Over 80% success and people that is happy with the results. They might not always win but it brings to resolution. If a farmer has a problem with zoning, we are allowed to help could we resolve it, I don't know but the farmers would come to mediation and where it would end up I guess we would find out. According to law if a farmer is having a problem we are allowed to help them.

Rep ?: How many cases are you guys handling on the average?

TOM: It would be difficult for me to say, I don't have the numbers with me right

Now but I can tell you there has been a significant increase July 2006 over 2005. The

numbers of assistances has scaled down as the numbers of farmers have scaled down.

If we stop one Suicide it is worth it. We are dealing with larger farmers and with different kinds of problems.

TOM: Mr. Chairman, I would like to make a comment. We have worked with Over ten thousand farmers since the inception of this program. Right now We have from eight to twelve farmers a month. Those are brand new farmers and ranchers. They have never used this program before.

REPRESENTATIVE BOE: What is the cost for this service?

WOODIE BARTH: It is \$15.00 per hour for negotiation services plus a \$25.00 Fee for mediation services. If a farmer can't pay we still do the work. We could handle a group for mediation. Some of the fees can be waved and all of it is kept confidential.

CHAIRMAN JOHNSON: Other to offer support. Others as to opposition?

REPRESENTATIVE Froelich made a motion for a Do Pass.

REPRESENTATIVE BRANDENBURG: seconded the motion.

The bill expands the authority of the agricultural mediation service to provide mediation services to USDA customers who are not farmers as defined under current law.

The bill increases the per diem for credit review board members.

The mediation services expansion is anticipated to slightly increase the number of mediation cases resulting in both increased revenues and expenditures. The fiscal impact is based on an estimated additional 20 mediation cases per biennium.

The increased per diem for credit review board members will increase the total per diem expenses.

Sen. Flakoll opened the hearing on HB 1341, a bill relating to persons eligible for mediation.

Members (6) present, absent (1)- Sen. Taylor.

Rep. Griffin, district 19, testified in favor of the bill.

Rep. Griffin- This bill was introduced at the request of the Ag department, the Ag department can explain more in detail the other programs and such.

Tom Silbernagel, Agriculture Department, testified in favor of the bill. See attached testimony.

Sen. Flakoll- when was last time there was an increase in the per diem?

Tom Silbernagel- I am not sure, I think that this is probably the first change.

Sen. Behm- how long does it for someone to go through a program to learn all of this?

Tom Silbernagel- we have training every year, we are certified mediators trained by UND.

We are required to provide that training by federal grant. We also provide yearly financial

training so that they understand how to deal with the financial disputes, how to restructure. We

do a lot of work with FSA and their program.

Sen. Erbele- how many mediators do you have and do you have enough?

Tom Silbernagel- right now we have 6 field staff and 3 of them are full time. We have been able to handle things so far but in the last 10 months we have seen almost a 100% increase in clients. We have asked permission and received it from the credit review board to allow mediators to move across the state and we found that to be an economical way to do that.

Sen. Flakell- these people that are mediators, do they normally work on an per hour basis?

Sen. Flakoll- these people that are mediators, do they normally work on an per hour basis?

Tom Silbernagel- yes they do.

Sen. Flakoll- do you track what their normal hourly rate might be?

Tom Silbernagel- yes we do and it varies according to skill level, but most of them would be around \$15-16 per hour.

Woody Barth, NDFU, testified in favor of the bill.

Woody Barth- We support the changes of the mediation program as proposed here. There has been some good discussion here, the board supports us moving into other areas. This is probably over due we should have moved on it many years ago. Line 12 pretty much explains who and what we are.

Sen. Erbele- back in the bill where it says mediation participants \$25 per hour, do you pay mileage to these mediators?

Woody Barth- the \$25 per hour refers to what we charge the participants of the mediation. What we pay our people that go to them is a salary plus mileage or else they use state vechicles.

Sen. Heckaman- what happens to these people right now that you are not able to serve or is there someone else that they are getting some assistance with?

Woody Barth- our success rate in mediation is about 80%, that is getting more and more difficult with the conditions out there. The people that we are coming to serve the situations are getting more then what we work with. NDSU and adult farm management are other

avenues and other options would also be the mediation service with farming rented out, work with other areas, work with relatives. There are many options, we look at all of them and look at what is best for that person.
