This bill allows one licensed organization to offer poker on up to 2 occasions per year, at another organization's current site, with approval also needed by the bar owner.

Current law allows raffles to be conducted by a licensed organization on special occasions by another regular organization. This bill adds poker as a game to be played at another licensed organization site. A raffle or poker can be offered if either the raffle or poker is physically separated from the area where a regular organization conducts their games; or with approval from the regular organization and the bar owner, at the same area and time as the regular organization's site.

Niki Wiessman, ND Hospitality Assoc. Spoke in support of the bill (meter 3:38) Any time a bar can enhance there income we are in support. She spoke of types of games and stated that the ND Foundation in Charitable Gaming is also in support of the bill.

I am Representative Gerry Uglem from district 19 (rural Grand Forks county).

My home town of Northwood has a bar that both our Legion Club and our Fire Department use for their poker tournaments. The Fire Department also has pull tab machines in this bar.

When the Legion has a poker tournament, the Fire Department pull tab machines have to be shut down. Present law states "Only one licensed organization that has a permit may conduct games at an authorized site on a day".

This bill allows for an exception so the Fire Department can keep their pull tab machines working on the two evenings a year that the Legion club has their poker tournaments. These are two very busy nights at the bar and our Legion club does not want the Fire Department to loose potential income on these nights. The Legion club requested this bill. The patrons at the bar are also disappointed when the pull tabs are not available.

I understand this conflict has occurred in other communities as well. Lets make it a little easier for these nonporofit organizations to do their fundraising.
