RE: HB 1382 - Filing Dates for County Elections

Both sections of this bill change the applicable timelines from 30 to 60 days before an election.

These changes are being made to establish the same deadline for all elections throughout the Century Code.

Similar timeline changes are included in other election related bills introduced this session.
