**Sen. Flakoll** opened the hearing on HCR 3034, a concurrent resolution directing the Legislative Council to study the feasibility and desirability of eliminating refunds from the potato assessment law. All members (7) were present.

Rep. Johnson, district 15, testified in favor of the bill.

**Rep. Johnson-** we introduced this study resolution because we did not know what the outcome would be on HD 1086.

Sen. Flakoll- is there any language that you think we should add or delete from here.

Rep. Johnson- that would be up to the committee.

Sen. Wanzek- depending what happens to HB 1086 could that reflect on this resolution?

**Rep. Johnson**- I think that whether HB 1086 gets passed or deleted that this resolution is something that the committee may want to look at.

Jack Scott, potato grower, testified in favor of the bill.

**Jack Scott-** I stand here in support of this. This issue needs to be addressed before ND becomes the first of 10 state check off programs to mandate payment. Because this issue is so important to our industry and to ND agriculture and because the potato industry ought to be

given a chance to internally resolve this issue on check offs and the perfect solution is to pass this resolution.

Jim Behrens, potato grower, testified in favor of the bill.

**Jim Behrens**- I have never applied for a refund nor do I plan on it, I stand in support of this resolution so that they can study this issue. Will we work it out in 2 years I am not sure but there are people on both side of the table that are willing to give it a shot.

Craig Steinbeisor, potato grower, testified in favor of the bill.

Craig Steinbeisor- I stand in support of this resolution.

Sen. Taylor- how long have you been growing?

Craig Steinbeisor- this will be my 7<sup>th</sup> crop year.

Cal Rolfson was also present and in favor of the bill.

No opposition to the bill.

Sen. Flakoll calls Duane Maatz to the podium.

Sen. Heckaman- can you tell me how you decide with your budget where it goes and what it is?

**Duane Maatz-** our goal is that we spend 1/3 of our dollars on research we have around a \$500,000 budget.

Sen. Heckaman- in the research who helps decide which way the research money goes?

Duane Maatz- we have a research committee.

Sen. Klein- where does the money come from fro the negotiation portion?

Duane Maatz- we provide that portion of the budget.

Sen. Klein- Is that administration?

Duane Maatz- that comes out of the marketing budget.

Sen. Klein- and so the marketing is what is left of the 30% after administration and research?

**Duane Maatz-** the other portion that we haven't discussed at all is national potato council dues, attendance and such.

**Sen. Taylor**- you have 10 members on the board what type of potatoes does the board grow? **Duane Maatz**- 3 members from Minnesota, 1 in the nw part of the state is a seed grower, 1 that is local to our office is a fresh grower, 1 that is from the Minnesota potato council. On the ND side we have 1 process representative, 1 ND potato council representative, 1 past chairman that is a russet grower from Steele, in the northern part of the valley there is 1 red grower, 1 is a chip potato grower and 2 others that I don't remember.

Sen. Flakoll- but there is no requirement that they have to be from a certain one?

Duane Maatz- no requirement.

Sen. Behm- is the board elected from all of the potato growers?

Duane Maatz- yes.

Sen. Flakoll closed the hearing.

- Page 1, line 2, after "of" insert "addressing the current imbalance in the funding and governance of the North Dakota State Potato Council and of"

Page 1, after line 2, insert:

"WHEREAS, the North Dakota Potato Industry Promotion Act was enacted in 1967 with the specific intent of dividing the state into five districts containing "as nearly equal potato acreage as practicable" with one participating potato grower elected from each district; and

WHEREAS, the potato districts have remained geographically unchanged since 1976, with potato districts 1 through 4 consisting of six counties and district 5 consisting of the remaining 47 counties; and

WHEREAS, currently the majority of North Dakota potato production occurs within the 47 counties of district 5; and"

Page 1, after line 21, insert:

"BE IT FURTHER RESOLVED, that the Legislative Council study the feasibility and desirability of addressing the current imbalance of representation in and funding of the North Dakota State Potato Council and the expenditure of checkoff funds by the council and the associations supported by potato checkoff funds; and"
