Chairman DeKrey: We will open the hearing on HCR 3048.

Rep. Mary Ekstrom: Sponsor, explained the bill (see attached testimony).

Rep. Delmore: Are you mainly hearing from medical people or from constituents.

Rep. Mary Ekstrom: Bonnie Palacek is here to address that issue. She brought the matter to my attention initially and then in testimony, this fund is presently handled by the DOCR. If you remember a few years back, it was under Workforce Safety at that time. It was transferred to the DOCR and it's always been the poor stepchild. It has never adequately funded by the state. From what I'm hearing, there are some federal dollars, not as many as there used to be. But there are some more federal dollars that we can access.

Rep. Onstad: How are you using the funds, but I will wait to ask Bonnie Palacek.

Chairman DeKrey: Thank you. Further testimony in support.

Charles Placek, Program Manager, DOCR, Field Services Division: (see attached testimony).

Rep. Delmore: How much money could we match all the dollars that we would put in to state and federal funds. I know we have been coming up short. Would it match up dollar for dollar if we put in \$500,000.

Charles Placek: The match, I believe is 60%. It's two years down the line. So the dollar that you pay today, it matched two years from now. There is a regular formula that you go through. That is one area where we are leaving federal dollars on the table.

Rep. Onstad: Was the \$25,000 for crime event was that set back in 1995, along with the set dollar amount.

Charles Placek: I believe the \$25,000 was set in 1975 when the program was set up. We were one of the most liberal states in the Union as far as the \$25,000 limit. We've got other states that are lower and some that are higher. It is \$25,000 per crime event and then we've got a \$3,000 burial amount.

Rep. Onstad: Is this just for individuals or families participating in this fund, has that stayed the same, or increased every year.

Charles Placek: Prior to the DOCR handling this matter, there was always left over funding. I believe we've done a good job in the DOC of notifying people that the fund exists, as a result the number of approved applications has gone up. I think we can all agree, also, that health care costs have gone up substantially since 1993. So it's a combination of increased applications coupled with increased costs. Along with that, we are seeing a lot more trauma to the head, so anytime you get trauma there, you get rather big medical bills.

Rep. Charging: What did Appropriations say about this money. If we pass this, it will kick it back to Appropriations again.

Charles Placek: It is my understanding that the Appropriations committee did allow for...

Rep. Ekstrom: There was a balance left in a fund, about \$584,000 sitting in a fund that they could not access for programs. What we did was transfer that amount over to the CVC fund to try and get this fund solvent this time through. It's a start, but we're still going to have a shortfall this biennium. I feel certain that we will be in a deficit position when we come back. I

Good morning Mr. Chairman and members of the House Judiciary Committee. For the record, my name is Mary Ekstrom. I represent District 11 in Fargo.

I introduced HCR 3048 to address a serious problem with the Crime Victims Compensation Fund.

While serving on the Appropriations Committee this session, I received testimony that the Crime Victims Compensation Fund was being mismanaged because the State has not adequately funded the program.

At the beginning of each new fiscal year the fund is paying off its outstanding debts and then, quite literally, the rest of the bills are put into a file drawer until the fund is replenished at the start of the next fiscal year.

The fund presently owes some \$400,000 in 1811s that are due from last September! I don't think that this is acceptable.

Much of this money is owed to medical providers who have given treatment to crime victims. It is an added insult that the doctors, clinics and hospitals have already discounted their bills by 20% as required by statute and then they are required to wait for months to be paid. We start each new biennium in a deficit position. I tried to catch the fund up this year but was unsuccessful. Maybe we can fix it in the Senate.

Additionally, because of our under funding, we are leaving federal matching dollars on the table.

This study would put all of the stakeholders at the table to discuss how to do this correctly. Surely, other states have figured this out.

I respectfully, request a DO PASS for HCR 3048 and I will try to answer your questions.

Good morning Mr. Chairman and members of the committee. For the record, my name is Charles Placek. I am a program manager for the ND Department of Corrections (DOCR), Field Services Division. It is my understanding that HCR 3048 was introduced following our division testimony before the House Appropriation's Committee. The DOCR welcomes the proposed study of the State's Crime Victims Compensation CVC program. In 1993, with the reorganization of the former Workers Compensation Bureau, the CVC program was transferred to the DOCR. The funding for the CVC program has not changed since it was transferred to the DOCR. It is set at \$426,403.

The CVC program is the payer of last resort for victims of violent crime in North Dakota. By law we will pay up to \$25,000 per crime event. Starting in 1995 we asked medical vendors to accept 80% of their billed amount and consider the bill paid in full. Most medical providers of this state have accepted our request.

In this current biennium, we estimated the CVC program will be deficit by approximately \$500,000. We have not paid any bills to our major medical vendors since the end of September 2006.

The federal fund allocation is set on a formula that reflects state effort. The more we expend using state dollars, the more the federal government provides two years from now.

Many states have developed dedicated revenues sources to fund their own state's CVC program. I believe we need to study the options that would work best in North Dakota to develop a strategy that will fund and meet the needs for the State of North Dakota. The DOCR supports HCR 3048.

Testimony on HCR 3048



Chair DeKrey and Members of the Committee:

My name is Bonnie Palecek and I am speaking on behalf of the ND Council on Abused Women's Services/Coalition Against Sexual Assault in ND. I am here to express grave concerns about the viability of the ND Crime Victims' Compensation Fund (CVCF). As victims' advocates we are out of patience with the Fund's operating in the red for the last ten years, and frankly out of faith that the situation will be fixed. If we are to salvage this fund for victims of violent crimes in ND, it is urgent we study its solvency.

As you know, the Crime Victims Compensation Fund is a Fund which compensates victims of violent crime for damages they have experienced as the result of violent crime. For example, it reimburses medical expenses for victims of domestic violence, funeral expenses for a victim of homicide, forensic and medical expenses for a child sexual abuse victim.

The Fund is a payer of last resort. Insurance must be billed first. Funds to any individual are capped at \$25,000 per violent crime. Funeral expenses are capped at \$3,000. In addition to compensating for physical damages, the Fund can also reimburse for counseling services. The intent is to "make the victim whole," at least insofar as monetary reimbursement can do that.

The funding mechanism is such that the federal government portion is based on what the state has spent in a previous year. The state is compensated at a rate of 60% of the state's expenditures, two years previous.

The Fund has been a godsend to victims of violent crime in North Dakota and in 49 other states. In North Dakota claims are considered in a timely manner, and there seems to be an efficient and effective base of collaboration between law enforcement, the advocacy network, and the Department of Correction's Crime Victims' Compensation administrator. A number of years ago, the fund was languishing, but with the move to the Department of Corrections and renewed collaboration with the advocacy community, it became a viable resource.

Here is the problem, however. The Fund has not been operating in the black for at least the last four bienniums, and things are getting worse. Right now, CVCF is almost a year behind in reimbursing service providers and victims. Rates to providers are already reimbursed at 80% of the going rate (for example to hospitals or therapists). In addition to that contribution, however, providers now have to wait nearly a year for their 80%

reimbursement. Some small private providers such as private practice therapists, are being stretched thin and may not be able to carry bills for an extended period of time much longer. Payments are so far behind, in fact, that the word is out that the Fund no longer exists, (which isn't true), and I have had to clarify its existence with those in our own network of domestic violence and sexual assault advocates.

We have been told that for this biennium money has again been "found", on a one time basis, to cover the deficit this biennium. We need a more solid fix. Applications for the Fund have grown from 142 applications for assistance in 1997 to 224 in 2005 to 302 in 2006. However, no additional funding has been added, with the result that the Fund goes deeper and deeper into deficit spending each biennium. This is no way to do business, and it is doing a real disservice to victims. In fact, North Dakota's allocation has been dropping since 2003, which sets an ominous tone for the future as we spend less and less. To illustrate, in 2003 our allocation was \$135,000, in 2004, \$98,000, and in 2005, just \$86,000. We are losing our leverage for the federal dollars.

Claims for domestic violence assaults account for 6.34% of the total Fund expenditures; domestic violence homicides, 1.90%, and sexual assault, 5.23%. "Other" domestic violence and domestic violence sexual assaults account for another 6.32%. The remaining 82% of claims are paid for victims of other violent crimes.

These victims truly have no one to speak for them, and they are among our most vulnerable citizens: victims of drunk drivers, hit and run crimes, physically and sexually abused children, and victims of violence assaults.

We had hoped that this would be the year to establish solvency for the Fund, and we were disappointed that once again no additional funds were included in the Department of Corrections' budget. We are grateful for the short term fix, but cannot stress enough the urgency of developing a solid funding plan to be implemented in the Department's 2009 budget. Thank you for supporting HCR 3048 and bringing us a step closer to resolution of this important issue.

Good morning Mr. Chairman and members of the House Judiciary Committee. For the record, my name is Mary Ekstrom. I represent District 11 in Fargo.

I introduced HCR 3048 to address a serious problem with the Crime Victims Compensation Fund.

While serving on the Appropriations Committee this session, I received testimony that the Crime Victims Compensation Fund was being mismanaged because the State has not adequately funded the program. Let me state again, the reason this fund is being mismanaged is because we, as legislators, have not provided adequate funding. I have the deepest respect for the Department of Corrections and I believe they have been doing the best job they can to manage this properly.

At the beginning of each new fiscal year the fund is paying off its outstanding debts and then, quite literally, the rest of the bills are put into a file drawer until the fund is replenished at the start of the next fiscal year.

The fund presently owes some \$400,000 in fills that are due from last September! I don't think that this is acceptable.

Much of this money is owed to medical providers who have given treatment to crime victims. It is an added insult that the doctors, clinics and hospitals have already discounted their bills by 20% and then they are required to wait for months to be paid. We start each new biennium in a deficit position. I tried to catch the fund up this year but was unsuccessful. Maybe we can fix it in the Senate.

Additionally, because of our under funding, we are leaving federal matching dollars on the table.

This study would put all of the stakeholders at the table to discuss how to do this correctly. Surely, other states have figured this out.

I respectfully, request a DO PASS for HCR 3048 and I will try to answer your questions.

My name is Vikki Lorenz. I am the director of the Williams County Victim Witness Assistance Program a position I have held for 21 years. I would like to comment on the importance of studying Crime Victims Compensation funding.

The Williams County Victim Witness Assistance Program provides eligible crime victims with applications for Crime Victims Compensation. While we are unable to make a victim emotionally whole, we can at least try to make them financially whole. A way of doing that is through Crime Victims Compensation. Currently I am working with 2 victims of crime whose livelihood was stripped from them as a result of a criminal action. Both victims severely injured are unable to work and rely on Crime Victims Compensation to provide them with a stipend for economic loss. Crime Victims Compensation ran out of money last fall which means these two victims are struggling to find alternative ways to pay bills for basic living expenses.....food, rent. One person who is an oilfield worker, lost his home and his car. He does not expect CVC to be his only source of income, but it did help to get that check until he is able to return to work.

It is important to have a reliable fund. The interim study which would include a review of other states' efforts which would provide some insight as to how we can do things better for innocent citizens of North Dakota who fall victim to crime. I would urge you to agree to HCR #3048
