Representative Wrangham: I think the title pretty much sums it up. What we're asking here is the study of some possible tax incentives which would be linked directly to the employment of payroll employments in ND. Most if not all States are doing some things to encourage economic development and businesses to locate in our State and this resolution studies incentives which encourage employment in ND. This resolution is targeted to encourage new and current employers to employ within ND to economic development.

Representive Vig: Does this include entrepreneurs as well?

HCR 3057 asks the Legislative Council to study the corporate and individual income tax laws to determine the feasibility and desirability of providing income tax benefits for employers to encourage expansion of employment opportunities in North Dakota.

The objective of legislation which may result from this study would be to encourage business development and increased hiring within the borders of North Dakota. The income tax benefits would result in a positive fiscal impact on state revenues because of offsetting benefits of expanded and improved wages.
