**Chairman Holmberg** opened the hearing at 11:00 am on January 22, 2007 regarding SB 2014 in reference to the appropriation for defraying the expenses of the **Committee** on Protection and Advocacy (PA)

Written Testimony (1) was distributed to the Committee from Jack McDonald, on behalf of The Arc of North Dakota. He was not here to testify.

There was a slight delay in further testimony as the Protection and Advocacy Department had the wrong time on their records for presenting testimony. The Legislative Council hands out a tentative schedule and the times may change.

James Jacobson Director of Protection and Advocacy Projects, the Protective Services Unit asked for the Committee's support for this bill. Case loads have become stable or rising through the years and we also see an increase of funding on the federal level which has been very helpful to our department. Funding has been provided by the federal government for the Assistant Technology Program and the Traumatic Brain Injury Program. We work very cooperatively with the State Department of Human Services (DHS) to try to receive funding for wages for people in that population. We see a continued need for our Protection and Advocacy Services and I am available for any questions the committee may have. **Chairman Holmberg** asked if the Department was aware of two new FTE's in the budget on the federal level and since they are involved in the funding do we have a choice on the state level whether to participate in this funding.

**Senator Christmann** asked questions regarding the federal funding, is there a mandate that these funds be used for federal employees only and requested an explanation in the responsibilities of the person hired in reference to the Help America Vote Act.

Corinne Hoffman, Director of Policy and Operations of the Protection and Advocacy

**Project (P AND A)** had written testimony (2) and gave oral testimony giving the highlights of the services of her department and a budget review. She stated the Protection and Advocacy agency is governed by an independent 7 member board, 2 are appointed by the Governor, 2 by the Legislative Council and three by advocacy organizations. The Agency receives federal funding for 7 advocacy programs by grants or other sources. Our primary mandate is to pursue legal, administrative and other appropriate remedies to ensure protection and assert the rights of people with disabilities. Written testimony (3) was distributed and the Protection and Advocacy Project Budget Analysis for 2007-2009 (4) was also distributed to the Committee

**Jon Larson, Executive Director of ENABLE, INC.** presented written testimony (5) in support of the SB2014 and gave oral testimony in support of the bill.

**Chairman Holmberg** stated all they require is in the budget and requested all interested parties at the hearing to sign the Registration Sheet. Those present in support of the bill but did not testify were James Moen, Joyce Smith, Connie Hofmann, Dotty Simes, Pamela Mack and Elaine Grasl. Ms. Grasl submitted written testimony (6) after the hearing was completed. The hearing on SB 2014 was closed by Chairman Holmberg.

He stated that he didn't believe there were any requests for any amendments but just note that there are two FTE's that are federally funded, one for Advocate for Disabilities and one for the Help America Vote Act. Could Council verify this for the committee. He was informed that one is federally funded and one is partially federally funded.

**Senator Christmann** asked the question that it appears it is a game to move one of the new positions to one fund and the other one to another fund. 

Teresa explained they worked with the Secretary of State's office to make sure that voting is accessible for disabled persons. Continued discussion regarding operating funds and FTEs on HAVA program. A breakdown of federal funds report was requested.



Chm. Svedjan opened the hearing on SB 2014.

Rep. Bellew distributed amendment .0103 (Attachment A).

Rep. Bellew motioned to adopt amendment .0103. Rep. Pollert seconded the motion.

**Rep. Bellew**: This is a budget called the Protection and Advocacy budget (PA). As you can see it is mostly federally funded. What these amendments do is that it adds one FTE to assist with help America Vote Act. My contention was because that we have the funds in the Secretary of States' office. Both PA and the Secretary of State disagree with that. However I would like the amendment to stand to remove the position. I don't know that they justified increasing this position. The second amendment we added was one that says the federal funding goes away from some of these positions and the position goes away too. With that, those are the amendments.

**Rep. Kempenich**: That all goes to the counties anyway, what does this person do? How are they going to work this?

Rep. Bellew: I don't remember the total discussion.

Rep. Kempenich: I was just curious as to what that one person was going to work that.

Rep. Wieland: It has to do with handicap.

**Rep. Kreidt**: It was in regards to handicap accessibility and we don't know how that was going to come down.

**Rep. Nelson:** I can add something to the discussion on that. The funding was a 50/50 state and federal match. The \$51,000 would mean an offset of \$51,445 for federal funds in that position as well.

Chm. Svedjan: The reduction to the federal fund is \$51,000.

**Rep. Pollert**: I'm just going to read off a testimony we got. This position will be designed to absorb additional administrative demands created by an increase in the number of federal grants received and changes in state administrative requirements and processes. The employee in this position will also work on voting activities while funds remain available or the grant be refunded. It's to help a little bit for administrative programs for voters or people with disabilities but that was only part of what it was. We felt that they hadn't brought forward to us for the whole reason why. It was more to help with the administrative. I think the feeling of most on the Section was it wasn't as much as helping disabilities was as to help administratively.

Chm. Svedjan: Is there any more discussion?

**Rep. Metcalf**: I realize there are two sections basically with this addition of the legislative intent. Is there anyway that we can vote for the legislative intent but not for the reduction of the position?

Chm. Svedjan: We can move to adopt these amendments and we can move to further amend.

The motion to adopt amendment .0103 carried by voice vote and the amendment was adopted.

**Chairman Fischer** opened the Conference Committee Hearing on SB 2014. All committee members were present. They are: Senators Krebsbach and Robinson; Representatives Bellew, Kreidt, and Ekstrom. Becky Keller, Legislative Council and Sheila Peterson, OMB were also present. Chairman Fischer asked Representative Bellew to explain the amendment #.0103.

**Representative Bellew** stated this was the second amendment added to the bill. Section 4 refers to the Legislative Intent regarding the Federally funded Disabilities Advocate and basically it says if the federal funding is not available the position will not be filled and will be eliminated in the agency's 2009-11 budget request. The second amendment says "This amendment removes funding for 1 FTE position that was included in the executive budget to assist with the Help America Vote Act program". Those were the two amendments the House added to the bill.

Chairman Fischer asked for further explanation regarding the federally funded.

**Representative Bellew** explained Disability Advocate is in the Bismarck office. This position is funded with federal dollars. The reason why we removed the second one is it says also included is 1 FTE for administrative position in the Bismarck office. This position is designed to absorb additional administrative demand created by an increase in the number of federal

grants received that changes the administrative requirements and process. We took that to mean that this position was going to be an administrative position. He continued to explain the employee in this position will also work on voting activities. It was our position that this employee would work on the voting activities as a secondary activity. And we thought that since this position is half funded some of us felt that this position should be more of a voting activity type of position.

Chairman Fischer stated would they rather have a Help America Vote Act position rather than an administrative position. He was told yes, even though half the funds are federal and half state. Chairman Fischer commented that this is partnered with the Secretary of State to have funds.

**Senator Robinson** said it was his understanding from testimony we heard they were making good use of the position. They were being good stewards and getting the most out of the resources that they invest in the position. There was question on our side as well about the addition here but after explanation and justification we came away thinking they were doing the right thing.

**Representative Ekstrom** stated the other aspect of this given these are federal dollars, the feds don't lightly give us grants and tell us we can do what we want with them. They give this money and tell us what they want us to do. As in the intention of Protection and Advocacy is to use it the way the federal government says we must and it seems to me we will be leaving federal dollars on the table by not refunding this position.

More discussion followed regarding the federally funded positions and the fact that there would be dual roles during voting activities for the administrative person.

**Senator Robinson** made comments regarding the agency and the things that happened within that agency in the past with this agency going through unusual scrutiny and the budgets

were reduced and FTE's were reduced and at that time I resisted those changes but they were made and personally I think we have an agency here that has responded and covered a lot of important basis. We had a lot of questions on the positions here but we came away feeling there was a justification for it.

**Senator Krebsbach** asked if there were 2 employees and the House cut out 1. Basically out of the two employees <sup>3</sup>/<sub>4</sub> of the money would be coming from federal. What we are talking about is <sup>1</sup>/<sub>4</sub> of money that the state would be giving up. I certainly understand the concern about the federal funds being reduced or eliminated but I think when that time comes that is when we have the opportunity to say either cut out the position or rework. She stated she thinks there is justification for two employees and I would like to see us continue those two employees.

**Chairman Fischer** commented about his involvement when serving as chairman of a board of a private provider and the action that takes place. His comment was he doesn't know how they do with what they have. He stated he has a special interest in Protection and Advocacy, not only because of the work they do but the amount of it that they do. I, like Senator Krebsbach feels, that the risk to the general funds in overall is not something we'd be willing to take to reduce these positions because these positions administratively can be dealing with those incidents that happen within homes.

**Representative Ekstrom** stated the other discussion that we've had overall in all these budgets is that to a great extent we're trying to get back into community based service. Moving people out of Grafton and into a community based situation and when we do that we do have to have this added protection, so again I think they are doing a lot with very little. But as a public policy we've really made the decision and we've tried to become community based. Page 4 Senate Appropriations Committee Bill/Resolution No. 2014 Hearing Date: 04-09-07

**Senator Robinson** concurred with the comments made by Representative Ekstrom. He also shared his experiences in reference to this issue. (12.43) He made comments about the graying population and the demand for their services is growing. The need for P and A is going to be there even more tomorrow than it is today. He said he would hope for the small investment we support Senator Krebsbach and the request to keep the two employees in. There was discussion regarding the HAVA Act.(14.07)

Theresa Larson, Director of Protection and Advocacy explained the funding, stating the HAVA funds are a grant directly from the federal government. She said that the grant doe not allow for fully funded position. (17.38) She stated they worked with the Secretary of State on issues like training and education, they do not tell people how to vote but will assist them, set up the voting machines for the disabled and train and educate people in using these voting machines. Our office does that around the state.

**Chairman Fischer** thanked her for coming in and answering questions for the committee. He stated he would entertain a motion.

Senator Krebsbach moved that the HOUSE RECEDE FROM THEIR AMENDMENT ON SB 2014. Seconded by Senator Robinson.

**Representative Bellew** asked what happens to the bill. He was told it goes back to the Senate version.

A roll call vote was taken resulting in 4 yeas, 2 nays. The motion failed.

# SB 2014 Appropriations for the Protection & Advocacy Project Senate Appropriations January 22, 2007

Good afternoon Chairman Holmberg and members of the Committee. I am Corinne Hofmann, Director of Policy and Operations of the Protection & Advocacy Project (P&A). During my testimony today, I will highlight P&A's services and review its budget.

# I. <u>SERVICES</u>

There is a protection and advocacy system for individuals with disabilities in every state and territory. While most are private, non-profit organizations, the North Dakota system is a State agency governed by an independent seven-member board - the Committee on Protection & Advocacy. Two of the members are appointed by the Governor, two by the Legislative Council, and three by advocacy organizations.

P&A receives federal funding, from different sources, for seven advocacy programs:

As outlined in Federal and State law, P&A's primary mandate is to pursue legal, administrative and other appropriate remedies to ensure protection and assert the rights of people with disabilities. To carry this out, P&A provides advocacy & legal representation, protective services, education & training, self-advocacy support, systems advocacy, and information & referral services. P&A's philosophy is to use the least intrusive service necessary to achieve problem resolution while, at the same time, supporting the individual (or family member, guardian) to resolve the problem themselves to the extent they are able. P&A does not duplicate services that are available to individuals from other entities.

Each year, after receiving public input, P&A develops priorities for its programs. This is a directive of the federal government in recognition of the fact that a P&A cannot be all things to all people. Current priorities include abuse/neglect/exploitation, accessibility, community integration, criminal justice, education, employment, and healthcare. P&A develops a strategic work plan for each area to ensure we are pursuing and achieving measurable outcomes. Progress is regularly monitored and evaluated.

During the last two federal fiscal years, P&A provided an impressive number of services to individuals across the State, including those on the reservations. Advocacy and legal representation were provided to 1,218 individuals or groups with disabilities. 93.5% of the problems resolved were resolved in the clients' favor. Information & referral was provided to 5,553 individuals. 6,985 people participated in one of the agency's educational events and 42,043 written materials were distributed.

While numbers are important for measuring outcomes and accountability, P&A staff is also involved in many activities that lead to

systemic change for people with disabilities. These include a number of task forces, committees, and advisory councils that address issues such as state compliance with the <u>Olmstead</u> decision, reducing the number of residents at the Developmental Center, state emergency preparedness and planning for vulnerable populations, criminal justice issues, educational services for students with disabilities, and employment.

P&A has been effective in working with other state entities to address disability-related issues. For example, P&A has partnered effectively with the Secretary of State's Office and the ND Association of Counties on implementation of the Help America Vote Act. P&A also partners effectively the Long Term Care Ombudsman program, Child Protective Services, Vulnerable Adult Services, and other agencies addressing the needs of our most vulnerable citizens that may be subject to abuse, neglect, or exploitation.

P&A is equally committed to working collaboratively with other advocacy entities to address issues, including such groups as the Mental Health Association of ND, the ND Association for the Disabled, the Interagency Project for Assistive Technology, the Centers for Independent Living, the Arc of ND, and other private non-profit groups committed to assisting people with disabilities. We believe this is an effective and efficient way to maximize the use of resources.

#### II. <u>BUDGET FOR 2007-2009</u>

Congress has not concluded the appropriations process for federal fiscal year 2007 and money is being provided at level funding under a continuing resolution. P&A's budget for the 2007-2009 biennium was developed with the assumption of level funding for four of its seven programs (DD, AT SS, and TBI). Based on the funding pattern for the previous two federal fiscal years, a 1% annual cut was budgeted for two of P&A's federal grants (MH, PR). Funding through the Help America Vote Act is predicted to continue through September 2007, but new funding was not included beyond that date. The proposed budget for the 07-09 biennium maintains nine offices located around the State (Williston, Minot, Belcourt, Devils Lake, Grand Forks, Fargo, Jamestown, Bismarck, and Dickinson). The office in Belcourt serves the Turtle Mountain reservation area.

#### A. Position Funding

The governor's executive budget includes increasing FTE's from 25.5 to 27.5. One additional FTE is for a Disabilities Advocate position in our Bismarck office. This adds an additional \$68,088 (\$95,950 with benefits) to P&A's position funding budget for 07-09. This is funded with federal dollars.

Also included is an additional FTE for an administrative position in our Bismarck office. This position will be designed to absorb additional administrative demands created by an increase in the number of federal grants received and changes in state administrative requirements and processes. The employee in this position will also work on voting activities while funds remain available or longer, should the grant be re-funded. This adds an additional \$68,088 (\$95,950 with benefits) to our position funding budget for 07-09, of which 50% (\$47,975) is general fund dollars.

With the additional FTE's, P&A employees will include: 16 disabilities advocates, 3 attorneys, 2 program/advocate supervisors, 1 fiscal manager, 2.5 support staff, 1 administrator, 1 operations/policy administrator, and an executive director.

An increase of \$196,138 is included in the 07-09 budget to fund existing salaries and benefits. This maintains salary increases provided in the 05-07 and covers additional increases for salaries and benefits in the 07-09 biennium. The 07-09 biennium budget for temporary salaries was decreased \$40,959.

#### **B. Operations**

The Executive budget includes \$991,262 for operating. This is a decrease of \$52,329 from our 05-07 budget. P&A made significant cuts in a number of areas to achieve this decrease and free money for position funding.

P&A decreased its budget for operating fees and services (\$32,806), grants (\$20,000), printing (\$10,450), other equipment under \$5000 (\$9,712), professional services (\$9,500), travel (\$2,772), IT contract services and repairs (\$3,350), IT telephone (\$2,981), postage (\$1,050), miscellaneous supplies (\$250), and equipment rent (\$50).

Increases are included for IT-data processing (\$18,490), office rent (\$15,199), IT equipment under \$5000 (\$10,222), repairs (\$1,975), dues and professional development (\$1,814), office supplies (\$1550), IT software/supplies (\$779), office equipment and furniture (\$775), and insurance (\$258).

# C. Summary

While the proposed budget for 07-09 entails a small increase for P&A, it closely maintains the percentage of federal dollars funding P&A services, as indicated in the following table:



I am also here today representing the North Dakota Association of Community Facilities (NDACF). I am here to testify in support of funding for the Protection and Advocacy Project.

NDACF is made up of 28 non-profit and for-profit agencies across the state. NDACF members provide services to some of the most vulnerable people in the State – those with developmental disabilities. Protection and Advocacy plays an important role in supporting the needs of these people.

Staff from Protection and Advocacy work in partnership with providers in assuring that needed services are advocated for and rights issues are appropriately addressed. Each year, after receiving public input, P&A develops priorities for its programs. This is a directive of the federal government in recognition of the fact that a P&A cannot be all things to all people. Current priorities include abuse/neglect/exploitation, accessibility, community integration, criminal justice, education, employment, and healthcare. Abuse/neglect/exploitation is always the highest priority.

Because there is no "typical case", I'd like to give you a few examples of our work with individual clients.

- Scott has a developmental disability, is in his late 20's and resides in a group home. On one occasion, it was discovered that staff failed to provide a dose of his medication which resulted in Scott having a major seizure. P&A's investigation substantiated neglect but, more importantly, provided recommendations to improve the plan of action developed by the service provider to prevent future problems.
- Peggy is 62 years old and has a diagnosis of mental illness. She relies upon a trustee in another state to appropriately manage her finances. Extensive investigation by P&A led to the determination that Peggy's medical and mental health care needs were not being addressed in a timely manner due to failure by the trustee to pay

for needed services. Steps were taken to resolve the issue with the trustee so that Peggy can access services in a timely manner.

- John is a 5<sup>th</sup> grade student with developmental disabilities. He attends a rural school. P&A's investigation found that John was being unnecessarily physically forced to a seclusion room resulting in him being injured and becoming afraid of going to school. P&A substantiated abuse based on excessive use of seclusion and restraint. The school re-evaluated John's behavioral issues and the seclusion was removed from his program plan.
- Jane is 19 years old and has a developmental disability. P&A received a report that she was sexually assaulted by a family friend.
   P&A verified that a report was made to law enforcement and there was a criminal investigation. P&A's role became that of helping the law enforcement community understand the impact of Jane's disability upon her ability to understand and respond to the alleged assault and ensure that Jane received counseling. P&A provided support to Jane throughout the court proceedings.
- Peter, who has MS and is dependent on a ventilator, moved into an institutional setting in 2003 when it was determined that community services were not available to provide the level of support he required. The move was intended to be temporary until community resources could be secured. While such services were not made available in North Dakota, P&A and Options Center for Independent Living were eventually able to secure the required services for community placement in a state of Peter's choosing. Less than 2 weeks ago, Peter moved to a residential home in Minnesota.
- Joey, along with his twin brother, was born 14 weeks premature.
   Joey's condition became life-threatening because he could not tolerate nutrition. After 4 surgeries, the prognosis continued to deteriorate. Joey was, in essence, starving to death. Physicians informed the family of a drug that was in the "testing stages". The

drug could not, however, be sold directly to the medical facility as it was still experimental. P&A assisted the family with locating a nonprofit agency that could fill the role of intermediary in order to obtain the medication. P&A also provided legal services for needed contractual agreements. After eight weeks of being on the medication, Joey was recently able to move home from the hospital. He is now accepting nutrition and doing well.

Since my last report to you, over the last two federal fiscal years, P&A provided an impressive number of services to individuals across the State, including those on the reservations. Advocacy and legal representation were provided to 1,218 individuals or groups with disabilities. 93.5% of the problems resolved were resolved in the clients' favor. Information & referral was provided to 5,553 individuals. 6,985 people participated in one of the agency's educational events and 42,043 written materials were distributed.

Numbers are important, and necessary, for accountability and measuring outcomes. P&A provides detailed reports annually to the federal government for each of its federal advocacy programs.

P&A staff is also involved in many activities that lead to systemic changes for people with disabilities. These include a number of task forces, committees, and advisory councils that address issues such as state compliance with the <u>Olmstead</u> decision, reducing the number of residents at the Developmental Center, state emergency preparedness and planning for vulnerable populations, criminal justice issues, educational services for students with disabilities, and employment.



P&A has been effective in working with other state entities to address disability-related issues. For example, P&A has partnered effectively with the Secretary of State's Office and the N.D. Association of Counties on implementation of the Help America Vote Act. P&A also partners effectively the Long Term Care Ombudsman program, Child Protective Services, Vulnerable Adult Services, and other agencies addressing the needs of our most vulnerable citizens that may be subject to abuse, neglect, or exploitation.

An example of advocacy partnership occurred when P&A was notified that a basic care facility was being closed. Its residents included many individuals with developmental disabilities, mental illness, and other types of disabilities. They all needed a place to live along with individualized services. P&A coordinated a meeting with the facility's social worker, area county social services offices, and other stakeholders. Discussion took place regarding available options, the understanding of "consent", and the role each entity could play to help. P&A also met with the facility residents to help them understand what was happening and to understand their rights. P&A's role helped to ensure smooth planning, transition, and due process.

### II. <u>BUDGET FOR 2007-2009</u>

P&A's budget for the 2007-2009 biennium was developed assuming that the annual federal grants will be approximately the same as those received in federal fiscal year 2006. One exception is funding for P&A through the Help America Vote Act. This was predicted to continue through September 2007 and new funding was not included in the budget beyond that date.

# A. Position Funding

The proposed budget for the 07-09 biennium maintains nine offices located around the State (Williston, Minot, Belcourt, Devils Lake, Grand Forks, Fargo, Jamestown, Bismarck, and Dickinson). The office in Belcourt serves the Turtle Mountain reservation area. The regional office model allows P&A staff to be more available to individuals with disabilities in the provision of advocacy, protective services, and pro-active work.

The budget includes increasing FTE's from 25.5 to 27.5. One additional FTE is for a Disabilities Advocate position in our Bismarck office. This adds an additional \$68,088 (\$95,950 with benefits) to P&A's position funding budget for 07-09. This is funded with federal dollars.

Also included is one additional FTE for an administrative position in our Bismarck office. This position will be designed to absorb additional administrative demands created by an increase in the number of federal grants received and changes in state administrative requirements and processes. The employee in this position will also work on voting activities while funds remain available or longer, should the grant be re-funded. This adds an additional \$68,088 (\$95,950 with benefits) to our position funding budget for 07-09, of which 50% (\$47,975) is general fund dollars.

With the additional FTE's, P&A employees will include: 16 disabilities advocates, 3 attorneys, 2 program/advocate supervisors, 1 fiscal manager, 2.5 support staff, 1 administrator, 1 operations/policy administrator, and an executive director.

An increase of \$196,138 is included in the 07-09 budget to fund existing salaries and benefits. This maintains salary increases provided in the 05-07 and covers additional increases for salaries and benefits in the 07-09 biennium. The 07-09 biennium budget for temporary salaries was decreased \$40,959.

### B. Operating

The budget includes \$991,262 for operating. This is a decrease of \$52,329 from our 05-07 budget. P&A made significant cuts in a number of areas to achieve this decrease and free money for position funding.

P&A decreased its budget for operating fees and services (\$32,806), grants (\$20,000), printing (\$10,450), other equipment under \$5000 (\$9,712), professional services (\$9,500), travel (\$2,772), IT contract services and repairs (\$3,350), IT telephone (\$2,981), postage (\$1,050), miscellaneous supplies (\$250), and equipment rent (\$50).

Increases are included for IT-data processing (\$18,490), office rent (\$15,199), IT equipment under \$5,000 (\$10,222), repairs (\$1,975), dues and professional development (\$1,814), office supplies (\$1,550), IT software/supplies (\$779), office equipment and furniture (\$775), and insurance (\$258).

# PROTECTION AND ADVOCACY SB 2014 BISMARCK REGION INFORMATION

For the 2005 and 2006 fiscal years, the Bismarck region generated **333** cases. Referrals are high for a number of reasons:

- Current advocates were very involved in the provider system for a number of years before coming to P&A and are well known and respected.
- Advocates conduct extensive outreach to the Standing Rock Reservation. One advocate travels there 1-2 times per week.

• Bismarck is our largest and most visible office due to co-location with the agency's state office. State office staff is involved in many state level systemic activities which are "rain makers" for the regional staff.

By comparison, our Grand Forks and Fargo regions together generated **285** cases. Advocates in these regions are very busy, but have manageable case loads.

Good morning Chairman Pollert and committee members. My name is Christina McComish. I am 19 and I currently live independently in an apartment in Bismarck. I am a Junior attending Century High School.

My parents and I will be forever grateful for all the help that Protection and Advocacy gave us. Last year my prior school district tried to once again send me to a 24 - 7 residential institution in South Dakota. I was informed that I had less than 2 weeks to pack my bags. We contacted Protection and Advocacy. They were able to help keep me from being forced to leave my parents, my home, my community and my neighbors.

Without their intervention, my education would once again be counting 10 nuts and bolts and putting them in bags for resale. I would now be having someone plan out my entire life for me, without my input.

How do I know that this would have been my future? I was at this institution already for 4 years, from age 10 and it was an absolute nightmare for my entire family to live through. P & A helped me return home in 2002.

I am now 19 and living by myself. I pay my own bills, buy my own groceries, use the CAT bus system, clean my own apartment, do laundry and cook my meals, all while attending high school full time. My classes include Geometry, English and History. I also decide what I will do on my free time.

I strongly encourage you to fund this necessary agency. Thanks to them, I now have my life back and am looking forward to college. P & A has helped many others improve or retain their lives. They help people of all ages. Luckily I was one of the people that they helped last year. With funding they can continue to help others.

Please help insure that Protection and Advocacy has the needed funding to help others as they have helped me.

Chairman and members of the committee, I am Elaine Grasl, I am a member of District 47. I am in support of SB 2014, a bill for an appropriation to defray the expenses of the Committee on Protection and Advocacy.

(This is mainly the same testimony that I provided previously to the senate, but I think it bears repeating.)

My regret about P & A is that I didn't learn about it sooner and that I let fear of the unknown allow me to hesitate, even a little while, before I made contact. I feel that fear of the unknown, fear of being judged, fear of failure, fear from previous experiences, (and so on) however, can be a force which can cause individuals with a disability and /or their families to hesitate to ask for help.

Protection and Advocacy provides a voice and a presence for those who traditionally, have not had one-or a microphone, so to speak, for those who have not been heard. More importantly, I feel, they listen respectfully to individuals, while they demonstrate to them how to project their own voices for their own benefit. (I envision) voice by voice, individuals can join to form a chorus serving to educate the populace about the realities of sharing one's life with a disability(ies).

People want the spectrum of possibilities and free choice. Worthwhile and worthy individuals, who happen to have a disability, should, I feel, be seen as individuals first; only one facet of them is their disability. I believe P & A recognizes the possibilities. I believe P & A recognized people as valuable individuals. I believe P & A more than deserves the dollars that it requests and are excellent stewards of those dollars.

Can you imagine someone that you love is vulnerable, and there no voice for them? There is more yet to do.

They have 9 offices across the state. And currently have 25.5 FTEs

Caseload:

They handled 1,218 cases in this biennium (93.5% were favorably resolved) They gave information and referrals to 5,553 people. They provided education to 6,985 and distributed 42,043 pieces of literature.

If you do not include the literature distributed, they helped 13,756 people. That translates to a caseload of 539.

The increase of 2.0 FTE in the Executive budget reduces the caseload to 500 people. The population is aging – the caseloads are going to go up. This is a very efficient operation.
