Chairman Holmberg opened the hearing on SB 2018 regarding the budget for the State Historical Society at 10:30 am on January 17, 2007.

Merl Paaverud, Director of State Historical Society of North Dakota provided written testimony (1) and presented the Society's Executive Budget Recommendations. He gave an Agency Overview, stating they now have 57 FTE, 40 seasonal staff and 200 volunteers who work to support the society. His Agency is responsible for 55 state historic sites, the Missouri-Yellowstone Confluence Interpretive Center, the Pembina State Museum, the State Archives and Historical Research Library, the State Artifact Collection, and the State Archeological Collection located in the North Dakota Heritage Center.

The 2007-2009 Optional Adjustment Requests or enhancements to the base budget that were included in the Executive Budget are: Salaries and Wages, Operation Expenses, Capital Improvements and Continuing Appropriations Narrative which include a Concession Fund, Gifts and Bequests and Archeological Permits. Spreadsheets for these three areas are attached to this document.

Senator Wardner requested information regarding the certification of local governments. **Claudia Berg, Director of Museums** had two exhibits on display; a \$5.00 bill from the FNB of Fargo, issued from 1898 to 1908 and carries the bank's Vice President Louis B. signature. This North Dakota businessman went on to become a North Dakota Legislator, Congressman and Governor of North Dakota. The second display is 2 patches from the 91st Missile Wing at Minot Air Force Base and the key is from the training silo at the Grand Forks Air Force Base. We are also hoping to preserve two sites near Cooperstown and national media including US Today have shown interest in that project.

Senator Robinson asked when the Chateau de Mores Interpretive Center will be completed. He also asked about repairs at other historic facilities and an explanation regarding gifts and bequests made to the Historical Society.

Senator Christmann inquired about the addition at the Heritage Center and why it is not adequate for storage use.

Senator Lindaas asked if the historical information is on the website or micro fish.

Senator Krauter questioned if there was an increase in bonding for the Chateau de Mores building plan.

Virginia A. Nelson, Executive Director of State Historical Society of ND Foundation

presented written testimony (2) and gave oral testimony regarding the Foundation's work in

North Dakota. The key needs are as follows:

1. Additional professional staffing to meet expanding responsibilities

2. Equity pay for the unique educational and professional skills of the staff

3. Marketing dollars to reach in-state and out-of-state visitors

4. Technology investments to bring more services to more people

We have a 10 Year Investment strategy recommended by the State Historical Society of North

Dakota commission. This commission was recommended by the five former governors -

William Guy, Art Link, Allen Olson, George Sinner and Ed Schafer and established by

Governor John Hoeven. Seven recommendations were set before us. Four of the seven have

been completed. Those recommendations yet to be completed are as follows: Invest in stateof-the-art technology to bring services to all sectors of society; Invest in professional staff as the delivery system for high quality programs and services and Invest in the NDHC as the "hub of history" in our state.

Minutes:

Chairman Wald: Opened the hearing on SB 2018 by introducing Mr. Merle Paaverud, director of the State Historical Society of North Dakota.

Paaverud: (See Handout #1, SB 2018, State Historical Society, SHS) provided testimony related to an agency overview, including attendance.

Chairman Wald: How do you track these numbers, what counting mechanism do you employ?

Paaverud: We keep sign-in booklets and we do surveys that we do with people who visit our sites. 29,500 people throughout the state enjoyed the TIES exhibit, continuing with a focus on projects around the state. The awards made in Historic Preservation Grants were enumerated (See Handout #4, SB 2018, State Historical Society, SHS).

Chairman Wald: What is the definition of a certified Local Government Operation?

Paaverud: It is a planning committee that would look at their community for its historical resources, thereby working with the local government for the purpose of identification. CLG's, anything on the National Register.

On Pages 3-4 the 2007-2009 Optional Adjustment Requests are outlined including salaries and wages, operating expenses and capital improvements.

Representative Klein: Expand on the Lincoln Bicentennial.

Paaverud: (See Handouts #2 and 2a, SB 2018, State Historical Society, SHS) This includes

programming for teachers.

Representative Klein: Regarding the three storage facilities....

Paaverud: Yes, the old Shiloh school, Lincoln storage, and the airport property. All need repair.

Chairman Wald: Where is Double Ditch?

Paaverud: It is about 8 miles north of town, a camp for Mandan Indians. About 2,000 people were living there prior to Lewis and Clark.

Continuing the Appropriations Narrative on page 4 includes the concession fund and gifts and bequests.

Chairman Wald: Do you have a list of the deferred payments and revenue from gate collections?

Paaverud: It is available and we will get that to you.

Vice Chairman Monson: The increased funding for bond payments on archives and the Chateau deMores interpretive Center, is that a new bond issue?

Chairman Wald: How often do you renew your admission fees?

Paaverud: About every two years, weighing attendance, etc. The charge is \$5.00 at sites, nothing at the Heritage Center by statute, we cannot charge admission but we do charge for

the use of facilities and that money is put back into furniture, upgrades for equipment, etc.

Representative Hawken: What is the charge per person?

Paaverud: Adults are charged \$5.00 and children \$2.50 and buses are \$1.00 per person.

Chairman Wald: At the Chateau, lacking about \$.25m for the furniture and fixtures?

Paaverud: The foundation is in very bad condition and needs to be replaced at a cost of about \$250,000 to replace just the building.

Vice Chairman Monson: Is that the old interpretive center?

Paaverud: Yes, it was taken down on Monday and will not be done until September but the main building will be open May 15th.

Virginia Nelson, Executive Director of the State Historical Society of North Dakota Foundation and a registered lobbyist for the Foundation: (See Handout #3, SB 2018, State Historical Society, SHS) provided testimony in support of SB 2018.

Vice Chairman Monson: Regarding the Missile Site Project and referring to the Green Sheets. I don't see how you are going to get it with \$1m every biennium from here on out. Paaverud: This would be one of those sites we go to see at \$5.00 a head bringing in \$100,000 a year trimming off \$150,000-\$200,000 on that. This would be a part of the Cold War Heritage Corridor on the national level.

Representative Klein: Where did this figure come from because 80% of the facility is underground, where do you come up with a maintenance bill of \$400,000-500,000 a year? **Paaverud**: That would be based on start-up costs for the facility for the biennium. It requires equipment, hiring of staff to work out there, plus the operating for the ventilation and that sort of thing.

Representative Klein: You're looking at 2 sites, a control site and a launch facility site.

Paaverud: Yes, using the national historic scenic byway. This would be an anchore.

Chairman Wald: What does an assistant collection curator do?

Paaverud: Cataloging, on-going process.

Vice Chairman Monson: What about the \$1m for grants. Can you specify?

Paaverud: Handout #4 has a summary of the grants.

Cordell Dick, Fundraising Consultant: (See Handout #5, SB 2018, State Historical Society,

SHS) provided testimony in favor of SB 2018. The Historical Society should do a better job of

marketing itself.

Chairman Wald: I am assuming this is a 501C3.....

Dick: Yes, fully deductible.

Chairman Wald: Questions or other testimony, hearing none, this concludes the hearing on

SB 2018. I have assigned a subcommittee of Representatives Martinson, Hawken and Gulleson to study this bill.

Chairman Svedjan: Opened the hearing for SB 2018.

Rep Martinson: I would move that a motion made to adopt the amendments 0108. Rep Gulleson: seconded the motion.

Rep Martinson: We added a section 7 to this bill if you look at that on page 2 in our amendments. This is regarding the Cold War Missile site. I think almost everyone is familiar with that. The Federal Government has \$250,000 available in matching funds. We are allowing the Historical Society to raise \$200,000 and we will match that on a dollar for dollar bases and then we are appropriating a flat out appropriations of \$ 50,000 for operating expenses to them.

Going down to the amendments you will see that we added in the Cultural Heritage grant line item \$50,000. We took out \$25,000 out of the 50,000 from the senate; I should say the Senate made no changes at all from the Executive Recommendation. We increased salaries and funding of \$22,378 to keep the raises that they had given during the first biennium. We added \$75,000 for marketing for the various sites. We decrease extra ordinary repairs \$100,000 and we added \$195,000 in operating and capital assets to the Chateau de Mores in Medora and that is primarily to the fact that once they started their construction, they realized they had some serious problems with the foundation which they had to replace. Because of that they

had no money to do anything in the interior and they had to use operating money, so we added

\$45,000 to the operating and \$150,000 in capital assets.

We authorized \$10,000 for the snow angel project.

The budget increase is \$277,378 and if they match the Federal money than the increase is

\$477,378.

Chairman Svedjan: The amendment show an increase in General Funds of \$477,000. If it is a dollar for dollar match, relatively what they raise why would that show up as a General Fund

Expenditure? Wouldn't that show up as estimated income?

Rep Martinson: I really can't give you that answer.

Chairman Svedjan: Maybe the LC can help.

Becky: Yes you are right this is an error in my part.

Chairman Svedjan: The other \$200,000 should show up as income. The net effect on the General Fund based on these amendments is \$277,378, would it not?

Becky: Where you see the 477 million that is the total house changes. If you look to the one left of it you will see the 650 is the total of all funds for the Cold War Missile site, 450 is coming from the less estimated income and 200 is coming from the General Fund. It is correct as stated.

Rep Carlson: What was it they changed for the extra ordinary repairs for the \$100,000? We always get accused not properly taking care of our facilities. Is this something we sold, we got rid of or don't have to retain anymore?

Rep Martinson: We asked the agency to find us the money. They told us that the \$100,000 was basically a carry over from the last interim and they did not need that \$100,000. We are not putting off repairs. They just found this money.

Rep Skarphol: This reflects a 23% increase in the salaries within this agency. In other words there is a 1.486 million dollar increase in the salary line. That is a pretty substantial increase. Are they adding quite a few more people on a temporary base? They are not adding FTE's but the salary line is going from 5.6 million to 7.1. I would like some kind of explanation. Rep Wald: The change in salary, they had some full time/part time people that were converted to a full time staff. We recognized that they we full time people so that is one of the reasons for the change.

Rep Skarphol: Is there commensurate increase in FTE's?

Becky: There is an increase in FTE's. They also provide funding for temporary salary increases for \$73,000, and when you include the 4/4 and the additional benefits that would relate to that you are probably going to get that increase.

Rep Carlson: I really have problems where we kill amendments the floor and then they are back in the bill. I know it will probably going to stay in there and pass but we had a rather lengthy discussion on the floor about the missile site. The bill was defeated on the floor. We should at least recognize the fact that this has been added after the vote has been taken on the floor.

Rep Martinson: There is no new information. There is just a number of people that changed their minds after the vote and asked the sponsor of that bill and asked that we put it in and we talked about it in our caucus. I don't know if the Democrats did.

Rep Skarphol: There is a pretty substantial increase, like 365,000 in professional fees.

Becky: I would have to refer to OMB on that increase; I don't have that on the green sheet.

Tammy; She is from OMB. I will need to check on that with the budget.

Chairman Svedjan: Took a voice vote in adopting the amendment 0108 for SB 2018. The amendment carried. Page 4 House Appropriations Committee Bill/Resolution No. SB 2018 Hearing Date: 03/21/07

Rep Kempenish: Made a motion to further amend. By taking out \$250,000 out of the professional fees line item and operating expense.

It was seconded by Rep Thoreson.

Rep Hawken: That would be a real arbitrary move since we don't even know what those were

for. It could be something extremely significant. I hesitate to make arbitrary cuts without the information on what these moneys are for.

Rep Carlson: Is the Metal of Honor one, is that the one in Minot? Is there a separate bill for that as well?

Chairman Svedjan: Yes.

Rep Carlson: So what happens and which one of them prevails?

Rep Martinson: There is not any money in this bill for the Metal of Honor monument.

Becky: The line on the bill that you are reading is a one time funding section.

Rep Martinson: Could we hold on this? I find unbelievable that we can make a motion to deduct \$250,000 when we do not know what it is for.

Chairman Svedjan: I don't disagree with that. I can delay consideration on this until we get the information.

Rep Kempenich: I will withdraw the motion. The second was withdrawn.

Rep Skarphol: The 60 FTE's in the Executive Budget and it shows 60 FTE's in the House version. I am still having difficulty understanding the addition of 3, when the number says 60 in both cases.

Chairman Svedjan: The Green sheet shows 57 for last year.

This will be set aside at your request.



Senator Grindberg opened the conference committee on SB 2018. All members were present.

Representative Bob Martinson went through the changes made by the House (meter 00:38). The Historical Society has the possibility of getting ownership of the missile site near Cooperstown. There is matching federal money available and the state needs to match that in order to gain ownership. The money expires before the end of the next biennium, so the House put authorization language in that if they raise \$200,000 we will match that with general funds (meter 01:10). Cultural Heritage grants were also reviewed (meter 01:21).

Senator Grindberg asked if the grants were requested by them.

Representative Martinson said no, it was not requested. They have been very easy to work with. Explanation of funding changes regarding the Lincoln Bicentennial, salary increases, marketing, remodeling at the Chateau de Mores, the Snow Angel project, and the missile site was given (meter 02:35).

Senator Grindberg asked if the House passed the salary and wage portion.

Discussion regarding specifics of the salary raise followed (meter 04:46).

Dave Skalsky from the State Historical Society commented on the need for money to maintain salaries (meter 06:34). We are technically under-funded in our budget to maintain salary.

Senator Grindberg stated that the House added funding and he expressed concern over adding to the equity pool if money is going to be sprinkled into every budget (meter 07:28). Is the issue of equity in alignment?

Mr. Skalsky explained that the added funding was to give to the minimum classification.

Representative Gulleson stated that there were concerns over the application of the additional equity funds in trying to be consistent and fair. They started showing up in other budgets in large amounts. We need an overview of where we are at right now with all of these budgets.

Representative Hawken stated that in some respects, it is two different things. Some of the budgets have additional equity; this really is not additional equity. The other issue is that we do not overpay many people in state government, particularly people in budgets like the Historical Society. The amount of money that they asked for was not out of line for the number of people. It is a legitimate thing to add here. Representative Gulleson's concerns were acknowledged. We do have a lot of different pools of money for salary in different bills, but this one is legitimate.

Senator Seymour stated that some employees are eligible for the equity pool and some are not.

Senator Grindberg asked for further discussion. There was none. The conference committee on SB 2018 was closed.

Senator Grindberg opened the conference committee on SB 2018. All members were present. Discussion regarding the intent of the Cultural Heritage Grant followed (meter 01:58). Merlan Paaverud, Director of the State Historical Society, explained that the re-grant program is one of the most popular programs they have. This program provides funding to do projects, have new exhibits, organize archives, and other special programs. Funding is also used to do marketing and make people aware of what is available. Funding was appropriated last session to add on to the Chateau de Mores, which has the most visitors of all of the State Historical sites. Further discussion regarding the building addition followed (meter 05:08). Interior details on the addition are not finished yet. This funding would allow those finishes to be completed. Mr. Paaverud answered that it is just east of Rapid City on I-90 and north of the interstate.

Representative Martinson asked about getting brochures.

Senator Grindberg asked Merlan Paaverud to go over the budget again. Is 1.2 million the goal for this?

Senator Krebsbach asked if the federal government would transfer the deed of property to the Historical Society.

Mr. Paaverud said yes, they would do that right now if we wanted them to do that. The money part is based on our board and our budget. We cannot venture into something like this without a financial plan.





Introduction

Mr. Chairman and members of the Committee, my name is Merl Paaverud and I am the director of the State Historical Society of North Dakota. I am happy to be here with you today to present the Society's Executive Budget Recommendation to you.

Agency Overview

The Society was established in 1895 as the primary state repository of artifacts, archival materials, and historic sites that are important to North Dakota's history. The mission of the state's history agency is to identify, interpret, preserve and promote the heritage of North Dakota and its people. The Society entered into a memorandum of understanding to provide laboratory, collections space and exhibit space to the Paleontology Office of the North Dakota Geological Survey. In return the Survey cares for the state fossil collection and provides its expertise about the paleontology collections for exhibits and programs.

- We now have 57 full time staff, 40 seasonal staff, and 200 volunteers who work to ٠ support the Society.
- We are responsible for 55 state historic sites, the Missouri-Yellowstone Confluence Interpretive Center, the Pembina State Museum, the State Archives and Historical Research Library, the State artifact Collection, the State Archeological Collection are located in the North Dakota Heritage Center.
- We offer support to over 100 local historical societies and groups, provide technical ٠ assistance for museum operations, historic preservation, collections care and educational programs. The State Historical Society is the resource for genealogy and history of the state and Northern Great Plains.
- We lead the way in historic preservation, history and education support for students • and teachers. The Society partners with institutions of higher education for archeological field schools, internship opportunities, research assistance and recognized expertise.

2005-07 Statistics:

- Over 500,000 people visit our museums and historic sites.
- Installed the new Corridor of Time Exhibit in cooperation with the North Dakota ٠ Geological Survey.

Below are the optional adjustments or enhancements to the base budget that were included in the Executive Budget.

Salaries and Wages:

- 1. \$228,208 (\$165,445 general and \$62,763 federal) The Executive Budget authorize this amount to fund 3.00 FTE positions. The positions are an Historian/Exhibit Planner, Assistant Collections Curator and a GIS Technician/Digitization Specialist.
- 2. \$73,928 general Funding for historic site seasonal staff salaries to raise the average hourly rate from \$7.28 to \$7.78.

Operating Expenses:

- 1. \$39,870 general Funding for operating expenses at the new Fort Abercrombie Historic Site Interpretative Center.
- 2. \$18,895 general Funding to obtain insurance for historic buildings which are currently uninsured or under insured.
- 3. \$50,000 general Funding for the state's participation in the Lincoln Bicentennial Commemoration.

Capital Improvements:

- 1. \$900,000 (\$700,000 general and \$200,000 federal) Funding for the completion of the Fort Abercrombie Interpretative Center.
- 2. \$100,000 general Funding for deferred maintenance.
- 3. \$500,000 (\$250,000 general and \$250,000 federal) Funding for building maintenance at the Fort Totten State Historic Site.



- 4. \$57,500 general Funding for repairs needed at our storage facilities. The storage facilities are storage east, Lincoln storage and the airport building storage.
- 5. \$150,000 (\$30,000 general and \$120,000 federal) Funding to complete the walking trail located at the Double Ditch State Historic Site.
- 6. \$220,000 general Funding for exhibits at the Heritage Center.

Continuing Appropriations Narrative:

Concession Fund

This continuing appropriation authority has been provided primarily for the operation of the Historical Society Museum Store operations for facilities at the North Dakota Heritage Center and State Historic Sites across the state. The Heritage Center Museum Store is viewed and operated as an extension of the overall State Historical Society education program. The store provides a forum through which museum exhibits and other aspects of North Dakota culture and history can be expanded upon for the benefit of the general public.

Although a profit margin is associated with all museum store items and is established by the director, profits realized from all sales are used to repurchase inventory and/or conduct other special educational projects through production of materials or publications for sale through the store. The emphasis of the store is not oriented toward large profits. Without the profits of the museum store, many publications and reproductions of exhibit related items would not be possible. All funds derived from the operation of the museum store are used for the purpose from which they were derived, namely the store operation and to supplement the publications activity of the State Historical Society. The Museum store aims to select quality items that meet specific criteria: Quality of work, whether in publications or crafts, must be professional; all items about North Dakota, its history, the culture of its people and its geography should be as accurate as possible; emphasis is given to selling items produced in North Dakota thought exceptions are made. However, all items should pertain to North Dakota and the surrounding area; items sold in the Museum Store cannot be derogatory to race, creed, color, sex or religion; all items which are reproductions of artifacts from any museum will be labeled "reproduction" or "replica"; the Museum Store will not sell any items made of or containing fossils.

The other aspect of the concession fund relates to fees that are collected for the use of the facilities of the agency, fees for admissions, and use charges for services provided such as photographic, research and microfilm services. All these funds are used to offset the direct costs associated with providing these services and include supplies, materials, equipment and temporary staff for seasonal historic sites assistance.



Gifts and Bequests :

Historically, museum operations have depended greatly on the generosity of supporters of the humanities for their continued existence. The authority provided for the acceptance of gifts and bequests stems from this desired support. All funds are maintained in the Bank of North Dakota or state treasury. Most gifts are given for a specific purpose either to support a specific exhibit, collection or program and such gifts are restricted to the purpose for which it was given. Most gifts are small and come through the agency's donation boxes. There has never been a large enough donation to establish a trust which could produce significant income on a continuing basis.

Archeological Permits

Any individual, organization, institution or company engaged on one's own behalf or on behalf of another to identifying, evaluating, or mitigating adverse effects on cultural resources, historic buildings, structures, or objects on any lands in North Dakota must obtain an annual permit from the director of the State Historical Society. Such fees are deposited in the revolving fund and must be used by the director for making investigations of permit applicants and for management and analysis of records and artifacts submitted to the director under sections 55-03-01, 55-03-01.1 and 55-03-02.

Spreadsheets for these three areas are attached to this document.

- 2. Attachment II provides projected revenue and expense information for the Cold War Missile Site.
- 3. A member of the committee asked about deferred maintenance items. Listed below are projects that need to be completed. Dollar amounts are not listed as a number of these projects would require estimates. While funding included in our budget for maintenance will not be sufficient to complete every project, we will complete as many as projects as possible.

Former Governors' Mansion - Painting, insulating back room, ADA access improvements, asbestos abatement.

<u>Fort Totten State Historic Site</u> - Painting, roof repair, chimney repair, window repair, floor repair, lead base paint abatement.

<u>Chateau de Mores (DeMores Memorial Park)</u> - Repair WPA stonework, landscaping, sidewalk repairs.

<u>Camp Hancock</u> - Paint the Church at Camp Hancock, build shelter for purposes of preservation over the train, heating for the quartermaster depot/signal office.

<u>Fort Buford State Historic Site</u> - Painting, board walk repairs. <u>Fort Clark State Historic Site</u> - Trail repair.

Good Morning—it is my pleasure to be here today to speak in behalf of the state's history agency. My name is Virginia Nelsen, Executive Director of the State Historical Society of North Dakota Foundation and a registered lobbyist for the Foundation.

I also want to thank members of the Foundation's growing History's Trustee committee—now over 200 business leaders and significant individuals from across the state---citizen partners in our work to see that the investments continue in our state's history resources. Thank you Trustees, for being with us today. The six governors also serve as Honorary Trustees with the Foundation in support of our work.

This is the beginning of my sixth year with the Foundation. Time flies when you are having fun. I want to compliment the State Legislature for being an able and willing leader in the development of our history resources. We all understand the value of the work of this agency and with your keen sense of critical investments the state has moved forward with many important and exciting projects.

Just outside my window we watch as the new State Archives expansion is coming out of the ground. This steel and concrete "tinker toy like" structure is arching towards the sky, "the secure vault" for the state's most precious records, photographs, newspapers, video tapes, maps, film and more. Thank you for supporting that project.

The Chateau de Mores Interpretive Center is also well under way to be ready for the 2007 tourism season. Fort Abercrombie Interpretive Center planning is creating a jewel in the Fargo area. Funding for the wildly popular Re-Grant Program has helped regional history groups all over the state. These investments, sound investments in heritage tourism--the spokes in the "hub of history" for our state, are creating a trail of the "legendary" stories and exciting adventures of our ancestors and native ancestors that crisscrossed the prairie.

Our work continues. Our work is not just constructing buildings. Our work is only accomplished with professional people--people with highly specific skills that make this organization the asset that it is to our state.

There are some key needs that the Society is addressing in their current appropriations before this committee and we are here to help support these needs:

- additional professional staffing to meet expanding responsibilities
- equity pay for the unique educational and professional skills of the staff
- marketing dollars to reach in-state and out-of-state visitors
- technology investments to bring more services to more people

It goes without saying the work of the state's history agency is based on the professional expertise of historians, architects, planners, technicians, archaeologists, teachers, photographers, archivists, researchers, professional writers, communications specialists and more. These are individuals with advanced college degrees in most cases, individuals with expertise that is significant and important to the work for the people of North Dakota.

As the Foundation works side by side with Merl and his staff, the Foundation sees the hard working, intelligent and resourceful people in this agency---dedicated to a fault, completing tasks that are complex and difficult, putting in many additional hours. We see this day after day. We trust you will work hand in hand with the Director to see these important issues are addressed in a way that compliments and honors this staff for the important work they do.

10 Year Investment Strategy for the Historical Society

Over the last four years, the Foundation has worked with the Society, the State Legislature, the former governors and citizens--advancing a 10 Year Investment Strategy recommended by the State Historical Society of North Dakota Commission in a 2003 report to Governor Hoeven. This Commission was recommended by the five former governors—William Guy, Art Link, Allen Olson, George Sinner and Ed Schafer and established by Governor John Hoeven. This important study that captured the work of the eighteen-member Commission set before us seven recommendations for the state's history agency – recommendations that would utilize the resources of this agency for economic development as well as education and tourism and research and quality of life.

These critical investments are building a "legacy" of history preservation and history promotion that will serve this state for generations---a "legacy" that makes everyone involved proud. We can all draw wisdom from the words of Mark Twain.

We are here today to encourage each of us to be bold.





Mr. Chairman, members of the committee,

My name is Cordell Dick. I am a fundraising consultant from Bismarck. I am speaking today in support of this appropriations bill for the State Historical Society. I want to address you in a general context of support related to my experience and observations as a fundraising consultant traveling around the state of North Dakota these past eighteen months. I have been working with the State Historical Society and the Foundation, first in planning for their fundraising campaign, then in conducting the feasibility study for that campaign, and finally in working directly with contributors, asking for their private financial gift support. The Society and the Foundation are committed to building a partnership among three parties; the State of North Dakota, the federal government and the private sector, seeking through this partnership to increase the resources necessary for the Society to market and expand the archives, historic sites and programs that keep the history of North Dakota alive.

What I have observed is this: The leadership and work of the State Historical Society and its Foundation are highly regarded by business and community leaders throughout our state, as clearly demonstrated by the feasibility study surveys as well as by individual conversations with contributors. In fact, an overwhelming majority of people throughout North Dakota endorsed the work of the Society *and* were willing to make financial gift commitments to its fundraising campaign. I was especially impressed with the level of support received from prospective contributors from the Red River Valley. They believe the work of the Historical Society provides state-wide benefit and is worthy of their own financial support as well as support from others.

One common suggestion, however, that I also hear many times is that the Historical Society should do a much better job in marketing itself and its services. Many people in the state have only a faint idea of the expansive work of the Society. An increased marketing budget would translate into a greater appreciation and use of the Society's historic sites and services as well as a greater participation in private gift support.

In my work as a fundraising consultant, I have been involved in requesting gifts for the Heritage Center expansion project from people throughout North Dakota. At this time the Foundation has *total private sector gift support of between \$3 and \$4 million for this project, when combining all signed commitments, verbal commitments and an estimate of eventual gifts from outstanding requests.* This has all been accomplished since we launched this campaign about five months ago. All of these contributors are waiting to see what the state of North Dakota will do and, in many cases, they have made their commitments *contingent* upon the state's participation.

Now on a more personal note. I've lived in North Dakota my entire life. I believe that an investment in the State Historical Society is really an investment in our future. A willingness to invest in our history is a statement to ourselves and the rest of the country that we want to accomplish something that will set us apart, that will clearly demonstrate who we are; where we come from; what defines us; what makes us unique and why we love this special land, which we call home. It is a commitment to future generations that we will preserve and present our collective stories so as to motivate future generations to improve upon the lives we have lived. The mission of the Historical Society is to educate and inspire everyone who lives in this state or visits our state, young and old alike, no matter what their background. Their work is a lasting legacy, which will continue for many years, affecting thousands of citizens and visitors.

I urge you to support the full appropriation for the state's history agency. Thank you.

Working Plan for Lincoln Bicentennial in North Dakota

What follows is a brief overview of ideas and a proposed general timeline for the Abraham Lincoln Bicentennial in North Dakota and represents the genesis of a working plan for the commemoration. It is a work in progress, intended to provide initial information about program/project possibilities and other ideas being considered for the Lincoln Bicentennial in North Dakota. These program and project possibilities and other ideas will expand in scope as discussions continue on a statewide basis.

This working plan begins with information about the creation of the national bicentennial commission, followed by some Lincoln connections to North Dakota, a list of bicentennial project/program possibilities generated during recent discussions with the above agencies, a proposed budget for the 2007-09 biennium, and other funding and program possibilities. It concludes with a proposed basic timeline for the Lincoln Bicentennial in North Dakota.



The 200th anniversary of the birth of one of our greatest presidents, Abraham Lincoln, is fast approaching. The story of

Lincoln's life is one of commitment to the ideals of freedom, democracy, human rights, and equal opportunity for all. Lincoln's

unwavering support for preserving the Union and his courageous actions to end slavery are the achievements for which he is best remembered.

The Abraham Lincoln Bicentennial Commission (ALBC), established by a Joint Resolution of Congress in January 2000, is charged with planning a fitting and proper observance of the 200th anniversary of Abraham Lincoln's birth. The commission is a diverse group of political leaders, jurists, scholars, and collectors united by their admiration for Lincoln and devotion to his ideals. The 15 members of the ALBC were appointed by President Clinton, the Senate, and the House of Representatives to commemorate Lincoln's 200th birthday and to emphasize the contribution of his thoughts and ideals to America and the world. Two of the commissioners are U.S. senators and two are members of the U.S. House of Representatives who represent states where Lincoln lived, practiced law, and served in the legislature. Commission cochairs are U.S. Senator Richard Durbin (D-IL), U.S. Representative Ray LaHood (R-IL), and Harold Holzer, Senior Vice President for External Affairs at the Metropolitan Museum of Art in New York City and one of the nation's leading

authorities on Lincoln and the political culture of the Civil War era. The other 12 commission members are Dr. Jean T. D.

Jackson, Jr. (D-IL); Lura Lynn Ryan of Illinois; Louise Taper of California; Judge Tommy Turner of Kentucky; and Chief Justice Frank J. Williams of Rhode Island. Its executive director is Eileen R. Mackevich, co-founder and president of the Chicago Humanities Festival from 1989 to 2005. Prior to that, she was a broadcast journalist and talk show host for 18 years at WBEZ, the Chicago affiliate of National Public Radio, and deputy director of the Illinois Humanities Council.

In addition, there is an Advisory Committee consisting of more than 100 Lincoln students, scholars, and other interested individuals and a Governors' Council consisting of a governor-appointed representative from each state (as of November 2006, 37 states were represented). The ALBC's website address is www.lincolnbicentennial.gov.

The ALBC adopted and presented a Report to Congress in June 2004 that outlined the general priorities and program areas for the Bicentennial Commemoration.


One of those priorities is the issuing of a Lincoln commemorative coin in 2009. Legislation was introduced in Congress in



2005 directing the Secretary of the Treasury to mint 500,000 one-dollar commemorative coins honoring President Lincoln. The Senate passed the measure on a voice vote September 8, 2006, two days after the House voted 401-0 to approve the bill. President Bush signed the legislation September 27, 2006 approving the commemorative coin, which will be comprised of 90 percent silver and 10 percent copper. The coin's design will be selected by the Treasury Secretary in consultation with the ALBC.

With the bicentennial observance of the Lewis and Clark Expedition (1803-06) concluding this year, the bicentennial of Abraham Lincoln's birth will provide an additional component to North Dakota's increasingly important emphasis on cultural heritage tourism. The state's commemoration of the Lincoln Bicentennial will be in conjunction with the official national commemoration dates, which begins with a major event at his birthplace in Kentucky on February 12, 2008, continuing through February 12, 2010. The state's major focus will be during the period leading up to and including Lincoln's 200th birthday on February 12, 2009.

Although Lincoln never visited North Dakota (part of what was then Dakota Territory), there are a surprisingly significant number of Lincoln connections to our state.

Lincoln Connections to North Dakota

Appointed the First Two Governors of Dakota Territory

With just two days left in his Presidency, James Buchanan on March 2, 1861 signed an act that created two new territories: the Nevada Territory, which Congress carved out of Utah, and Dakota Territory, which included what would become North Dakota, South Dakota, Montana, and part of Wyoming by 1890.

Lincoln took office on March 4, 1861, and soon appointed as Dakota Territory's first governor Dr. William Jayne (1826-1916), his personal physician from Springfield, Illinois. Prior to his appointment as territorial governor, Javne had been the mayor of Springfield (1859-61). He became a member of the Illinois State Senate in 1860, and resigned in 1861 to accept Lincoln's appointment as the new governor of Dakota Territory. During his first months in the Territory's capital of Yankton, Jayne lived in a small log cabin that served as the governor's executive office. After resigning in 1863 he returned to Illinois, served as an Indiana U.S. Representative for one year, and then returned to his medical practice. He again was mayor of Springfield from 1865-80.

Lincoln also appointed the second governor of Dakota Territory, Newton Edmunds of Yankton (1819-1908), who took the oath of office on November 2, 1863, the only resident of Dakota Territory ever to hold the office. His most important contribution was participating in the 1865-66 negotiation of treaties with the Sioux and other tribal groups along the Missouri River. As territorial governor, he also served as Superintendent of Indian Affairs for Dakota Territory. Upon his return from a peace mission in August 1866, he was replaced as governor, as a result of political quarreling between President Andrew Johnson and Radical Republicans in Congress.

Other officials from the Dakota Territory days who had contact with Lincoln included Alexander McKenzie (1851-1922). political agent for the Northern Pacific Railroad who was pivotal in removing the territorial capital from Yankton to Bismarck in 1883, also known as "Alexander the Great, Boss of North Dakota"; Enos Stutsman (1826-74), an elected representative to the territorial legislature in Yankton and customs agent for the federal government; and Walter Burleigh (1820-96), who represented Dakota Territory as a non-voting delegate in the U.S. House of Representatives from 1865-69. Counties in North Dakota are named after all three men.

Signed the Homestead Act

On May 20, 1862 Lincoln signed into law the Homestead Act, which had a major impact in opening up settlement of the Northern Plains, including what is now North Dakota. A total of 275 million acres, or 10 percent of the United States, were claimed under the act. Under its provisions, which took effect on January 1, 1863, anyone who was the head of a household and 21 years of age was eligible to claim 160 acres of land. The only cost to the homesteader was an \$18 filing fee, after making the necessary "land improvements" of constructing a house and plowing the ground. The homesteader had five years to make the required improvements. The act spurred a great land boom in the western United States, and was largely responsible for populating what is now the state of North Dakota. Pioneers settling in North Dakota came in two waves

as a result of the Homestead Act. Between 1879 and 1886, more than 100,000 people settled in the northern Dakota Territory. which became North Dakota after statehood was granted in 1889. The second great movement began in 1898 and continued until about 1915.

Signed the Charter for the Northern Pacific Railroad

Congress approved a bill for a northern railroad route. and President Lincoln signed the charter for the Northern

warriors for more than six weeks. As a result of the Dakota Conflict, 393 Dakota and mixed bloods were put on trial for "murder and other outrages" committed against white settlers. Of these, 303 were sentenced to be hanged. Lincoln

pardoned all but 39, those convicted of rape or participating in the massacre of settlers. One of them was reprieved between the date of Lincoln's order and the actual execution date of December 26, 1862 in Mankato, Minnesota, which marked the largest mass execution in American history. Lincoln's clemency created considerable resentment, enough so that in the 1864 Presidential Election, he won Minnesota by only a narrow margin over his Democratic opponent, General George B. McClellan.

1869, when financing was provided by the banking house of Jay Cooke and Company of Philadelphia. By 1873, track had been completed from Duluth, Minnesota to Bismarck, North Dakota, where it stopped when the NPR went bankrupt as a result of the Panic of 1873 and had to reorganize.

Lincoln and the Dakota Conflict. Including the Siege at Fort Abercrombie

In the summer of 1862, President Lincoln sent his private secretary, John G. Nicolay, to accompany the U.S. Commissioner of Indian Affairs, William P. Dole, on a treaty-making mission to the Chippewa nation. In preparation, Dole's party assembled in St. Cloud, Minnesota in mid-August. However, they had barely started west to Fort Abercrombie when the Dakota

Forts Named in Lincoln's Honor

Located seven miles south of Mandan, the U.S. Army established an infantry post on June 14, 1872 and originally named it Fort McKeen, for Colonel Henry McKeen, killed during the Civil War at the Battle of Cold Harbor, Virginia in June 1864. On November 19, 1872, it was renamed Fort Abraham Lincoln, in honor of the assassinated President. In 1873, it Bismarck, Fort Lincoln was first occupied in 1903, with facilities for four companies of infantry and supporting detachments. It was used as an active U.S. Army training base for World War I trainees. Fort Lincoln was used during World War II as an internment camp for German and Japanese military and civilian personnel. After the war, the U.S. Army Corps of Engineers used it as the planning center for the Garrison Dam

became a ninecompany cavalry and infantry post, with a garrison of about 1,000 people. including 655 soldiers. Beginning the same year, Fort Abraham Lincoln served as the final base of operations for Lt. Colonel George A. Custer and the Seventh U.S. Cavalry. The

flamboyant "Boy General" of the Civil War departed from the post with his troops on May 17, 1876. Six weeks later, 265 soldiers, including Custer, were killed in a battle with Sioux, Cheyenne, and Arapaho warriors along the Little Bighorn River in Montana Territory. Fort Abraham Lincoln was abandoned on July 22, 1891. A second fort, also named after the 16th President (this one did not include the first name of Abraham), was authorized for construction in 1895, to replace nearby Fort Yates. Built south of Project. Today, it is the campus of United Tribes Technical College, which opened in 1969.

<u>Lincoln's Tomb</u> <u>Includes Statue</u> <u>Designed by</u> <u>Sakakawea</u> <u>Sculptor</u> The

sculptor of the Sakakawea statue on the state capitol grounds in Bismarck and in National Statuary Hall in

Washington, D.C., Leonard Crunelle (1872-1944), also designed a statue, entitled Lincoln the Soldier, that is featured inside Lincoln's tomb in Springfield, Illinois. The original statue of Lincoln the Soldier stands in Dixon, Illinois. The sculpture shows Lincoln as he might have looked as a soldier in the Black Hawk War of 1832. Lincoln recalled that he "went to the campaign, served nearly three months, met the ordinary hardships of such an expedition, but was in no battle."



Lincoln Statue in Norway Funded/Dedicated by North Dakotans

In 1914, as part of the 100th anniversary of Syttende Mai, Norwegian Independence Day, a group of Norwegian-Americans in North Dakota collected enough money to erect a statue of Lincoln in Oslo, Norway. The idea for the heroic-sized bust of Lincoln was inspired by a similar sculpture North Dakota Governor Louis Hanna had seen on a trip to Gettysburg to attend the 50th anniversary of that battle in July 1913.

A delegation traveled to Norway to present the bust as a gift from the people of North Dakota, with the unveiling taking place on July 4, 1914. Speeches were given by Governor Hanna, Editor P.O. Stromme of Grand Forks, and Smith Stimmel, a Fargo man who had once served as a bodyguard to President Lincoln. Governor Hanna's daughter, Dorothy, unveiled the statue, which still stands today in Frogner Park in Oslo. It was accompanied by two engraved bronze tablets. One featured an excerpt from Lincoln's Gettysburg Address and reads "Government of the people, by the people, for the people, shall not perish from the earth." The other reads, "Presented to Norway by the people of North Dakota, U.S.A., July 4th, 1914."

During Germany's occupation of Norway during World War II, the Lincoln bust became the site of silent anti-Nazi protests. Each July 4 beginning in 1940 until the war ended in 1945, Norwegians turned out by the thousands to gather around the statue, their heads bowed in silence. Typically, the Germans forbade any public gatherings or demonstrations, but did not halt this annual event.

The statue was done by 21year-old Paul Fjelde (pronounced Fell-dee) (1892-1984), an artist living in Valley City who had a long and successful career as a sculptor and was known for his sculptures of famous Norwegian-Americans like Charles A. Lindbergh. Fjelde was selected by a committee chaired by Governor Hanna to create the bust of Lincoln, which was cast in bronze in Chicago. This is the only statue in Oslo's Frogner Park that is not the work of Norwegian sculptor Gustav Vigeland (1869-1943).

A replica of the Lincoln bronze bust is located on the front lawn of the Traill County Courthouse in Hillsboro, where it was dedicated in ceremonies on September 8, 1918. A second bronze replica, now at the Geneseo Historical Museum in Illinois, was originally located at the Union Stockyards in Chicago. When the stockyards closed in 1971, it was moved elsewhere in the state before being purchased by a former resident of Geneseo and donated to the museum in 1998. The original plaster cast of the bust is housed in the Allen Memorial Library at Valley City State University. Fjelde was a student at then-Valley City State Normal School when he created the statue.

North Dakota Lincoln Bicentennial Project, Program Possibilities

Here is a breakdown of project and program possibilities as identified by each agency during recent discussions, followed by a proposed budget for the 2007-09 biennium that provides additional details about some of the projects listed here.

Many of the following project and program possibilities are dependent on state and/or federal appropriations. Additional funding beyond that listed in the proposed 2007-09 biennium budget included later in this report would allow many of these proposals to become a reality.

The State Historical Society of North Dakota (SHSND)

- The SHSND will premier an exhibit at the North Dakota Heritage Center in February 2008 in conjunction with the official launch of the national bicentennial. It will explore the impact of the Homestead Act and the Northern Pacific Railroad charter on what was in Lincoln's time Dakota Territory. The exhibit will also make clear that the 150th anniversary of the Civil War is approaching (2011), and that topic's ties to North Dakota history will be examined in detail at that time. Based on this exhibit, two user-friendly traveling exhibits will also be made available for smaller venues throughout the state, such as public libraries, county and local museums, community centers, and other public locations. These exhibits will be administered through the SHSND's Traveling Interpretive Exhibits Service (TIES) program.
- Enhance the North Dakota Heritage Center's main gallery with Lincoln-specific labels added to appropriate stories and artifacts.
- Develop curriculum for grades K-12, to also include development for posting on the SHSND website.
- Host summer teacher institutes, through what are now Lewis and Clark Teacher Institutes, to be renamed the Teacher Resource Council, to include building on themes of the Lincoln Bicentennial. These institutes involve several agencies,

including the North Dakota Council on the Arts. Grants from the National Endowment for the Humanities and the Teaching American History program are available for such institutes. Target dates are the summers of 2008 and 2009.






- Work with the SHSND Foundation and Cass-Clay Creamery, Inc., of Fargo to continue the *Fun Facts* series created for the Lewis and Clark Bicentennial, to include Lincoln and his connections to North Dakota. SHSND staff will continue working with Cass-Clay to provide images and information to feature on milk cartons. This partnership began in 2003, when the two partners announced plans to feature Lewis and Clark history items on 120 million milk cartons during 2003-07 in North Dakota, South Dakota, and Minnesota. This partnership will continue, highlighting Lincoln items, as well as significant historic sites, in all three states, for the next several years. The SHSND Foundation is a private, non-profit organization which supports programs and activities of the SHSND.
- Feature as the theme of the 2007 and 2008 Governor's Conferences on North Dakota History Lincoln and his impact on the state, including the Homestead Act and the coming of the railroad. Also explore the idea of North Dakota hosting a national symposium on Lincoln.
- Consider featuring Lincoln-related articles in the quarterly journal, *North Dakota History*, addressing such issues as the coming of the railroad, Lincoln's Indian policy, the Homestead Act and other topics.
- Work with the North Dakota Department of Public Instruction to identify K-12 schools statewide with the Lincoln name and develop appropriate school-based programs.
- Explore with the North Dakota Department of Public Instruction (DPI) the idea of republishing or posting on the SHSND's website a 24-page booklet issued by DPI in 1909 for Lincoln's 100th birthday, entitled Abraham Lincoln Centenary. It includes a foreword by then-

"With malice toward none, with charity for all, with firmness in the right, as God gives us to see the right, strive on to finish the work we are in to bind up the nation's wounds ..." Abraham Lincoln Second Inaugural Address, March 4, 1865 Superintendent of Public Instruction W. L. Stockwell, who wrote: "We do hope that on February 12, 1909, in every school house in the state the children will be gathered with their teachers and parents for the purpose of spending at least the afternoon of that day in contemplation of the true greatness of Lincoln and that all will drink deeply from this foundation of unselfish devotion to duty."

• Work with North Dakota's tribal communities to discuss areas of possible interest in commemorating the Lincoln Bicentennial.

The North Dakota Humanities Council (NDHC)

- Use the North Dakota Reads program to generate book discussions throughout the state on books relating to Lincoln.
- Look at developing some Lincoln-related characters for Chautauqua by 2008.
- Include Lincoln-related items on the *Dakota Datebook* history series that airs daily on North Dakota Public Radio, and is sponsored by the NDHC and the SHSND.
- Look at using the NDHC Speakers' Bureau as a source for programs statewide, as well as the national Lincoln Bicentennial Commission's Speakers' Bureau.

- Submit an application to bring the Museum on Main Street traveling exhibit program in 2008-09 to small towns in North Dakota (specifically, six towns with populations under 10,000). The theme that year will be "The History of Transportation." Museum on Main Street is a partnership project of the Smithsonian Institution, state humanities councils, and rural museums nationwide. It is funded by the Congress.
- Work with speech/oratory clubs and classes to feature Lincoln speeches, such as the Gettysburg Address and Second Inaugural Address.

The North Dakota Council on the Arts (NDCA)

- Work in partnership with others in development of website-based curriculum, including collaboration with the North Dakota Information Technology Department's EduTech program.
- Work with state symphonies/orchestras to feature music programs related to Lincoln and his times.
- Sponsor discussion groups to discuss Steven Spielberg movie, A Team of Rivals, featuring Liam Neeson as Abraham Lincoln, after its release.



- Support Shakespeare festivals/productions, emphasizing Lincoln's love of Shakespeare. Lincoln, said his private secretary John Hay, "read Shakespeare more than all other writers together." Hay said he would listen for hours, "evening after evening," as Lincoln read to him from his favorite plays: *Hamlet, King Lear*, the histories, and especially *MacBeth*.
- Sponsor an art exhibit emphasizing values symbolized by Lincoln, such as freedom, human rights, equal opportunity.
- Work with speech/oratory clubs and classes to feature Lincoln speeches, such as the Gettysburg Address and Second Inaugural Address.
- Spotlight opera houses throughout the state that were constructed as a result of the influx of settlers responding to the Homestead Act signed by Lincoln.
- The NDCA has included an optional funding package in its proposed budget for FY 2007-09 for Lincoln-related programming statewide.

The North Dakota Department of Commerce Tourism Division

- Use the Lincoln Bicentennial as one of the vehicles of transition into cultural heritage tourism as the state moves beyond its commemoration of the Lewis and Clark Bicentennial.
- Emphasize and promote attractions featuring events for the Lincoln Bicentennial. While difficult to highlight Lincoln in the state, since he never visited what is now North Dakota, the bicentennial will generate programs, activities, exhibits, and more that the State Tourism Division can market and promote to North Dakota's tourists, as well as state residents.
- Use the State Tourism Division's new Learning-Based Vacation program, launched in May 2006, which creates learning-based vacations customized for people interested in combining learning with fun and adventure, as a vehicle to encourage attendance/participation at Lincoln-based programs and activities throughout the state.

The North Dakota Parks and Recreation Department

- Highlight programs/guest speakers at the state park named after Lincoln, Fort Abraham Lincoln State Park in Mandan, including possibly Chautauqua.
- Research Lincoln's record as a public official to see if any possible conservation/environmental issues that could be highlighted in regard to the bicentennial.
- Work with the SHSND's quarterly journal, North Dakota History to feature an article or articles related to the 100th anniversary of the establishment of Fort Abraham Lincoln State Park in 2007.
- Include an insert on Lincoln in the Dakota Explorer youth, ages 6 to 14, activity booklet for all state parks.
- Use state parks as special events sites for the Lincoln Bicentennial.

Proposed Budget for Lincoln Bicentennial in North Dakota FY 2007-09

Here are estimated costs for some of these proposed programs and projects the State Historical Society of North Dakota and other agencies could fund with the proposed \$50,000 'seed money' that Governor Hoeven has agreed to include in his Executive Budget proposal for FY 2007-09. Specifically, this \$50,000 will be included in the State Historical Society's proposed budget for FY 2007-09.

\$15,000 -	Traveling Exhibit about Abraham Lincoln and North Dakota/Dakota Territory. Developed and produced by the SHSND as part of its Traveling Interpretive Exhibits Service (TIES) program. Two copies of the exhibit would be produced for maximum circulation statewide to public libraries, county and local museums, community centers, and other public locations, with a variety of handouts included for free public distribution. This would also include adapting the format for use on the SHSND website. Explore the possibility that the exhibit development process could also result in an article or articles for <i>North Dakota History</i> relating to these topics.
\$15,000 -	Curriculum development for grades K-12, useable for teachers, students, and other interested groups and individuals, to also include development for posting on SHSND website. Examining Lincoln and his impact on the state, including the Homestead Act, the coming of the railroad and related issues. Look to work in partnership with the North Dakota Council on the Arts for development of website-based curriculum, in collaboration with the North Dakota Information Technology Department's EduTech program; and the North Dakota Humanities Council to encourage Lincoln-related reading through its <i>North Dakota Reads</i> program.
\$7,500 -	Exhibit at the North Dakota Heritage Center about the impact of the Homestead Act and railroad on what is now North Dakota.
\$5,000 -	Chautauqua living history program to present a series of Lincoln-related characters to the public and school groups statewide by 2008. This funding amount would be matched by the North Dakota Humanities Council, through a grant from the National Endowment for the Humanities. An additional federally funded match would also be possible through the North Dakota Council on the Arts.
\$5,000 -	Through the North Dakota Teacher Resource Council, use this as a cash match for a Teach American History grant from the U.S. Department of Education, as well as other grant resources.
\$2,500 -	National History Day 2008 resources applied to North Dakota students, working with the Lincoln-related National History Day theme for the year 2008 (this idea is still being explored by the National Lincoln Bicentennial Commission).
\$50,000	Total

Other Funding and Program Possibilities

- Prairie Public Broadcasting, to include funding partnerships to develop program(s) relating to the Lincoln Bicentennial and connections to North Dakota.
- We the People, a funding initiative from the NEH that explores significant events and themes in our nation's history through grants to scholars, teachers, museums, libraries, filmmakers, and other individuals and institutions.
- The North Dakota Cowboy Hall of Fame's Center of Western Heritage and Cultures exhibit on the Homestead Act,, which will include an original copy of the Homestead Act signed by President Lincoln in 1862. The exhibit is scheduled to be at the Center from May through October 2007.
- Railroads (grants)
- Save Our History, a grant program from the American Association for State and Local History (AASLH), designed to encourage collaboration between history organizations and schools or youth groups. The AASLH has partnered with The History Channel to

offer grants of up to \$10,000 annually to support unique educational community preservation projects.

- Ford-Lincoln Mercury dealers
- State Bar Association of North Dakota. Explore the possibility of its annual meeting theme in 2009 to be Lincoln-related, as well as featuring Lincoln-related articles in its publications.
- North Dakota Newspaper Association

Tentative Basic Timeline

In this age of "instant communications" via the Internet, email, conference calls, fax machines and more, staying in touch is not a problem. Because of this, and because of Lincoln's relatively limited history with the state in comparison with states like Illinois, Indiana, and Kentucky, a Lincoln Bicentennial commission/advisory council for North Dakota is not necessary. Instead, as Governor Hoeven's designated representative on the Governors' Council of the national Lincoln Bicentennial Commission, Rick Collin will serve as the contact and coordinator to get the word out via a statewide network that will be developed. This will include a presence on the State Historical Society of North Dakota's website that includes a schedule of events, curriculum, and other Lincoln bicentennial related activities, as well as electronic newsletter that Collin will launch in 2007. Meetings for bicentennial planning will be arranged when needed.

Efforts will also be coordinated when needed with the Governor's Office to publicize events and activities relating to the Bicentennial.

As a point of information, as of November 2006, the legislatures of the following states have approved legislation to appoint a Lincoln Bicentennial commission for their state – Delaware, Idaho, Illinois, Indiana, Kentucky, Missouri, New York, Pennsylvania, Rhode Island and West Virginia.

Basic working timeline for the Lincoln Bicentennial in North Dakota

February 13, 2006 – Initial meeting of Lincoln Bicentennial Commission state coordinators and commission members in Washington, D.C.

Spring/Summer 2006 – Develop details of Lincoln Bicentennial budget based on \$50,000 seed money to be included in Governor's Executive Budget for the 2007-09 biennium beginning July 1, 2007 and continuing through June 30, 2009. Work to include matches for additional funding where possible. 0

Summer/Fall 2006 – Continue discussions about bicentennial with groups/individuals now involved and expand discussions to also include other groups/individuals statewide.

January 2007 – Introduce resolution in 2007 North Dakota Legislative Assembly promoting Lincoln Bicentennial in the state.

February 11, 2007 – Second meeting of the Lincoln Bicentennial Commission and state coordinators. Meeting location will be Springfield, Illinois.

Spring 2007 – Contact appropriate leadership in the North Dakota Legislative Assembly to form a committee to begin planning the official commemoration of Lincoln's 200th birthday on Thursday, February 12, 2009, during the 2009 Legislative Assembly.

Spring/Summer 2007 – Establish Lincoln Bicentennial in North Dakota website as part of the SHSND's website, to include a link to the national commission website. Also launch electronic newsletter to keep extensive statewide network informed about North Dakota's commemoration. February 12, 2008 – Official launch of the National Lincoln Bicentennial at his birthplace in Kentucky, a National Park Service site.

January 2009 – Finalize preparations honoring actual 200th birthday of Lincoln on February 12 as program at 2009 North Dakota Legislative Assembly.

February 12, 2009 – 200th anniversary of Lincoln's birth, marked by nationally televised event and rededication of the Lincoln Memorial in Washington, DC. The ceremony will be built around the bicentennial themes of freedom, democracy and equal opportunity and will feature fireworks, music and a Presidential Address. A program will also be featured at the North Dakota Legislative Assembly this day.

February 12, 2010 – Official close of the National Lincoln Bicentennial.

February-December 2010 – Bicentennial transition to 150th anniversary of Lincoln's election as President and the beginning of the Civil War.
