

The North Dakota Board of Veterinary Medical Examiners has submitted several proposed amendments to the veterinary medical practice act (NDCC 43-29) for consideration by the 2007 Legislature. These amendments are included in House Bill 1052. In preparing the amendments, the board noted several inaccuracies in the practice act's statement of purpose (43-29-01). Several possible revisions were discussed by the board. The statement of purpose was also discussed in two open sessions hosted by the North Dakota Veterinary Medical Association, but there was no consensus on what changes, if any, should be proposed. The board also considered the recommendation on page 95 in the Legislative Council's 2007 North Dakota Legislative Drafting Manual, which states: "A statement of legislative policy, purpose, or intent should not be used. Such statements are unnecessary as the purpose of a properly drafted bill should be self-evident. It is unknown how future amendments to the substantive provisions of the bill affect, or are affected by, a legislative policy, purpose, or intent statement that is not amended to reflect those future amendments. In addition, statements contained in a declaration of finding or intent may be used for a purpose unintended by the drafter." During a conference call on November 21, the board voted to propose repeal of the purpose statement, which SB 2056 accomplishes.

Senate Bill 2056 House Agriculture Committee, March 8, 2007 John R. Boyce, Executive Secretary, North Dakota Board of Veterinary Medical Examiners

The North Dakota Board of Veterinary Medical Examiners submitted several proposed amendments to the veterinary medical practice act (NDCC Chapter 43-29) for consideration by the 2007 Legislature. These amendments were included in House Bill 1052, which has now passed both the House and the Senate.

In preparing the amendments to the practice act, the board noted several inaccuracies in the practice act's statement of purpose (43-29-01). Several possible revisions were discussed by the board. The statement of purpose was discussed in open sessions hosted by the North Dakota Veterinary Medical Association in Fargo on September 27 and in Bismarck on November 9. At these meetings, there was no consensus on what changes, if any, should be proposed.

The board also considered the recommendation on page 95 in the Legislative Council's 2007 North Dakota Legislative Drafting Manual, which states: "A statement of legislative policy, purpose, or intent should not be used. Such statements are unnecessary as the purpose of a properly drafted bill should be self-evident. It is unknown how future amendments to the substantive provisions of the bill affect, or are affected by, a legislative policy, purpose, or intent statement that is not amended to reflect those future amendments. In addition, statements contained in a declaration of finding or intent may be used for a purpose unintended by the drafter."

During a conference call on November 21, the board voted to propose repeal of the purpose statement, which SB 2056 accomplishes.

CHAPTER 43-29 VETERINARIANS

43-29-01. Purpose of the chapter. This chapter must be deemed an exercise of the police powers of the state of North Dakota acting through the legislative assembly to the end that the general welfare of the agricultural public, the livestock industry, and the people as a whole will be preserved and enhanced through the control and supervision hereby vested in the North Dakota state board of veterinary medical examiners, in licensing of veterinarians, defining their scope of activity in treatment of livestock, fixing their responsibility in the conduct of their practice, listing the requirements necessary to pass an inspection of their facilities, listing of the educational requirements necessary for licensing renewal, listing of the rules of professional conduct, defining the handling of abandoned animals, defining the duties and conduct of graduate veterinary technicians, and preventing unqualified persons from engaging in veterinary practice by instituting the necessary legal proceedings for the law's proper enforcement.

43-29-01.1. Definitions. As used in this chapter, unless the context otherwise requires:

- 1. "Accredited or approved college of veterinary medicine" means any veterinary college or division of a university or college which offers the degree of doctor of veterinary medicine or its equivalent and which conforms to the standards required for accreditation or approval by the American veterinary medical association.
- "Accredited program in veterinary technology" means any postsecondary educational program of two or more academic years that has fulfilled the essential criteria established by the committee on veterinary technician education and activities and approved by the American veterinary medical association house of delegates.
- 3. "Animal" means any animal other than a human being. The term includes any mammal, bird, fish, reptile, or fowl, whether wild or domestic, living or dead.
- 4. "Board" means the board of veterinary medical examiners.
- 5. "Certificate" means a certificate issued by the educational commission for foreign veterinary graduates or the educational equivalence program of the American association of veterinary state boards, indicating the holder has demonstrated knowledge and skill equivalent to that possessed by a graduate of an accredited or approved college of veterinary medicine.
- 6. "Licensed veterinarian" means a person who is licensed by the board to practice veterinary medicine.
- 7. "Licensed veterinary technician" means a person who has graduated from an accredited program in veterinary technology or an equivalent program as determined by the board, and who has passed an examination prescribed by the board.
- 8. "Practice of veterinary medicine" means to:
 - a. Diagnose, treat, correct, change, relieve, or prevent animal disease, deformity, defect, injury, or other physical or mental conditions. The term includes the prescription or administration of any drug, medicine, biologic, apparatus, application, anesthetic, or other therapeutic or diagnostic substance or technique, the use of any manual or mechanical procedure for testing for pregnancy, or for correcting sterility or infertility, or to render advice or recommendation with regard to any of the above.
