Minutes:

Sen. Tim Flakoll-chairman opened the hearing on SB 2107, a bill for an act to amend and reenact section 4-33-12 of the North Dakota Century Code, relating to deposit of fees for agricultural export certification services.

David Nelson, manager of the phytosanitary certification program in the Department of Senate Agriculture testified in favor of the bill. See attached testimony.

Sen. Taylor- so the certificate for exporters and their exporting plants or plant seeds, what's a example of these exporters and what they are and what they're doing?

David Nelson- foreign countries require a certificate to assure them that their plant requirements have been met, we issue these certificates.

Sen. Wanzek- so up till now they didn't charge a federal fee and now they decided to charge it?

David Nelson- USDA has struggled to figure out how to fund the administration of this program and they do have a large staff that works with foreign countries to determine what foreign country regulations are, and they have a database that we have access to to figure out what those regulations are, they have a large amount of work to do to develop policies.

Sen. Wanzek- so your saying they're not doing anything new it is just to help fund some of the costs that they have?

David Nelson- that is correct.

Sen. Klein- so its your job then to go out and inspect and then to develop the certificates?

David Nelson- we do inspect some shipments but the majority of shipments are officially sampled by the federal grain inspection service or by one of the agencies that they over see.

Other times they forward the official samples to us and we inspect it.

Sen. Klein- so if something shows up in the Philippines no certificates, what happens?

David Nelson- I contact USDA-APHIS and there's a form that we actually fill out where the exporter provides all the details, whose holding it up, what's the reason, is there a official document supporting that. Once APHIS has that document then they contact Senate Agriculture in the foreign country and find out what the issue is and how to resolve it, sometimes they come back to me and I provide additional information on the inspection or some other pieces of information relative to the plant pest status of the shipment. Sometimes they make that inspection right on sight.

Sen. Klein- and there are commodities from North Dakota that have been delivered directly to the Philippines?

David Nelson-Yes.

Sen. Flakoll- In the fiscal note looking at 2100 and the next number 2800 what is the justification?

David Nelson- those are the average number of phytosanitary certificates that we've issued in recent years the reason its 2100 and 2800 is because we don't expect this new fee to take effect until we're a quarter of the way through the next biennium.

Sen. Wanzek- so it will ultimately be guys like me that pay the \$16 right? You just need the authority to collect my money and turn around and pay the federal government?

David Nelson- that is correct. One other point the USDA-APHIS has to go through the federal rule making process so there will be a federal register note, so when that happens I will make the industry grain dealers association and so forth aware of that existence of that federal register note.

Sen. Wanzek- so your anticipating that the government is going to raise this fee, it hasn't actually been done yet, and these charges will not go through your department until the federal government actually implements that increase registration?

David Nelson- that is correct, because we only meet every other year, if this were to happen in the middle we would be in some trouble because we don't have the operating funds to pick up this fee ourselves so it's just the anticipation of that, if they don't do it there's no effect. No opposition of the bill.

Sen. Flakoll closed the hearing.

Sen. Klein motioned for a Do Pass and was seconded by **Sen. Heckaman**. The motion was carried on a roll call vote 7 yeas, 0 nays, 0 absent. **Sen. Klein** was designated to carry the bill to the floor.

Senate Bill 2107 amends NDCC 4-33-12 to allow the commissioner to deposit a portion of phytosanitary certificate fees in the commissioner's operating fund. This amount is equivalent to new fees assessed by USDA for federal plant export certificates.

USDA has indicated that they intend to pursue charging states an administrative fee of \$16 per federal phytosanitary certificate as early as the Fall of 2007.

The department anticipates that USDA will charge a \$16 administrative fee for each federal phytosanitary certificate issued by the state. The commissioner would then increase fees charged to exporters by \$16 to cover these charges. We estimate that 2,100 certificates will be issued during the 2007-2009 biennium resulting in additional revenues of \$33,600 and estimate that 2,800 will be issued during the 2009-2011 biennium resulting in additional revenues of \$44,800.

The department will expend all additional revenues to cover the new administrative fee charged by USDA for federal phytosanitary certificates issued by the department.

Dave Nelson, Dept of Agriculture: (testimony attached)

Rep Mueller: The phytosanitary certificates are issued for what?

Nelson: Agricultural products that foreign countries require a certificate for entry.

For example, dry edible beans are required to have a certificate in many countries.

But there are many others too. Seed potatoes to Canada.

Rep Mueller: Are we currently charging fees and what we want to do is raise them \$16?

Nelson: Yes, currently we charge \$20 and the federal government charges \$50. Many other

states charge closer to \$50. We are providing a pretty good fee schedule for ND shippers.

The additional \$16 will cover the administrative fees the feds will be charging us.

Rep Mueller: Why are they doing that again?

Nelson: They provide a lot of support services including a data base.

Rep Boe: You indicated that we could get this certificate through the Ag Dept or the Feds.

Who is that? The grain inspection?

Nelson: No the agency in ND is the USDA-APHIS and they have an office in Bismarck.

Rep Boe: Did the seed department ever issue these?

Nelson: At one time the seed dept issued state phytosanitary certificates not federal certificates. Foreign countries no longer accept state phytosanitary certificates. The seed dept has one person able to issue phytos for seed potatoes within the last year

Rep Boe: The fee schedule has nothing to do with the volume of the sale? The cost could cover 100,000 or 1,000 bushels?

Nelson: I'm not exactly sure how the final federal rule will come out. They have had one fee for commercial shipments and a lesser fee for a smaller amount. We just have a flat fee of \$20.

Rep Brandenburg: Usually when an inspection is done someone comes out and inspects a box car and sends it in.

Nelson: We try to get creative and certify entire bins. Particularly shipments to Canada.

Rep Brandenburg: It also gives protection to the seller. The cost is worth it.
