Testimony In Support of Bill:

Sen. Robinson, Dist. #24 Opened and introduced the bill (meter 0:01) Spoke of who approached him to sponsor this bill. There are 11 institutions that this will effect. Att. # 2

Rep. Aarsvold, Dist. #20 In support of the bill Sen. Robinson gave his testimony (Meter 2:20)

Sen. Robinson spoke of his position at the University compared to another who is a salaried employee. Referred to Email support he had received (meter 4:30)

Sen. Nething questioned line 8, (meter 6:15) how the current law allows financial/tax records as already being exempt. Yes, but there are other issues out there that are not covered, this bill fills in the loop holes not covered (meter 6:30)

Sen. Nelson questioned about the "glossy" book they print of the donors and at what level they donate-will they be unable to do this? No they will still be able to do this. (meter 8:00) Discussion of annual reports and other type of documentations.

Gordon Binek, Interim President and Vice President of BSC (meter 9:13) Gave testimony – Att. #1.

Sen. Fiebiger requested a definition of "affiliated non-profit organization" (meter 10:49) and how wide spread this title would fall. Sen. Olafson question "net worth" of donors (meter 11:30) Mr. Binek discussed the information he has from working in this field the past 23 years.

Sen. Fiebiger question the language "any record related to perspective donor" (meter 12:54) was to broad? Discussion of this. They also discussed different types of publications.

Testimony in Opposition of the Bill:

15:17) I am not entirely opposed to the bill it is some of the language we have problems with. We are in opposition to line 11 language "any record" is overly broad. The original statute we did not have an opposition to. Restrictive language in line 9 and 10-there are some foundations that this does not effect and some the original bill does not protect. This bill by using "any records" effects to many things. Mr. McDonald requested to do a friendly amendment that would do what the bill is trying to do with out using such broad language (meter 17:50) **Sen. Nelson** spoke of ways to do this.

Sen. Robinson: I'm going to make some brief comments on this bill. The bill before you was heard on the Senate side in the Judiciary committee. I might add that they spent some time on this bill. Anytime that you deal with the issue of open records there is a lot of sensitivity. On the Senate side we have a census involvement with Jack McDonald. He was very involved in crafting these amendments and working through the bill. What you have before you represents consensus on the right thing to do. This bill is being introduced at the request of several foundation officers of the ND University System. The intent of the bill is to exempt some information of the donors of those institutions from open records. The privacy of this information is critical to the work that a foundation officer needs. Many donors wish to remain anonymous with their giving. Unfortunately some donors who have made gifts to one institution find themselves solicited by numerous other charities immediately following the timing of the gift. Some of the information that the bill intends to address is issues such as electronic mail. tax records, estate planning, etc. These schools are organized to provide support for their respective institutions. This bill will help them ensure that the donors there receive the privacy that they deserve. I urge your support of SB 2160. I serve as the foundation officers for one of the member schools of the NDUS. I can assure you that this very delicate issue. Picture

yourself of supporting your charity. You submit a contribution and within days you have 3 or 4 others soliciting you because that knowledge somehow got out. The donors want privacy. Some of them want to be totally anonymous. In this day and age when so much information is available, the intent here is to restrict some of that information. We are never going to have a fool proof system. We need to work on what we have. As for the officers on several other foundations, they want to remain anonymous. What we have here is a consensus. We have come together because we had concerns. We want to work with you. We aren't trying to do anything here that is at all wrong in any way. There has got to be a happy medium. We feel we have it in the changes that were made. With that I would stand for questions.

Gordy Binnick: BSC. I too am in support of this bill. A couple of issues I want to talk about. As the bill was written previously there was a feeling that it did not protect the foundation themselves. Rather it talked about the colleges and so on. Then it was modernized for electronic email addresses and so forth. I've been doing this foundation work for 23 years. I can tell you that I was asked on the Senate side if the public solicits the donors. People often do that. We do some of that. We want to protect the donors who want to remain anonymous and their specific information in terms of how much was actually contributed. We asked the owners for permission when we do disclose information. As I said I've been doing this for 23 years now. I know a lot of things about a lot of people's financial situation that they don't want to disclose to others. If you want to throw cold water on someone making a charitable gift is tell them that the information might become public someday. These are very important changes to the record. It's improving the situation that did exist. I support this bill.

Rep. Dahl: I just have one question. The foundations are private correct?

Gordy Binnick: Yes.

Rep. Dahl: They are not considered private.

Gordy Binnick: No, they are non profit corporations.

Rep. Kasper: What type of entities or organizations have asked you for this type of information that you wished you wouldn't have had to give but you have to because of the open records law.

Gordy Binnick: We have never been in this situation where we have had to tell someone that we wouldn't disclose that information. I think that the media has been very cooperative with this. I can see a situation where some day someone will come to us and say that they demand that information. In that case we would have to give it to them.

Rep. Kasper: How long as your foundation been in existence?

Gordy Binnick: We've been in existence since 1978. There was a situation where the NDUS was asked for specific donor information.

Rep. Kasper: In your particular case it is 27 years that you have not had a single request of your work.

Gordy Binnick: Not that I'm aware.

Rep. Amerman: Can you give me some examples of an affiliated non profit organization?

Gordy Binnick: The BSC foundation. That would be the type of affiliated non profit organization that we are talking about. The foundations that serve the members of the NDUS.

Rep. Haas: Is there any more testimony for SB 2160? If not we will close the hearing on SB 2160.

Remarks of Gordon Binek Vice President for College Advancement and Federal Relations Bismarck State College

For Senate Judiciary Committee January 16, 2007

Senate Bill No. 2160

The proposed change to 44-04-18.15 is important to Bismarck State College Foundation for two reasons:

The current statute does not specifically include organizations such as Bismarck State College Foundation. Although BSC Foundation is organized to support and assist the development and advancement of Bismarck State College, it may not be covered under the existing statute.

Donors and prospective donors to Bismarck State College Foundation must have confidence that the proprietary information they share with representatives of BSC Foundation is protected from record searches. Donors and prospective donors disclose personal, confidential information as they consider and enter into planned giving arrangements. Such information needs to remain confidential. Details, such as how much individuals have contributed also needs to remain confidential. If such information were open to public disclosure it would be a disincentive for many donors, they would not make major contributions which support and assist the NDUS colleges and universities and the students we serve.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1 AMENDMENT. Section 44-04-18.15 of the North Dakota; Century Code is amended and reenacted as follows:

44-04-18.15 – Fundraising and donor records of the board of higher education university system, and affiliated nonprofit organizations exempt. Any donor or prospective donor name, address, telephone number, email address, estate planning information, tax record or financial record information; including data detailing dates of gifts, payment schedule of gifts, form of gifts and specific gift amounts made by donors; or other personal information and correspondence received or retained by a board of higher education or university system officer or employee, or by an affiliated nonprofit organization that provides support to and is organized and operated for the benefit of an institution under the authority of the board of higher education, is exempt.
