Minutes: Relating to Immunity from liability for consumption of alcoholic beverages for under age.

Senator David Nething, Chairman called the Judiciary committee to order. All Senators were present. The hearing opened with the following testimony:

Testimony In Support of Bill:

Sen. Nick Hacker, Dist. #42 (meter :80) Introduced and reviewed the bill – Att. #1.

Sen. Nething questioned on page 3, how was 12 hours derived? (meter 7:12) It was an arbitrary number and any could be used, Colorado used similar language.

Sen. Nelson questioned (meter 7:49) on line 18, questioned in the case of a “keg” or fraternity party were it was a large group of people, who would be immune and who would be prosecuted. Discussion about the importance of having enough people with immunity to keep the panic down and possibly help medically, better odds with more then one or two.

Sen. Fiebiger asked how often (meter 9:13) have been charged. I am not aware of any charges. Law enforcement states that they do not charge the minor, but I have heard conflicting stories that they have been charged This bill is two fold, you can not legislate that a person makes the right decision to not do something, all we want to do is cut them some slack in the law part and second is “get help”!

Sen. Fiebiger questioned on page 5, 14-10-06 do they refer to the sexual conduct part of the code. Discussion of the part of law that a underage person could be charged with curfew. This is in here because of the delinquency "catch" all for minors.



Minutes:

Chairman DeKrey: We will open the hearing on SB 2204.

Sen. Nick Hacker: Sponsor (see attached testimony).

Rep. Dahl: Was this unique to ND, or have other states done this and to what result.

Sen. Nick Hacker: One other state has adopted similar legislation, this is modeled after the state of CO, and they believe it has achieved pretty good success.

Rep. Onstad: Would you call this a Good Samaritan law.

Sen. Nick Hacker: Yes.

Rep. Onstad: A couple of questions that have come up. If kids go out and go drinking, don't worry if you get alcohol poisoning, we'll take care of it.

Sen. Nick Hacker: I don't think that's the message we're trying to send here. I think the message we're trying to send is, get some help. Sometimes people are going to break the law no matter what you do. I don't think that this bill is going to encourage them to go out and binge drink. I think if they are going to do that, they will do it anyway. If they have the intent to binge drink, I think they are going to binge drink. This bill does not address minors drinking.

We need to do that at a different level besides legislation. We cannot dictate whether or not people are going to make good or bad decisions. All we can do is regulate on what happens

after they make that decision. Ideally, you would change at the root of the problem, this is beyond that stage.

Rep. Onstad: You made a statement, good or bad decisions. When is the time when a person becomes responsible for their own actions.

Sen. Nick Hacker: I'm not sure how to answer that question, because that bill does not address whether or not they should be responsible for their actions. If you want to talk about being responsible for actions, maybe we should take a look and say, we're going to allow you to be responsible to go out and seek the help that is needed, not to take it into their own hands and decide that, in fear of retribution, that they should take care of it and be the responsible one on their own. This sends a clear message, and I believe a little more responsibly, to call the police and come we need help.

Rep. Klemin: Under this, under the premise that this bill does not protect at all the person requiring medical assistance from consuming alcoholic beverages. If that person is under 21, they are subject to all the other penalties that are already on the books.

Sen. Nick Hacker: Yes.

Rep. Klemin: If the individual that calls 911, there are certainly other telephone numbers that could be called for emergency help, such as the sheriff, police department, etc. Is there some reason why you limited it to 911 rather than any call that's been made to emergency personnel.

Sen. Nick Hacker: No, if you wanted to put emergency personnel in there, or something along those lines, that's fine.

Rep. Klemin: Immunity, the maximum number of individuals that can be immune for any of these purposes, is 5 individuals. Are we going to have five people making telephone calls.

Sen. Nick Hacker: In the situation, what we wanted to try and avoid, the number is arbitrary, it could be three, five, four, a small group. If you have intoxicated individuals that are underage, trying to tend to an individual that is sick, it's probably not wise to say, one individual, everybody else has to leave. Now you've left yourself with a situation where you have a sick individual and another minor who is intoxicated waiting for help to arrive, that's kind of the idea behind the small group number.

Rep. Klemin: So if we had six people, then we have to decide which one has to leave. That person would not be immune and the rest would be.

Sen. Nick Hacker: Under the current draft of the law, yes. Because we don't know how to state small group, if you say small group, what does that mean. It was an arbitrary number. Colorado had three or four.

Rep. Koppelman: Just to pursue that, I think I understand your incentive. Doesn't that open up a possibility of a small gathering where people are indulging in this practice, that are underage and all becoming immune because we have protection for up to five people, so let's all call 911. I know that's not your intent, but I'm just wondering if you had thought of that.

Sen. Nick Hacker: Only one person needs to call 911, not all five. It provides immunity for the maximum number of up to five and that is just to address the same situation.

Rep. Koppelman: On page 2, line 12, item #7, it says an individual under 21 years of age is immune from criminal prosecution under this section if that individual called 911 and reported... Then at the bottom of that paragraph, it says the maximum number of individuals that may be immune for any one occurrence is five individuals. I would read that to say that all five have to call 911 to be immune.

Sen. Nick Hacker: I can see how you're reading that.

Rep. Klemin: It seems to me that this subsection 7 that is being referred to, contains the word "or" on page 2, line 15, or provided assistance to the individual in need of medical assistance... One called 911, the others provided assistance.

Sen. Nick Hacker: Yes.

Rep. Wolf: Do you have any statistics how many children are dying from alcohol poisoning in ND.

Sen. Nick Hacker: No, I don't have any statistics.

Rep. Wolf: Would this help.

Sen. Nick Hacker: Well, I think it will. Sometimes we have several purposes for why legislation is introduced. Sometimes it's about a message and sometimes it's the logistics. I think this runs a parallel track. It's to send a message that says if you need help, seek help and you will not get in trouble. I think it may not help all cases, but it may help some. To be honest, I think this help on some of our college campuses, because they will get the word out about things such as this.

Chairman DeKrey: Thank you. Further testimony in support. Testimony in opposition. We will close the hearing.

Chairman DeKrey: We will take a look at SB 2204.

Rep. Griffin: Explained his amendment.

Chairman DeKrey: Voice vote. Motion carried. We now have the bill before us as amended. What are the committee's wishes in regard to SB 2204.

Rep. Kingsbury: I move a Do Pass as amended.

Rep. Meyer: Second.

Rep. Wolf: I have real concerns about this, I understand what he is saying about college kids. I think it is a wonderful bill for college kids. It won't take long for the word to get out on the college campuses that this bill is here. My concern is that the word that is going to get out with high school students, a bill that says we can all go out and get drunk, and the worst of the

ones will call and none of us are going to get into trouble. If I call 911 I won't get into trouble, this is a concern to me.

Chairman DeKrey: I have the same concern too. Law enforcement will be back if there are problems with this bill.

Rep. Delmore: If you call 911, there better be an emergency, or you will get in trouble for that.

Rep. Wolf: I have a problem with page 3, where it talks about delivering alcohol to a minor and calling within 12 hours there will be mitigating circumstances.

Rep. Klemin: There is judicial discretion.

Rep. Onstad: I go back to the discussion about being responsible for yourself. If you are out drinking, you know it is breaking the law but it happens. I'm not going to sit there and look at the century code and I'm going to do the right thing and call 911. People need to be responsible.

Rep. Griffin: I just don't see the high school students doing this, I don't know why they would call the cops and say we've got someone sick here, they just wouldn't do anything here.

Rep. Klemin: When I was in college there were two incidents of people that died from overdrinking. One was in his room and one was in a closet.

Rep. Delmore: I think many of us remember the binge drinking bill that we passed last session for binge birthday drinks. I think we try to address it, but just to ignore the fact that somebody's life is in danger, I don't think it is very responsible for us not to pass this bill.

Minutes: Relating to immunity from liability for consumption of alcoholic beverages for under age.

Senator Lyson, Chairman of the conference committee called the members to order. All Senators and Representatives were present. The hearing opened with the following work:

Sen. Lyson requested that a House member explain the amendment. **Rep. Griffin** explained the first change was to take the word police and change it to law enforcement or emergency medical services. The second would allow them to be immune to prosecution as well.

Sen. Lyson asked if that is why you took out the maximum number? No, that was not my amendment it was the committees decision because they had concerns on which five.

Sen. Lyson stated that all that attended the party would become immune, even the ones that showed up later-to be part of the immunity. He also had concerns that the person needing assistance should become immune? The people who help should be immune. They discussed a scenario. (meter 3:00) **Sen. Fiebiger** stated his discussions with officers, usually they do not charge the people helping. If you do not have a cap then where is the line.

The committee discussed that the number would be decided by the police and the judge in the investigative process. They discussed the five people was derived with people staying with the sick person, a person calling for help, possible person directing the help arriving.

Sen. Lyson stated that the bill was designed to have someone stay and get help for the person who needs it. The first part of the amendment was in agreement with the committee. There was a discussion of an individual in need of help rejecting help because of the fear of getting into trouble. They spoke of a true medical emergency; seizure.

Sen. Fiebiger stated that the title states the immunity was relating to the individual. The committee discussed how things in the past were done and the need to have some parameters. They discussed the kids knowledge of the law and if it looks better if you stay then why run? **Rep. Griffin** would be in support of a number. They spoke of the law enforcement using their discretion and the kids who do the right thing generally do not get charged.

Chairman Lyson called for the motion:

Rep. Boehning made the motion that the House recedes from the houses amendment and adopt the amendment, **Rep. Griffin** seconded the motion. All members were in favor and the motion passes.

Senator Lyson, Chairman closed the hearing.
