Minutes:

All members of the committee were present.

Sen. Dever, Chairman, opened the hearing on SB 2239.

Jim Silrum, Deputy Secretary of State, introduced the bill. See attachment # 1.

He mentioned that the bill will need an amendment. There is repeated language in Section 2.

At the bottom of page one, lines 21-23, when one subsection is deleted, it leaves only one subsection so there is no need for a subsection. There was discussion about how to fix this oversight. Intern, Peter Zuger, will work on it.

Senator Horne asked what the procedure will be for a voter who needs to ask for assistance.

Jim responded that it was on page 2, line 6-9 that a voter had to say why he needed assistance. With this change, a voter can cast a ballot just like any other voter would on Election Day.

Senator Dever remarked that there may be some election workers who were insensitive about a voter's disability.

Jim replied that under the Help America Vote Act of 2002 every state is required to develop a grievance policy or complaint system whereby voters who believe they have been denied access to voting on issues that relate to disabilities have a chance to file that. The only ones

that have been filed since that grievance procedure has been in place have been exactly for

that reason. They went to the polls, were unwilling to declare why they needed assistance, and

the poll workers said they could not vote with assistance unless they would declare why they

needed assistance.

Senator Dever asked how a write-in vote can be done on the Automark System.

Jim explained that there is a keyboard on the screen and directional arrows.

Bruce Murry of ND Protection and Advocacy testified in favor of SB 2239. ND Protection and

Advocacy used to run an election hotline informally on the nights of elections and used to get

calls from voters who ran into barriers because of their disabilities. He reported that there were

no calls this past election from voters with disabilities who had difficulty voting.

Al Jaeger: Testimony attached.

Rep. Meier: Is there a designee at every polling place to help people who need assistance or can anybody do it?

Al Jaeger: There are restrictions as to who can do it. Someone that is connected like a candidate cannot do it. If there is nobody there, the two judges have to be there. You can't just go into the booth when you are the only member of a political party there. It is very well defined. It is just saying that you can't ask questions. It is very well restricted.

Rep. Potter: On page 1 at the bottom, would you explain they are crossing out those lines? **Al Jaeger**: Because line 21 says primary elections and not general elections. It is saying something about an election that the chapter doesn't pertain to.

Bruce Murry: I just want to support this bill and share a brief story that will illustrate the reason to you. They have an example of a voter from western ND who had been asked why he needed help. He had been troubled by that and contacted us. I want to comment on the general sensitivity that is resulting from the effort. Protection and Advocacy used to have a very informal election hotline for people with disabilities. We routinely get calls throughout the evening of the election saying that they weren't allowed to vote or they had a bad experience. I

think it is important to note that since I am the supervisor I was manning that phone line this year's election night. I had a very quite night of paperwork and didn't receive a single call. I think that says something about the increase training and sensitivity.

Rep. Haas: Do you have any statistics on the incident rate of people going to the polls and asking for help?

Bruce Murry: I don't have any statistics on that. I could check into it and let you know.

Rep. Haas: Is there any other testimony on SB 2239? If not we will close the hearing on SB 2239.





Section 1: Requires the candidate's contact telephone number as a part of the requested information on the completed forms.

Section 2, page 1, lines 21-23: Removes an unneeded reference to primary elections in the chapter describing general elections.

Section 3, page 2: Removes the need for a voter desiring assistance to complete their ballot to announce their reason for needing help to the election board.

Section 1: Requires the candidate's contact telephone number as a part of the requested information on certificates of nomination.

Section 2, page 1, lines 21-23: Removes an unneeded reference to primary elections in a chapter that pertains to general elections.

Section 3, page 2: In a situation where the voter requests assistance in completing his or her ballot, the voter is not obligated to provide a reason as to why they are needing the help.
