**Sen. Flakoll** opened the hearing on SB 2278, a bill relating to county and township zoning regulation of concentrated animal feeding operations and a repository for zoning regulations. **Sen. Wanzek**, district 29, testified in favor of the bill.

**Sen. Wanzek**- What this bill is trying to do is that when a local political subdivision does eventually draft some ordinances or some regulations regarding the establishment of feed lots, they would have to file those ordinances in a central location and in this case the state health department.

**Wade Moser**, ND stockmen's association, testified in favor of the bill. See attached graph that he refers to and goes over, time 2:02-8:20.

Sen. Flakoll- which was the red county?

Wade Moser- Pierce county.

**Sen. Taylor**- in your vision of this, would you see there being different gradiations of zoning? **Wade Moser**- I would say that would probably be one of the advantages of having that.

Sen. Klein- it almost sounds contradictory of what we have been debating the past 2 days,

now you are telling us that the townships have zoning authority and here the people are

fighting this because they think the don't have any zoning authority. Are we trying to pass this

central location thing when we really shouldn't be because they can't do it because we have taken that power away?

**Wade Moser**- we have never deviated from that authority at all. We never supported taking that authority away from the townships or counties to do the set back provisions for the zoning. Just let us know what you have got on the books.

**Wayne Carlson**, program manager for NDDA, testified in favor of the bill. See attached testimony.

**Sen. Taylor**- do you envision the global positioning being part of this or is that something that the Ag department would want to do as a service?

Wayne Carlson- at the present time I don't think that we have the resources to do something like that.

Woody Barth, ND Farmers Union, testified in favor of the bill.

**Woody Barth**- We stand in support of this bill. We believe that this would help animal agriculture move forward in ND and we support the intent and purpose of this bill and ask a do pass.

Eric Aasmundstad, president of ND farm bureau, testified in favor of the bill.

**Eric Aasmundstad**- We stand in support of the concept that is contained in within this bill to have a central location for information regarding zoning regulation. I think we have a question whether or not the health department is the correct place to put this. I think the bill ha come about because of the misunderstanding of the current law. The reason that we would think that maybe the health department isn't the place to put this is because we believe there is a very clear distinction between environmental health regulations that the health department takes care of and the actual zoning authorities that counties and townships have. We do believe it would be very good to have a web based list somewhere in existence. The set back

requirements on a county by county or township by township basis because we believe that is the power that is invested into counties and the townships now. That could be unattractive for someone wanting to come into ND and set up shop with a animal feeding operation. We do support the concept and just not sure if the health department should be put in there I would think it would maybe be more appropriate for the secretary of state.

**Sen. Klein**- it is this conflict that I am trying to make sure that we understand, in one bill that we are talking about it talks about taking all this power away, here we are talking about all this power that we have they want it in a depository so what is right here?

**Eric Aasmundstad-** I understand the confusion, I don't believe myself that there really should be any. I believe there is a need for depository so that people that want to set up animal feeding facilities in the state of ND have the ability to go and see how a county or a township has established set back distances. That is the authority that they have under the law now. The counties and the townships are not losing any authority.

Dave Glatt, NDDH, testified in favor of the bill.

**Dave Glatt-** We have no objection to having this housed by the state health department. I think there is some developments that need to be done that e could absorb the costs of. We wouldn't be providing legal advice whether or not an ordinance actually applies. I don't have any objection to this bill.

**Sen. Flakoll**- if you were to have this on there would you have some type of disclaimer on there that to the best of your knowledge the data is up to date?

Dave Glatt- that would be a good idea.

Sen. Taylor- you were never asked to produce a fiscal note for the bill?

**Dave Glatt-** we talked about it a little bit, I think the amount that it will cost to set up we will be able to absorb.

Testimony of Wayne R. Carlson Livestock Service Program Manager Senate Bill 2278 Senate Agriculture Committee Roosevelt Room February 9, 2007

Chairman Flakoll and members of the Agriculture Committee, I am Wayne Carlson, Program Manager for Livestock Services for the North Dakota Department of Agriculture. I am here today in support of SB 2278 would require townships and counties to file their zoning ordinance with the health department to be stored in a central repository.

A North Dakota law allows counties and townships the right to zone land use for concentrated livestock feeding operations. Each county or township can adopt the model zoning or can develop their own zoning requirements. These ordinances vary for county to county or township to township. Access to this information is very important when producers from our state or out of state producers are looking a possible site for a concentrated feeding operation.



Presently the only access to this information is calling to the individual counties and asking for their ordinances. This can be real cumbersome when individual townships also have zoning requirements.

This spring our Marketing Specialist, Bobbie Talmadge, did a survey on all 53 counties asking them these three questions:

Do you have township zoning for livestock feeding operations? Does your county have zoning for livestock feeding operations? If your county is zoned, did you adopt the states model zoning?

I have enclosed the results of her survey for your review. The results of this survey are not really that important as to the purpose of the bill, but the trouble she had finding the information illustrates the problem that exists. In most cases, with a little prodding and repeated correspondence, the county information was available. However most of the information regarding townships adopting a livestock zoning ordinance was not available.


If livestock production is to proceed in this state, we need to provide a place where anybody can go and look at zoning requirements of every county and township. This would save time and money for anybody involved in placing an operation where it is wanted and where it makes sense to place the operation. This bill would provide this type of service to the livestock industry. It would in no way infringe on counties' right to zone as long as they submit the zoning ordinances to the Health Department. Chairman Flakoll and committee members, I urge a do pass on SB 2278. I would be happy to answer any questions you may have.
