

Minutes:

Chairman Holmberg opened the hearing on SB 2374.

Senator Ryan Taylor, District 7, Towner, testified in support of SB 2374, discussed biodiesel fuel and incentives to use the fuel. The main purpose of this bill is to assist bigger users in the state with grant funds to relieve the fuel costs. Counties are especially in need of incentives to aid in fuel costs. The bill asks the State Treasurer to offer incentive payments for number two diesel or 5 percent diesel.

Senator Tallackson asked why the diesel is so expensive and whether service stations were set up to blend the fuel. The response was that the cost was more than likely due to the demand and the fuel can be blended wherever.

Senator Bowman indicated if the fuel is so good, why is an incentive needed. The response was that the counties are so short of funds and this would give them an additional support.

Senator Holmberg asked if SB 2374 and 2408 were separate bills and the response was yes.

Other questions included the difference in price between the two diesels, how the amount of the bill was arrived at, and why is Diesel #1 not included.

Terry Trainer, Assistant Director, Association, of Counties testified in support of SB 2374, indicating the counties are very excited about this bill.

Woody Barth, ND Farmers Union, testified strongly in support of SB 2374, being hopeful that it will increase the use of biodiesel fuel.

Barry Coleman, ND Northern Canola Growers, testified in support of SB 2374 as the Canola Growers believe it would help to grow the biodiesel industry in the state. Biodiesel has a lot fewer emissions than regular diesel which increases the air quality standards, slows wear and tear on equipment.

Questions raised included whether Canadian Canola is the same price as that in ND, if the reduction of wear and tear on equipment is documented, why do we have to pay an incentive to use the fuel, and if there is any horsepower lost with biodiesel.

The responses included yes, prices of Canola in Canada is the same as ND, it is basically an educational effort to get people to use the fuel, and in a test in Minot there was no power drop.

Senator Tallackson made favorable comments about the use of diesel fuel and a conference on diesel fuel he had attended.

Dennis Bremer, citizen Southwest of Bismarck, member ND Soybean Growers, member ND Soybean Council, appeared as a farmer, in support of SB 2374.

Senator Wardner asked about the successes when using diesel fuel in the busses. The response was the fuel is cleaner and it prolongs the equipment.

Chairman Holmberg closed the hearing on SB 2374.


