**Minutes**: Relating to the authority of a federal law enforcement agent to make an arrest for a violation of state.

**Senator David Nething**, Chairman called the Judiciary committee to order. All Senators were present. The hearing opened with the following testimony:

**Testimony In Support of Bill:** 

Sen. Curtis Olafson, Dist. #10 Introduced the bill (meter 1:55) This bill makes good sense.

**Rep. Rick Berg**, Dist. #45 (meter 2:40) The genesis of this bill is the DEA personnel in charge of ND approached us with this idea. Due to the cooperation of the parties the bill gives the D.E.A. the same authority as the F.B.I. This is a good bill to help reduce crime.

**Sen. Nelson** asked if there were any other agents then FBI or DEA? There are other Federal Agents but we only want to open it up to these two. Spoke of the definition.

**Sen. Fiebiger** seemed concern (meter 5:30) in the change of offense. The question is the determination of the level of the crime at the time of the arrest. Reasonable grounds is broad and the additional language would bake it broader.

Dan Ortega, DEA, (meter 7:01)I have been a special agent for 21 years, I was trained at the same academy as the FBI, approx. 90% of our training is the same. Our concern is that when

we are working out in a task force and are assistance is requested, we would have to keep our

weapon holstered. Sometimes on a probation check they see a domestic incident occur and

would like to have our assistance. In the 3 1/2 years I have been hear, I have never had the

call to make an arrest. We do not look for this and this law would very seldom be used. This

would open us up to liability issues we do not want to involve with.

**Sen. Fiebiger** asked other then a domestic; why else would you need to change the offence.

Mr. Ortega spoke of going in on an assist, due to hearing that there may be drugs present; we

are out in our cars. If we get a call for assistance, this would allow us to help. He was asked

(meter 11:00) how many agents in ND 5 DEA non-supervisor and 1 supervised and less then a

dozen FBI agent.

Minutes:

Vice Chair Klemin: We will open the hearing on SB 2378.

**Sen. Curtis Olafson:** Sponsor, introduced the bill. It is so that DEA agents will have authority to make arrests when they see crime being committed, and they are out there in an element of society, where it appears that often happens, so it seems to me that having this kind of authority makes a lot of sense to me. I don't claim to be an expert in this area, and there are others here to provide some expert testimony.

Rep. Klemin: Thank you. Further testimony in support.

Dan Ortega, Special Agent, DEA: I have been an agent for 21 years. I have served in three domestic posts and one foreign post. Our duties here keep us in close contact with our local counterparts on a regular basis. We work very closely with our state and local counterparts. There are five DEA agents here in ND, they carry weapons. There are two here in Bismarck and three in Fargo. I work here in Bismarck. I work very closely with the Narcotics Task Force here in town. A lot of times we go out and conduct business as they do, surveillances, meeting with people under cover, help with arrests. In those situations, sometimes we may need to assist our counterparts in conducting an arrest, it's not covered by the Title 21 statute. So this really gives us the authority to provide support to our local counterparts. We think it is

important. We certainly don't want to be out in a situation with law enforcement and have to think about whether we are able to do this or back up the fellow law enforcement officers. This gives us a little bit more ability to act.

Rep. Klemin: What is Title 21?

**Dan Ortega:** It's the federal controlled substances act, it's everything that has to do with investigating cases of sale of illegal, narcotic controlled substances. It's a federal statute. We have jurisdiction throughout the United States to enforce those statutes.

**Rep. Klemin:** You would have authority to arrest for a violation of those statutes.

Dan Ortega: Yes.

**Rep. Meyer:** You referred to yourself as Special Agent. In reading this, would special agent no longer be applicable, would you just be a federal agent or what.

**Dan Ortega:** This bill addresses DEA in particular. There are other federal agents in the state, but my understanding is that this is meant to provide for DEA only. There are other federal agents that carry guns in law enforcement; they are called criminal investigators in the city.

**Rep. Delmore:** Is this opening it up then to other federal agents besides people such as yourself, as we've changed the special agent to federal agent.

**Dan Ortega:** I believe it says Drug Enforcement Administration in there, as well. Then that would be only special agents.

Rep. Delmore: The Federal Bureau Investigation or federal drug enforcement.

**Dan Ortega:** We have some DEA employees that are not gun carriers. They are support personnel, they are not included.

Rep. Delmore: Wouldn't that change the provisions for them as far as carrying a firearm.

**Dan Ortega:** For the ones that normally don't? I would probably say no, I can't see that they want to be in a position where they are making an arrest or needing weapons for the purpose of making an arrest. They are not side arm personnel; they are secretaries and office support personnel.

Rep. Griffin: Most other states allow the DEA agents to assist in arrests?

Dan Ortega: I don't know if all of them do, but I have worked in states that do allow them, yes.

Rep. Klemin: Other questions. Thank you. Further testimony in support. Testimony in

opposition. We will close the hearing.
