Minutes:

Senator Judy Lee opened the public hearing on SB 2410 to require the state department of health to conduct a system survey of employee and volunteer training in the areas of public health and safety and to report to the legislative council; and to provide an appropriation.

Senator Warner introduced SB 2410 (attached testimony).

Representative Charging testified in support of SB 2410. She stated that in her lifetime she has had opportunities to work with this group of people and this is a growing need in North Dakota. She had a personal experience with a brother who was a quadriplegic. He broke his neck when he was nineteen years old and lived fifteen years in that condition. He didn't need a nursing home but he needed something. He just didn't fit anywhere. She said that the type of work that is described in this bill is exactly the kind of services he required. She asked the committee for their support.

Senator Lee asked for any testimony opposing SB 2410. There being none she asked for any neutral testimony. There was none.

Senator Lee closed the public hearing on SB 2410.

This bill requires the Department of Health to conduct a study of Emergency Medical Services (EMTs) personnel within the state of North Dakota. The amendment to the bill removed the appropriation and one-half time equivalent position.

The purpose of this study is to determine the potential impact of SB 2379, the nurse consortium bill to provide distance learning in the rural areas in nursing training. We would need to survey rural EMS providers in ND to determine if RN training would deplete the volunteer EMS provider ranks. One of the prerequisites for nursing training in this model is that the person has professional experience as an EMT or CNA. This could entice EMTs to go into nursing training and leave their volunteer positions.

Madam Chairman, Members of the Committee,

Senate Bill 2410 was both a forethought and an afterthought relative to Senate Bill 2379, the Nursing Consortium bill that we heard yesterday. When we first conceived of the idea of systematizing the step-up approach to providing for the education of medical professionals and paraprofessionals I think that we expected that the first step would probably be no more than a study resolution laying out a plan which would evolve over several biennia. When we approached Dean Covington for her suggestions we found that she had a fully conceived plan literally in her pocket and so we were ready to move forward, launching a full fledged bill. While we hope that the nursing consortium bill is a raving success we are left with two problems.

1. If we successfully elevate large numbers of paraprofessionals into nursing we will deplete those still essential numbers of Qualified Service Providers and Emergency Medical Providers.
2. There is a continued and growing need for medical and health training for workers whose primary job is not health related but who must have some medical or health training. These are people like school secretaries who are required to act as medication aides or prison guards who need to monitor inmates for psychological disorders.

This bill would have the Health Department pull together various types of training courses which probably already exist into a sort of college catalog, looking for places where it would make sense to provide them as distance learning opportunities and looking for ways to encourage cross discipline training.

Once these courses were standardized I would hope that a certificate could be attached to their completion and that these certificates would be a part of the job application process. For instance a secretary might list a Medication Aide III certificate or a prison guard a Cognitive Restructuring II certificate as part of their resume. Employers who wanted to add these skill sets to their workforce would be able to rent video materials or go on line to train employees.

This bill includes ½ FTE and an appropriation. There is an existing ½ FTE in Health who deals with EMT training and this provision would have made that position full time. I'm not entirely certain that this would be necessary to assure that the goals of this bill are met and it may be that these provisions could be dropped in which case the remainder of the bill is essentially a study resolution.
