

Minutes:

**Chairman Wrangham** opened the hearing on HB 1047.

**Roxanne Woeste, Legislative Counsel:** Read and explained the bill. There is a revised fiscal note for this bill. The Governor's budget does provide a similar increase; that increase is the maximum fee for facilities from \$150 to \$475. That change is included in HB 1015 which is currently in House Appropriations. The governor is not changing the per chemical fee, but are changing the National fee per facility.

**Rep. Headland:** Who actually pays the fees? Is it the distributor and then the supplier or both?

**Roxanne:** I believe it is whoever has control of the storing of the chemical. I believe the department can address that issue later.

**Rep. Conrad:** Did they have a formula or a rationale for raising the fees this amount?

**Roxanne:** I think that should be addressed to the task force.

**Rep. Kretschmar:** Why do we have a revised fiscal note? (Discussed it but not any real question on it except use the revised one.)

**Greg Wilz, Deputy Director, Dept. of Emergency Services:** (see testimony #1).(see testimony #2 from Dave Sprynczynatky.)

If this bill passes then pieces of HB 1016 needs to go away because we would be double dipping from the agency and that is not our intention. This bill does three things; it fixes the agencies problem with running in the red in the program; provide money for the counties and provides some money to train the fire fighters and other first responders. What sites are actually involved with this? In the state of ND we track about 4,000 different chemicals and there are approx. 3,000 facilities across the state of ND. They are owned by 900 different entities. The other facilities that would have that threshold to meet would be bulk plants, gasoline stations, propane and chemical supplier and distributors, concrete plants, sites with batteries that contain sulfuric acid; military sites, food processing plants, water and waste water plants and airports. It is in public law 99-499 and it is federally driven and the state has to have this program. I brought a copy of the Hazardous Program summary report to leave and letter that asked us to do this.

**Rep. Headland:** You mentioned 3-4,000 different sites. I think they are probably being charged fees at multiple locations. It does not seem appropriate to me. Explain to me how the risk of storing these chemicals has increased?

**Greg Wilz:** As far as fees that are collected either by federal or state, I am not aware of any other fees that a storage facility or a handler at a storage facility pays in relationship on having those fees on site within a local jurisdiction. When you think of \$25 to track these chemicals; for that fee I can bring any amount of chemical into the state. That is what caused the law 99-499. Last year ND had 729 chemical spills but only 52 actually required emergency responders. There is an elevated risk across the state of ND to the people that live here and the increases in incidents we have seen in the last few years.

**Rep. Kretschmar:** Why was the fiscal note revised?

**Greg Wilz:** It was a mistake at the agency. The fiscal note that you have revised is the most correct fiscal note. We have run about \$14,000-\$17,000 in the red and that is why we have increased the fees.

**Rep. Nancy Johnson:** Are they getting taxes twice?

**Greg Wilz:** No agricultural user pays these fees, only the local businesses.

**Rep. Nancy Johnson:** Is this a onetime fee?

**Greg Wilz:** No it is a onetime charge. TRI (Toxic Relief Inventory) Sites does not pay these fees. It is the manufacturing plant that brings in the chemical and consumes them there.

**Rep. Klemin:** Discussed the fee discrepancies and wondered why.

**Greg Wilz:** I do not know all the rules but if 1027 because auditors watch how the funds are used and this bill will do this.

**Rep. Headland:** Who pays the fees and are there other areas that require fees as well to train our emergency service providers?

**Greg Wilz:** To my knowledge no, there are no other laws that are specifically driving fees collected to support specific parts of training. This fee is mandatory for that training. The number of hours of training for firefighters for their time on a location. It will take the fire fighters four, five or six years to get everyone trained to the higher standards.

**Chairman Wrangham:** Hazardous chemicals is not new; why the demand now?

**Greg Wilz:** Since 911 a lot of things are being looked at again. Chemicals and the amount of them and how they are being used are continuing to involve. We are seeing more of that in the state of ND than before so the risk is increasing.

**Rep. Conrad:** How is it paid?

**Greg Wilz:** It is a yearly fee and a onetime fee. They pay on the chemicals they have if they increase their fees. They do reports that go in with the amount they fee.

**Rep. Conrad:** Same amount no matter how much they have?

**Greg Wilz:** It is based on a threshold of 50 pounds by the federal guidelines. They hope that the storage facility so that the right to know is kept.

**Rep. Conrad:** Does the railroad pay this fee?

**Greg Wilz:** No they do not.

**Rep. Jerry Kelsh:** Would it not be easier to manage the fees if the chemicals in ND were paid by the manufacturers and distributors, not the dealers.

**Greg Wilz:** Discussed amount of chemical fees and thinks the fee has promoted honesty. We assisted hundred to help them do their reports and I think there is a level of honesty in the agency. I think if we are going to leverage fees outside the state that might be hard to do.

**Rep. Jerry Kelsh:** The reason for this is that it is community specific and people have the right to know?

**Greg Wilz:** Yes, people in the community have the right to know what chemicals are around and what risks they present for their life safety.

**Rep. Hatlestad:** You talked about transport. Is the transportation company required to notify anyone that they are shipping hazardous chemicals through ND?

**Greg Wilz:** sometimes maybe. The railroads have to provide to the local jurisdiction a list of chemicals that are shipped through their jurisdiction. They do have that information on hand at homeland security and they do not have to share that in case of terrorist attacks.

**Rep. Nancy Johnson:** People are pretty good reporting now; won't the increase in fees change this?

**Greg Wilz:** We are talking about \$416 dollars here. I don't think this is a large amount.

**Rep. Klemin:** How long has it been since these fees have changed?

**Greg Wilz:** Since 1992.

**Rep. Corey Mock:** Has a formula based on quantity been considered?

**Greg Wilz:** The report they have to fill out might cause people to fudge that a little bit. That is the reasoning behind a flat fee.

**Rep. Kilichowski:** Is there anything in statues for criminal prosecution if they are not reporting properly?

**Greg Wilz:** The State Emergency Response Commission has the authority to leverage funds. It is the only agency that has the authority up to \$25,000 per day of people not in compliance. Frankly in the three years I have been here it has only been used one time for a company who refused for 2-3 years to fill out their reports.

**Chairman Wrangham:** If the purpose is to notify the public for people's right to know, then there would not be a higher expense to SARA if there were a larger or smaller amount of chemical. The notification is still the same.

**Greg Wilz:** That is correct.

**Chairman Wrangham:** The expenses are what?

**Greg Wilz:** \$252,000 if collected. Fifty percent goes out to the counties; fifty percent stays with the agency. About \$126,000 is for program management and administrative costs.

**Chairman Wrangham:** So your deficit is 10% yet we are looking at a large increase in fees. If the purpose of SARA under title III is to notify the public. Is this a way to fund the preparedness? Do you think it is good to have all these sources funding the same thing?

**Greg Wilz:** yes, I think this is appropriate. If you are going to play you have to pay. The original law allowed for local jurisdictions to do the training and other activities that need to occur in and around hazardous chemical.

**Rep. Conrad:** Does it cause more work if they add another chemical at the same location?

**Greg Wilz:** Across the state they normally call us if they are going to have something different happen. Normally if that happens it goes through the Emergency Disaster system to the locality for the firefighters. That way they can be prepared.

**Lois Hartman, ND firefighter's Assoc:** (see testimony #3).

**Rep. Kilichowski:** Is this a mandate?

**Lois Hartman:** Yes

**Rep. Headland:** How often do people have to be trained on hazardous material?

**Lois Hartman:** Annually.

**Rep. Kretschmar:** Is this also in HB1016?

**Lois:** I don't know.

**Rep. Klemin:** When FEMA put in this requirement was there any additional funding for this?

**Lois:** No

**Rep. Headland:** This \$5,000 cost per individual; would you anticipate that would come down?

**Lois:** We are working on several options to get that to come down, but at this point that is what the cost is.

**Terry Trayner, ND Assoc. of Counties:** In ND we don't have a lot of disasters, but there are always spills going on, but often times the EMS Manager of the county dispatches the fire department to be there just in case. I don't think there is opposition to this bill since this is a service they get in responding to problems when they arise.

**Chairman Wrangham:** If this bill happens, of course, a lot of responders would have to go to that site. Usually if it is a spill caused by negligence there is usually a fine or penalty associated with that. Where does that fee go?

**Terry:** I do not know.

No opposition.

No neutral.

**Greg Wilz:** Since we started talking about changing this law, those discussions moved to the state EMS. By law I chair that commission with 17 members which include private industry as well so they are aware of this. They we OK with the fee rise if the money was going to the responders. Most of the things that happen go through the Health Department if it is environmental based.



Minutes:

**Chairman Wrangham** reopened the hearing on **HB 1047**. I prefer this one because it doesn't increase the \$25/fee but raises the cap for people that use it allot. So the only change in this bill is it raises the cap from \$150 to \$475. The new language is not part of HB 1484.

Quite a few members of the committee have talked to me about the fact that mixing this money with fire associations is a problem with them. HB 1484 does not mix the money.

**Rep. Headland:** Rep. Belter gave me some information that there is a federal bailout.

Homeland security is going to get a whole bunch of money to help train first responders. I think it would be a mistake at this time to raise fees on our local business in this area. I think we should kill the bill.

**Rep. Nancy Johnson:** concerned about the chemical storage; where are they and homeland security requires this.

**Rep. Corey Mock:** HB 1484 was introduced by whom?

**Chairman Wrangham:** All leadership.

**Rep. Klemin:** If we think there is some good and some bad in this bill we could amend it to make it what we think it should be and then we won't have to worry about what might happen in another committee at some other time. Or we could make it identical to the other bill.

**Rep. Kilichowski:** I like that some of these funds do go to the firefighters. Especially for training and preparedness and chemicals. There are new chemicals coming out all the time.

**Rep. Headland:** In the testimony didn't Mr. Wilz say that they are already doing the training. They just have to revert to some of their general funds in order to pay for it. Isn't that proper use of their own money they already have rather than to increase fees on our local businesses in order to pay for something they are already paying for?

**Chairman Wrangham:** The way I understand it lets give them all the money we can find to give them, but I think this section of law was set up for notification about hazardous chemicals being in the area. So why don't we collect enough money for what this section is suppose to do instead of trying to funnel money out of that so that is my problem with it.

**Rep. Conrad:** I think people are breathing in the chemicals; they need to be responsible for it so the rest of us know it is there.

**Rep. Koppelman:** Lines 16-18 it appears that currently the money goes to the county half of this money goes to the county hazardous chemical preparedness and response account. Under the bill one third would go there.

**Rep. Zaiser:** the only way I would support the bill is if all the money goes to the local groups.

**Rep. Headland:** I am not asking this to come out of the state's general fund. The department budget has been picking up the overrun because the current \$25 does not cover the cost of the full training program.

**Rep. Hatlestad:** I thought they said they weren't in deficient because they covered it with their own budget \$16,000 of the cost overrun for inspections and information for the whole state, but they were having to take money out of their budgets to pay bills that should have been covered by the fees.

**Rep. Klemm:** A person from the firefighters association said they had increased the requirements to qualify and they needed more training to get firefighter certification; however, there is no federal money being provided to get this additional training they need to become certified. That was the reason they were proposing transferring one third of these funds to the firefighters association.

**Rep. Jerry Kelsh:** I think there is more emergency money coming; maybe we don't need this. That would take care of the county's share of fees. We have a little time. I would prefer we hold it for awhile and see.

**Rep. Klemm:** Our alternative is for us to take action on this bill and if we do pass it; the federal action is suppose to happen before the senate is done with theirs so if the fire fighters get a lot of training money out of this federal law then they don't need it out of this. But what if they don't?

**Rep. Jerry Kelsh:** then I think HB 1047 is a better bill than HB1484. At least it does go to the firefighters.

**Rep. Corey Mock:** On going through Mr. Wilz testimony I can't help but see a number of discrepancies. At the end of Mr. Wilz testimony he sites also HB1016 that withstanding \$25/chemical for the first 15 chemicals to the first 19 chemicals. In HB 1047 it also says we raise the amount per chemical to \$52 and I did not see where it changed from the first six to the first 8, but they say \$415 is maximum and that would be 8 chemicals. There are three bills with three different funding formulas and charge formulas for these chemicals so I think we need to contact with Mr. Wilz or the leadership that introduced HB 1484 and determine what is the ideal formula for this so we can take appropriate action.

**Chairman Wrangham:** It has a fiscal note so we are going to have to act on this soon.

**Rep. Pietsch:** I think they talked it over and if the HB1016; if nothing happens to this it might affect what we are doing.

**Chairman Wrangham:** Can we kill this bill?

**Rep. Klemm:** Can we have that other bill re-referred to this committee??

**Chairman Wrangham:** I think we can if it is not scheduled but found out their hearing is scheduled. Check with your leadership and we will check with ours'. This has a fiscal note so we will have acted on ours' before next Friday.



Minutes:

Chairman Delzer opened the hearing on House Bill 1047. Roll was taken at a previous hearing earlier today. The title of the bill was read.

Representative Wrangham, Chairman of the Political Subdivisions Policy Committee, explained the bill.

**Representative Wrangham:** The bill deals with the amount that is charged a fee for chemical registration. The committee heard testimony and decided to not decide. It came out of the committee without recommendation on a vote 6-6. The bill raises the fee from \$25 to \$52 for chemical and it raises the total amount collected per year from \$150 to \$416. Also in the bill is at the bottom of page one lines 19-22, distributes some of this money raised to the Firefighters Association to use to support training and response capabilities of these firefighters.

**Representative Kaldor:** Is it the chemical companies that would pay this bill?

**Representative Wrangham:** The way I understand it to be the people who bring the chemical into the area, the wholesaler or the distributor if you will.

**Chairman Delzer:** In the end it is the purchaser that pays them though. We all understand that. Yesterday I had mentioned the brake down for the firefighters. What this bill is trying to do

is raise another \$160,000 for the Firefighters Association. My understanding on this situation is when they came to the Governor's Office they said they needed \$500,000 which is what they put in the Insurance Commissioner's bill. After that and Tammy, correct me if I am wrong, my understanding is after that the Firefighter's Association went and talk was made to the Public Safety committee that on top of the \$500,000, they needed this \$160,000 so they put this bill in to raise these fees. It changes the direction of the fees. Currently the fees go half to the counties and half to Emergency Management, I believe it is. With this bill it would go a third, third and a third and it is the same money for counties and Emergency Management but then the Firefighters Association will also get \$160,000. That is what OMB has said, the deal was made at \$500,000 and that was supposed to be enough to support the Firefighters Association and that is why they put the \$500,000 in the Insurance Commission bill that we dealt with yesterday afternoon. This would be on top of that. Now the Firefighters schedule for this says that they need this to cover everything they want. My understanding from the visit with the Fire Chief out of Garrison was that his understanding was they needed the money and that it was upfront before. My understanding from Tammy is that the deal was made and then this was asked for after the \$500,000.

**Tammy Dolan, OMB:** That is basically what happened. The interim Public Safety committee looked at this issue and they came up with a number of bills and this is one that came out of that as I understand. It was to do exactly what you said. When we put the Governor's Budget together, we took a different approach and appropriated directly to the Firefighters Association instead of changing the way this fee was distributed. That is why we had included the \$500,000 in the Insurance Department budget.

**Chairman Delzer:** Your understanding was that the \$500,000 was supposed to cover it.

**Tammy Dolan, OMB:** That is correct.

**Representative Wrangham:** Coming out of committee without recommendation, maybe I could just give you a little bit of each side said. Those who supported the bill supported more education and training for firefighters and thus supported the bill. Those who opposed the bill said that they also supported more money for firefighters but thought there was a better way for them to get the money and that would be through the appropriations committee and through funding from the General Fund in that this chemical fund was set up originally for notification. The fee was designed to cover the cost of notification of the community that these hazardous wastes were present. Not to be used to supplement training for the firefighters. Everyone supported the training for the firefighters it was just a matter of how to fund it.

**Representative Berg:** So this came without recommendation.

**Chairman Delzer:** Right.

**Representative Meyer:** I know you have said this again but for those of us with bad memories how many firefighters does \$500,000 train? How much is it for each firefighter?

**Chairman Delzer:** They pay \$40 on top of this and that is part of that schedule. This is supposed to be enough to train every firefighter in this state in the next two years. I was told that is what they needed to be eligible for the federal grants. For them to fill out requests for a federal grant, one line item in there says are you trained to section 1022a or something that way. That is what this would do. I think they can do it without this \$80,000. That is what we are giving them the \$500,000 which the Governor's Office suggested was enough.

**Representative Kaldor:** If I could ask OMB, when deliberating on this as a General Fund appropriation as opposed to what is laid out in HB 1324, were you aware of what the Legislative Council Public Safety committee had passed out?

**Chairman Delzer:** My understanding is that the Governor's Office passed this out first.



**Tammy Dolan, OMB:** We knew that the Public Safety committee was working on this. In the budget that we were working on with the Adjutant General this issue also came up because it comes up in their budget. We looked at it and said that we would like to do the training, we think it will be beneficial. We did not want to raise the fees to this level and change the distribution. We thought it would be an easier funding approach to use the Insurance Department.

**Representative Glassheim:** Was there any discussion whether the counties or agencies need the additional money to do this or does the bill mainly benefit the fire.

**Chairman Delzer:** This just does the change for the firefighters. We have already passed the bill on the floor I believe that made the changes. It was a part of the Insurance Commission bill, it was pulled out. That went through GVA and I believe that has already passed on the floor.

**Representative Glassheim:** The increase in fees has been passed already?

**Chairman Delzer:** Not the same increase but the increase that the counties and the department wanted. This one here simply makes the change. It raises the fees again but all of the money that this bill raises goes to the Firefighters Association.

**Representative Glassheim:** Not according to the fiscal note. But that is what you were saying is that this has already been done in the other bill.

**Chairman Delzer:** Right. All of the new money that this bill would raise would go to the Firefighters Association.

Chairman Delzer closed the hearing.

Mr. Chairman and members of the committee, my name is Greg Wilz. I am the Deputy Director of the Department of Emergency Services (NDDDES) and Director of Homeland Security for the state of North Dakota. Today I am here as a representative of the task force established at the request of the interim Public Safety Committee. The Public Safety Committee asked that the task force be established to request improvements to emergency services by adding organizational changes, system upgrades, process or protocol changes and statutory changes to ensure the future viability and capability of emergency services in North Dakota. My intent is to provide background information as was discussed within the task force and not to take an agency position on HB 1047.

The department administers the state's Superfund Amendments and Reauthorization Act (SARA) Title III program as outlined in 37-17.1-07.1. One and two-thirds FTEs support administration and operational requirements of the program. For the past three years, increased work demand has forced the department to operate at a deficit and use general fund dollars to support program requirements. HB 1047 will resolve programmatic funding issues but more importantly will create a funding stream to assist first responders build response capabilities for incidents involving hazardous chemicals.

The task force identified that the requirement for firefighter certification in hazardous chemical response was being raised from an "awareness" to "operational" level. Approximately 7,000 of the state's 8,000 firefighters require this training and the financial impact would severely reduce operational and maintenance funding within local fire departments. The task force felt it was appropriate to shift the cost burden for response capability to the industries that have increased the risks of hazardous chemical incidents.

HB 1047 provides funding to train responders in hazardous chemical response, allows the department to administer the program using special funds, and provides Local Emergency Planning Committees (LEPCs) increased funding to support training, exercise, and response equipment as outlined in 37-17.1-07.1.

As General Sprynczynatyk indicated yesterday, you would be informed about those Interim Public Safety Committee bills that were included in the agency's budget. Part of this one is in HB 1016. In a separate action, the executive budget included funding for the North Dakota Firefighter's Association (NDFA) to improve training. Due to the availability of those funds, the agency's budget in HB 1016 raises the maximum revenue that can be collected per facility as defined in section 312 of SARA Title III by increasing the threshold of chemicals that incur a charge. In current law, \$25 is the charged per chemical for the first six threshold chemicals; HB 1016 allows \$25 per chemical for the first 19 chemicals. The increased revenues offset program deficits and provide LEPCs enhanced funding.

I have received the request the Public Safety Committee made at its July 17, 2007, meeting, that I, as Chairman of the Legislative Council, encourage the Adjutant General to assemble a task force for the purpose of identifying the strategic structure and capability of emergency services in the state of North Dakota, including emergency response organizations, response protocols, interoperable communications, and emergency management.

Task force membership should include the following response organizations:

1. Division of Homeland Security.
2. Division of State Radio.
3. North Dakota National Guard.
4. North Dakota Police Chiefs Association.
5. North Dakota Sheriffs Association.
6. North Dakota Fire Chiefs Association.
7. North Dakota Metro Fire Chiefs Association.
8. North Dakota EMS Association.
9. North Dakota Healthcare Association.
10. North Dakota Emergency Management Association.
11. North Dakota 911 Association.
12. Department of Emergency Services.
13. Other members as determined by the Adjutant General.

The primary goals of the task force will be to:

1. Suggest the future structure and capability requirements necessary to fulfill North Dakota's emergency services needs through 2015.
2. Identify gaps between the current state of emergency services and the prioritized capabilities required in the future.

3. Provide the Public Safety Committee recommended initiatives for possible consideration by the 2009 Legislative Assembly which will help bridge the organization and capability gaps.

The task force should focus its efforts to improve emergency services by addressing:

1. Organizational changes;
2. System upgrades;
3. Process or protocol changes that need to be established in the North Dakota Century Code; and
4. Statutory changes that should be considered to ensure the future viability and capability of emergency services in North Dakota.

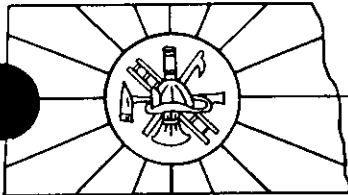

## **HB 1047** **Lois Hartman** **Executive Director**

Mr. Chairman and members of the House Political Subdivision Committee, my name is Lois Hartman. I am the Executive Director and the State Training Director of the North Dakota Firefighter's Association (NDFA). I appear before you today in support of HB1047.

As the state training agency for the fire service it is the responsibility of the North Dakota Firefighter's Association to offer training and education opportunities that meet the national standards required by FEMA. This past fall, the National Fire Prevention Association, which is the professional standards setting body, updated the qualifications standard for firefighter certification. The updated standard requires that all first responders be trained to the hazardous materials operations level. At the current time, the NDFA offers awareness level training, which is a 4 hour course. Operations level is the next step and is a 24 hour course. It is also much more expensive to offer because of the equipment required for the training and the additional instructors for the hand-on portion of the curriculum. The cost of the initial operations level course is about \$5,000 with a required annual refresher course costing about \$2,500. The 4 hour awareness level training costs about \$500 with a required refresher every 2 years at a cost of \$500.

The NDFA has 376 member fire departments. If it were possible to certify each of the departments to the operations level in a two year period, it would cost an estimated \$1,880,000 and an additional \$ 564,000 for the first year of annual refresher courses. The cost for providing the operations level training far exceeds the NDFA budget. While the funding from this bill will not cover the cost of providing operations level training, it will certainly help with that need. Therefore, I urge a do pass on HB 1047.

Thank you, Mr. Chairman. That concludes my prepared remarks. I would be happy to answer any questions you or the committee may have.
