Greg Wilz, Deputy Director, Department of Emergency Services: (Attachment #1)

(testimony #2) Explained proposed amendment.

Rep. Koppelman: the original version of the bill as you indicated talks about exemption for willful negligence is still there?

Greg: When you add in the folks you are looking at beginning of paragraph I on page 1 line 7, it cares down through 15 except case of willful misconduct, gross negligence so it is covered there. If you carry it on down it says will not be held liable.

Rep. Koppelman: Both the original bill and your amendment talks about all these organizations or people are working in coordination and under the direction of appropriate state agency. However, ND is a state where neighbor helping neighbor and I grew up in a community where everyone helps everyone else. Discussed sandbagging when flood was happening. Do you want that immunity for anyone or do you want them to be sued too?

Greg: I think any law has a loop hole of some kind. The state law says any person performing a function as directed by another entity is included here as a worker. If you were pitching those sand bags you are an emergency worker and you would have been covered.

Rep. Koppelman: Is there a Good Samaritan law that takes over where some of those questions would come in?

Greg: Yes we believe it does.

Rep. Zaiser: Under the existing law we have now is the law the way it is written been a deterrent for people providing assistance?

Greg: It has not been a deterrent but the level of disasters has not reached the level of the Katrina's or Greens Berg Kansas level. In those instances we have seen large benefactors come in and help. The corporate folks are demanding this; that they be held free of liability if they are going to make donations. It is something that if we would have an incident, as opposed to having to do separate legal agreements on receipt of goods, this law would cover us and makes us ready and prepared.

Rep. Zaiser: Everyone has the right to sue and be sued; equal protection under the law. I am concerned about community trying to create immunity for some business or some group; whatever. If we start adding these immunities in the law the only ones left to be sued is us individuals.

Greg: I believe that the greater good has to be looked at here. We are still able to be sued due to misconduct or negligent.

Rep. Conrad: I am pleased to see your amendment. It looks like you guys are getting off. In 1969 the most important heroes were the Corp of Engineers. We all knew we did what the corp. said or we were out of there. I think it is very important we have you guys in charge and able to be ones that determine how goods and services are offered. I know you are the ones liable for goods and services.

Greg: I think appropriately so. At the level that we would be bringing the stuff in clearly we would have exhausted all local resources; mutual aid resources and at some level state resources.

Rep. Corey Mock: Talking about the Good Samaritan law to protect them in these kinds of emergency's why is there not an emergency clause?

Greg: Good question. Feel free to add it.

Rep. Hatlestad: In your amendment you talk about under the direction of the appropriate state or local agency and you mention something about a government entity. Does there have to be a state agency in order to get this protection?

Greg: What we said was under the direction of the appropriate state agency. Our attempt there was the appropriate agency with regard of the product that is coming in.

Rep. Hatlestad: could state agency be the common emergency director that was coordinating that activity. Does it have to be you in order for that person to donate something? Does it have to be under the direction of a state agency?

Greg: No it does not have to be under a state agency. However, it would normally generally be because that is the process when it comes in at this level. I don't believe it precludes any local emergency operation center. Our intention was the large corporate organizations.

Rep. Kretschmar: Has anyone been sued based on this law?

Greg: I have not heard of anyone being sued.



I am the Deputy Director of the Department of Emergency Services (NDDES) and Director of Homeland Security for the state of North Dakota. My intent is to provide information concerning the importance of HB 1128 as it relates to NDDES.

In paragraph one, HB 1128 amends NDCC 37-17.1-16 by extending immunity and exemptions to people, organizations, or private entities that donate goods and services during emergency events. The intent is to increase the willingness of various benefactors who contribute based upon wealth, corporate policy, and a sincere desire to help.

Recently, new sources of aid have made a distinct difference during response and recovery phases of large scale disasters. From Katrina to the Greensburg Tornado, it is the resources from this huge cross section of donors that is vital to public safety.

Immunity and exemptions legislation facilitate these donations. When Walmart and Target want to deliver mass quantities of food, water, ice, or blankets, there is a level of state commitment expected that will not hold them liable for actions resulting from product or service problems after the delivery.

I do not know the extent North Dakota will benefit from passage of HB 1128 but I do know the national trend is to adopt such protective measures that clearly open more opportunities for assistance.

Chairman Wrangham and members of the House Political Subdivisions committee, good morning.

My name is Katie Moore Aitchison and I am here today representing the Bismarck-Mandan

Chamber of Commerce.

I am here supporting House Bill 1128, relating to immunity and exemptions for organizations and entities when contributing for the sake of disaster relief.

Businesses and organizations are not only willing to help when the need is there, they want to. People do not generally have the desire to stand by and watch as their neighbors struggle due to an emergency situation. There is an inherent desire to help. However, if an organization fears their assistance today might mean a liability suit and the organization may not be around to assist another day that inherent desire drains away.

House Bill 1128 will allow businesses to give and volunteer, as well as allow our community ties to be strengthened. Over 1200 businesses and organizations are members of the Chamber. If, god forbid, an emergency were to be declared for our area, those 1200 members could have an amazing impact on the area, working to restore the community to pre-disaster conditions. If a fear that each of those 1200 members could face a potential lawsuit if something accidently went wrong, the effect on the community will be as devastating as the disaster itself.

When fear of litigation and liability overshadow the need for products and services during a disaster or emergency, we are asking for a longer struggle and harder road. Passing House Bill 1128 opens the doors for giving and assistance without the fear there will be repercussions.
