amendment we are going to give specific and special exemption to individuals who are injured

through negligence - through fault - of somebody. It just happens you get injured in a land

area such as in a situation, you can have some extrordinarly harmeful events. When he talks

about putting a \$250,000 cap he is not talking about insulating a landowner what he is talking

about is insurance that is available to that. Shifts the burdon for that injury - for that loss -

from the insurance company to the person that is injured. The \$250,000 immunity is not to be

applicable. We ask you NOT to support this amendment. Questions

## Testimony, North Dakota House of Representatives Natural Resources Committee Presented: January 23, 2009 – 9:00 a.m.

Good morning. My name is James Odermann. I live in Billings County and speak to you today on behalf of the North Dakota Nature and Rural Tourism Association. The North Dakota Nature and Rural Tourism Association is an organization dedicated to sharing North Dakota's natural assets with a growing tourism industry. We have membership across the state from Pembina to Bowman, from Wahpton to Williston and parts in between.

Our natural resources determine the quality of our life's place. The quality of place is further defined by the space that abounds (less than 10 persons per square mile) and the reason(s) why we CHOOSE to stay in North Dakota. This is an attraction and we need to commit resources (time, talent and treasure) to develop a vision that can protect our quality of place and assist others with basic needs to sustain life choices.

The North Dakota Nature and Rural Tourism Association membership is comprised of entrepreneurs who do not have expenses accounts, company cars or per diem. A common thread among our members is their connection to the land.

In actuality, our membership is at risk everyday seeking to find ways to generate a revenue stream to cover associated costs. Liability concern is a major limiting factor in enterprise development.

The proposed language in section 53-08-05 to exempt those with sales under \$100,000 is a major step to helping alleviate the liability concerns. This protection could invite young people to become engaged in "staying home" to vertically integrate our land base and develop nature based tourism activities. These activities can supplement traditional revenue streams of production agriculture, enhance local economies and promote our state.

I speak today asking for your favorable consideration of House Bill 1189 to provide liability protection for many of our members
