Chairman Porter: I agree in part with this bill. You can't list every crop. The problem with the bill & the law previous to this was that it didn't include oil seed corps it just said cereal crops.

Chairman Porter: We have a motion from Rep. DeKray – do we have a 2<sup>nd</sup>?

2<sup>nd</sup> from Rep. Nottestad. On line 9 after the word crambe insert the words soybeans,. Any discussion on the amendment? Any discussion on the amendment? All in favor Yeas – unison vote — opposed — no opposition. Motion carried.

Chairman Porter: Rep. Nottestad

Rep. Nottestad: If I read this the intent of this bill is good and I agree with it. There is so much that is open. It lists alfalfa grown for seed, but in a good year the third cutting of alfalfa in an irrigated area is grown for hay. My amendment would be cereal crops grown for seed or hay. That would cover both.

Chairman Porter: I read that different than what you are reading it. The reason is on line 8 the definition of cereal crop include alfalfa. Then you go back up to line 7 and it says an unharvested cereal crop is covered. Alfalfa is covered as a cereal crop in the present for it is

written. I think your amendment makes it cloudier and takes away from the clarity that is already there. Rep. Hofstad

Rep. Hofstad: I think the whole thing is cloudy. We are leaving out edible beans etc. It is going to be hard to list every edible bean crop.

Chairman Porter: Chief would you like to step up here for a minute?

Chief Timian - Chief Game Warden - ND Game & Fish - Rep. Nottestad

Rep. Nottestad: How do you interrupt it? If someone is hunting in an unharvested crop are we going to go down the list of all the crops or how are you going to interpret it?

Chief Timian – It is a question dealt with in the court, not in my officers. Most hunters don't go into unharvested crops unless they ask. We do get some that do. The technical stuff you are asking gets handled between attorneys and judges not us. When we use the word cereal crops include – when the word INCLUDE is used it does not limit the list only to those crops. It says those crops MUST be included. There could be other crops included but are not listed. If

Rep. DeKray: That answered my question. Why don't we just end it with unharvested crops period?

Chief Timian - Maybe you could say unharvested crops that have commercial value.

it said cereal crops ARE, then only those crops listed could be considered.

Rep. Clark: Why not just let unharvested crops define the issue.

Chairman Porter: Rep. Keiser

Rep. Keiser – I concur -- when in reads includes it means implied. It is asking that oilseed crops be included and it seems reasonable.

Robert – It is reasonable – I don't think if we had a bean or pea crop that was unharvested I don't think we would have a problem prosecuting but there again that would be between the

attorney and the judge. We have had an issue with the oilseed crops because they aren't raised for food they are raised for oil.

Chairman Porter - The interpretation of 3<sup>rd</sup> cutting alfalfa.

Robert – Bill doesn't say 2<sup>nd</sup>, 3<sup>rd</sup> cutting alfalfa, so that would be considered an unharvested crop.

Rep. Nottestad – The reason I brought it up is what the rest of it says – grown for seed. If the farmer/rancher wanted to cut it instead of letting it go for seed.

Robert - I would suggest that is your decision.

Rep. Hunskor – Is the committee ready for a Do Pass? I would so move.

Chairman Porter - There is a motion on the floor – I was going to ask Rep. Nottestad to withdraw his motion and second. And bring this up at a later time.

Rep. Nottestad – I withdraw my motion.

Chairman Porter - And a 2<sup>nd</sup> from Rep. DeKray to rescind the motion. Close hearing on HB 1217.

**Senator Freborg** why isn't it easier to say it is unlawful to hunt or pursue game in ANY or ALL un-harvested crops?

Senator Triplett I think that Senator Freborg makes a valid point. The way the law is written now it only says un-harvested cereal crops. There are some prosecutors out there, like Senator Hogue said, who might not know that corn is a cereal crop and there are other crops that should be included.

Senator Schneider Can we include corn within the definition of cereal crops just to be clear?

Senator Lyson according to Senator Krauter it is already defined as a cereal crop.

**Robert Timian,** Chief Game Warden with the Game and Fish Department, My understanding as to why this was introduced was not to broaden it too much, but to make it clear what is considered an un-harvested crop. People have their own definitions of un-harvested crops.

**Senator Hogue** there is a definitions section in the code and cereal is not defined. I think of small grains as a term that is more often used to define cereal crops. Is there a place where we can look to see if cereal crops are defined in the code?

**Robert Timian** I can assume you can make whatever definition you wanted. We haven't had a big issue with this law other than couple instances with oil crops where a couple of attorney's questioned it.

**Senator Triplett** a couple of years ago we did have some complaints of hunters walking through winter wheat fields and apparently not knowing that they had been planted. I assume that is clearly covered in the reference to cereal crops.

**Senator Triplett** Would we want to include such things as vegetables? We have heard testimony in relation to a water bill that people grow vegetable gardens in fairly good sizes for truck gardens. They are also a known attraction for deer.

**Senator Triplett** asks Mr. Timian how he would interpret that if you were discussing with a prosecutor under this law if someone complained about hunters trampling through their unharvested pumpkin patch was a problem.

Robert Timian it has never happened, but I suppose it could. We would view it as an unharvested crop and that is the way we would argue it.

Senator Triplett it doesn't fit within either of these definitions.

Robert Timian any of these laws can be argued in court by attorneys.

**Senator Triplett** they can be argued but they should be decided on the plain meaning of the language. I think the judge would look at these very specific definitions and say "I'm sorry but vegetables are not included".

**Robert Timian** if you feel strongly that you want to include it I would have not opposition. I don't think it is a major issue out there in terms of enforcement.

Mr. Chairman,

Members of House Natural Resources Committee,

Century Code 20.1-01-22 addresses hunting game on lands having unharvested crops. As written, there is a question of whether oilseed crops are included in the definition of unharvested crops.

Timony

Hettinger County State's Attorney brought this to my attention. There was an incident in our county where a farmer discovered hunters going through his unharvested sunflowers. The farmer looked at prosecution; the attorney revealed hunters may be within their rights, the law isn't quite clear. My understanding is that Game and Fish were also contacted; they also expressed concern of "safety" hunting under those conditions.

I am not familiar with the original intent of the law, but feel strongly that oilseeds should be included in definition of unharvested crops. Clarifying the question I believe will help foster more positive farmer/hunter relationships, plus enhance the safety of all involved.

Please look at HB 1217 favorably, it's intent is not to restrict hunting in any way - this clarification should benefit all.
