I worked with Rep. Pollert to put some language together for a study resolution. Unfortunately, when it went to Legislative Council, it inserted state child protection team in a number of places in here. That is incorrect. Mr. Murphy's intent

I requested that Representative Pollert introduce this legislation as I feel that many of the cases that come before social services have inadequate evidence of the true situation.
