Chairman Keiser: Opened the hearing on SB relating to workers' compensation permanent partial impairment awards for loss of vision, provide for application and declare an emergency.

Ellen Le Tang

Jennifer Clark~Legislative Council. This bill has been engrossed. Dealing with permanent & partial impairment awards as it relates to WSI. Generally, what it means is that you reached you maximum medical assortment and you still have some type of impairment. The WSI law is designed to compensate for you that damage to your body. It doesn't directly have to do with the loss of wages with your inability to go back to work, that's not it. It's saying that the body is damage and there is a value to that and we are going to recognize it. That's the universe that we are in now. Now we are going to value how much your body has been damaged. You have two different systems within that universe with what we call PPI. We have a basic analysis with a whole lot of impairment evaluation. Let's say I have a significant leg, hip and back workforce injury, they are going to evaluate all those parts together and figure out how much of my body is impaired. If it's 16% or more, I'm going to get a PPI award or a lump of sum paid over time. That's one way to get your award, 16% or more full body impairment.

That's not what we are dealing with here; we are dealing with the other way you can get a PPI award. We have what you call a scheduled list and these are primarily amputations. That

where we put specific value to that outside of that universal whole body impairment. If you

look on page two at the very end on lines 29 & 30, we are adding on a new type of scheduled

injury. It's not for the physical loss of your eye, you can still physically have your eye, but the

vision loss to your eye, with correction, the best you can see is 20/200 out of that eye. That's

how we are going to reimburse you and you will get a multipliers and I will leave it to WSI to

talk about how those multipliers help you. I want to point out that we have an application and

emergency clause on the third page.

**Representative Ruby:** These are one time payments?

**JClark:** That's my understanding.

#### Testimony of Bill Shalhoob North Dakota Chamber of Commerce SB 2057 January 19, 2009

Mr. Chairman and members of the committee, my name is Bill Shalhoob and am here today representing the ND Chamber of Commerce, the principle business advocacy group in North Dakota. Our organization is an economic and geographical cross section of North Dakota's private sector and also includes state associations, local chambers of commerce development organizations, convention and visitors bureaus and public sector organizations. For purposes of this hearing we are also representing six local chambers with total membership over 3,900 members ten employer associations. A list of those associations is attached. As a group we stand in opposition of SB 2057 and urge a do not pass from the committee on this bill.

The addition of loss of vision "based on a change of corrected visual acuity" creates an open ended claim that the bureau will have difficulty applying a consistent standard for. Vision loss and change is tied to aging as much or more than any outside event. How are we to determine which factor, the workplace accident or normal aging, caused the loss of vision? We feel by adding this open ended language we will be creating a benefit that will become a source of contention for the bureau and claimants.

## 2009 Senate Bill No. 2057 Testimony before the Senate Industry, Business, and Labor Committee Presented by: Tim Wahlin, Chief of Injury Services Workforce Safety & Insurance January 19, 2009

Mr. Chairman, Members of the Committee:

My name is Tim Wahlin, Chief of Injury Services with WSI. I am here on behalf of WSI to testify in opposition to this bill, a proposal submitted by the Interim Legislative Workers' Compensation Review Committee, and to provide information to the Committee to assist in making its determination. WSI's Board of Directors opposes this bill.

This bill is intended to augment and ultimately increase one particular area of Permanent Partial Impairment awards specifically having to do with gradations of vision impairment suffered by an injured worker in the course of employment. WSI's opposition is based upon the bill's departure from a system of impairment rating that already exists. The system which has been adopted has standardized rating methodologies and relative weights assigned to awards within our system.

North Dakota law has codified the usage of the American Medical Associations fifth edition of <u>Guides to the Evaluation of Permanent Impairment</u>. This publication is compiled in order to provide a standardized method to assess permanent impairments and the relative impacts those impairments comprise on an individual's ability to perform activities of daily living.

The <u>Guides</u> use objective and scientifically based data when available and reference these sources. When objective data is not available, estimates of impairment are based upon clinical experience and consensus of a wide variety of medical specialists.

The objective of the <u>Guides</u> are to provide a valid and reproducible measurement system which standardizes the relative impacts an impairment may have on an injured worker's activities of daily living. The <u>Guides</u> are subjected to a constant process of refinement and redefinition as medical evidence evolves and new research becomes available.

WSI's concerns with this legislation are that this bill rejects the scientific rating system and supplants that with the subjective valuations regarding certain impairments. WSI views the departure from this longstanding and scientifically supported rating system as a step backwards, to a system of scheduled impairments.

Scheduled awards still exist within WSI's law for a limited number of amputations. They are the lone departure from our <u>Guide's</u> regulated system and are a carry over from earlier days. They are manageable based upon the clarity of the injury and the immediately measurable impairment. This is not the case with the bill before this committee.

WSI's concerns are not with respect to an increase in the awards for vision loss, but, rather with the methodology and ultimately with the dislocation of award values as compared with other impairments.

SB 2057 does contain an emergency clause and would apply to injuries occurring after the effective date of this Act. The bill will serve to increase future benefit costs, but the potential increase is not likely to be material to statewide premium levels.

The objective of the <u>Guides</u> are to provide a valid and reproducible measurement system which standardizes the relative impacts an impairment may have on an injured worker's activities of daily living. The <u>Guides</u> provide for the rating of vision loss, however, not at the level proposed by this bill.

North Dakota law also provides for PPI awards in cases of amputation pursuant to a schedule contained within the statute. This bill adds vision loss in one eye which equals or exceeds 20/200 corrected, to this schedule. The corresponding award is an

impairment multiplier of 100. Currently, with one third of the state's average weekly wage at \$209, this will make an award under this provision worth \$20,900.

Engrossed SB 2057 contains an emergency clause and would apply to injuries occurring after the effective date of this Act. The bill will serve to increase future benefit costs, but the potential increase is not likely to be material to statewide premium levels.

Mr. Chairman and members of the committee, my name is Bill Shalhoob and am here today representing the ND Chamber of Commerce, the principle business advocacy group in North Dakota. Our organization is an economic and geographical cross section of North Dakota's private sector and also includes state associations, local chambers of commerce development organizations, convention and visitors bureaus and public sector organizations. For purposes of this hearing we are also representing six local chambers with total membership over 3,900 members ten employer associations. A list of those associations is attached. As a group we stand in support of SB 2057 as amended and urge a do pass from the committee on this bill.

The addition of loss of vision and the 20/200 standard in the bill is consistent with the other applications in this section and incorporates the objective and measurable standards necessary for fair and impartial claims adjudication.

#### PROPOSED AMENDMENT FOR SB 2057

Sylvan Loegering, ND Injured Workers Support Group March 2, 2009

SECTION 1. AMENDM, ENT

On page 3 line 7, change the word "fifth" to "sixth".

**NEW SECTION 2. AMENDMENT.** Subsection 6 of section 65-05-12.2 of the North Dakota Century Code is amended and reenacted as follows:

6. A doctor evaluating permanent impairment shall include a clinical report in sufficient detail to support the percentage ratings assigned. The organization shall adopt administrative rules governing the evaluation of permanent impairment. These rules must incorporate principles and practices of the fifth sixth edition of the American medical association's "Guides to the Evaluation of Permanent Impairment" modified to be consistent with North Dakota law, to resolve issues of practice and interpretation, and to address areas not sufficiently covered by the guides. Subject to rules adopted under this subsection, impairments must be evaluated under the fifth sixth edition of the guides.
